

President's Message

Friends,

Mrs. Nirmala Sitharaman, India's first full-time lady Finance Minister presented the nation's Union Budget 2019-20 on July 5. Being inclusive and balanced, the Budget comes across as citizen-friendly, development-focused and future-oriented. It aims to empower the poor and provide a better future to the youth, as opined by our Prime Minister, Shri. Narendra Modi. I too believe reforms proposed shall work as building blocks for a prosperous New India, also as quoted by the Finance Minister from Chanakya Niti's sutra, "Karya purusha karena lakshyam sampadyate," meaning "with determined human efforts, the task will surely be completed."

This budget reflects the government's intent in its second term to spearhead the Indian economy towards a GDP of US\$ 5 trillion by 2024-25 with the proposal of achieving an immediate goal of US\$ 3 trillion by end of this fiscal year. It targets to revive the recent slowdown in growth through kick starting the virtuous cycle of investments and commits to follow the path of fiscal consolidation without compromising on public expenditure. Despite global headwinds, the Indian economy holds immense potential to grow at more than 8 percent in the coming years with a whopping increase in manufacturing and exports.

With a strong focus on socio-economic development, I truly appreciate the budget proposals that focus on MSMEs and start-ups, infrastructure, affordable housing and women's empowerment. Further, opening various sectors to foreign investments and providing credit to non-banking financial companies will also mean increase in liquidity. MSMEs being our niche segment, the Chamber is positive that all these measures will give a massive boost to job creation and provide better opportunities for the common man.

Significant reforms in terms of 2 percent interest subvention for all GST registered MSMEs on fresh or incremental loans and creation of a payment platform will facilitate better access to credit to the MSMEs. Streamlining of multiple labour laws would reduce compliances for the industry, particularly for MSMEs, and provide more room for deployment of workforce in factories. Going further, the government's commitment to support start-ups by solving the 'Angel Tax' issue with no scrutiny on their funds by the Income Tax Department would strengthen the business environment for start-ups.

Fulfilling the demands of industry, the Finance Minister has lowered corporate tax

rates to 25 percent for companies with an annual turnover of Rs. 400 crores. This will enhance business sentiment. However, I would like to comment here that the move to tax the super-rich has concerns, particularly levying a surcharge on individuals having taxable income above Rs. 2 crores and more. Further, bank recapitalization of Rs. 70,000 to public sector banks and support to non-banking financial companies is laudable as it will increase the pace of lending in the economy.

Though the budget has given a strong focus to rural development with focus on infrastructure for fisheries, animal husbandry and dairying sectors, there is need for new initiatives to tackle farmers' distress. The formation of 10,000 new Farmer Producer Organizations to ensure economies of scale for farmers, along with the proposal to set up livelihood and technology business incubators to develop skilled entrepreneurs in agro-rural industries plus promotion of zero budget natural farming need to be further increased. We suggest that certain reforms such as agricultural marketing, warehousing support, educating farmers to adopt mechanized farming, increasing public investments in agriculture sector and modernizing agriculture need to be introduced on a large scale.

I must highlight that the government's move to invest Rs. 100 lakh crores in infrastructure sector over the next five years and developing an action plan to deepen the long-term bond markets is highly appreciable. The program for Railway modernization, industrial corridors and Bharatmala phase 2 will push the infrastructure health of the country to the next level. The government proposes use the Public-Private Partnership

model to supplement its own funding. I must also applaud the announcement of a blueprint for developing gas grids, water grids, i-ways and regional airports on lines of One Nation, One Grid for power availability to all states at affordable rates.

Affordable housing is another thrust area of the Chamber. I must commend the plan to build 1.95 crore houses in the second phase of PMAY-Gramin in rural areas and also the proposal of interest rate deduction for low cost housing loans. The cost of these affordable houses under the Income Tax Act with GST Acts, has been fixed at Rs. 45 lakh and below, which will boost the housing and construction sectors.

The introduction of a new education policy proposed in the budget with focus on learning outcomes will play a big role in revising the current education system. To encourage women entrepreneurship, Women SHG Interest Subvention Programme will be expanded to all districts in India. Moreover, the commitment to skilling the youth by adopting the new age technologies, like AI, Internet-of-Things, Big Data, Virtual Reality and Robotics, indicates the progressive thoughts of the government to steer the economy towards prosperity.

The Chamber continues to play an important role in policy making by interacting with government functionaries at the senior-most level. This month, I led high-level, delegations to meet several Union Ministers that included Mr. Nitin Gadkari, Minister of Road Transport and Highways and Micro, Small and Large Enterprises, Mr. Prakash Javadekar, Minister for Information and Broadcasting, Mr. Gajendra Singh Shekhawat, Minister for Jal Shakti and Mr. Hardeep S Puri, Minister of State for Housing and Urban Affairs, Civil Aviation and Commerce and Industry.

We opine that the Modi government has crafted this year's budget with a 10 year vision in mind to boost India's growth and development in the 21st century. Having said this, I would rest my pen with a famous quote, "You don't have to see the whole staircase, just take the first step." We at the Chamber would like to earnestly remain inspired and work assiduously with the government towards building a new Inclusive and Prosperous India.

Budget Viewing Session 2019-20

India Inc. Speaks^{LIVE}

The Economic Affairs Committee of PHD Chamber organized the Budget Viewing Session- 2019-20 on July 5, 2019 at PHD House, New Delhi.

Chief Guest, Mr. Gopal Krishna Agarwal, National Spokesperson of BJP (Economic Affairs) said that as far as macroeconomic parameters are concerned, indices like inflation, GDP growth, forex reserves, etc are in the good terrain. He said that the investment should be for asset creation and infrastructure creation so that it will create demand in the economy and liquidity into the whole economic set-up. He said that this would create high consumption which will attract private investments and there is need for Ease of Doing Business. He said that at this time, disinvestment of large PSUs is only source where revenue can be generated by the government and from there onwards government will increase expenditure. He concluded by saying that the Budget will be a roadmap to achieve a USD 5 trillion economy and manufacturing sector is an important area where several initiatives of the government will come in the budget.

Mr. Pratip Chaudhuri, Former Chairman, SBI said that the highest market capitalization has been by the banking sector and not by core industries. He suggested that the glory has to be brought again to manufacturing as that is where the core strength of the country is. He said that

the high real rate of interest is coming in the way because if an entrepreneur sets up a facility, he expects the sales to grow by the rate of inflation, apart from the output growth. Secondly, he pointed towards the large volume of exchange reserves. He said that government is borrowing at 6.8% or 7% and investing in dollar bonds at 0.5% or maximum at 1%. So there is negative carry of 6%, so is there a need for such high level of reserves.

Mr. Rajeev Talwar, President, PHD Chamber said that there has been an unimaginable mandate given to this government after 5 years. He said that the government in its multifarious tasks has huge responsibility and opportunity of boosting exports, high liquidity, manufacturing, infrastructure, high tax revenues, low tax rates and large number of tax assesses.

Mr. Rajeev Talwar, while sharing his views on the budget announcement, said that this budget is an excellent vision statement to make India a USD 5 trillion economy. He stressed that emphasis on infrastructure, micro, small and medium enterprises and Digital India are going to be the key sectors for achieving 8% growth. He added that provisions for affordable housing and a new rental policy, 19.5 million homes in rural areas and monetization of public sector assets will give impetus to job creation and ease of

living. He said that opening various sectors to foreign investment and providing credit to non-banking financial companies from banks will also mean huge liquidity for investments. He concluded by saying that this budget will provide massive boost to employment but this budget will require detailed implementation and close monitoring.

Mr. D K Aggarwal, Senior Vice President, PHD Chamber appreciated the continuous efforts of the government and said that going ahead, the Union Budget must also address the reforms, such as rise in investments by increasing government spending, creation of jobs by making labour laws flexible, rationalization of direct taxes, reforms in MSMEs and infrastructural development.

Mr. D K Aggarwal stated that the lowering of tax rates to 25% for companies with annual turnover of Rs 400 crores is a great decision in right direction as it was proposed by the industry since



the last many years. This would mean corporates having more money at their disposal. He further stated that private investments have got a significant boost in the budget. He suggested that continuous efforts are required to sustain the higher economic growth trajectory and insulating the economy from global headwinds by focussing on key engines of economic growth.

Mr. Sanjay Aggarwal, Vice President, PHD Chamber said that the share of manufacturing sector in GDP is around 17% which is lower than many of the leading and comparable economies. He verbalized that the manufacturing sector needs to be given a huge impetus for the Indian economy to move to a higher growth trajectory. He said that India has nearly 6 crore MSMEs but they are unable to deploy much labour due to stringent labour laws. He said that if labour laws are made flexible and if each and every MSME employs an individual, then MSMEs would succeed in giving employment to crores of people in the country.

Mr. Sanjay Aggarwal opined that the Hon'ble Finance Minister asserted that the focus on MSMEs, development of infrastructure, affordable housing and women empowerment would go a long

way to promote all-inclusive development in the economy. He highlighted that the lowering of tax rates to 25% for companies with annual turnover of Rs. 400 crores is encouraging as it was proposed by the industry since the last many years. He said that the allocation of Rs. 70,000 crore for the PSU banks recapitalization will enhance the health of the PSU banks and push up the pace of lending in the economy.

Prof. (Dr) Gurbachan Singh, Eminent Economist & Adjunct Faculty, Indian Statistical Institute opined that the budget has a lot of positive aspects, however, there exists a basic issue of planning versus the market economy and in the last five years there has been a shift from planned economy to market economy. He stated that schemes, such as affordable housing, skill India, among others reflect planned mind set and not the market mind set and therefore, a lot needs to be done in this direction. According to him, in order for markets to work properly, there is a need to focus on overall legal aspects and regulatory environment.

Mr. Akhil Bansal, Chairman, Economic Affairs Committee, PHD Chamber, said that India has not yet missed its "manufacturing bus" and it is right time for India to invest in the manufacturing sector, if India has

to become a USD 5 trillion economy. The biggest job creation can come from the MSME sector with regulatory hurdles to be reduced for efficient progress of MSMEs.

Mr. Anil Chopra, Chairman, Direct Tax Committee, PHD Chamber stated that reduction in corporate tax rate for the companies having turnover upto Rs 400 crores is appreciable and would incorporate 99.3% of companies. He suggested that there needs to be reconciliation in the GST audit and GST returns.

Mr. Bimal Jain, Chairman, Indirect Tax Committee, PHD Chamber opined that the GST has been beneficial and has subsumed many taxes, however, still exist a lot needs to be done to make it simpler and efficient. He further stated that 28% slab should be done away, especially on cement, to be in sync. with affordable housing target. He opined that petroleum products and diesel should be brought under ambit of GST.

Mr. Frank Pereira, Anchor/Consultant Rajya Sabha TV moderated the session.

Dr S P Sharma, Chief Economist, PHD Chamber highlighted the Economic Survey which says that India forms part of 30% of the global growth and India's contribution has become much more valuable to global economy.

Budget 2019-20: A blueprint for inclusive India

The Union Budget 2019-20 very well represents the government's long term vision to build an inclusive India of an economic size of USD5 trillion. The bottom-up approach of the budget is envisaging building a New India, going forward. The announcements on various socio-economic fronts indicate fulfilment of aspirations and promises of progress. The focus on MSMEs, development of infrastructure, affordable housing and women empowerment are the focused areas to promote all-inclusive development in the economy.

The 10 points vision including achieving minimum government maximum governance; pollution-free India; digitization in every sector; state of art physical and social infrastructure; self-sufficiency and export of food-grains, pulses, oilseeds, fruits and vegetables; a healthy society with well-nourished women & children, safety of citizens; and emphasis on MSMEs, Start-ups, defence manufacturing, automobiles, among others, under Make in India would strengthen the growth story of the Indian economy and increase its presence in the international economic arena as the country has potential to become a growth engine of World economy.

Continuous focus on infrastructure development such as Railway modernization, infrastructure connectivity through the projects such as industrial corridors, Bharatmala, etc., the target of building 1.95 crore houses in the second phase of PMAY-Gramin, additional tax benefits for first time home buyer, a further tax deduction of Rs. 1.5 lakhs for interest

paid on housing loans sanctioned in the current fiscal year upto 31st March, 2020 are the steps toward revitalising the growth in the short term and strengthening in the medium to long term to establish a strong and sustainable growth trajectory.

Further, the proposal to invest Rs 100 lakh crore in infrastructure over the next 5 years is highly encouraging and will put India's economic growth on a high road. The multiplier effect of infrastructure investments would give a big push to the potential growth areas of the economy with millions of new employment opportunities for the growing young workforce.

The government has shown its priority of strategic disinvestment of select central public sector enterprises (CPSEs), other than Air India, in view of the current macroeconomic parameters. The disinvestment target of the government has been increased to a little over one lakh crore for FY2010 from Rs 90,000 announced in the interim budget. This will help government to boost its revenue and use it in development of infrastructure, public goods and socio-economic development of overall economy.

In continuation of the phased reduction in the corporate taxes by the government, the announcement of lowering of tax rates to 25% for companies with annual turnover of less than Rs 400 crores would enhance the sentiments of the businesses and strengthen the growth of MSMEs with new possibilities for expansion and deployment of more workforces in their respective factories. This reduction was proposed by the industry since the last many years. It will cover and benefit 99.3 percent of the

companies and will enhance business sentiments and production possibility frontiers in the economy.

The labour laws in India have been relatively stringent and one of the biggest hurdles for entrepreneurs. The industry had been propounding for flexibility in labour laws since the last many years. The proposal to streamline multiple labour laws into a set of four labour codes is inspiring as simplification of labour laws would reduce the compliances for the industry particularly for the MSMEs and provide more room for deployment of workforce in the factories. This would result in making business environment more conducive and promote ease of doing business.

The Budget has focused on attracting foreign investors to increase capital flows with the easing of local sourcing norms for FDI in Single Brand Retail and 100% Foreign Direct Investment (FDI) permitted for insurance intermediaries. The announcement to merge NRI portfolio route with foreign portfolio investment is appreciable as it would make NRI investments in India easier. Further, the decision to organize global investor's meet in the country is investment growth provoking as it would expand the global players' investments in India.

MSMEs are the potential growth engine of the Indian economy. The government has very rightly diagnosed the importance of MSMEs in the economy; the announcement of 2% interest subvention for all GST registered MSMEs on fresh or incremental loans and creation of payment platform for MSMEs would facilitate them in getting better access to credit and



expansion in business activities.

The allocation of Rs. 70,000 crore for PSU banks recapitalization will enhance the health of the PSU bank and push up the pace of lending in the economy, by increasing the sentiments for credit availability. Various praise-worthy announcements such as solving the issue of 'Angel Tax' by introducing e-verification, speedy assessments of start-ups and redressal of their grievances and relaxing some of the conditions for carry forward and set-off of losses for start-ups would strengthen the start-up campaign in the economy.

The focus on encouraging PPP in unleashing faster development and completion of tracks, rolling stock manufacturing and delivery of passenger freight services in railways would not only promote industrial growth but also provide better service delivery to masses.

The prime focus to affordable housing in this budget as alignment of the definition of affordable housing in the Income-tax Act with the GST Acts and providing the limit on cost of the house at Rs. 45 lakh in line with the definition in the GST Acts would create demand in the housing and construction sector activity.

In addition, the usage of land parcels held by Central Ministries and Central Public Sector Enterprises all across the country for public infrastructure and affordable housing is encouraging and growth provoking. The additional income tax deduction of Rs. 1.5 lakh on interest paid on loans taken to buy electric vehicles and additional deduction of up to Rs 1,50,000/- for interest paid on loans borrowed up to 31st March, 2020 for

purchase of an affordable house valued up to Rs 45 lakh are highly beneficial for middle class buyers.

The Budget has a strong synergy for the new education policy and made comprehensive allocation of Rs. 400 crores for FY 2019-20 to transform education system with the focus on learning outcomes which will play a big role in revising the current education level. Further, the Study in India campaign of the government would help make India move towards being a global hub of education for the foreign students, as the students would get premium education at affordable rates. This would also benefit in the development of infrastructure, education level and facilities available in the top institutions of India.

The thoughts of the Hon'ble Finance Minister regarding encouragement and facilitation of the role of women in the economy are appreciable. The Budget announced to expand the Women SHG interest subvention programme to all districts and made provisions for overdraft of Rs. 5,000 to be given to verified women SHG member. These measures would strengthen women's role in the society, going forward.


The government has very rightly focused on agriculture sector and increased the allocation of agriculture sector. The decision to promote and encourage 'zero budget farming', also called 'going back to the roots', is highly inspiring. Zero budget farming means natural farming without using any credit and without the monetary purchase of inputs. Zero budget farming helps in reducing the cost of cultivation, enhance

soil fertility, prevent environmental damage and all this without the use of money. Zero budget farming has already been implemented and tested in a few states and according to the government, this model is needed to be replicated in other states also, followed by whole country. This will, at a great extent, help reduce the problem of agriculture distress, as the farmers do not have to take expensive credit to buy the inputs and other raw materials from the market. Zero budget farming would also create the scenario of self-reliance among the farmers, going forward.

Going ahead, there are certain reforms which need to be addressed in the coming times to give a major thrust to spur economic growth trajectory to the next level, such as introduction of agricultural marketing reforms, provision of adequate and efficient warehousing support within easy reach of villages, particularly for marginal farmers; educating farmers to adopt mechanized farming; minimising the wastages to less than 10% from the current level of 30 to 35%; increasing public investments in agriculture sector, modernizing agriculture along with technological reforms and promoting food processing exports.

In a nutshell, the government aspires to make India a USD 5 trillion dollar economy, thorough focussed reforms and strategic investments in the most critical areas, such as infrastructure, digital economy, job creation, ease of doing business and kick-starting the virtuous cycle of investments. Overall, the Union Budget 2019-2020 is a balanced, pragmatic, welfare inducing and growth revitalising reforms agenda for India's long term growth story.

Nirmala Sitharaman's maiden budget and the first budget of Modi Sarkar. 2, struck all the right chords by addressing the current pain points of the economy, yet at the same time maintaining fiscal rectitude. Hon'ble FM's disclosure of a lower fiscal deficit of 3.3%, sends just the right signal to global investors that India retains its pole status as a stable and attractive economy, in the midst of a global slowdown.

Union Budget 2019 has outlined several new reform initiatives like big privatization push, relaxation of norms for foreign portfolio investors, further liberalization of FDI/FPI policy, incentives for making GIFT as a global financial hub, and a paradigm shift in moving government borrowings to foreign markets. All these announcements bear the unmistakable stamp of a clear cut recognition within GOI that India's humungous infrastructure dependent growth needs, as also outlined in the FM's budget speech, cannot be met without resorting to substantial foreign funding.

Laudable initiatives for fixing liquidity issues in the financial sector involve more than expected hikes in capital infusion for banks, which will get INR 70,000 crore (INR 700 billion), and NBFCs, which can offload some of its higher-rated assets to banks to obtain liquidity while the banks themselves have been given a partial credit guarantee for 10% of any losses for six months after these NBFC assets are taken over.

To boost 'Make in India', GOI seeks to woo foreign majors with a package of direct/indirect tax benefits and beyond to build hi-tech facilities for semiconductor fabrication, solar photo-voltaic cells, computers and laptops, and electric battery charging infrastructure. If the red carpet works, this will be the first effort by India to directly seek benefit from the global shift in investment away from high-cost China due to the current US-China imbroglio.

In absence of any big bang measures in this budget to create more jobs, an area on which the opposition has constantly targeted the Modi government, the Hon'ble FM has betted on her investment acceleration initiatives in job-creating sectors, to take care of this concern. Recognizing the need to unshackle the entrepreneur spirit of the Aam Admi, one area where the budget seeks to make a big difference is in the MSME sector, where loan up to INR 1 crore (INR 10 million) are targeted to be sanctioned in less than an hour, and a platform is to be created for speeding up payments due to MSME for

supplies made by them. The startup ecosystem is being spruced up and the onus is now being shifted to the taxman who seek to challenge the share valuations, and are now to accept them as long as the investments are from e-verified sources. The angel tax issue controversy should hopefully find a permanent burial.

There are many announcements in the budget on utilizing through PPP mode, the huge and idle lying land parcels held by railways and government institutions. This should help enhance the level of activity in the real estate sector. Affordable housing gets even better, with interest deductions on properties costing up to INR 45 lac (INR 4.5 million) now going up to INR 3.5 lac (INR 0.35 million) a year. For the environment conscious, the budget has incentives for faster adoption of next generation technologies such as electric vehicles.

On the direct tax front, relief measures include the extension of lower tax rate of 25% to Companies with a turnover of up to INR 400 crore (INR 4 billion), which though may cover 99.3% companies numerically, but the major export oriented companies would still have to pay a higher tax and continue to remain uncompetitive, due to lowering of tax rates globally. Other tax measures announced include benefits on purchase of affordable housing, on purchase of electric vehicles, etc. Individuals and firms who deposited cash during demonetization will get another chance to come clean. Faceless scrutiny may soon become a reality with E-assessments being fine-tuned for implementation. High net worth individuals may heave a sigh of relief that the budget makes no mention of inheritance tax.

On the downside, there was no reduction in personal tax rates, though this was only expected, due to little leg room with the GOI. Instead, surcharge rates have been spiked for high income earners, a measure which has sharply divided public opinion on the merits thereof. The flip side to ease of filing returns through pre-filled tax return forms, with information sourced through multiple points such as banks, stock exchanges, mutual funds, etc., is the increasing compliance burden to report even lower transactions as well as the apprehension of the common citizen on the ever increasing GOI oversight on their personal information.

On the indirect tax front, hike in import duties, besides increasing costs for many items, may be seen as akin to going back to the old era of promoting import substitution, rather than following the progressive means of seeking to bolster exports through enhancing industry competitiveness.

The amnesty scheme to resolve pre GST era disputes, by way of providing relief varying from 40% to 70% of tax due is a very welcome step. This will allow businesses to withdraw from litigating on legacy issues and focus on their core activities.

India has been the bright spot in global economy, growing faster than all major economies in the last few years. In the new term, especially in the back drop of slowing growth and the ambitious target of taking the economy to the 5 trillion USD level, the expectation from the Government was that it will propel the economy by unshackling it from the barriers holding it back. In this regard, the FM has delivered a steady budget. The Budget is growth oriented in the sense that it bets more on investments than consumption to anchor it, spurs private investment, keeps government's fiscal consolidation track record intact and uses a variety of methods to bolster the investment cycle led by government spending. Critics may doubt that the budget is long on announcements but short on details. That the proof of the pudding lies in eating it, need not be emphasized. Yet, as was aptly put across by the Hon'ble FM during her speech "यकीन हो तो कोई रास्ता निकलता है, हवा की ओट भी लेकर चिराग जलता है", nothing more needs to be said.

Intellectual Property through Collaborative Enforcement

PHD Chamber organized a conference on “Intellectual Property through Collaborative Enforcement” on June 20, 2019 at PHD House, New Delhi in collaboration with the Office of Controller General of Patents, Trademarks and Design. The main objective of the conference was to emphasize the importance of collaborative enforcement with collaboration of Judiciary, Police officials and Custom officers and to develop a holistic approach in tackling IP

crime with collaborative approaches in its investigation.

Mr. Rajeev Talwar, President, PHDCCI in his welcome address highlighted that the cornerstone for India's growth and development are because of two pillars i.e., Judiciary and Parliament. He further highlighted growth of the Indian Economy has a close linkage with Intellectual Property Rights awareness and its enforcement. The Indian Government has been doing a lot by encouraging entrepreneurs to be

more innovative. He further mentioned that the challenge before the country is to scale up the process of IP creation and increase commercialization of the technology that is developed.

Chief Guest, Hon'ble Mr. Justice Dipak Misra, Former Chief Justice of India in his address emphasized that while property of the mind or proprietary knowledge has been recognized over centuries, it has gained significance in the current context due to developments in technology and trade. He

highlighted that increasing significance of intangible assets in the global economy is forcing business corporations to actively manage their Intellectual Property concepts as a key driver for building and sustaining competitive advantage and achieving superior performances. He stated that stringent laws and collaborative enforcements are vital to safeguard intellectual property rights in India, as businesses in global economy focus on actively managing the intellectual property to remain competitive. Further he stressed on the need for "Intellectual Vigilance" with a view to protect those who are creating, inventing or are busy in the field of innovations with the need for collaborative cooperation between regulators, rights owners and citizens to provide strong punishment to the violators.

Hon'ble Mr. Justice Manmohan Singh, Chairman of Intellectual Property Appellate Board discussed the entire jurisprudence of enforcement and development of the Intellectual Property Rights regime in India. He also highlighted his own experience related to IPR laws and how certain cases were handled in favour of IP owners. He also mentioned about various judgements passed by the judges which are very useful for understanding the IP law in India.

Mr. Suvashis Chaudhary, IPS, Additional Commissioner of Police, Economic Offence Wing (EOW) emphasized that Delhi Police has a significant role in fighting the menace of counterfeiting and implementing enforcement of IPR on a greater scale. He highlighted that various operational issues are being faced by the

investigative officer as a lot of IP owners and attorneys do not turn up at the time of investigation and are only interested till search and seizure. As a result, evidence gets destroyed and there is pendency of the cases in the Economic Offence Wing. He also said that if a menace is sorted out in one state then the same appears in interstate and hence this kills innovation.

Prof (Dr) C J Rawandale, Director, Symbiosis Law School gave his perspective on Institutional and Academic front and emphasized that human creative mind should be given importance and protection through adequate enforcement of Intellectual Property rights is the need of the hour.

Mr. N R Meena, Deputy Controller of Patents and Design, Office of Controller General of Patents, Designs & Trade Marks gave an overview for filing an application for patent, trademarks etc. He said that now within 1 or 2 years patent gets filed and a confirmation SMS is sent to the applicant. He highlighted that earlier in 1996 there were only 50 examiners and 20 controllers and now they have 650 examiners and 200 controllers for effective and smooth running of the organization so that applications can be easily and quickly processed.

Mr. Sudarshan Kumar Bansal, Partner, United IPR in his address shared best practices for IPR enforcement in India. He further stressed on the applicability of the rule of law in the enforcement of Intellectual Property Rights. He also pointed out that there are adequate laws and mechanisms present in India,

however there is an imminent need to create effective awareness and prioritize the same and IPR laws.

Mr. Sanjay Aggarwal, Vice President PHDCCI in his vote-of-thanks highlighted that in today's era various IP crimes have spanned over the physical and digital domains and infringements like counterfeiting, piracy etc. are being carried out on a very large scale.

A panel discussion on 'Enforcement of IPR in the markets of India and at the territorial borders' was chaired by Dr H.P. Kumar, Advisor PHDCCI and Former CMD NSIC. Speakers included Mr. Mahesh Kumar, Deputy Commissioner of Customs; Mr. Amardeep Sehgal, Assistant Commissioner of Police, Economic Offences Wing of New Delhi and Mr. Gaurav Gogia, Advocate and Senior Associate, United IPR.

Another panel discussion on 'Industry's perspective on enforcement of Intellectual Property Rights' focused on brand awareness and identification aspects of the participating right-holders. Speakers included Mr. Naveen Chandra Kushwaha, Head Legal, Luxottica India, Mr. Sushant Singh, Advocate IPR and representatives from various brands like Procter & Gamble, Hugo Boss, L Brands, Lacoste and Audemars Piguet. The discussion drew references to counterfeit products being freely circulated and sold through several E-commerce platforms as well as in the markets. Panelists emphasized that there is an imminent need to combat the menace of counterfeiting, both online and offline.

Mr. Sanjay Aggarwal, Vice President, PHD Chamber apprised the Ambassador about PHD Chamber, its focus on MSME sector and how MSMEs can add impetus to business cooperation between India and Ireland keeping in mind the fact that Ireland is the fastest growing economy in the EU for 5th year in a row with GDP growth of 6.7% in 2018.

Interaction with Chairman and Managing Director-RAILTEL

The Telecom Committee of PHD Chamber and Telecom Equipment Manufacturers Association (TEMA) jointly organized an interaction with Mr. Puneet Chawla, Chairman and Managing Director-RAILTEL on June 28, 2019 at PHD House, New Delhi.

Mr. Ashutosh Vasant, Director, POM, Railtel; Mr. S.N Gupta, Chairman, National Railways Advisory Council, TEMA; Mr. Sanjay Aggarwal, Vice President, PHDCCI; Mr. Sandeep Aggarwal, Chairman-Telecom Committee, PHDCCI; Mr. Yogesh Srivastav, Principal Director, PHDCCI and Prof. NK Goyal, Chairman E TEMA & President CMAI were also part of this interaction.

Mr. Puneet Chawla, Chairman and Managing Director-RAILTEL, said that the development of ICTs is to a great extent responsible for the unprecedented upward mobility in the socio-economic sector. He informed that almost 1606 Railway Stations have already been provided with Wi-Fi facilities and RAILTEL is in the process of equipping 4000 more Railway Stations with Wi-Fi facilities in the near future to provide broadband & internet access across the country. Railtel would also provide kiosks at 200 stations which would provide the services mentioned on the e-governance platform of the Government.

Railtel has also planned on installing CCTV cameras at railway stations and in the trains. They have targeted at least 7020 coaches of premium trains within a year so that the issues relating to security are also addressed. All railway offices are being connected through video-conferencing. Railtel is also actively working on the Bharat Net project.

Mr. Sanjay Aggarwal, Vice President, PHDCCI lauded the contribution made by RAILTEL to social & economic empowerment of the people across the nation by installing free Wi-Fi at railway stations for general public and stated that Railtel has turned railway stations into digital hubs.

Mr. Sandeep Aggarwal, Chairman-Telecom Committee, PHDCCI, suggested that working towards the Rail Track policy is essential as it would be helpful for the anti-collision system. Also using the already laid optical fibers along the railway tracks for the security of railway tracks by using passive sonar technology will save a lot of capex of Track Protection System.

Mr. Ashutosh Vasant, Director-POM, Railtel spoke about the contribution made by Railtel. He said that it is the only dividend paying and debt free company under the Government of India. He also added

that Railtel is the only company which started with tele-presence –HD Video conferencing as a service to help solve procurement problem of the government. All the promotional displays, reviews and interviews are held through this. He also added that Railtel has brought ETCS and LTE and the idea behind this is to possibly create the country's first Public Protection Disaster Recover (PPDR) network which only four to five nations across the world have. Security is an important issue and this is one step closer to it.

Mr. Satya N. Gupta, Chairman, National Railways Advisory Council, TEMA mentioned that if a station gets wi-fi, ten villages around it also benefit without laying further fibre. Since every wi-fi hotspot creates a job too, RAILWIRE can help in making at least 70,000 villages with wi-fi facilities easily and create 70,000 jobs. He also said that according to an empirical study, if a valuable or scarce resource is given to anyone through an auction, it runs into winner's curse which means that the person (winner) will tend to overpay due to emotional reasons or incomplete information. If that scarce source is unbridled, then its efficiency increases 100 times, like wi-fi.

The programme was highly successful and attended by senior officials from the Department of Communications, Ministry of Communications and Ministry of Railways; Telecommunications Consultants India Limited, Telecom Regulatory Authority of India; embassies & high commissions, telecom service providers and other industry stakeholders.

work closely with "Target audience" comprising of Clusters Managers, Cluster organizations and Teachers in Technical Institutions (ITIs/Polytechnics/ Engineering Colleges etc). PHDCCI will play the role of a facilitator and will be the Monitoring Body for the implementation of the project.

Filing of GST Annual Return (GSTR -9) & GST Audit Report (GSTR - 9C) - Outward Supply & Input Tax Credit - Understanding Issues & Compliances clause by clause

The Sixth Conclave of the GST Series was held on Filing of GST Annual Return (GSTR -9) & GST Audit Report (GSTR - 9C) – Outward Supply & Input Tax Credit - Understanding Issues & Compliances clause by clause was held on June 7, 2019 at PHD House, New Delhi.

Mr. D K Aggarwal, Sr. Vice President, PHDCCI in his welcome remarks praised the government's initiative to put GST in the right perspective and proper GSTN mechanism and said that challenges in due course of time will be resolved.

Mr. Bimal Jain, Chairman, Indirect Taxes Committee, PHDCCI in his theme presentation appreciated the government to bring in procedural changes in GST format. Mr. Jain pointed out that on export front, the process for refund disbursement has smoothed but on input tax credit front a lot more needs to be done. He urged the government to bring in more facilitation for GST procedures and regulations.

Mr. Upender Gupta, Principal Commissioner (GST), CBIC in his address explained about extension of June 30 deadline for filing of GST returns.

Mr. Avinash Poddar, ASHVA Legal Advisors LLP through his presentation highlighted that outward supply in relation to a taxable person, means supply of goods or services or both, whether by sale, transfer, barter, exchange, licence, rental, lease or disposal or any other mode, made or agreed to be made by such person in the course or furtherance of business, both which is leviable to tax under this Act.

in his presentation on 'Reconciliation of Gross Turnover' explained that only those registered taxable persons whose aggregate turnover during a financial year exceeds Rs. 2 crores are required to file reconciliation statement in Form GSTR-9C along with the filing of an annual return in Form GSTR-9. Provisions of section 44 (2) of the Central Goods and Service Tax Act, 2017, mandates that the registered person file a reconciliation statement provided he is required to get his accounts audited under GST.

Ms. Archana Jain, Archana Jain & Co. critically analyzed the Input Tax Credit and its Constituents. She mentioned that the audit under Section 35(5) of the CGST Act to be conducted by CA or CWA is applicable only to a Registered Person. A non-filer is a Registered Person under Section 25 of the CGST Act; the audit is required to be conducted under Section 35(5) of the said Act, if it satisfies the condition stated in the section. Practically

such a person would not have filed his returns at all and therefore Form 9 & 9C would not be possible. Therefore, there may be no audit for him. However an unregistered Person who is liable to take registration under Section 25 of the CGST Act is a person who has to pay tax.

Mr. Jatin Harjai, J. Harjai & Associates stated that the objective of the audit will be to ensure that the assessee has paid GST properly and has not contravened provisions of the Act or the Rules made there-under. A proper reconciliation statement needs to be prepared for reconciling the balances of Electronic Liability Ledger, Electronic Credit Ledger, Electronic Cash Ledger etc. Further, Transitional Credit availed needs to be accounted properly in books of accounts.







PHD Chamber participated in a meeting called by Dr Anup Wadhawan, Commerce Secretary, Ministry of Commerce and Industry on June 7, 2019 at Ministry of Commerce, New Delhi. The Chamber provided inputs to strategically enhance India's exports to China and suggested ease of doing business reforms for companies relocating from China to India for establishing production processes and enhancing exports from India.

Latest Developments under Economic & Commercial Laws

The Corporate Affairs Committee of PHDCCI organized a seminar on 'Latest Developments under Economic & Commercial Laws' on June 26, 2019 at PHD House, New Delhi.

Mr. Abhi Narayan Mishra, Principal Director (Finance), PHDCCI moderated the session and stated that as the area of economic and commercial laws undergo frequent changes, it becomes necessary for everyone to constantly update themselves with the various legislative changes made as well as judicial pronouncements rendered from time-to-time.

Mr. P K Rustagi, Co-chairman, Corporate Affairs Committee, PHDCCI in his welcome address, mentioned that India has made considerable economic progress since its Independence. Over the years, various policy initiatives and economic reforms have made India one of the fastest growing economies in the world. Therefore, to provide an understanding of certain economic and commercial legislations which have direct bearing on the functioning of companies, the Corporate Affairs Committee has structured this seminar.

Dr Girish Ahuja in his keynote address on "Benami Law: Concerns & Challenges" highlighted that several amendments were made in the earlier Benami Transactions (Prohibition) Act, 1988 and the Benami law in its new avatar came into force from November 1, 2016, known as Prohibition of Benami Property Transactions Act, 1988. Under this law, persons who are guilty of offence of a benami transaction would be liable for fine which may extend up to 25 percent of the fair market value of the property and rigorous imprisonment up to 7 years. He highlighted that in India considering the family tradition, it is a common practice that property is often held in the name of the father/mother as a mark of respect but the funds are provided by the child. Now, these types of transactions get covered under the new Benami law.

Mr. Mukesh Singhal, Co - Founder, KNM & Partners Law Offices gave a presentation on "Setting up Liaison/Branch Office of Foreign Companies in India". He highlighted that establishment of a representative office of foreign companies

in India is regulated by Section 6(6) of Foreign Exchange Management Act, 1999.

Mr. Amit Chugh, Chartered Accountant gave a presentation on "Understanding of Key Audit Matters (SA 701)". He highlighted that KAMs are those matters, which in the auditor's professional judgment, were of utmost significance in the audit of the financial statements of the current period. He highlighted the changes in the report structure of the Auditor's Report. He mentioned the applicability of implementation guide to SA 701.

Mr. Pramod Jain, Partner, Lunawat & Co gave presentation on "Unregulated Deposit: Provisions & Regulations". He highlighted that Unregulated Deposits

Schemes Bill 2019 was passed by Lok Sabha on February 13, 2019, but could not be passed by Rajya Sabha and became an Ordinance w.e.f February 21, 2019. He also explained the provisions related to central database, competent authority, depositors, offences and punishment under BUDS.

Mr. P K Rustagi, Co-chairman, Corporate Affairs Committee, PHDCCI summarized the views of the speakers and delivered vote-of- thanks to the Speakers, Sponsors, Associate Partners and Participants.

The seminar concluded with an extensive discussion and Q & A Session with an overwhelming response from the participants.

AYUSH for Prevention and Control of Diabetes “Mission Madhumeh”



Dr Deepika Gunawant, Senior Consultant, Ayurvedic and Wellness, Max Super Specialist Centre; Dr V.K.Chauhan, Former Principal, Dr B. R. Sur Homoeopathic Medical College; Mr. Vivek Seigell, Principal Director, PHD Chamber,; Dr Rajendra Soni, Assistant Professor, Ch. Brahm Prakash Ayurvedic Charak Sansthan and Mr. Pradeep Multani, Chairman, AYUSH Committee, PHD Chamber.

PHD Chamber organized a seminar on AYUSH for Prevention and Control of Diabetes, “Mission Madhumeha” on May 31, 2019 at PHD House, New Delhi. The objective of the conference was to sensitize the stakeholders regarding the importance of the Indian Systems of Medicines in treating lifestyle diseases especially diabetes and to deliberate on the scope, opportunities and challenges in AYUSH Industry.

Mr. Pradeep Multani, Chairman, AYUSH Committee, PHD Chamber in his welcome address, cautioned that diabetes is increasing at an alarming rate in India. Majorly 90% of the disease can be treated by the AYUSH System and Ayurveda can play a major role to keep the blood sugar level in control. According to WHO, It has become one of the most common problems in the world. A few life style changes can help in control of diabetes, Mr. Multani suggested.

Dr Deepika Gunawant, Senior Consultant, Ayurvedic and Wellness, Max Multispecialty Centre, New Delhi gave a brief presentation on how diabetes has been classified in Ayurveda. Diabetes is linked to various factors like genetics, sedentary lifestyle, obesity, as well as unhealthy diet and eating habits. She mentioned that the number of people with diabetes has risen from 108 million in 1980 to 422 million in 2014 and in 2016, an estimated 1.6 million deaths were directly caused by diabetes. Dr Gunawant advised adoption of a simple lifestyle and maintaining healthy body weight for prevention and control of diabetes.

Vd. Karunaidhi Sharma, M.D. (Ayu), NIA, Multani Pharmaceuticals Ltd gave a presentation on how Ayurveda can play a significant role in curing diabetes. He suggested life style modifications such as regular exercise, sufficient sleep, avoidance and proper management of stress and anxiety supported by Ayurvedic medicines can improve the quality of life of a diabetic patient in a significant manner. He also mentioned that Multani Clinic at Okhla, New Delhi has treated more than 500 patients of diabetes in OPDs.

Dr Sachin Kumar, Research Officer, Ministry of AYUSH said that the Ministry has taken several steps towards adopting the AYUSH system under the leadership of Hon’ble Minister of AYUSH. He mentioned that during the first day of Ayurveda celebration, the Ministry launched a protocol for prevention and control of diabetes through Ayurveda. Separate NCD

(Non-Communicable Diseases) wings have been created by the Ministry of AYUSH with institutes under it.

Dr Rajendra Soni, Assistant Professor, Ch. Brahm Prakash Ayurvedic Charak Sansthan said that a balanced diet and adopting yoga can help in curing diabetes.

Dr V. K.Chauhan, Former Principal, Dr B. R. Sur Homoeopathic Medical College gave a presentation on the Prevention and Control of Diabetes and how homeopathy can play a major role in treating the disease. He also shared the common symptoms of diabetes and how a balanced life can help in curing diabetes. He pointed that homeopathy is a holistic system for treating any disease. According to a WHO report, diabetes is a growing challenge in India with an estimated 8.7% diabetic population in the age group of 20 to 70 years.

Mr. Major Singh, Director, MSME-Development Institute, Ludhiana apprised industry of the various fiscal incentives and support by the Ministry of MSMEs.

Mr. A K Verma, Branch Manager, NSIC Amritsar stated that participation of MSMEs in both domestic and international exhibitions is necessary for promoting business prospects.

Total fertility rate declines to 2.2%: SRS Statistical Report 2017


According to the Sample Registration System (SRS) Statistical Report 2017, Ministry of Home Affairs, the Total Fertility Rate (TFR) for the country has declined marginally to 2.2% in 2017 after being at 2.3% for the last four years from 2013 to 2016. Bihar has recorded the highest TFR of 3.2% in 2017, while Delhi has reported the lowest TFR of 1.5%. The TFR in rural areas has declined from 5.4% to 2.4% from 1971 to 2017 whereas the corresponding decline in urban areas has been from 4.1% to 1.7% during the same period.

India experienced the fastest absolute reduction in poverty

The Multidimensional Poverty Index 2019, jointly developed by the United Nations Development Programme (UNDP) and the Oxford Poverty and Human Development Initiative (OPHI) at the University of Oxford, the 2019 global MPI offers data for 101 countries, covering 76% of the global population. According to the report, across 101 countries, 1.3 billion people-23.1%-are multidimensionally poor. India experienced the fastest absolute reduction in poverty in the 2019 Multidimensional Poverty Index. As first reported in the 2018 Multidimensional Poverty Index (MPI), India lifted 271 million people between 2005/06 and 2015/16, with the poorest regions, groups, and children, reducing poverty fastest. The indicators included nutrition, child mortality, years of schooling, school attendance, cooking fuel, sanitation, drinking water, electricity, housing and assets. India strongly improved assets, cooking fuel, sanitation and nutrition between 2005/06 and 2015/16.

PHDRDF SKILL DEVELOPMENT

PHDRDF has been undertaking skill development programs with various corporate organizations to enable the under privileged youth to be economically independent. These programs include training in stitching & tailoring, beauty culture, computer literacy including tally software, spoken English language, soft skills, etc

A. PHDRDF- BRY-AIR (ASIA) PVT. LTD.

Bry-Air (Asia) Pvt. Ltd. and PHDRDF have come together to implement a project – “Bry-Air Udaan Skill Development Centre for Electrician”. The project is aimed to impart skill development training to the rural youth to improve their income generation capacity. A Training centre for electrical training has been established in Jatoli village near Pataudi, Gurugram. The training started in June with a batch of 20 students in this trade. A total of 40 youth will be trained as electricians.

B. PHDRDF- DRI Pvt. Ltd.

DRI Pvt Ltd. and PHDRDF have signed a MoU to implement a project – “Bry-Air Udaan Skill Development Centre for Basic Computer training”. The project is aimed to impart skill development training to adolescent girls and rural women to empower them. A centre for computer training is being established in which a batch of 20 adolescent girls and rural women will be imparted computer training. A total of 80 girls will be trained in computer applications.

C. PHDRDF-DOW AGROSCIENCES INDIA LTD

Dow Agro Sciences India Ltd has partnered with PHDRDF to implement a project for empowering rural women by training them on “Beekeeping” as a supplementary source of income. An estimate of 200 women will be trained in bee keeping and harvesting honey and allied products like – royal jelly, bee wax, bee pollen etc. The project will be implemented in Manchar, Pune, Maharashtra and Rewari for a period of one year. The project was launched on May 21, 2019, ‘World Honey Bee Day’ in the presence of Dr Ashok Dalwai, Chairman, Committee on Doubling the Farmer’s Income by 2022 and CEO NRAA; Dr BNS Murthy, Horticulture Commissioner, Department of Agriculture Cooperation and Farmers Welfare and Member, National Bee Board; Dr DK Aggarwal, Senior Vice President, PHDCCI and Mr. Sanjay Bhatia, Chairman, PHDRDF. Women have been mobilized to participate in the project.



D. PHDRDF- DONALDSON INDIA FILTER SYSTEMS PRIVATE LIMITED

PHDRDF in collaboration with Donaldson Filters India Pvt Ltd is running a Skill Development Centre since the last three years in village Mohammadpur Gurjar, Sohna block, Gurugram. Till date, a total of 185 students in both courses have successfully completed the training. Currently, two batches consisting of 20 girls in each batch for Cutting & Tailoring and Beauty Culture courses are undergoing training that will be completed in June 2019. A Mobile digital literacy camp was also organized at Donaldson Skill Development Centre to make the girls aware about mobile technology.

E. PHDRDF-TCI FOUNDATION

PHDRDF and TCI Foundation have partnered for the project titled “Enterprise Development - Low Cost Sanitary Napkin Production Enterprise by Women Self-Help Group” which aims to address the dual purpose of economic empowerment for women and provide low cost sanitary napkins to rural women and adolescent girls in and around Jamhar Village, Khunti District of Jharkhand through enterprise development of manufacturing low cost sanitary napkins. Market linkages for the product have been established for the Women SHG and women have started earning out of their SHG.

PHDRDF and THDC have come together for a women empowerment and livelihood generation project through sanitary napkins manufacturing. The manufacturing unit will be established through women SHG model at Rishikesh, Dehradun.



PHDRDF SCHOOL DEVELOPMENT

PHDRDF has been actively working towards improving the quality and standard of school education and literacy by supporting the existing Government schools in different states.

A. PHDRDF- TEVA API INDIA LIMITED

Teva API India Ltd and PHDRDF have come together for a project - “Aadharsh Vidyalaya- Integrated Development of Government Schools in Gajraula, Uttar Pradesh and Malanpur, Bhind” in Madhya Pradesh. The buildings of both the schools have been upgraded including refurbishing of classrooms, mid-day meal area, sanitation and drinking water facility, playground, proper boundary wall with gate and BaLA. The civil work in both the schools has been completed. Swings and slides in both the schools have been installed. Currently, the schools are closed for summer vacations and recurring activities will be resumed after the schools reopen.

B. PHDRDF- HAGER FOUNDATION

A project on “WASH and Quality education in five Government Schools in Sikar, Rajasthan” is being implemented for the last four years with support from Hager Foundation. The buildings of the schools have been upgraded including refurbishing of classrooms, mid-day meal area, sanitation and drinking water facility, playground, proper boundary wall with gate and BaLA. Regular hygiene practices were introduced by a health worker in all the schools. It is being ensured by the health worker that menstrual hygiene is being maintained by the school girls on a regular basis. Besides above, computer classes and English speaking classes have also been introduced in these schools.

C. PHDRDF- CAF INDIA

CAF INDIA and PHDRDF have partnered together to implement a project – “Gaon Mera”- Phase V for construction of a Assembly Hall in Sarsai Government School, Sarsai, Kullu District, Himachal Pradesh. The objective of the project is to ensure a child friendly learning atmosphere by providing sufficient, safe and furnished community hall with educational wall art – BaLA. The project will also enable students and teachers to have an open space for assemblies, extracurricular and cultural activities.

PHDRDF WATER MANAGEMENT

PHDRDF has been constantly working towards recharging of ground water table through construction of Rain water harvesting structures.

A. PHDRDF - COCA COLA FOUNDATION

PHDRDF and Coca Cola Foundation have partnered together to promote sustainable solutions for water resource management with surface water conservation and ground water recharge, through construction of seven check dams in water-stressed regions of Ranchi District in Jharkhand. The project aims towards increasing the ground water table and thereby improving access to water for agriculture and domestic use in two blocks of Ranchi District – Kanke and Ratu where the ground water has been over exploited. The project will reach out to more than 15,000 people, creating a total water recharge capacity of 292,100 cu. mts.

B. IREDA and Rotary Club of Delhi Central (RCDC)

PHDRDF with support from IREDA through Rotary Club of Delhi Central inaugurated a water harvesting structure, namely Sushil Check Dam and a Fluoride treatment plant with a capacity of 5000 litres per hour on June 2, 2019 at Sikar Rajasthan. A team of 20 people from IREDA and RCDC including Mr. KS Popli former CMD, IREDA, Mr. Srinivasan GM CSR, IREDA and Mr. Sunil Jain, President RCDC were present for the inauguration. Mr. Sanjay Bhatia Chairman, PHDRDF graced the event with his presence. Representatives from RDF and villagers were present in large numbers. Fluoride is present in high content in water in Sikar, with a defluoride plant, 10.0 litres of treated water will be available to villagers at Rupee One.

C. PHDRDF- FMS

PHDRDF and FMS have partnered for the first time to construct a check dam 'Paliwala check dam' along with laying of pipelines for drinking water distribution in Sirsodi ki Dhani Village in Kotputli, Jaipur. The construction of this check dam is in progress. This check dam will have 650,000 cu ft which will impact the lives of 1022 people of one village.

PHDRDF HEALTHCARE INTERVENTION AND SANITATION



PHDRDF has been actively conducting free health camps for the low-income population in various geographical locations across the country to increase access to healthcare. A team of a qualified Doctor, ANM, Lab Technician and project coordinator are present for each camp and are responsible for its success. Emphasis is given on generating awareness among the community on sanitation & hygiene, child & maternal health, waterborne diseases, communicable diseases and other geography-based medical problems.

A. PHDRDF- KADIMI TOOLS MANF. CO.PVT LTD

PHDRDF and KADIMI have partnered to implement a project titled “Infrastructure Development and Access to Sanitation & Hygiene”. The project entitles to construct two public toilets in Ram Chowk, Dundahera and Kapasera Border – Foot over bridge, Dundahera, Gurugram district, Haryana. Construction of the public toilet under foot over bridge is in full pace and likely to be completed soon.

B. PHDRDF- GAIL INDIA LTD

PHDRDF with support from GAIL India Ltd initiated a project on “Mobile Medical Unit” in district Shravasti, Uttar Pradesh. A team of doctor and paramedical staff will conduct 69 health camps in 60 villages through a Mobile Medical Unit. Diagnosis along with various blood tests and free medicines will be provided to the patients. The Mobile Medical Unit will reach out to more than 1600 beneficiaries in a month. During this period, a total number of 23 generic health camps were organized reaching out to a total of 1840 patients.

BSES Yamuna Power Ltd. collaborated with PHDRDF for another one year to implement a Mobile Health project in Central and East Delhi. The objective of the project is to provide basic health care services to the low-income residential clusters of East and Central Delhi. During June 2019 to March 2020, a total of 162 health camps will be organized in 18 locations and approx. 19440 patients will be benefitted. In the month of June, 1680 patients have benefited through the 14 health camps that were organized.

Industry upbeat about RBI move

New Delhi, June 6

HAILING THE RBI'S decision to cut lending rate by 25 basis points as a welcome step to boost demand and revive economy, industry chambers said there is more room to slash rates further. "There is room for further rate cut...this third consecutive rate cut in repo rate will lead to effective transmission, encouraging banks to lower their lending rates for both retail and corporate credit," said Sandip Somany, president, Ficci.

Reviving business confidence, consumer confidence and triggering animal spirits in the economy is the need of the hour, the chamber said in a statement.

Assocham said the shift in policy stance from neutral to accommodative is looking significant and these measures would

rekindle economic growth and improve business sentiments. "The credit policy resolution and the RBI governor's emphasis on faster and higher transfer of rate cuts will be reassuring if done by the banks. This, when coupled with improved liquidity, would reduce the cost of borrowing," said Assocham president B K Goenka.

PHD Chamber also welcomed the rate cut and said it will help to stimulate demand, boost investments, enhance exporters' competitiveness and growth of the industrial sector. "At this juncture, the transmission of the policy rate cut by the banking sector in terms of reduced lending rates would be crucial to boost liquidity. Going ahead, we expect repo rate to come down to 5% in the coming quarters for adequate availability of credit to the industry especially to the MSMEs sector," the chamber said.

Stringent laws needed to safeguard IP rights: Ex-CJI

Stringent laws and collaborative enforcement are vital to safeguard intellectual property rights in India, as businesses in global economy focus on actively managing the intellectual property to remain competitive, former Chief Justice of India Dipak Misra said on Thursday.

Misra, who was speaking at a conference on 'Intellectual Property through collaborative enforcement', emphasised that while the property of the mind or proprietary knowledge has been recognised over centuries, it has gained significance in the current context due to developments in technology and trade. "The increasing significance of intangible assets in the global economy is forcing business corporations to actively manage their Intellectual Property concepts as a key driver for

building and sustaining competitive advantage and achieving superior performances," he said at the conference organised by PHD Chamber of Commerce and Industry.

Knowledge-sharing

In ancient India, knowledge sharing surpassed all other forms of giving, he said and added that IP today builds strategic alliances of socio-economic and technological growth. It is, in fact, the basic structure of sustenance in a competitive economic state. "IPR is necessary to promote inventions...In present times, the statutory regime is in force and its in consonance with the framework of progressive countries...That is not enough. Some more stringent laws are required because we are growing as a developing economic nation," he said.

NEW DELHI: The government plans to nurture agri-entrepreneurs to give an impetus to farming in the country.

"Agriculture is no less than industry and we consider every farmer as entrepreneurs. For a sustainable growth in agriculture, fresh ideas need to be sown and youth should be encouraged to be part of one of the oldest professions," said a senior agriculture department official

The spirit of government is well reflected in

the budget presented by finance minister **Nirmala Sitharaman**, who advocated for facilitating "ease of doing business" for farmers also while calling upon all the states to allow their farmers to trade on eNAM - the national online trading platform created by government for transparent bid based trading of commodities across 585 mandis in the country.

She also invited private entrepreneurship in farming and allied sector while announcing mega public investment in agriculture sector. She indicated for private investments in renewable energy sector associated with agriculture.

"Annadata can also be urjadata," she had said in her budget speech.

"There is a vast potential in biogas energy and solar energy. The kind of land we have under cultivation and number of livestock, we can easily have biogas plants at village level which can be utilised locally in generating electricity and meeting other energy requirements. They can also install solar panels in vast open fields to generate solar power," said Mahesh Y Reddy, Secretary General of PHD Chamber of Commerce & Industry, a trade body.

He said that there are certain other things also to be addressed in the coming times to give a major thrust in agri sector.

"Educating farmers to adopt mechanized farming, minimising the wastages to less than 10% from the current level of 30 to 35%; increasing public investments in agriculture sector, modernizing agriculture along with technological reforms; and promoting food processing exports are few steps that will go a long way in doubling farmers income by 2022," he said.

Vijay Sardana, an agri economist said that there is great potential of private investment in agriculture sector and India can do better if private players are encouraged.

"Except India and China, it's private investment which is pushing the agri sector in all countries. It's a good step of government to encourage private investment," he said.

Cap personal income tax rate at 25% to boost demand, says PHDCCI

New Delhi, June 12

The maximum personal income tax rate in the country should move towards 25 per cent to increase disposable income, thereby boosting demand in the economy, the PHD Chamber of Commerce and Industry (PHDCCI) said on Wednesday.

The industry body, in a statement, said liquidity infusion, job creation and low cost export finance would be crucial at this juncture to revitalise the economy and accelerate it to a higher growth trajectory.

The maximum personal income tax rate presently stands at 30 per cent.

The government must expedite liquidity infusion through gradual reduction in CRR from the current level of 4 per cent to 2 per cent and in SLR from 19 per cent to 15 per cent, PHDCCI President Talwar said.

Cash Reserve Ratio (CRR) is the portion of the deposits which banks are required to park with the RBI, whereas SLR or Statutory Liquidity Ratio is the portion of funds which banks are required to park in treasury bills and other instruments.

We appreciate the recent cut in repo rate by 25 bps and

expect that the repo rate would be reduced by 125 bps gradually from the current level of 5.75 per cent to 4.5 per cent in the coming quarters, Talwar said.

The transmission of policy rate cut by the banking sector in terms of reduced lending rates would be crucial to boost liquidity and induce demand in the country, he added.

Besides, he said, creation of jobs in the economy would require structural reforms in the labour laws.

In a separate statement, Assocham Deputy Secretary General Col Saurabh Sanyal said labour and land reforms would go a long way in attracting new investment not only from within the country but also overseas.

"Such reforms would send a very positive message across the world about India unleashing an investor-friendly regime, making the country the best bet among the emerging markets," Sanyal said.

We expect to get Cabinet approval to float InvIT by September: NHA Chief

NEW DELHI: The National Highways Authority of India (NHAI) expects to get Cabinet nod for floating its infrastructure investment trust (InvIT) in two to three months, its Chairman N N Sinha said Wednesday.

To fund the country's ambitious highways building plans, including Bharatmala, NHAI also plans to mobilise Rs 75,000 crore from the market this fiscal, he said.

"This is the first time we are attempting something like this (InvIT) so cannot say firmly when the trust will take shape. We expect to get Cabinet approval in two to three months and implementation will take four to five months," Sinha said on the sidelines of an event here.

He said the NHAI board has already approved the InvIT and talks are on with market regulator SEBI for its approval.

InvITs are instruments on the pattern of mutual funds and are designed to pool small sums of money from a number of investors to invest in assets that give cash flow over a period of time.

Besides InvIT, NHAI is looking at raising Rs 75,000 crore from the market this fiscal.

"In (this year) we propose



to mobilise around Rs 75,000 crore from the market and a significant part of the highways development comes from the borrowings... Our ministry is looking at creating an agency for financing... This is a long term issue," he said.

Sinha said NHAI is also looking to tap the carbon credit market for various green highways, including the Delhi-Mumbai expressway that is set to reduce travel time between the two metros to 12-13 hours from the present 24 hours.

"We know that green highways like Delhi-Mumbai goes through backward area... with controlled access the speed of movement will be much more... This should also ensure tapping the carbon credit market. Our ministry is looking at various modes of mobilisation of resources for the highways development programme," he said.

Sinha said NHAI is going to tap all kinds of resources to propel infrastructure growth and contribute towards making India a \$5 trillion economy.

He emphasised that growth of economy is critically linked to the highways sector.

Earlier, addressing the National Roads and Highways Summit organised by PHD Chamber of Commerce and Industry, he said due to escalation in land acquisition cost, Bharatmala's timeline could be stretched.

"Forty four economic corridors have been identified for construction of 9,000 km under Bharatmala based on surveys of 12,000 km of routes and mapping of 600 cities," he said.

Sinha said economic corridors would assure last mile connectivity and eventually the target was to reduce the existing logistics cost to about 8-9 per cent from 14-15 per cent.

INDIA'S POTENTIAL AS TEXTILE SOURCING HUB FOR GLOBAL BRANDS

Dr. Ranjeet Mehta

India enjoys a unique advantage of having abundant raw materials and presence of manufacturing in all segments of the textile value chain but it's yet to become the most favored destination for sourcing by International Brands. The Textile & Apparel industry is one of the largest and the most important sectors for the Indian economy in terms of output, foreign exchange earnings and employment. It also provides direct employment to over 45 million people and is the second largest provider of employment after agriculture. As per the WTO in its World Trade Statistical Review 2018, India is ranked as 5th largest exporter of Ready Made Garments (RMG) in the world. Given that Ready Made Garments manufacturing units can be viable at all size levels, particularly because of low cost of plant and machinery, the units range from small to large. Consequently, the RMG sector continues to be dominated by unorganized players. However, the branded apparel market has



made inroads in the past few years.

The decentralized power looms and knitting sector forms the largest section of the textile sector. The major sub-sectors that comprise the textile sector include the organized cotton/manmade fiber textile mill industry, the manmade fiber/filament yarn industry, the wool & woollen textile

industry, the sericulture and silk textiles industry, handlooms, the jute & jute textiles industry and textiles exports. As per the data, Indian Textile industry is one of the largest in the world with a large raw material base and manufacturing strength across the value chain. India is the largest producer and the second largest exporter

of cotton in the world. India is also the leading consumer of cotton. Domestic Textile and apparel industry contributes 2% to India's GDP and accounts for 14% of industrial production, 27% of the country's foreign exchange inflows and 13% of country's export earnings with huge potential to grow. This sector is all the more important because it's dominated by women workers, with 70% of the workforce being women. To me this is one sector which can uplift rural women from abject poverty and also goes with the empowering women in the larger interest of India. If we look closely, the Indian textile and apparel sector, the sub sectors of weaving, processing and garmenting are fragmented and lacking the requisite scale for success in global markets. Most of the manufacturing units have small capacities and low manufacturing efficiencies which make it difficult for them to compete in global markets.

At 50% of world production, India is the largest producer of raw jute and jute


