I opine that President, Ms. Murmu's term will align with the words of former, US President, Eisenhower, "Accomplishment will prove to be a journey, not a destination. If you're walking down the right path and you're willing to keep walking, eventually you'll make progress."

With India entering its 76th year of Independence and celebrating its 'Azadi Ka Amrit Mahotsav', Ms. Murmu's first quote as President of India, "India is ready with new thinking as it celebrates 'Amrit Kaal', the 75th anniversary of its Independence. We are building 'Ek Bharat - Shreshtha Bharat' by embracing many languages, religions, food habits and customs," very aptly fits with our Chamber's mission and acknowledges India's journey during the last 75 years. Prime Minister, Mr. Narendra Modi's 'Har Ghar Tiranga' campaign to hoist Tiranga (the national flag) in every household between August 13-15, 2022 will further boost the country's morale. A very stimulating decision, it will promote patriotism and foster a sense of personal connection to the Tiranga among the citizens of India. We proudly acknowledge the corporate sector's motivation to contribute in the initiative through distribution of free flags to the households. Such benefaction of corporates should be included in their regular CSR activities to reinstate and enhance the spirit of nation-building.

In celebration of India's 75th year of Independence Day, the Chamber invited Mr. G Kishan Reddy, Union Minister of Tourism, Culture & DoNER; Ms. Anita Bose Pfaff, daughter of Netaji & Senior Economist; Mr. Chandra Kumar Bose, Grandnephew of Netaji & Convener, The Open Platform for Netaji and Mr. Sanjeev Sanyal, Member, Advisory Economic Council to the Prime Minister to address the first Netaji Subhas Chandra Bose Memorial Lecture. We all know that Netaji Subhash Chandra Bose took daring steps to free India and we are glad that the Modi government is taking steps to preserve his legacy by propagating his vision and ideologies.

As the world navigates through a very challenging journey of slowing global growth, increasing inflation and tightening of monetary conditions, it is heartening to point out that India responded to the COVID-19 pandemic and geo-political tensions with resilience, driven by the Government's proactive policy reforms. India stands amongst the top ten actively growing economies having exhibited consistent improvement in its macroeconomic performance during the last four years.

India's manufacturing activity expanded at a quick pace in July 2022 on the back of new business orders and output. High-frequency indicators such as GST collections, E-way bills, sale of passenger vehicles, and tractors all show positive trends in the current fiscal year. A well-capitalised financial system and comfortable foreign exchange reserves to withstand the trade shocks are helping to strengthen the economy. The rupee movements have been relatively orderly due to Reserve Bank of India's (RBI) intervention across markets. We fully agree with experts including the RBI that the Indian economy is expected to grow in the range of 7.2-7.5 percent in FY 2022-23.

I must comment that there is a possibility of some advanced economies slipping into recession in case there is continued disruption in gas supplies from Russia. Having said, India is well protected from recession or stag inflation as the Reserve Bank of India is making all efforts to bring down retail inflation below 7 percent by hiking key interest rates. Further, the Federal Reserve's move to hike its interest rates and further expected monetary tightening by the US central bank may transmit to lowering India's inflation.

We note that India has maintained a tightrope walk between Russian-Ukraine crisis. Being a major importer of crude oil and fertilizers, India purchased more than one

million barrels a day in July at a discounted rate, while it imported about 7.74 lakh tons of fertilizers during April-June 2022 versus 11.02 lakh tons in the whole FY 2021-22.

In order to foster international co-operation and strengthen trade and economic relations, the Chamber in coordination with Konrad-Adenauer-Stiftung organized its 37th edition of the Ambassadors' Meet on July 22, 2022 at New Delhi. The Meet was graced by Dr Rajkumar Ranjan Singh, Minister of State for External Affairs and Mr. Rameswar Teli, Minister of State for Petroleum & Natural Gas, Labour and Employment. The Meet witnessed participation of more than 112 diplomats representing 70 countries. This symbolizes that we are very much open to engaging with the industry fraternity across the world to carry forward the mission of creating "Shared Prosperity" following our national principle of 'Vasudhaiva Kutumbakam'.


Climate change has today emerged as an unprecedented existential crisis. Radical changes are needed to avert this impending calamity. India should strongly push for green hydrogen as energy transition stands to be key for this transformation. The Chamber is organizing an International Climate Summit 2022- 'Opportunities for Green Hydrogen' in August 30-31, 2022 at Bergen, Norway to identify incentives required for setting up mega-scale hydrogen plants in India for industrial and domestic consumption and exports. Union Minister, Mr. Nitin Gadkari, Minister of Road Transport will lead the delegation along with His Holiness Sri Sri Ravi Shankar, Founder of Art of Living. I invite our esteemed members to kindly join the summit at Norway.

As we achieve higher levels of competitiveness, I as President of the Chamber, while celebrating 'Azadi Ka Amrit Mahotsav,' pledge to work in collaboration with the government for building an Atmanirbhar India. I draw immense strength from the energy, passion and dedication of my industry members and Team PHD for achieving Progress, Harmony and integrated Development of the Nation leading up to the 100th year of India's Independence. Let me conclude by saying that, "The best teamwork comes from people who are working independently toward one goal in unison."

**HOIST A FLAG AT YOUR HOUSE
FROM 13-15, AUGUST 2022**



SALIENT FEATURES OF FLAG CODE OF INDIA, 2002

1. The Indian National Flag represents the hopes and aspirations of the people of India. It is the symbol of our national pride and there is universal affection and respect for, and loyalty to, the National Flag. It occupies a unique and special place in the emotions and psyche of the people of India.

2. The hoisting/use/display of the Indian National Flag is governed by the Prevention of Insults to National Honour Act, 1971 and the Flag Code of India, 2002. Some of salient features of the Flag Code of India, 2002 are listed below for the information of the public:-

a) The Flag Code of India, 2002 was amended vide Order dated 30th December, 2021 and National Flag made of polyester or machine made Flag have been allowed.

Now, the National Flag shall be made of hand spun and hand woven or machine made, cotton/polyester/wool/silk khadi bunting.

b) A member of public, a private organization or an educational institution may hoist/display the National Flag on all days and occasions, ceremonial or otherwise, consistent with the dignity and honour of the National Flag.

c) The Flag Code of India, 2002 was amended vide Order dated 19th July, 2022 and clause (xi) of paragraph 2.2 of Part-II of the Flag Code of India was replaced by the following clause:-

(xi) **“where the Flag is displayed in open or displayed on the house of a member of public, it may be flown day and night;”**

d) The National Flag shall be rectangular in shape. The Flag can be of any size but the ratio of the length to the height (width) of the Flag shall be 3:2.

e) Whenever the National Flag is displayed, it should occupy the position of honour and should be distinctly placed.

f) A damaged or dishevelled Flag shall not be displayed.

g) The Flag should not be flown from a single masthead simultaneously with any other flag or flags.

h) The Flag should not be flown on any vehicle except of the dignitaries mentioned in Section IX of Part III of the Flag Code, such as President, Vice-President, Prime-Minister, Governors etc.

i) No other flag or bunting should be placed higher than or above or side by side with the National Flag.

FREQUENTLY ASKED QUESTIONS (FAQS) ABOUT THE INDIAN NATIONAL FLAG

Q1. Is the use, display and hoisting of the National Flag guided by any overarching set of instructions?

Yes- The 'Flag Code of India 2002' and the Prevention of Insults to National Honour Act, 1971.

Q2. What is the Flag Code of India?

The Flag Code of India brings together all laws, conventions, practices, and instructions for the display of the National Flag. It governs the display of the National Flag by Private, Public, and Government Institutions. The Flag Code of India took effect on 26th January 2002.

Q3. Which material can be used to produce the National Flag?

The Flag Code of India, 2002 was amended vide Order dated 30th December, 2021 and National Flag made of polyester or machine made Flag have been allowed. Now, the National Flag shall be made of handspun and handwoven or machine-made, cotton/polyester/wool/silk/khadi bunting.

Q4. What is the appropriate size and ratio of the National Flag?

As per paragraph 1.3 & 1.4 of the Flag Code of India, the National Flag shall be rectangular in shape. The Flag can be of any size but the ratio of the

length to the height (width) of the National Flag shall be 3:2.

Q5. Can I display the National Flag at my home?

As per paragraph 2.2 of the Flag Code of India, a member of the public, a private organization, or an educational institution may hoist/display the National Flag on all days or occasions in accordance with the dignity and honour of the National Flag.

Q6. What is the timing for flying the National Flag in the open/at the home?

The Flag Code of India, 2002 was amended vide Order dated 20th July,

2022 and clause (xi) of paragraph 2.2 of Part-II of the Flag Code of India was replaced by the following clause:-

(xi) “where the Flag is displayed in open or displayed on the house of a member of public, it may be flown day and night;”

Q7. What should I keep in mind while displaying the National Flag at my home?

Whenever the National Flag is on display, it should occupy the position of honor and should be distinctly placed. A damaged or disheveled National Flag should not be displayed.

Q8. What should I keep in mind to avoid incorrect display of the National Flag?

- The National Flag shall not be displayed in an inverted manner; i.e.; the saffron band should not be the bottom band
- A damaged or disheveled National Flag shall not be displayed
- The National Flag shall not be dipped in salute to any person or thing
- No other flag or bunting shall be placed higher than or above or side by side with the National Flag; nor shall any object including flowers or garlands, or emblem be placed on or above the flagmast from which the National Flag is flown.
- The National Flag shall not be used as a festoon, rosette, bunting, or in any other manner for decoration
- The National Flag shall not be allowed to touch the ground or the floor or trail in the water
- The National Flag shall not be displayed or fastened in any manner as may damage it
- The National Flag should not be flown from a single masthead (top part of a flagpole) simultaneously with any other flag or flags
- The National Flag shall not be used to cover a speaker's desk, nor shall it be draped over a speaker's platform
- The National Flag shall not be used as a portion of costume or uniform or accessory of any description which is worn below the waist of any person nor shall it be embroidered or printed on cushions, handkerchiefs, napkins, undergarments or any dress material

Q9. Are there any rules for prevention of insult to the Indian National Flag?

Yes. In accordance with explanation 4 to section 2 of “the Prevention of Insults to National Honour Act, 1971”, the following should be observed:

- The National Flag shall not be used as a form of drapery in any form whatsoever, including private funerals
- The National Flag shall not be used as a portion of costume or uniform or accessory of any description which is worn below the waist of any person nor shall it be embroidered or printed on cushions, handkerchiefs, napkins, undergarments or any dress material
- There shall be no lettering upon the National Flag
- The National Flag shall not be used to wrap, receive, or deliver things
- The National Flag shall not be used to cover the sides, back, and top of any vehicle.

Q10. What is the correct way to display the National Flag in the open/on public buildings?

As per Section III of Part III of the Flag Code of India, if the National Flag is flown on public buildings, it should be flown on all days from sunrise to sunset, irrespective of the weather conditions. It should be hoisted briskly and lowered slowly.

- When the National Flag is displayed flat and horizontal on a wall, the saffron band shall be upper most and when displayed vertically, the saffron band shall be to the right in reference to the National Flag i.e., it should be to the left of a person facing it.
- When the National Flag is displayed from a staff projecting horizontally or at an angle from a windowsill, balcony, or front of a building, the saffron band shall be at the farther end of the staff.

Q11. Should the National Flag be flown at half-mast?

The National Flag shall not be flown at half-mast except on occasions instructed by the Government of India. When flown at half-mast, the National Flag shall be hoisted first to the peak/top of the staff, then lowered to the half-mast position. Before lowering the National Flag for the day, it should be raised again to its peak.

Q12. Can I display the National Flag on my car?

The privilege of hosting the National Flag on motor cars is only limited to the following persons as per paragraph 3.44 of the Flag Code of India, 2002.

- President
- Vice-President
- Governors and Lieutenant Governors

- Heads of Indian Missions/Posts
- Prime Minister
- Cabinet Ministers, Minister of State, and Deputy Ministers of the Union
- Chief Minister and Cabinet Minister of a State or Union Territory
- Speaker of the Lok Sabha, Deputy Chairman of Rajya Sabha, Deputy Speaker of Lok Sabha, Chairman of Legislative Councils in States, Speakers of the Legislative Assemblies in States and Union Territories, Deputy Chairman of Legislative Council in States, Deputy Speakers of Legislative Assemblies in States and Union Territories
- Chief Justice of India
- Judges of Supreme Court
- Chief Justice of High Courts
- Judges of High Courts

Q13. How can we display the Indian National Flag along with flags of other nations?

- As per paragraph 3.32 of the Flag Code of India, when the National Flag is displayed in a straight line with flags of other countries, the National Flag shall be on the extreme right. The flags of other nations will follow in an alphabetical order as per the English versions of names of the nations.
- If the flags are flown in a closed circle formation, the National Flag is flown first and is followed by flags of other national in a clockwise manner.
- When the flag is displayed against the wall with another flag from crossed staffs, the National Flag shall be on the right and its staff will be in front of the staff of the other flag.
- When the National Flag is flown with flags of other nations, the flag masts shall be of equal size.

Q14. How should the National Flag be disposed?

- As per paragraph 2.2 of the Flag Code of India, if the National Flag is damaged, it shall be destroyed as a whole in private, preferably by burning or any other method considering the dignity of the National Flag.
- The National Flag, if made of paper, is waved by the general public, these flags should not be discarded on the ground. These should be discarded in private, keeping in mind the dignity of the National Flag.

DR BHAI MOHAN SINGH
(1970-71)

Dr Bhai Mohan Singh of Ranbaxy Laboratories as the Chairman of the Chamber in 1970-71. The year, saw the influx over six millions refugees from Bangladesh. And the people reposed their trust in the government which received a massive mandate. On the issue of foreign capital, Dr Singh felt that it was "only through a free flow of savings and capital across national frontier" that economic development could be achieved. Dr Singh observed "within the framework of a mixed economy, private enterprise is capable of facing the challenges of development and willing to play its part, provided its initiative and enterprise are not inhibited."



MR. MAN PHOOL CHOPRA
(1971 - 1972)

Mr. Man Phool Chopra of Ravi Cold Storage was the Chairman of the Chamber in 1971-72. August 15 that year was an important landmark in the annals of our country, the Silver Jubilee of India's Independence. Reiterating that "industrial peace and harmony is essential if we want to successfully implement the 'Garibi hatao Programme', he appealed for eschewing strikes and lock-outs. It was during his tenure that the Chamber was offered a piece of land in Defence Colony, Delhi. Mr. Chopra opined, "we certainly feel that there is scope for a marriage between the managerial expertise of the private sector and the financial resources of the public sector institutions."



MR. PREM PANDHI
(1972 - 1973)

Mr. Prem Pandhi representing Metal Box Company Ltd., was the Chairman of the Chamber in 1972-73. At the 68th Annual General Meeting, he pointed out that there had been an improvement in our technological competence and professional management. Expressing his concern about the high growth rate of population, Mr. Pandhi urged fellow members to carry out family planning programmes and set apart at least one percent of their profits "for this immensely worthwhile cause". Mr. Pandhi also advocated recognition of the role played by Chambers of Commerce and observed "Chambers of Commerce had been rendering useful service not only to industry and business but even to the community at large in a variety of ways."



MR. RAUNAQ SINGH
(1973- 1974)

Mr. Raunaq Singh of Bharat Steel Tubes Limited was the Chairman of the Chamber during the year 1973-74, a period of strict government controls and spiralling prices due to oil embargo that affected the industry. Mr. Singh consistently highlighted the high cost of delays in getting government approvals, which were the order of the day during his Chairmanship. Mr. Singh advocated a realistic credit policy that should address to the hyper-inflation and at the same time could power the industry to push up their production and productivity.



MR. M K MOHTA
(1974-1975)

Mr. M K Mohta of Bhagwani Cotton Mills Limited was the Chairman of the Chamber during the year 1974-1975. Mr. Mohta believed that revival of capital market held the key to a dynamic economy. The tax structure, he argued, should be investor friendly and tax base should be current consumption rather than gross income, which he felt could boost the saving habits of the people. This could be coupled with lower rate of corporate taxation, which could enable corporations to distribute higher dividend to the shareholders. He called for creating exportable surpluses in the economy by refashioning policies and attitudes.



MR. BISHAMBER DAS KAPUR
(1975-1976)

Mr. Bishamber Das Kapur of Atlas Cycle Industries Limited, was the Chairman of the Chamber during the year 1975-1976. Mr. Kapur laid emphasis on exploring export markets or Indian products for which then existed considerable scope, in view of the availability of appropriate technology, lower wage costs as well as indigenous availability of inputs. He called for adopting forward looking approach by way of major liberalization of export credit. He also advocated for setting up of an Export-Import Bank, which eventually materialized, in successive years.





MR. D D PURI
(1976 - 1977)

Mr. D D Puri of Saraswati Industrial Syndicate Limited, having interests in diverse areas such as sugar, steel, industrial machinery, etc., was the Chairman of the Chamber during the year 1976-77. He reiterated early implementation of the proposal for a Dry Port to encourage exports from northern land-locked states. He advocated a cautious and calibrated import policy. "If any indiscriminate liberalization of imports of capital goods is allowed, it would endanger domestic industries producing such goods or similar goods," he said at the 72nd Annual General Meeting of the Chamber.



MR. L M THAPAR
(1977 - 1978)

Mr. L M Thapar heading the Ballarpur Industries Group was the Chairman of the Chamber during the year 1977-78. A staunch supporter of the Chamber of Commerce movement, he observed that the Chamber was of great help in constructing bridges of understanding and filling the communication gap between the policy framers and the business community. He was against the price preference policy of the government, which gave undue advantages to the public sector at the cost of the private initiatives. He also championed the cause of social responsibility of the business circles.



DR BHANSI DHAR
(1978 - 1979)

Dr Bhansi Dhar of Delhi Cloth and General Mills was the Chairman of the Chamber during the year 1978-1979. Rural Development and supporting the small-scale sector as well as broad basing the entrepreneurial base had occupied high priority during his chairmanship. He had lent valuable support to the Rural Development Cell of the Chamber, which motivated more and more industrial enterprises to take up development works in rural areas. He exhorted the business community to maintain the price level since any upward movement of prices would create hardship to the common man.



MR. C K HAZARI
(1979 - 1980)

Mr. C K Hazari of Escorts Limited was the Chairman of the Chamber during the year 1979-80. He drew attention towards measures needed to improve viability of industrial projects due to steep rise of taxation. It was during the chairmanship that the Chamber adopted its present name and also several amendments were made to the Memorandum and Articles of Association of the Chamber. The Head of the organization was redesignated from Chairman to President.



MR. K G KHOSLA
(1980 - 1981)

Mr. K G Khosla of Khosla Compressors Limited was the President of the Chamber during the year 1980-1981. He laid emphasis on the government-business partnership as an effective vehicle for further growth. Laying emphasis on the contribution of the labour, he maintained that "we also subscribe to the philosophy that the labour is as vital a part of industry as the employer." Mr. Khosla also highlighted the need to check inflation, which he said was important not only to check the galloping price level but also to conserve the purchasing power of rupee.



MR. MOHINDER PAL PURI
(1981 - 1982)

Mr. Mohinder Pal Puri of M P Puri and Company was the President during the year 1981-82. The Chamber believed that the Sixth Plan objectives could be achieved only through a combination of measures including fiscal correction, monetary policy tooling and focus on accelerated export promotion. Mr. Puri suggested that the government should follow a policy to progressively reduce Cash-Reserve Ratio and Statutory Liquidity Ratio to pump out more credit into the system, which was otherwise locked up with the banks. He called for organizing export of machinery and removal of inputs and infrastructure bottlenecks.





MR. V P PUNJ
(1982 - 1983)

Mr. V P Punj of Lloyd and Company Ltd., was the President during the year 1982-83. He advocated for review of the reservation policy for the small sector. Building international connectivity was his priority, which he believed, would open up new avenues for exports and investment in the country. Recognizing the necessity to strengthen economic corporation among the South Asian countries, Mr. Punj, as President of the Chamber led delegations to Pakistan and Nepal. Mr. Punj also suggested that in order to industrialize areas with locational disadvantages, MRTD/FERA companies be encouraged to go into No-industry districts by allowing their expansion in those areas.



MR. K K MODI
(1983 - 1984)

Mr. K K Modi of Modipon Limited was the President during the year 1983-84. "Economic growth can take place only through the efforts of 70 million people of India, but it can be vastly aided or hindered by the Government action and policy," commented Mr. Modi at the 79th AGM of the Chamber. Mr. Modi also highlighted the distortions brought in the economy by high rate of taxes, which encourages tax evasion, leading to loss of revenue and emergence of a parallel economy, resulting in increased disparities of income and encouragement to wasteful expenditure. He called for an end to case-by-case examination of all proposals for industrial expansion, which resulted in scope for arbitrary decisions and counter productive delays.



MR. W N TALWAR
(1984 - 1985)

Mr. W N Talwar of Talbros Automotives was the President during the year 1984-85. Promoting competitiveness was the mission during Mr. Talwar's Presidency. During his Presidency, the long standing demand of the Chamber to have a National Capital Region for the Chamber was accepted by the Government through an Ordinance Promulgated by the President of India. The Northern Region, he felt, should lay emphasis on infrastructure and entrepreneurship development. Taking further the Chamber's international linkages, Mr. Talwar led delegations to Gulf countries and China. He called upon the government to follow the Chinese model for development of special economic zones to create modern industrialized cities.



MR. SHIV RAJ GUPTA
(1985 - 1986)

Mr. Shiv Raj Gupta of Central Distilleries and Breweries was the President during the year 1985-1986. He led delegations to Jordan, Egypt, Greece and Turkey. He made presentation to the government on how the policy measures were helpful in transforming Turkey. He commended the deregulation policy being pursued by the government. Mr. Shivraj Gupta called for constructive cooperation between government and private sector to achieve vital national objectives. Mr. Gupta also emphasized the need to bring down tax rates to encourage investments. Interactions at the highest level at both the Centre and State levels were an important hallmark of his Presidency. At these interactions, he took up various issues being faced by the industry in general and in Northern



MR. MANMOHAN SINGH
(1987 - 1988)

Mr. Manmohan Singh of Frick India Limited was the President during the year 1987-1988. The nation was in the grip of a severe drought, which had caused innumerable difficulties to the people and the farmers in particular. In the meantime, the nation was entering the English Plan period. Mr. Manmohan Singh had definite ideas about the planning process. He opined that one of the major drawbacks of our planning has been that it tends to lay too much emphasis on the size of investment and expenditure incurred. There should also be a drastic rationalization and reduction not only in non-plan expenditure so that we do not land into the vicious problem of resource crisis.



MR. M M SABHARWAL
(1988 - 1989)

Mr. M M Sabharwal, Chairman, Bata India Limited was the President during the year 1988-1989. Mr. Sabharwal pitched for further liberalization to attract more investment since the domestic investible resource were limited. He was quoted to have said, "I would suggest that we need to review and modify the concepts of monopoly and dominant undertakings so as to be in tune with the competitive environment in the world." Mr. Sabharwal pitched for import of capital goods and technology at a concessional rate of duty to facilitate modernization at minimum cost.





MR. S S KANWAR
(1990 - 1991)

Mr. S S Kanwar of Bharat Steel Tubes Limited was the President during the year 1990-1991. That was the year when the nation had launched the new economic policy with focus on reform process. Mr. Kanwar felt that the new policy had removed most of the barriers to production and investment. The reforms would usher in an era of stiff internal competition. The import compression policy should not be allowed to continue. To help the industry to finance their modernization and expansion plans, they should be allowed to enhance their internal accruals by reducing the corporate tax to 40 percent.



CH. DEVINDER SINGH
(1992 - 1993)

Ch. Devinder Singh of Industrial Cables Limited was the President during the year 1992-1993. He felt that it was imperative that the messages for reforms are spread to the states and local levels, which could change the mindsets of the people. He laid emphasis on research and development. Another important point highlighted by him during his Presidency was the need for a Mass Rapid Transit System for Delhi as an alternative to the heavily burdened transport system. In order to attract foreign investment, he urged propagation of the process of economic reforms and to build a positive image for the Indian business. He led delegations to CIS countries, South Africa and Nepal.



MR. VINEET VIRMANI
(1993 - 1994)

Mr. Vineet Virmani of S P Virmani & Sons Pvt. Ltd. was the President during the year 1993-1994. Mr. Virmani laid emphasis on evolving a proactive policy to promote small and medium enterprises in the country. He was of the view that the SSI sector's cumbersome procedural requirements acts as a dampener to this sector in getting the required support from the government. It was during his presidency that the Chamber launched a project 'Governance for Development' in collaboration with the Centre for International Private Enterprise, Washington, D.C.



MR. P K RAJGARHIA
(1995 - 1996)

Mr. P K Rajgarhia of Orient Aster Communication Pvt. Ltd. was the President during the year 1995-1996. The external debt situation was a worrying one at US\$ 100 billion in 1995-1996. Any further increase, Mr. Rajgarhia felt, could create serious problems to the nation in terms of getting entangled into a debt trap. The escape route, he said, was putting the borrowed resources into productive uses so that it could generate more resource than the outflow on account of repayment. One important aspect of his presidency was the emphasis on environ-management. He wanted the government to take corrective actions to minimize pollution and environmental degradation in the country.



MR. BINAY KUMAR
(1996 - 1997)

Mr. Binay Kumar of Banaras house Limited was the President during the year 1996-1997. During his tenure, the Chamber laid emphasis on 'Ethics is Good Business' and adopted it as a motto and promoted empowerment of women. He led A high powered delegation to Pakistan and a joint Indo-Pak Study Team was constituted. Leading the Chamber during the 50th year of country's independence, Mr. Binay Kumar also called for reforms at the state level to improve the competitiveness of the national economy. During his tenure, the Chamber also extended its services to Madhya Pradesh which was included in its geographic jurisdiction.



MR. O P VAISH
(1997 - 1998)

Mr. O P Vaish of Vaish Associates was the President during the year 1997-1998. The East Asian crisis had affected the state of the world economy. To come out of the contagious effect of the East Asian crisis, Mr. Vaish felt that India should lay focus on foreign direct investment by creating an investor friendly environment. He also advocated the involvement of states in international commercial affairs. One way of achieving this was reorienting the attitudes of the state officials towards international trade. Mr. O P Vaish was a strong votary of reforming the tax administration system and also called for implementation of state level VAT and abolition of octroi.





MR. ARUN KAPUR
(2001 - 2002)

Mr. Arun Kapur of Limrose Engineering Works Pvt. Ltd., and also associated with Atlas Cycle Industries Ltd. was the President of the Chamber in 2001-02. He led many study delegations to China, Japan and South Korea on behalf of the Engineering Export Promotion Council. With an aim to attract investments for industrial revival in Punjab, as President of the Chamber, Mr Kapur interacted with the Chief Ministers of Punjab and Haryana. The President focused on human resource development, setting up of economic zones in the States, and adopted aggressive marketing of the States as investment destinations. He opined that the FDI policy should be made flexible, consistent and transparent to boost foreign investors' confidence. He opined that an enduring partnership between government and business is crucial to facilitate global competitiveness.



MR. SATISH BAGRODIA
(2008 - 2009)

Mr. Satish Bagrodia, Adviser of Winsome Textile Industries Limited was the President of the Chamber in the year 2008-09. Mr. Satish Bagrodia was a true symbol of progress, enterprise and social commitment. During his tenure as President, the Chamber played a catalytic role to build consensus on wide ranging subjects ranging from corporate governance, agribusiness, tourism, skill development, taxation, labour laws, defense, economic reforms as well as industrial relations. The Chamber conducted numerous socio-economic activities to promote women empowerment, AIDS awareness, mother and child care, water harvesting, rural development as well as various community development initiatives.



Sachindra Nath Sanyal (1893 – 1942)

In 2022, the Nation remembered Revolutionary Sachindra Nath Sanyal on his 80th death anniversary. Sachindra Nath Sanyal was associated with the Indian Revolutionary movement. Originally hailing from Bengal, Sachindra Nath Sanyal was born in then North-Western Province in the city of Benaras in 1893. Right from an early age, Sanyal was known for his maverick views and revolutionary ideas. At the age of 20, he opened a branch of Anushilan Samiti in Patna.

Sachindra Nath Sanyal was a mentor for revolutionaries like Chandrasekhar Azad and Bhagat Singh. He along with Rashbehari Bose attacked Viceroy Hardinge and injured him while he was entering the new capital of Delhi in 1912. After Bose escaped to Japan, Sanyal was considered the most senior leader of India's revolutionary movement. Sachindra Nath Sanyal was closely involved in the plans for the Ghadar Conspiracy. He faced imprisonment for involvement in the "Kakari Train case". Sanyal was sentenced to life for his involvement in the Kakori Train Action and was imprisoned at Cellular Jail in the Andaman and Nicobar Islands, where he wrote his book titled 'Bandi Jeevan' (A Life of Captivity, 1922). Sachindra Nath Sanyal passed away in Gorakhpur Jail on February 7, 1942.

Mr. Ravi Kaushal, Chief Manager, SBI stated that women are gifted with communication skills, empathy and flexibility to adjust. There are many schemes for Entrepreneurs but one directed especially to women is, 'Stand-up India' for SC and ST women.

Ms. Amrita Dubey, Secured & Unsecured Loans, Small Business Banking, Vice President, Axis Bank Ltd. stated that all organizations have been mandated to hire 33% of women work force. Ms. Shresha Srivastava, Circle Head, Axis Bank said that with increased digitalization, especially after COVID-19 loans can be taken through Apps by just registering on the App.

Ms. Dubey said that it has also been noted that rural women are less defaulters compared to men for which their CIBIL ratio is not necessary.

DISCOM CONCLAVE

He termed bad financial health of DISCOMs, lack of funding support for clean-tech projects from FIs, free electricity to residential areas and non-revision of electricity tariffs as major problems in the power sector.

Mr. Pradeep Multani, President, PHDCCI, in his presidential remarks highlighted the significance of new technologies like Smart Grids, Smart Meters and Digitization and urged DISCOMs to provide clean and cheap electricity to the industry.

Mr. Salil Gupta, Chair, Power, RE & AE Committee, PHDCCI, said that the Indian government has been taking significant steps to improve the operational efficiencies and financial viability of DISCOMs. Mr. R

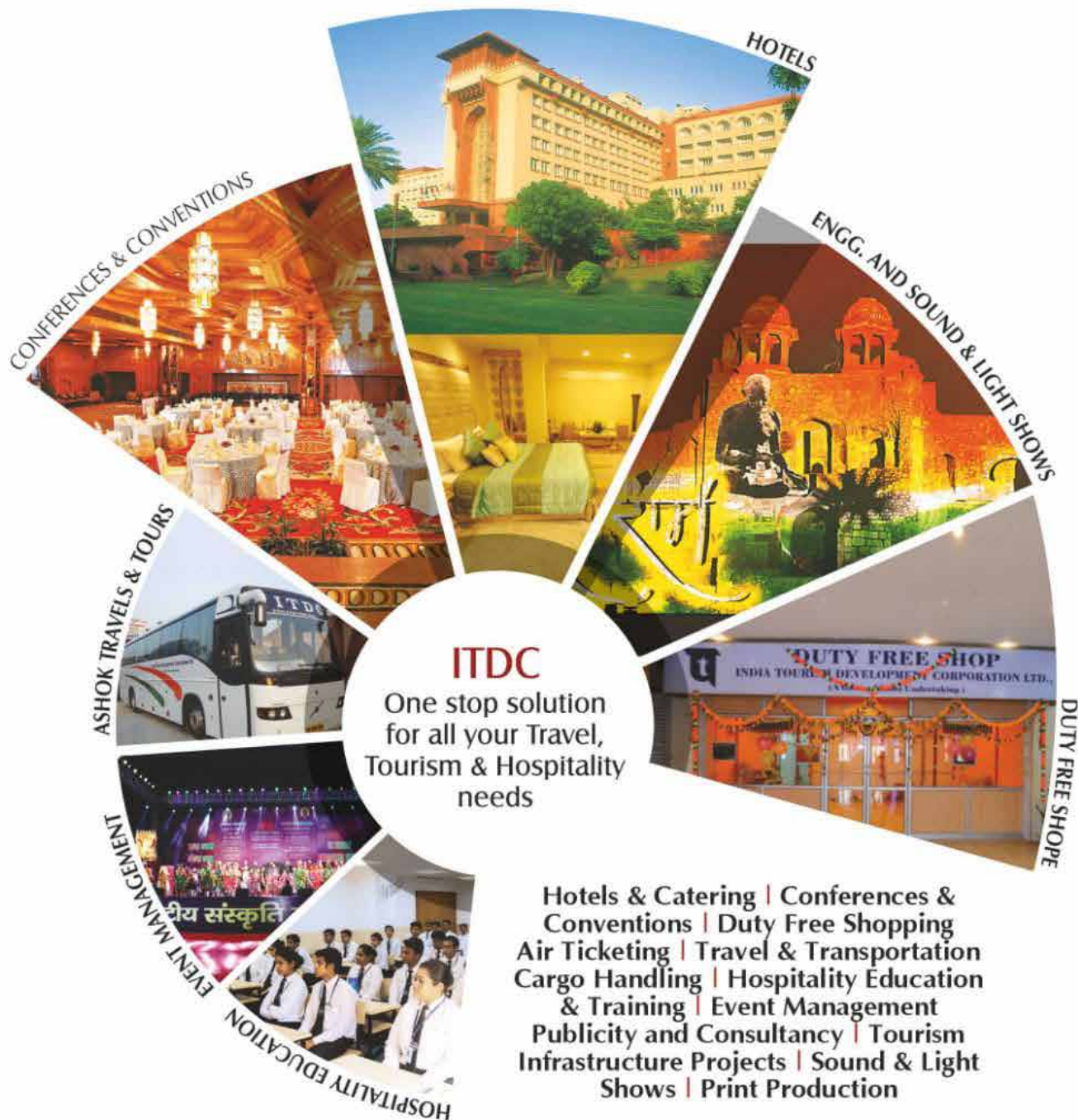

Mr. Saurabh Gupta, Co-chair, Power, RE & AE Committee, PHDCCI, complimented the Government agencies and BSES for launching program for installation of smart meters on a mass scale, which was essential for controlling T & D losses and improving the financial health of DISCOMs.

Mr. Girishkumar Kadam, Senior Vice President & Co-Group Head - Corporate Ratings, ICRA Limited & Knowledge Partner said that focus on improving operational efficiency, timely issuance of tariff orders with adequate tariff revisions and timely subsidy payouts were necessary to ensure financial sustainability of Discoms along with a strong political will and support from state governments.

A knowledge report prepared by ICRA and PHDCCI was also released at the Conclave.

GST CONCLAVE -5 YEARS OF GST

The Indirect Taxes Committee of PHD Chamber organized a National “GST Conclave – Evolution and Challenges – 5 Years of GST” on July 7, 2022 at PHD House, New Delhi (HYBRID MODE).

Chief Guest, Mr. Vivek Johri, Chairman, CBIC, Ministry of Finance, informed that the 5th anniversary took place close on the heels of the 47th GST Council Meeting, where the Council made significant announcements, to provide ease of business to the trade including the MSME sector. Mr. Johri addressed concerns over the revenue collection from GST. He said that it's unfair to blame GST for some extreme factors like the global economic scenario and the COVID-19 pandemic. He mentioned that 2021-2022 did not register good revenue collection from GST, however it continued to grow at a fast rate.

Mr. Pradeep Multani, President, PHDCCI in his Presidential address referred to GST as India's most significant and historic indirect tax reform.

Mr. Bimal Jain, Chairman, Indirect Taxes Committee, PHDCCI said that GST has provided in true sense 'One Nation, One Tax, One Market'. He lauded the role of the GST Council for playing a pivotal role in bringing the centre and states together and commended the Council for taking several important decisions at the recent 47th GST Council.

Mr. Ashok Kajaria, Former President, PHDCCI, stated that before GST came in, the ceramics and tile manufacturers were paying taxes

anywhere between 28-33 percent, depending on the state they were operating in, which is now relaxed at 18%.

Dr Mahesh Gupta, Former President, PHDCCI requested that clarity to be provided in the implementation of divergent advance rulings.

Mr. Gopal Jiwarajka, Former President, PHDCCI suggested that the provisions made for tracking - for example, tax deducted at source (TDS) and tax collected at source (TCS) - should be made in such a way that it doesn't affect the cash flow. He highlighted the impact of taxes on colour television wherein 28% GST is being applied.

Mr. Rajeev Talwar, Former President, PHDCCI emphasized on the role that GST played during the

pandemic.

CMA P. Raju Iyer, President, The Institute of Cost Accountants of India, shared about the GST courses, that have been introduced in the Institute.

CA. Rajendra Kumar P, Chairman, GST & Indirect Taxes Committee, ICAI gave details about the capacity-building programs done by the ICAI.

CA Pawan Arora, Co-chair, PHDCCI suggested that an accountability check for the GST Officers should be in place.

Following the inaugural ceremony, topics discussed included 'GST-Most Litigated Issues,' 'GST-Evolution and Challenges - Issues,' and 'GST-Compliance and Challenges - Issues'.

Mr. K.P. Narayanan, Director Zoho Finance Plus, gave a presentation titled '5 Years of GST and the Role of Technology.'

Dr Yogesh Srivastav, Assistant Secretary General, PHDDCI, delivered the concluding remarks.

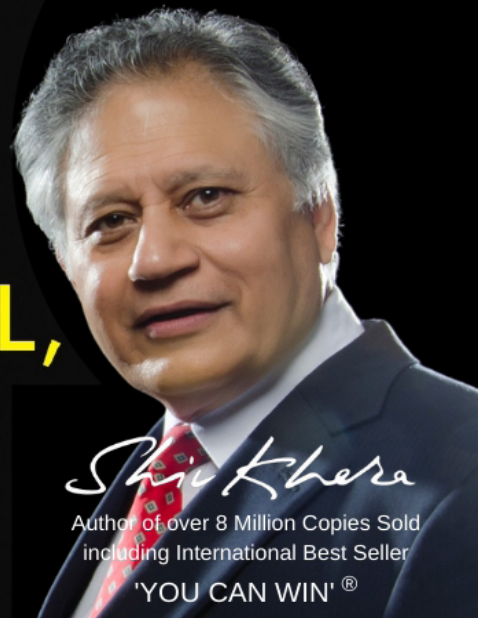

EASE OF DOING BUSINESS – INSTITUTIONAL SUPPORT TO MSMEs



The MSME Committee of PHD Chamber organized a conference on 'Ease of Doing Business – Institutional Support to MSMEs' on July 07, 2022 at PHD House, New Delhi.

Chief Guest, Mr. Bhanu Pratap Singh Verma, Hon'ble Minister of State of MSMEs, mentioned that over the past couple of years, the Ministry of MSMEs initiated a slew of measures for the promotion and growth of MSMEs. With certain landmark decisions, like change in the definition of MSMEs, introducing a new simplified 'Udyam Aadhar' registration, Champions portal, and expansion of credit guarantee, to name a few would go a long way to building a stronger MSME sector. The Minister also mentioned increasing the budget for the MSME sector for the year 2022-23 to Rs. 21,422 crores from last year's budget allocation of Rs. 15,700 crores, thereby providing greater financial support to the MSMEs.

He stated that the 'Atmanirbhar Bharat' Package announced by the Government for the MSME sector which comprised of some major

financial and other policy measures to help the sector, provided a lot of help to MSMEs to not only restart their operations but also provided newer opportunities to a large number of enterprises.

Mr. Pradeep Multani, President, PHDCCI highlighted that Ease of Doing Business is important for the promotion and growth of MSMEs which not only requires policy and regulatory changes by the government to fast track various registration requirements and removing tardy regulatory compliances but also strengthening the institutional support mechanism. He also requested the banks to look into the issue of collaterals which becomes a very large amount for MSMEs to bear while seeking loans.

Dr H P Kumar, Former CMD, NSIC and Advisor, PHDCCI, in his theme address apprised about the various schemes of the Government for the benefit of the MSMEs.

Dr S S Acharya, General Manager, SIDBI pointed out that only 94 lakh MSMEs are registered on the Udyam Portal which is nearly about 15-20%. Still around 80% of the MSMEs are out

of the formal system which is a large number. He underlined that MSMEs have to be under the formal system to avail the formal financial needs for business operations.

Mr. Yogendra Pathak, Additional CEO & CFO, Government e-Marketplace, apprised that Government procurement is the largest procurement sector. He further advised the MSMEs to register on GeM portal which could be beneficial for them to get bulk orders from various Central and State Governments. The GeM portal is completely contactless, paperless and seamless system with minimum intervention required.

The Banking, Financial Services and Insurance Committee of PHD Chamber organized a “Workshop on Cyber-Security, Crime & Insurance 2022” on July 15, 2022 at PHD House, New Delhi.

Mr. Anuj Agarwal, Chairman of Centre for Research on Cyber Crime and Cyber Law stated cybercrime tops the list as it involves a lot of money. Many cyber stations are coming up across the nation due to the alarming rise of cybercrimes. Mr. Agarwal suggested that corporates should employ the services of cyber-experts and follow the IRDA and RBI framework standards as well as the normal cyber complaint procedures.

Mr. Arun Kumar Verma, Inspector working as SHO, Cyber Police Station, South Delhi, informed that the Delhi Police has built separate police stations that focus on only cybercrime cases in each district and also set up a helpline - 1930 that can be used to

report a cyber-crime.

Mr. Najm W. Bilgrami, National Head - Financial Lines, Tata AIG General Insurance Company Ltd., Mumbai, stated that manufacturing companies are more likely to be the target of hacking attempts than IT corporations or financial institutions as they tend to utilize technologies without the basic firewalls, encryption, and password security protection in the technologies, making them easy targets for hackers.

Mr. Sameer Nandwani, Specialist Insurance Lawyer said that cyber claims are not rejected because they are huge and even if the insurance company rejects them, it falls in the category of bad reputation which is eventually paid off.

Mr. SK Jain, Former VP & Director, Insurance Brokers Association of India, elaborated on the role of an insurance broker, which is important as they have a greater understanding of the

technicalities in insurance policies.

Mr. Ashish Biji, Director Risk Advisory - Cyber and Strategic risk, Deloitte Touche Tohmatsu India LLP, maintained that the primary responsibility to prevent cyber fraud resides with an individual first, then with the government and people should utilize secured CCTV cameras.

Mr. S K Sethi, Co-chair, Banking, Financial Services & Insurance Committee, PHDCCI, in his presentation, titled ‘Some Facts About Cybercrime, Security & Insurance’, forewarned that in the modern world, data is a precious asset and that one should not take cybercrime lightly because it can happen to anyone. He suggested that SEBI should make it mandatory for the listed companies in its listing guidance to take cyber insurance.

Mr. Saurabh Sanyal, Secretary General, PHDCCI, stated that there is a need to educate the staff as cyber-attacks usually take place through harmless-looking e-mails and WhatsApp messages.

NEED FOR DIVERSIFICATION IN AGRICULTURE AND ROLE OF FOOD PROCESSING INDUSTRY IN DOUBLING THE FARMERS' INCOME



The Agri Business, Food Processing and Logistics Committee, PHDCCI organized a National Conference on “Need for Diversification in Agriculture and Role of Food Processing Industry in Doubling the Farmers’ Income” on July 21, 2022 at PHD House, New Delhi.

Chief Guest, Ms. Anita Praveen, IAS, Secretary, Ministry of Food Processing Industry, shared the government’s perspective about the agri-food sector. She mentioned that India has moved from deficit to surplus in production, exports and demand but now our focus should shift on food processing. By joining hands together, the food processing industry can reach greater heights in the coming future, added Ms. Praveen.

She apprised that the Ministry of Food Processing has taken various schemes for good financial standing of the sector, like, PM Kisan Sampada Scheme and PLI, which are the major fund allocators in agri-business industry to make the sector creditworthy.

poised for huge growth, increasing its contribution to world food trade every year due to its immense potential for value addition, particularly within the food processing industry.

Mr. N K Agarwal, Chair, Agri Business Committee, PHDCCI while appreciating the various schemes of the government, such as providing subsidies in fertilizers, deciding minimum support prices for crops and E-Nam procurement benefits, mentioned that the farmers in the country are facing severe distress. He suggested more focus on farm

mechanization, price assurance to further increase production and assured income in the hands of farmers which in turn may benefit the economy. He underlined that improving agricultural contribution and output could become a growth engine for the Indian economy, if the entire ecosystem is thought afresh as traditional systems have a limited role in doubling farmers’ income.

Mr. Kunal Gupta, Co-chair, Food Processing Committee, PHDCCI highlighted the major blooming reasons for the processing industry

in India may be attributed to the increasing urbanization, change in lifestyle and food habits, and increasing number of nuclear families with working women. 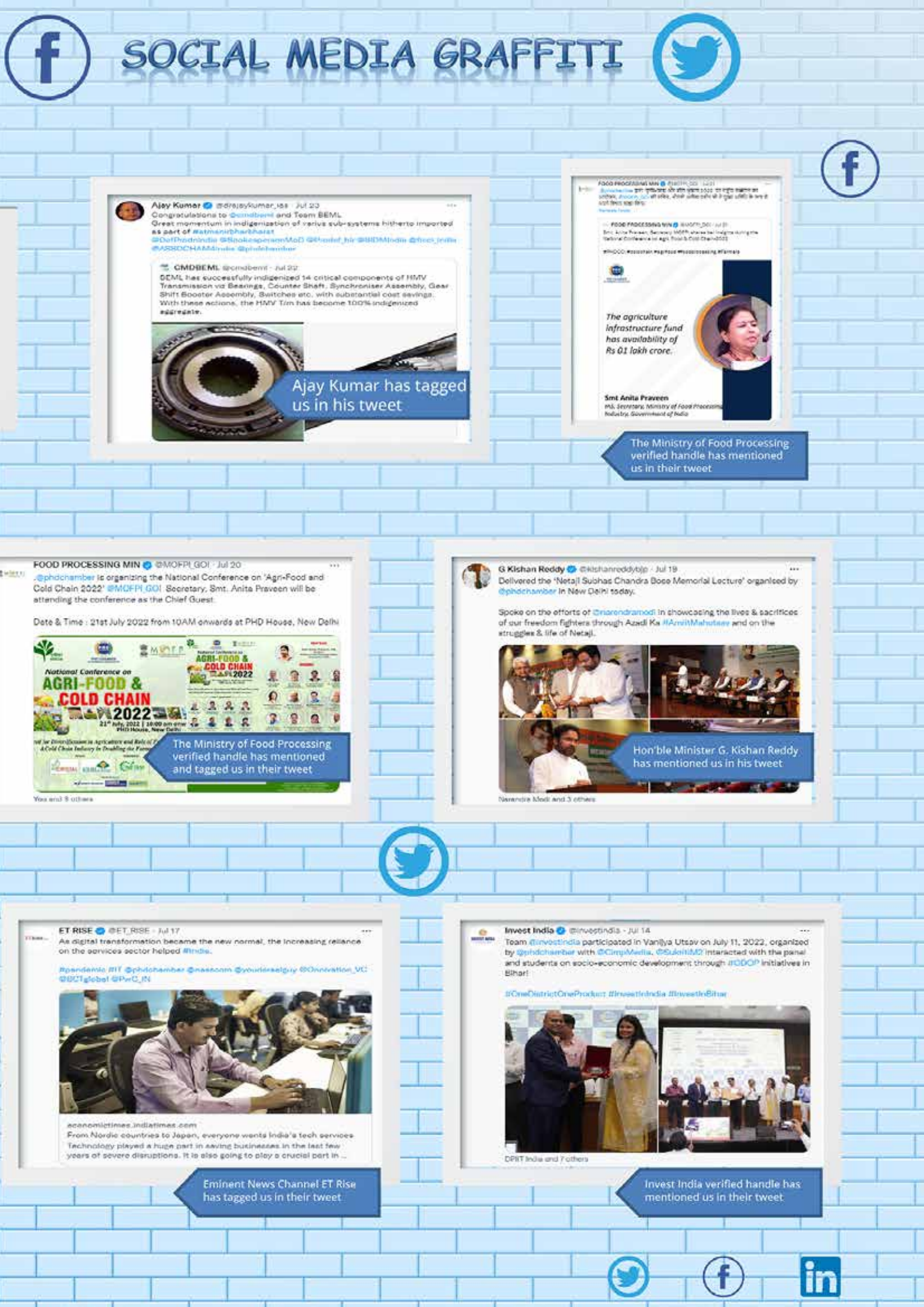

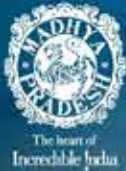

During the month of July, 12 OPDs with specialization on Gynaecology, General Physician and Paediatric and Dental were conducted and more than 250 patients treated. The patient health record data is being maintained digitally for easy examination of the patients and for easy access to a patient's medical history. Community meetings have also been organized to inform the people regarding upgraded facilities available at PHC Behniwal and motivated them to visit the centre for any health concerns. TRANSFER OF SHARES UNDER FEMA

Transfer of shares is a vital aspect in transactions involving acquisitions, business transfers, etc. With increasing complexities in business structures, there are several factors and regulations which need to be considered while entering into such transactions. This becomes especially necessary in cases of transfer of shares where both the parties (buyer and seller) are not Indian residents.

Transfer of Shares between a resident Indian and a Non-Resident is, inter alia, regulated under the Foreign Exchange Management Act, 1999 (FEMA). The primary regulatory authority for such transactions is the Reserve Bank of India (RBI), and the main regulation that govern such transfers being the Foreign Exchange Management (Transfer or Issue of Security by a Person Resident Outside India) Regulations, 2017 ("FEMA Transfer Regulations").

Transaction between an Indian Resident and a Non-Resident:

Under the foreign exchange regulations, transfer of shares or security from a Resident Indian to a Non-Resident Indian is allowed, subject to certain conditions. As per Regulation 5 of the Foreign Exchange Management (Transfer or issue of security by a person resident outside India) Regulations, 2000, a person resident outside India is required to take prior permission from the RBI before making an investment. The investment made by the Non-Resident must be according to the sectoral caps which restrict the non-resident to hold more than a prescribed percentage of share capital in a company involved in a particular sector.

Person resident Outside India (Non-Resident Indians) are allowed to invest in an Indian company either by way of acquiring existing shares from an existing shareholder, or by Acquiring shares from a Non-resident shareholder. Prior permission is required under certain sectors.

A Person resident outside India other than an erstwhile Overseas Corporate Bodies can transfer shares through the way of sale or gift of shares. Apart from securities such as shares, convertible debentures can also be transferred to the NRI.

There are two routes for transfer of shares namely, automatic route and Government/ Approval route. Under the Automatic route, no prior permission is required from the Government of India, and only disclosures are to be made. Under the Approval Route, prior permission is required from the Government of India. Investment under these sectors would generally include sensitive matters.

The shares can be transferred by the way of sale of shares, or the transfer can be by

way of a gift. Share transfers from a Resident Indian to a Non-Resident Indian have certain conditions to be complied with by each party involved in the share transfer i.e., the transferor (resident of India), Transferee (NRI), Authorized agents appointed on behalf of the authorized dealer, authorized dealer/ authorized bank carrying out the foreign exchange transaction and RBI being the main regulatory body for FEMA.

Transfer of shares and convertible debentures also includes the transfer of subscriber shares issued by the Indian company. The terms of the transfer have to be mutually decided between the transferor and the transferee. For this, the parties have to enter into a private agreement.

In case the transaction involves transfer of such shares transfer upon which approval from the Central Government was taken, then such transactions would also require a general permission from the RBI.

Payment for the shares or securities received by the Non-resident Indian would be according to the normal modes of bank transfer. Payment received would be subjected to the Know Your Client (KYC Norms). The KYC has to be carried out by the authorized bank when funds are received by the bank. If the money is transferred through different banks, then the KYC must be carried out by the bank where money is finally received.

The mode of payment to be carried out for the transfer of shares for a "Non-Resident", "Foreign Institutional Investors (FII) and Foreign Portfolio Investors (FPI) and for a "NRI" are different.

For a "Non-Resident" payment can be made for the transfer of shares through an inward remittance to the concerned authorized bank category I. This is the normal

mode of making a payment for share transfer.

For a "Foreign Institutional Investor" (FII) and "Foreign Portfolio Investors" (FPI) the payment for share transfer can be through the process of debiting the NRE or the FCNR Account. For a NRI, the payment can be made by debiting the NRE or FCNR account. This would be applicable for shares that are got through a repatriation basis. For shares received on a Non repatriable basis, they can be credited through normal banking channels as prescribed by the bank.

For the transfer of shares as stated in the preceding paragraph, the following documents are required to be submitted:

- (i) Form FC-TRS - This form must be submitted to the authorized bank category -I. This must be submitted in quadruplet within 60 days of receiving the consideration or payment for the transfer of shares.
 - (ii) Evidence of Submission- Apart from Form FC-TRS, the submission proof must be present. This would be required to be submitted by the transferor.
 - (iii) In case of shares that are taken by the non-resident through the stock exchange under the FDI route, the investee would have to submit form FC-TRS.
- There are certain documents which have to be maintained for record by the authorized banks such as:
- (i) Consent Letter- The letter of consent must be signed by the transferor and the transferee. The letter must contain details of the transfer, amount of shares transferred, the investee company name and the price of the shares transferred.
 - (ii) Exchange Letter- This must include the agreement of sale between the parties. by the parties.
 - (iii) Power of Attorney- If a duly authorized agent has acted on behalf of the parties, then a power of attorney is required to be executed by the buyer and the seller.
 - (iv) Share Holding Pattern- The transferee company must submit the share holding pattern showing the equity participation of residents and non-residents.
 - (v) Valuation Certificate- The Valuation certificate, which states the price at which shares are transferred. and carried out by a SEBI registered merchant banker or a chartered accountant.
 - (vi) Undertaking by the Buyer- An undertaking must be submitted by the buyer that the shares can be acquired according to the pricing guidelines and the sector limit prescribed by the RBI.
 - (vii) Undertaking from the Foreign Institutional Investor- If there is a foreign institutional investor, an undertaking must be provided by the FII that sector limits have been followed.

'GST e-invoice turnover threshold to dip to ₹5 cr'

Floor being lowered in phases: Johri

GST-registered businesses with annual turnover of more than ₹5 crore will soon have to generate electronic invoices for B2B transactions, a top official said on Thursday.

Central Board of Indirect Taxes and Customs (CBIC) Chairman Vivek Johri said the GST Council, comprising Finance Ministers of the Centre and States, had decided to implement the proposal in a phased manner and with e-invoices being generated for every B2B (Business-to-Business) transaction, invoice matching by tax authorities would not be required under the Goods and Services Tax (GST).

"We started with a very high threshold and soon we are going to have all tax-



payers with an annual turnover of more than ₹5 crore having to generate e-invoices for their B2B part of business. With the launch of e-invoice, we don't need invoice matching," Mr. Johri said at an event organised by industry body PHDCCI here.

Currently, businesses with turnover of more than ₹20 crore have to generate e-invoices for B2B transactions.



Fuel price hike hit household budgets

Noida: State-run retailers, who control 90% of the market, haven't revised pump rates since November under an informal government directive despite a 53% rise in crude cost. The increase in fuel prices will dent household budgets by making goods and services costlier. Costly fuel will also stoke inflation as LPG, petrol, diesel and jet fuel — the prices of which were raised by 18%. This could prompt the RBI to tighten policy, which will hit interest rates and instalments. PHDCCI said the price-cost margins of businesses would be impacted as raw materials and utilities will cost more, also impacting the household budget of common people.

A rebound in contact-intensive services is likely to bolster urban consumption, going forward. Investment activity is expected to be supported by improving capacity utilisation, the government's capex push, and strengthening bank credit, a statement from RBI read.

Meanwhile, Pradeep Mutani, President, PHD Chamber of Commerce and Industry mentioned that the FY 2021-22 GDP data reflects that the country has crossed the pre-pandemic GDP level (at constant prices), and registered a growth rate of 1.5 per cent over for FY 2019-20.

"The GDP growth in Q4 FY 2022 was significantly higher than the corresponding period of the previous year. The recovery is also evident from the performance of various key economic and business indicators during Q4 FY 2022 and the first two months of FY 2023. This exemplary recovery in economic activity, as compared to the lull caused by pandemic Covid-19, has been possible on the back of meaningful reforms undertaken by the government and RBI during the last 2 years," Mutani added.
