

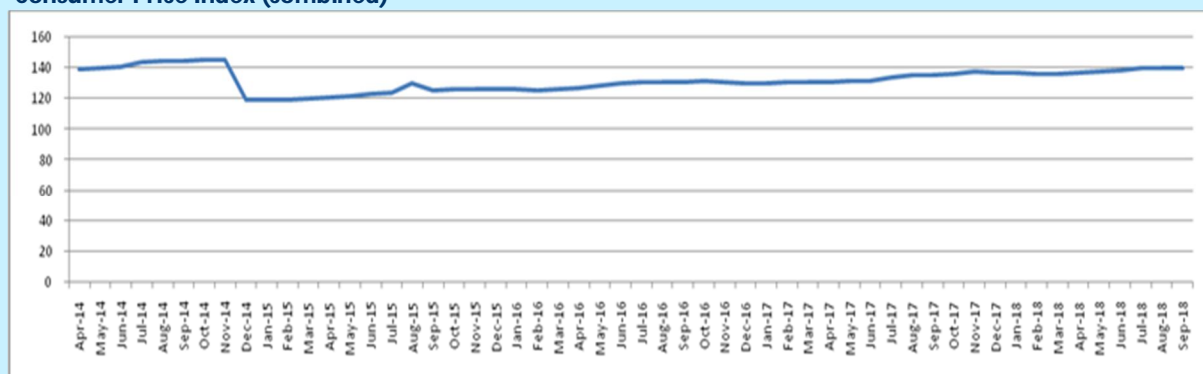
September 2018 CPI inflation stands at 3.77%

Urban India inflation stands at 4.31% in September 2018 as compared to 3.99% in August 2018

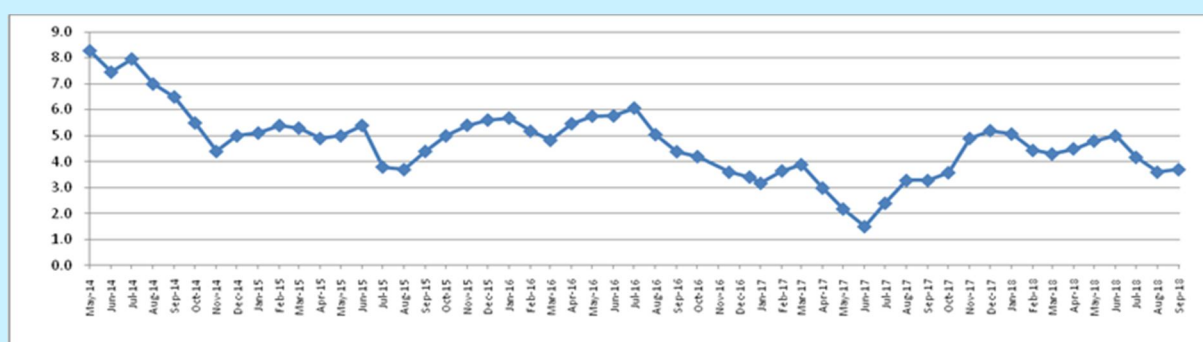
The all India general CPI inflation (Combined) for September 2018 (Prov.) grows at 3.77% as compared to 3.69% in August 2018. The inflation rates for rural and urban areas for September 2018 (Prov.) are 3.34% and 4.31% respectively, as compared to 3.41% and 3.99% respectively, for August 2018. Rate of inflation during September 2018 (Prov.) for fuel and light (8.47%), housing (7.07%), transport and communication (6.42%), education (6.40%) and health (5.90%) etc.

Consumer Price Index for the month of September 2018 for rural, urban and combined stood at 142.2, 138.1 and 140.3 respectively. In addition to this, Consumer Food Price Indices (CFPI) of September 2018 for rural, urban and combined stands at 140.0, 137.0 and 138.9 respectively.

Provisional annual inflation rate based on all India CFPI (Combined) for the month of September 2018 stands at 0.51% as compared to 0.29% in the previous month. The corresponding provisional inflation rates on all India CFPI for rural and urban areas for September 2018 are 0.94% and (-)0.22% respectively as against 1.14% and (-)1.21% respectively in August 2018.
