

## Amendment of import policy of items under HS code 7108 12 00 under ITC (HS), 2017, Schedule – I (Import Policy)

In exercise of powers conferred by Section 3 of FT (D&R) Act, 1992, read with paragraph 1.02 and 2.01 of the Foreign Trade Policy, 2015-2020, as amended from time to time, the central government has amended the import policy of items under HS code 7108 12 00 under ITC (HS), 2017, Schedule – I (Import Policy).
