India has now finally opened a new chapter in its accounting reforms initiative with the implementation of Ind AS from 1st April, 2016 onwards for certain class of companies. The Phase I companies have already started to publish their annual reports prepared in accordance with Ind AS. Under Phase II, all listed companies and companies having net worth from 250 to 500 crore also began implementation of Ind AS from 1st April, 2017 onwards. Banks, NBFCs and Insurance companies would be required to comply with Ind AS from 1st April, 2018 onwards.

These standards lead to a better reflection of the financial performance of an entity and more relevant information in the hands of users of financial statements. However, implementation is a quantum leap from mere intent. The corporate sector needs to carefully plan for their Ind AS implementation strategy which will require a thorough strategic assessment, alignment of resources, effective project management as well as smooth integration of the various changes into normal business operations.
