

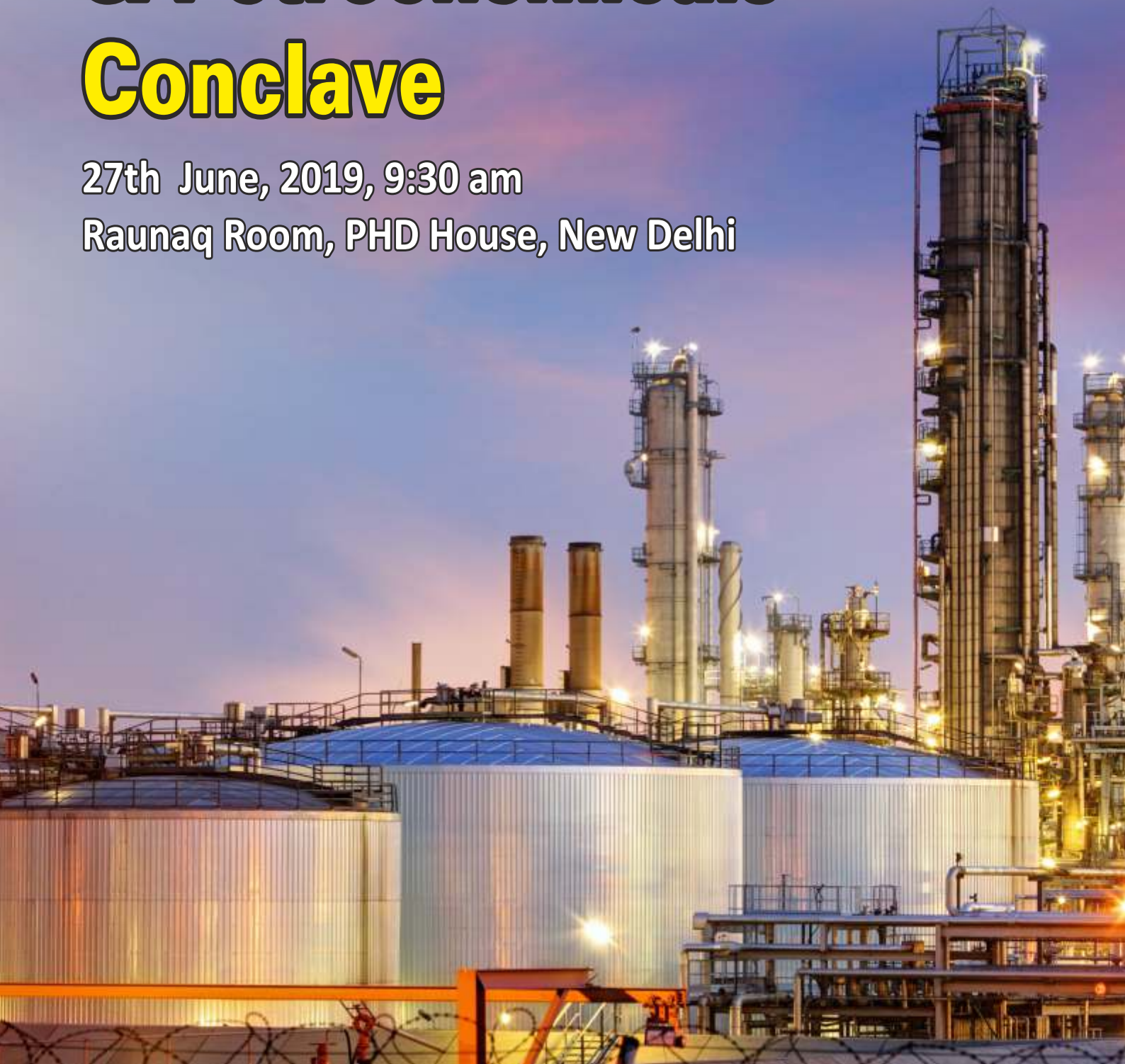

# National Refining & Petrochemicals Conclave

India's crude oil refining capacity is growing rapidly to meet the burgeoning demand for petroleum products. The booming automobile and aviation sectors, fast urbanization and growing use of liquefied petroleum gas (LPG) for cooking are the major drivers for refined products in the country.

The total refining capacity of India in 2018 was 5,010 thousand barrels (of oil) per day (mbd), which is 15% of Asia's total refining capacity in 2018. According to Global Data's report: 'India Crude Oil Refinery Outlook to 2023' the country's total refining capacity is set to grow at an average annual growth rate (AAGR) of 5.3% to 6,525 mbd in 2023. India's planned crude oil refining capacity is also expected to increase to 580 mbd in 2023. India aspires to continue to be a major player in Asian refining and to also become a petrochemicals hub. To effectively support its growing economy, India requires a huge amount of oil and gas. The demand will prompt its private and state-owned refiners to pursue ambitious brownfield and Greenfield expansion plans in coming years, undaunted by the widespread push to embrace alternative energy forms.



Against this dynamic background, PHD Chamber is organizing a **“National Refining & Petrochemicals Conclave” on 27th June, 2019 at 9:30 am, PHD House, New Delhi**. The objective of the Conclave is to bring together key players of the Oil & Gas industry on a same platform to discuss and explore winning strategies and technologies, by means of digitisation in tackling the current and future challenges of the Indian Petroleum sector.
