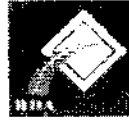

1. Invitation of Bid

The Wastewater Management Authority is inviting sealed bids from eligible, qualified and experienced local and international firms for the operation and maintenance of the St. Martin Wastewater Treatment Plant in accordance with the Conditions of Contract, Scope of Services & Performance Specifications and other requirements as set out in the Bidding Document.

2. Eligibility

The Bid is open to local and international firms having experience in the Operation & Maintenance of wastewater treatment plants as morefully described in the Bidding Document.

3. Scope of the Services

The Services include the Operation & Maintenance of the St. Martin Wastewater Treatment Plant comprising of wastewater treatment, sludge treatment, UV disinfection, Anaerobic digestion, Combined, Heat & Power (CHP), biogas collection and utilisation and other miscellaneous installations and asset replacement works as morefully described in the Bidding Document.

The duration of the Contract shall be seven (7) years.
