President's Message

Friends,

Emerging as a bright star globally, while playing a significant unifying role, India is at the cusp of a major economic transformation. I say with pride that our country continues to be the fastest growing economy worldwide, though at a slightly slower pace of 7.1 percent registered in the July-September quarter against 8.2 percent rate during the previous quarter. At the same time, I would like to congratulate Prime Minister, Mr. Narendra Modi for his recent commitment to play a "due and responsible" role by reducing our greenhouse gas Emissions Intensity of Gross Domestic Product (EIGDP) by 33 percent to 35 percent below the 2005 levels by 2030, according to the UN Environment Program.

India's investment climate has become conducive with big reforms such as the Insolvency and Bankruptcy Code, GST, fiscal consolidation and good governance practices being adopted by the government in recent months. These proactive measures have helped India leap up by 23 places to reach 77th position in the global ranking out of 190 countries in the World Bank's 'Doing Business 2019' report released recently, making it South Asian region's top ranked economy. Substantial efforts have been undertaken to enhance Ease of Doing Business (EoDB), starting from registering an enterprise, dealing with regulatory permits and also movement of goods across borders. PM's recent launch of a Grand Challenge Campaign on resolving seven identified 'EoDB problems' with the use of cutting edge technologies is a great initiative to encourage startups and private enterprise and provide them with a platform to showcase their innovative ideas on Artificial Intelligence, Internet of Things, Big Data Analytics, Block Chain and other technologies to further reform the government processes. Improvements in EoDB have the potential for India to become a US\$ 100 billion investment destination in the next very few years from US\$ 62 billion FDI it attracted in FY 2017-18.

Going ahead, the Chamber commends the US government for extending a significant waiver to India to trade with Iran, allowing Indian oil companies including Oil India Limited and Mangalore Refinery and Petrochemicals Limited to import more than 1.25 million tons of oil in the coming months. I also wholeheartedly welcome the US government's decision to favour India for developing the strategically located Chabahar Port in Iran, along with the construction of a railway line connecting it with Afghanistan. This would facilitate bilateral trade between India and Iran especially of agricultural



and pharmaceutical products. As India's trade deficit with Iran traditionally has been dominated by import of crude oil, and keeping in view Iran's vast natural gas resources and India's LNG capacity, gas could be another important part for future ties, going forward.

The recent softening of crude oil prices and the rupee appreciation may help India save billions of dollars in oil bills. Lower oil prices means less pressure on inflation, lower Current Account Deficit and less pressure on Reserve Bank of India to raise interest rates. Further, the recent softening of vegetables and fruits prices shall keep food inflation under control.

Though uncertain global trading environment has led IMF to lower its targets for global growth citing US-China trade dispute as a major factor, India shall continue to provide machinery, electrical equipments, vehicles and transport parts, chemicals, plastics and rubber products and other competitive goods to the US markets. Alongside, Indo-China trade would continue as India plans to export two million tons of raw sugar to China in 2019 and also non-basmati rice.

PHD Chamber's niche is in the states where it works for the government and industry at the grass root levels. This very well corroborates with Vice President, Mr. Venkaiah Naidu's recent assertion wherein he stressed upon the importance of building a 'Team India', a resurgent India, a strong India where the states work seamlessly, in harmony, complementing and compensating each other, even while competing with each other. I strongly concur that states need to implement new game-changing models for improving the living standards of their people and not resort to conventional or populist measures. I am happy to inform that the Chamber is working vigorously to form State chapters- Pan India, in order to help the State governments to frame policies for the benefit of industry. Recently, we launched our

Kerala State Chapter, that was inaugurated by the Union Minister of State for Tourism, Mr. Alphons Kannanthanam.

Former American President and a distinguished Statesman, Theodore Roosevelt once said, "Rhetoric is a poor substitute for action, and we have trusted rhetoric. If we are really to be a great nation, we must not talk big, we must act big." Keeping in sync with this, the Chamber in November organized a number of mega events such as DILLI: KAL, AAJ, aur KAL, "Towards a Sustainable and Smarter Delhi" that saw the presence of Mr. Hardeep Puri, Union Minister of State (IC) for Housing & Urban Affairs; Mr. Manish Sisodia, Deputy Chief Minister of Delhi; Mr. Satyendar Jain, Minister for Industries & Power, Government of NCT of Delhi who all suggested viable solutions to overcome the challenges being faced by the people of Delhi such as pollution and infrastructure deficit and make Delhi an ideal place to live in with smooth traffic, cleaner air and better civic amenities.

The 4th PHD Chamber's Air Cargo Summit - 2018 "Enabling continued growth of Air Cargo" also saw the presence of Dr. Suresh Prabhu, Union Minister of Commerce & Industry & Civil Aviation and Mr. Jayant Sinha, Union Minister of State for Civil Aviation, wherein the government announced that a new Integrated Logistics and Air Cargo Policy would be announced very soon to the best satisfaction of all stakeholders.

At the G20 Summit held in late November, PM Modi offered to host the 2022 G20 Summit in India, coinciding with our country's 75th year of Independence. We hope to play a pivotal role as a Chamber in organizing the event and providing crucial advocacy support to the government.

India is primed to become a US\$ 5 trillion economy and the 3rd largest consumer market in the world by 2025. As quoted by Former Secretary General of UN, Ban-Ki-moon, "Sustainable development is the pathway to the future we want for all. It offers a framework to generate economic growth, achieve social justice, exercise environmental stewardship and strengthen governance." India's contribution to global economic growth and prosperity underlines its endeavor to support fair and sustainable development. I am certain our industry-led by India's young demographics shall continue to exhibit dynamic enthusiasm, technological innovativeness and an unquenchable quest for excellence in all sectors. In the times to come, India's growth story will be mainstreamed in a holistic manner, so that while ensuring basic livelihood needs of the entire populace, we move ahead on a rapidly soaring trajectory to become a global economic power by 2022.



4th PHD AIR CARGO SUMMIT - 2018

Enabling continued growth of Air Cargo

PHD Chamber's Civil Aviation Committee organized its 4th PHD Air Cargo Summit 2018- "Enabling continued growth of Air Cargo" on November 20, 2018 at PHD House, New Delhi. The summit was inaugurated by Dr. Suresh Prabhu, Hon'ble Union Minister of Civil Aviation and was also graced by Mr. Jayant Sinha, Hon'ble Minister of State for Civil Aviation; Mr. S. Machendranathan, Chairperson-Airports Economic Regulatory Authority of India-AERA and Mr. Rajiv Nayan Choubey (IAS), Secretary, Ministry of Civil Aviation.

Mr. Rajeev Talwar, President, PHD Chamber while welcoming the distinguished dignitaries acknowledged the policy measures of the government claiming that these would further propel the economy, particularly the civil aviation sector.

Inaugurating the Summit, Union Minister of Commerce & Industry and Civil Aviation, Dr Suresh Prabhu declared that the new Integrated Logistics and Air Cargo Policy would be announced 'very soon'. The Minister emphasized that the solutions to critical issues relating to agriculture and manufacturing output and their supplies including exports would be sufficiently explored though the possibilities of making improvement in such an Integrated Policy.

Dr. Prabhu also shared that a specific Department of Logistics has been created in the Department of Commerce which is finalizing the nitty-gritty of logistics

dimensions as well as cargo movement. He opined that the speed and cost of the movement of cargo needs to be addressed properly which will give the necessary boom to the economy.

Guest of Honour, Hon'ble Minister of State for Civil Aviation, Mr. Jayant Sinha in his special address said that with the commissioning of Jewar Airport, the western belt of UP would become a manufacturing hub for a host of economic activities and air passenger & cargo movement. Mr. Jayant Sinha was specific that consumer durables including electronics in particular in and around Jewar and the entire western UP would witness a phenomenal growth

and expansion. The Minister hoped that "Logistics and air cargo connectivity will also pull the host of clusters in the region to come to mainstream as soon as the Airport becomes operational in due course of time".

Secretary, Ministry of Civil Aviation, Mr Rajiv Nayan Choubey shared that India is a price-sensitive economy and Air Cargo transportation is a costly mode of transportation and the need of the hour is to come up with a solution on how it thrives in a price sensitive economy. Mr Choubey opined that India has a very poorly organized logistics chain and the ecosystem in which air cargo functions is fragmented which leads to higher cost of

services. He shared that the government is trying to shift as many functions of Air Cargo off-site as airport spaces are expensive and the Aviation Ministry is actively pushing for the establishment of freight stations in the country. The Secretary also shared the initiatives being implemented by the Ministry like reducing the cost of operations and establishing green fields-Brand new airports at Delhi, Navi Mumbai, Goa, Bhogapuram near Vizag, Purander near Pune and many more with dedicated spaces for air cargo.

Chairman-AERA-Airports Economic Regulatory Authority of India, Mr. S Machendranathan shared the role of AERA, a regulatory authority body for airports and setting up of tariffs and performance standards are monitored by them.

Chairman and Co-Chairman, Civil Aviation Committee, PHDCCI, Mr K Narayana Rao and Mr Vipin Vohra in their respective observations urged the government to put in place policy measures for the civil aviation sector that are pragmatic and convenient to be followed. Mr Rao was also of the view that industry and government should work together to find out solutions to increase India's cargo business with suitable measures in place including issues grappling the sector such as capacity creation, offsite stations, connectivity and the like.

A Knowledge Paper -"Enabling continued growth of Air Cargo" prepared by the Knowledge partner -Auctus Advisors was also released on the occasion by the dignitaries and Mr. Manish Cheddha Managing Director, Auctus Advisors.

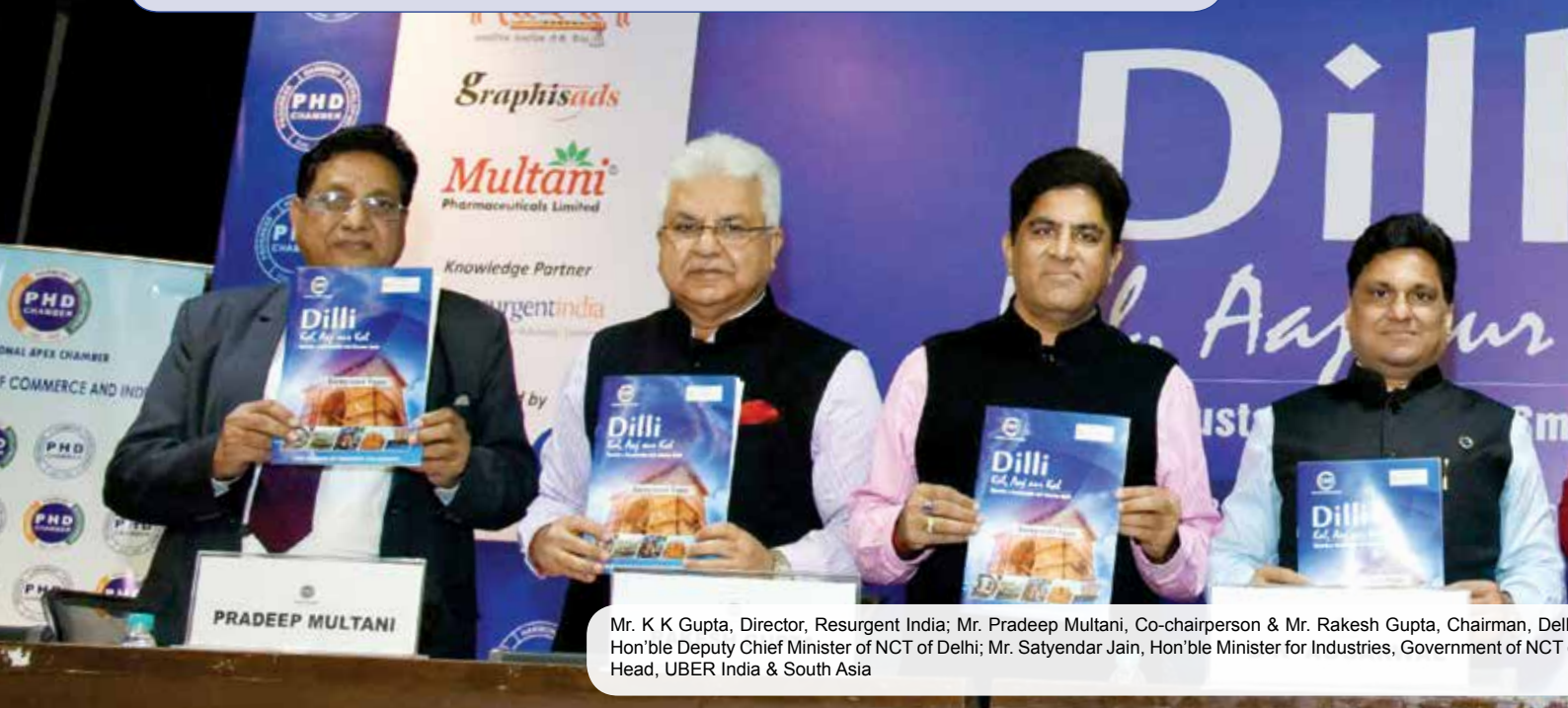

The first edition of DILLI: KAL, AAJ, aur KAL 'Towards a Sustainable and Smarter Delhi' was organized on November 17, 2018 at the NDMC Convention Centre, New Delhi. The objective of the annual conference was to deliberate on issues and challenges faced by the citizens of Delhi and their possible solutions with all the stakeholders.

The conference was addressed by Mr. Hardeep S Puri, Hon'ble Minister of State (IC) for Housing & Urban Affairs; Mr. Manish Sisodia, Hon'ble Deputy Chief

Minister of Delhi; Mr. Satyendar Jain, Hon'ble Minister for Industries & Power, Government of NCT of Delhi; Mr. Adesh Kumar Gupta, Mayor of North MCD and Mr. Narendra Chawla, Mayor of South MCD among others.

Seminar on Sexual Harassment of Women at Workplace and Bringing Industry Closer to Talent Opportunities - NCS Portal

PHD Chamber jointly with KAS organized a seminar on 'Sexual Harassment of Women at Workplace and Bringing Industry Closer to Talent Opportunities – NCS Portal' on November 16, 2018 at Lemon Tree Hotel, Gurgaon.

Ms. Seema Trikha, Member of Legislative Assembly, Haryana inaugurated the seminar. Ms. Trikha in her address stated that being a girl is not a punishment rather we must be proud of being a girl. She said that women contribute more than men in the society. She also referred to the irrational and undesirable behaviour of men in and outside homes, which every second girl has to face in her routine life. She asserted that the victims of sexual harassment are mostly girls/women which indicates that it is not safe for girls to move out of their houses as they are harassed everywhere be it an educational institute or workplace. A little school going girl or a middle aged lady are same in the eyes of harassers. She emphasized that this evil can be challenged by disseminating proper information, education and by making women financially independent. Moreover women should also educate their sons to respect girls like their sisters, she further added.

Mr. Ravi Wig, Chairman, IR and HR Committee, PHD Chamber in his introductory remarks said that it is the duty of all to create a clean environment for women so that they can also contribute their share in growth of family, society

and the country. He opined that women should be respected as a mother and various forms of Devi, as worshipped in our culture.

Technical Issues on sexual harassment of women at workplace were addressed by Ms. Priya Khanna, Advocate, and Ms. Shikha Anand, Director, Directorate General of Employment, Ministry of Labour and Employment. Ms. Bhawna Singhal, Project Manager, Directorate General of Employment, Ministry of Labour and Employment made a presentation on how employers can make use of National Career Service (NCS).

Ms. Priya Khanna, Advocate discussed the history of the law and provisions of present law which was enacted in 2013. She stated that the guidelines by the Supreme Court in Vishaka case have not been followed by the Government, Public or Private sector employers. But after enactment of law in 2013, all employers who employ 10 or more persons need to set up an Internal Complaint Committee with a senior lady officer as a Presiding Officer and a member from an NGO and also other members with knowledge of law and committed to the cause of women. Women should form the majority in the Internal Complaint Committee. Ms. Khanna mentioned that when any complaint is received by an employer or through any member of the Complaint Committee, it should be addressed and investigated. Enquiry must be held based

on established principles of natural justice. Every organization must have a policy on prevention, prohibition and redressal of sexual harassment and organize programmes for members of Internal Complaint Committee to keep them updated of the requirements. Employers must fill in annual returns and also send the intimation to the government on the complaints received and action taken on the Complaint.

Ms. Shikha Anand and Ms. Bhawna Singhal gave a presentation on National Career Service (NCS). Workshop on Bulk Utilization of Crop Residue for Economic and Environmental Sustainability

The Environment and Water & Solid Waste Management Committee, PHD Chamber organized a workshop on 'Bulk Utilization of Crop Residue for Economic and Environmental Sustainability' on November 16, 2018 at PHD House, New Delhi.

Mr. Varun Gupta, Chairman, Water & Solid Waste Management Committee stated that burning of crop residues leads to release of soot particles and smoke causing human and animal health problems. It also leads to emission of greenhouse gases namely carbon dioxide, methane and nitrous oxide, causing global warming and loss of various plant nutrients. The burning of crop residues is a wastage of valuable resources which could be a source of carbon, bio-active compounds, feed and energy for rural households and small industries.

Dr. S K Goyal, Sr. Principal Scientist & Head, CSIR-NEERI Delhi Zonal Centre mentioned that rising level of crop residue surplus on account of higher crop biomass production, poses a great challenge for its effective and efficient management. He also stated that suitable strategies need to be devised for its on-farm utilization, which inter alia includes proper incorporation and decomposition so as to supply organic matter for improving the soil physico-chemical and biological properties.

Dr. Indra Mani Mishra, Head, Division of Agriculture Engineering said, "If farmers can use the Paddy Straws for soil fertility enhancement purpose, than it will definitely reduce the additional cost on fertilizers, which will ultimately save farmers money". He said crop residues

can be a feedstock for composite products such as fibreboard, paper, liquid fuels and others. Several straw-to-fiber board business ventures have emerged in recent years with mixed success. Likewise, crops residues have been investigated as a feedstock for pulp for making paper. Conservative estimates indicate that there are enough crop residues to expand the supply of papermaking fiber by up to 40 percent."

Mr. V.N. Kale, Additional Commissioner, Department of Agriculture, Cooperation & Farmers Welfare said last year that out of 20 million tonnes of paddy straws, about 17 million tonnes were burnt, but this year it was around 13-15 million tonnes and this needs to stop. He also mentioned that stubble burning in neighbouring states combined with other factors in Delhi such as vehicular emissions, industrial pollution and smoke from firecrackers around Diwali plague the national capital's air quality every year. This year too, pollution levels spiked to severe-plus emergency levels.

Dr. Bhure Lal, Chairman, EPCA and Hon'ble Member, Supreme Court Monitoring Committee pointed out that "there is a need to bring a change in the mentality of people so that they look at the alternatives to this practice." He also mentioned that younger generation was ready to look for alternatives, but the older generation still wanted to stick with stubble burning. "It takes a period of 45 days for paddy straw to decompose completely and then be used as fertilizer, but farmers usually have just 25 days, if we succeed in reducing this period of 45 days to 25 days, our problems related to stubble burning will be solved" the EPCA Chairman said.

Dr. J.S. Samra, Senior Adviser (Renewable Energy Programme), CRRID, Chandigarh in his address on "Bio CNG and Bio Manure Productions" said in the near future, vehicles would run on CNG. "The Government of India has earmarked Rs 7,000 crore budget in 2018-19 for setting up marketing infrastructure for bio-CNG. Indian Oil Corporation Limited has already signed a memorandum of understanding with the Punjab Government for setting up 400 plants in the state for the production of bio-CNG from paddy straw," he disclosed.

Dr. Nitin Labhsetwar, Chief Scientist and Head Energy and Resource Management Division, CSIR-NEERI said that India being a agriculture based country, generates more than 600 million tons of biomass waste from different crops and produces 140 million tons of rice straw annually. To dispose the rice straw for making field ready for next crop, farmers are burning it in the fields. The burning of rice straw poses lot of environmental, health and economic issues in India. On one hand, rice straw is a good source of renewable energy but on the other it has got some inherent problems. Therefore, to mitigate the problems due to the burning of rice straw, rice straw can be converted into useful product by torrefaction process i.e. biocoal. In India, generally bituminous coal of gross calorific value (GCV) in range of 3500-4000 Kcal/kg and density 800-900 kg/m³ is used in the thermal power plants for generation of electricity.

He further added that regulatory interventions are increasing day-by-day which is a main bottleneck for the growth of pharma industry in India. He also talked about the danger of online pharmacy like high chances of abuse, fake prescription can be created, scan signature has no authentication, online pharmacy can also lead to black marketing with sky high discount schemes, multiple dispensing, high risk of self-medication, non-compliance, easy accessibility to mentally ill patients, etc.

Mr. Atul Nasa, Deputy Drug Controller, Controlling & Licensing Authority, Drugs Control Department, Govt. of NCT of Delhi said that in 2016 when the system started, the Government of India constituted a committee to regulate online pharmacy

where Dr. S. Eswara Reddy, coordinators of 5 state Drug Controllers and 17 stake holders were present. No one was against online pharmacy, everybody suggested that it should be there but followed by strict regulations and well in place so that it should be controlled.

There were some concerns which IDMA proposed to be included in notification like Good Distribution Practices and Good Storage Practices mainly for cold chain products and Substitution should not be allowed.

He further added that as a regulator, our role is whatever rules are finalized, they should be strictly implemented to be successful and consumer awareness is also one of the major factors for safe online pharmacy.

Mr. Bejon Kumar Misra, Chairman, Task Force on Consumer Affairs & Public Health, PHD Chamber gave an insight about online pharmacy.

PHD Ambassadors' Economic Forum organized an interactive session on 'Rising Income Disparity--Implications for World Security' on November 15, 2018 at New Delhi. Amb K V Rajan, Convenor, PHD Ambassadors' Economic Forum moderated the session.

Mr. Sanjay Aggarwal, Vice President, PHD Chamber highlighted that the distributional effect of economic growth plays a significant role in determining long-term sustainable development trends and socio-economic well-being of the citizens. He also mentioned that the government can adopt a package of redistributive measures including more progressive tax systems that redistribute incomes fairly and by increasing investments in good-quality, free public services and social protection programmes.

Dr. Rajat Kathuria, Director General, Indian Council for Research on International Economic Relations (ICRIER) introducing the theme, 'Rising Income Disparity-Implications for World Security' asserted that we should be more concerned about the rising intra-country inequality rather than inter-country inequality. He added that capitalism can contribute to the cause and even facilitate growth if there is an egalitarian distribution of income.

Dr. Augusto Lopez Claros, a distinguished Economist, with strong World Bank and IMF credentials, a reputed specialist on Global Prosperity issues and a Professor at Edmund Walsh-School of Foreign Services, Georgetown University

in his theme address discussed the evolution of income disparity and how some high income countries leveraged technology and their high income status to multiply their GDP. It is important to note that reduction in world poverty is not exclusively but greatly a Chinese phenomenon. Elaborating further on the topic, he mentioned that the combined GDP of Switzerland and Netherlands is equal to the GDP of Sub-Saharan Africa, while their combined population is 2.6% of Sub-Saharan Africa. It should also be noted that while world poverty has reduced but poverty in Africa has actually increased.

He also shared an observation by one of his IMF colleagues that currently the low income countries are growing at twice the rate of high income countries and if this continues for a long period, then the low income countries will eventually catch up. Based on this observation, there was also an experiment proposed called "The dirty little secret of development economics".

Dr. Claros was of the view that to control the rising disparity, we need to adopt a mix of traditional and non-traditional solutions. Under traditional solutions, he mentioned progressive taxation and availability of social security net to control inequality because if the labour market laws are rigid, the labourers will move towards formalization which will lead to higher inequality. One of the non-traditional policies is removal of the energy subsidy provided by the government. In 2015, IMF conducted a study which showed that 5

trillion dollars of subsidy was provided by the government to the energy sector, out of which, 60% of the subsidy goes to the top quartile. According to him, subsidising the energy sector incentivizes its overuse and if this subsidy is discontinued, there will be a 20% reduction in global warming. Other non-traditional solutions can be tackling the issue of gender inequality and introducing a universal level of basic income.

He concluded by stating that factors like difference in the level of education, skill sets of people and economic policies contribute to increasing income inequality.

Dr. Surjit Bhalla, a renowned Indian Economist, in his concluding reflections, raised a question over India not being given credit for its contribution in bringing down the level of global poverty. He also agreed with Dr. Claros's suggestion that achieving gender equality is the way forward for reducing income disparity. Dr. Bhalla cautioned not to trust the data available blindly. He stated that we need to question the origin of the data because there have been instances where two different authors used same data but arrived at different results. He supported his statement by highlighting an example of the different Gini Coefficients derived by Thomas Piketty, Abhijit Banerjee and Lucas Chancel for the same period with same data.

Interactive Session on Equality for Women - A Pre-Requisite for Global Prosperity

PHD Ambassadors' Economic Forum organized an interactive session on 'Equality for Women – A Pre-Requisite for Global Prosperity' on November 16, 2018 at PHD House, New Delhi. Amb K V Rajan, Convenor, PHD Ambassador's Economic Forum introduced the subject and highlighted that gender equality is the greatest antidote to poverty.

Mr. D. K. Aggarwal, Senior Vice President, PHD Chamber mentioned that according to the United Nations Gender Inequality Index 2017, India ranks at 127 out of 160 countries, faring better than some of its SAARC counterparts. He believes that for India to be a global leader, more concentrated efforts are required at local and national level to bring women at parity with men. He also mentioned that while increasing representation of women in public spheres is important, an attitudinal shift is equally essential for women to be considered as equal within their homes and in society. Educating children from an early age about the importance of gender equality could be a meaningful start in the direction.

Dr. Augusto Lopez Claros, a distinguished Economist, a professional with strong World Bank and IMF credentials, a reputed specialist on global prosperity issues, and a Professor at Edmund Walsh-School of Foreign Services, Georgetown University, in his theme address, mentioned that there is an urgent need to introduce laws aiming at integrating women in the labour force. He also talked about a survey of 6,500 companies, which

were then split into groups on the basis of number of women on the corporate board and it was noted that the companies with more women on board are less prone to corporate governance scandals and frauds which ultimately undermines investment climate and growth.

He also mentioned that some countries use laws to discriminate against women and shared an alarming fact that till 1970, women in Indonesia were so restricted that they had to take permission from their husbands to open a bank account. Also in a few countries, the law gives control of household assets only to men.

Dr. Claros concluded that gender equality does not involve loss for men, it only means that we are moving into a world in which the gender doesn't determine

whether the person should achieve their full human capability.

Mr. Anil Khaitan, Immediate Former President, PHD Chamber in his address raised concern on how to bring to mainstream 375 million women in India who are under the age of 30 and willing to work but are bound by family culture and stringent laws.

Ms. Priya Hingorani, Chairperson, Arbitration & Dispute Resolution Cell, PHD Chamber suggested that to bring about gender equality, there is a need to spread awareness at the grass roots level.

Amb K V Rajan, Convenor, PHD Ambassador's Economic Forum, concluded the session with a formal vote-of-thanks to the guests.

National Smart Grid Conclave

Gupta, IAS, Additional Secretary (Energy), Niti Aayog mentioned that India's total power requirement by 2030 shall become three times better as per the present requirement and the government has almost universalized the access to electricity to everyone and by March next year, everyone would have access to electricity in the country.

Guest of Honour, Dr. A. K. Tripathi, Director General, National Institute of Solar Energy (NISE) mentioned that Smart Grids would interface with renewable energy in a big way and it should be taken into account that when we design and operationalize

these Smart Grids in the future, it could be a boon for the producers and consumers of electricity as it reduces distribution of losses.

Mr. Pankaj Batra, Former Chairman, Central Electricity Authority (CEA) stated that the Government has set an ambitious target of installing Smart meters to the consumers consuming 200 and above units of electricity by 2019.

Mr. Rajeev Mathur, Chairman, Energy Committee, PHD Chamber highlighted the policy initiatives of the Government of India such as electric grid modernization, introduction of Electric Vehicles, green corridors for high voltage transmission interconnection and introduction of Smart Meters. This has caught the attention of global investors and technology companies and India is fast emerging as a preferred destination for investments.

Dr. Ranjeet Mehta, Principal Director, PHD Chamber proposed a formal vote-of-thanks and on behalf of the Chamber requested the government to devise "Smart Micro Grid Policy" and "Separate Tariff Policy" for consumers getting electricity through smart grids particularly in solar and wind segment.

India inks MoU with Iran to pay crude oil in rupees

Media reports that India has signed an agreement with Iran to pay for crude oil it imports from the Persian Gulf nation in rupees. The MoU was signed following the US letting India and seven other nations to keep buying Iranian oil despite imposition of sanctions on Iran. Sources said Indian refiners will make rupee payments in a UCO Bank account of the National Iranian Oil Co. Half of these funds would be earmarked for settling payments for exports of Indian goods to Iran. Under US sanctions, India can export foodgrains, medicines and medical devices to Iran. India had won the exemption after it agreed to cut imports and escrow payments. Under the 180-day exemption, India is allowed to import a maximum of 300,000 barrels a day of crude oil. This compares to an average daily import of about 560,000 barrels this year. India, which is the second biggest purchaser of Iranian oil after China, has since then restricted its monthly purchase to 1.25 million tons or 15 million tons in a year (300,000 barrels per day), down from 22.6 million tons (452,000 barrels per day) bought in 2017-18 financial year.

India to retain top position in remittances

According to World Bank's Migration and Development Brief, India is expected to receive a total remittance of \$80 billion in 2018. India retains its top spot, followed by China (\$67 billion), Mexico and the Philippines (\$34 billion each), and Egypt (\$26 billion). As global growth is projected to moderate, future remittances to low and middle-income countries are expected to grow moderately by 4 percent to reach \$549 billion in 2019. Global remittances are expected to grow 3.7 percent to \$715 billion in 2019. The future growth of remittances is vulnerable to lower oil prices, restrictive migration policies and overall moderation of economic growth. Remittances have a direct impact on alleviating poverty for many households.

The rulebook for behavior towards women colleagues is the same as earlier. It's the men who need to toe the line and be more sensitive. Elaborating on the Policy for Prevention of Sexual Harassment Act and Sexual Harassment Electronic Box launched by the Ministry of Women and Child Development (WCD) recently after the #MeToo campaign said, "There is no tool for development more effective than the empowerment of women. An inclusive

work environment that is respectful to both men and women will become one of the most important yardsticks for measuring a successful workplace."

Besides, every organization as a preventive approach should conduct monthly meetings with the employees. Rajasthan as a state is still not very compliant with the POSH Act and has only 1450 Internal Committees. "Under penalties for non-compliance with the POSH Act, an employer should be penalized if he fails to constitute an Internal Committee or fails to take action under Section 13 (inquiry report by the IC) and Section 14," she said.

Cabinet approves revised Model MoU between India and foreign Financial Intelligence Units (FIUs) for exchange of information

The Union Cabinet has given its approval to the revised Model Memorandum of Understanding between the Financial Intelligence Unit (FIU) – India (FIU-IND) with its counterpart foreign Financial Intelligence Units (FIUs) for exchange of information on money laundering. The core functions of FIU-IND in relation to foreign FIUs include screening and processing requests from foreign Financial Intelligence Units (FIUs), disseminating information to foreign FIUs, establishing and maintaining relationship with foreign FIUs, and facilitating, administering and negotiating MoUs with foreign FIUs. Most of the foreign FIUs require an MoU to be signed for sharing of information with them.

India: Though steady, still fastest growing economy

Fluctuations in economic indicators are natural in a globally well integrated economy. Tough, Q2 GDP growth has slowed down to 7.1% as compared to 8.2% in the Q1 of FY 2018-19; India is still the fastest moving emerging economy. The fact is that escalation in crude oil prices in July-September period along with sharp depreciation in Rupee impacted the growth of manufacturing from 13.4% in Q1 FY 2018-19 to 7.4% in Q2 FY 2018-19 which has impacted the overall GDP by 0.9 percentage points. The uneven distribution of monsoon, unwanted and untimely rains in some regions not only undermined the agriculture growth

scenario but also impacted the mining growth drastically. Going ahead, state of the art infrastructure, flexible labour laws, reforms for availability of land, supply of power, and reach to formal finance along with speedy administrative reforms would push growth back on high road.

The fastest growing emerging economy

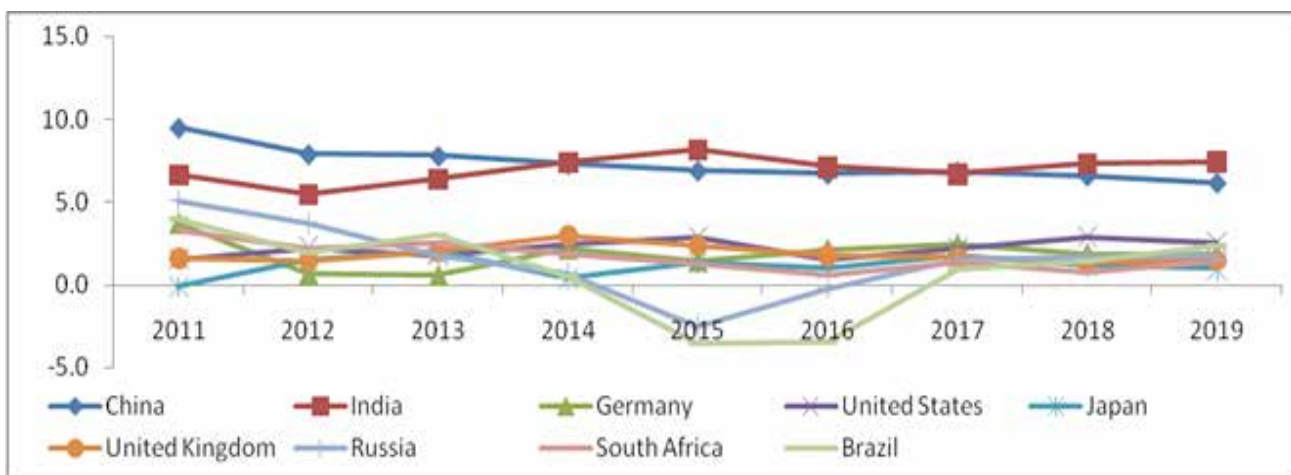
India is a bright spot in the global eco system. According to IMF, China and India stood out as the fastest growing economies throughout 2011-17. China recorded the highest growth over the years 2011-2013; however, India remained the fastest growing economy over the years

2014-2016. In 2017, China recorded GDP growth rate of 6.9% and India's growth rate stood at 6.7%. However, according to World Economic Outlook 2018, India would be the fastest growing economy, with the growth rates of 7.3% and 7.4% in 2018 and 2019, respectively, thus surpassing China. Other economies, such as United States, Germany, Japan and United Kingdom recorded growth rate of 2.2%, 2.5%, 1.7% and 1.7%, respectively in 2017. Brazil recorded the minimum growth rate of 1% in 2017, following a negative growth rate of 3.5% for two consecutive years in 2015 and 2016.

Crude impact on economy in Q2 FY 19

GDP stands at 7.1% in Q2 FY2019 as compared to 8.2% in Q1 FY2019 and 6.3% in Q2 FY2018. The agriculture sector growth stands at 3.8% in Q2 FY2019 from 5.3% in Q1 FY2019. Manufacturing sector

registered a growth of 7.4% in Q2 FY2019 as compared to 13.5% in Q1 FY2019. Construction registered a growth of 7.8% in Q2 FY2019 as compared to 8.7% in Q1 FY2019. Growth of Trade, Hotel, Transport; Communication registered a growth of 6.8% in Q2 FY2019 versus 6.7%

in Q1 FY2019. Financial, Real Estate & Professional Services registered a growth of 6.3% in Q2 FY2019 as compared to 6.5% in Q1 FY2019. Public Administration, Defence & Other Services registered a growth of 10.9% in Q2 FY2019 from 9.9% in Q1 FY2019.

Growth looks promising in the coming quarters

GDP growth rate is expected to pick up in the coming quarters. Growth of GDP is 7.1% in Q2 FY2019 as compared to 8.2% in Q1 FY2019. Manufacturing sector registered a growth of 7.4% in Q2 FY2019 as compared to 13.5% in Q1 FY2019. However, growth in manufacturing is expected to recover as exports are showing good recovery in recent months. Reforms in the agriculture sector would be critical to strengthen the growth of the sector and create employment opportunities in the food processing sector. With improvement in India's ranking on Ease of Doing

Business and announcement of major reforms for the MSMEs, we expect growth of the manufacturing sector to improve in subsequent quarters. Growth of private final consumption expenditure at 7% at constant prices is an indication of revival in demand and so will be the industrial activity in the coming times. Overall higher growth of GDP in 2018-19 at around 7.5% is expected as compared to 6.7% in 2017-18.

Ease of doing business to attract more foreign investments

Sharp jump in ease of doing business rankings to the level of 77 from 100 is highly inspiring and more than the expectations.

The reform measures undertaken by the government have started paying off and fruitful outcomes are visible now. India has improved by 65 spots during the last 4 years from 142nd rank in 2014 to 77th rank in 2018. India is one of the economies to make to the list of top 10 improvers for the second consecutive year. The improvement in ease of doing business would attract investments in the economy. Foreign investments are expected to increase significantly in the coming times. India has potential to become a US\$100 billion investment destination in the next very few years. India attracted US\$62 billion in FY2018 which is highest ever FDI received in a year.

The improvement in World Bank's Ease of Doing Business rankings has been observed primarily due to significant improvement in dealing with construction permits with improvement of 129 spots from 181th rank in 2017 to 52nd rank in 2018 and Trading across borders with improvement by 66 spots from 146th rank in 2017 to 80th rank in 2018. The implementation of GST and Insolvency and Bankruptcy Code along with improvements in registering for new electricity connection, up gradation of port infrastructure, among others have yielded positive results and facilitated the country to improve in various parameters. Given the ongoing reform momentum, India is expected to rank at around 50 on the Ease of Doing Business Index in the next few years.

Outreach Initiative for MSMEs sector to increase their significance in growth

The Hon'ble Prime Minister, Shri Narendra Modi, recently launched a historic support and outreach programme for the Micro, Small and Medium Enterprises (MSMEs) sector. As part of this programme, the Prime Minister unveiled 12 key initiatives which will help the growth, expansion and facilitation of MSMEs across the country. The 12 decisions will mark a new chapter for the MSME sector. There are five key aspects for facilitating the MSME sector including access to credit, access to market, and technology up-gradation, ease of doing business, and a sense of security for employees.

The host of measures for revival of MSMEs is a big milestone as they will transform the entire micro, small and medium enterprises and push them substantially upward to enhancing their contribution far more to national GDP and employment generation. The Rs.6,000 crore package announced for MSMEs through various technological upgradation channels will ultimately encourage and inspire the micro, small and medium enterprises to make products and invent processes that will ensure their global participation and upscale their demand

trajectory domestically. The launch of TReDS and compulsory on-boarding of CPSEs on GeM portal; simplification of filing of returns under prevailing labour laws; special relaxation in environment clearances for MSMEs; special provisions for the pharma sector are highly appreciable and will go a long way in facilitating MSMEs to contribute to India's growth story.

Trade liberalisation increased in protectionism environment

One of the recent developments in the area of trade protectionism is the ongoing trade war between world's two most significant economies i.e. USA and China. The opening shot was released by the U.S. early this year wherein it announced the imposition of tariffs on steel and aluminum imports from a large number of its trading partners and so on. An immediate result to this announcement saw China come out with retaliatory measures. China and the U.S. dominate world foreign trade, together accounting for 23% of world trade standing at USD 35 trillion in 2017. On the other hand, India's share in world trade stands at 2.1% only in 2017. India's top exporting partner is the U.S. contributing around 16% in India's total exports in FY2018 and China has maintained the top position in terms of sources of imports of India,

contributing 16.4% share in India's total imports during the same period. The rising trade protectionism between US and China will force the countries to redesign their supply chains, diversify their production locations and look for alternatives outside for imports and investments.

Notwithstanding developments in World's two largest economies, India's trade liberalization process is intact. Though, international economic environment was volatile during the post Lehman period, India's trade liberalization remained intact. Indian economy is resilient enough to withstand the external shocks on the back of strong macroeconomic fundamentals and well supported dynamic policy environment.

In the post-Lehman period, there is a significant increase in our merchandise trade to GDP ratio. Merchandise trade to GDP ratio has increased during the post-Lehman period (2008 to 2017) to 36% from 25% in 2001 to 2007 period. The merchandise exports to GDP ratio has increased to 14% during the post-Lehman period (2008 to 2017) from 11% in 2001 to 2007 period. The merchandise imports to GDP ratio has increased to 22% during the post-lehman period (2008 to 2017) from 14% in 2001 to 2007 period.

Going ahead, there is a need to focus more on logistics infrastructure to make our exports more competitive in the international market. Focus on logistics at the states level would go a long way to increase the states' competitiveness and employment opportunities for growing young population in the respective states. Considering the recent momentum in exports and global demand conditions,

we have potential to increase our exports growth trajectory at a much higher level.

Conclusions

Slow and steady wins the race! India has dual advantage, steady and fastest. I believe, time is most opportune to win the race. The need of the hour is to create employment opportunities for the growing young population. Economic fundamentals are moving in the right direction; the sharp

jump in ease of doing business should be materialised at the ground level with more and more participation by the MSMEs. As innovation leads to higher growth and productivity, focused approach to insert innovations in the promising sectors would increase the global competitiveness and increase the manufacturing share in GDP and new employment opportunities.

FAO playing a pivotal role in India

On 16 October, 1945, 42 countries came together in Quebec, Canada to give birth to the Food and Agricultural Organization (FAO) of the United Nations. Achieving food security for all is at the heart of FAO's efforts – to make sure people have regular access to enough high-quality food to lead active, healthy lives. FAO's mandate is to raise levels of nutrition, improve agricultural productivity, better the lives of rural population and making sure that food security is not only achieved successfully, but that people have regular access to enough good quality food and thus contributing to the growth of the world economy.

India has come a long way since 1945 when it became one of the founding members of FAO as a low-income food-deficient country. The Food and Agricultural Organization of the United Nations (FAO) has enjoyed valuable partnership with India since it began operations in 1948, helping change the dynamics of Indian agricultural systems, making it a country that is not only self-sufficient in several grains, but now a leading exporter of a range of food products.

FAO continues playing a catalytic role in India's progress in the areas of crops, livestock, fisheries, food security, and management of natural resources. Operations in India also cover issues

like access to food and nutrition, livelihoods, rural development and sustainable agriculture, livelihoods, rural development and sustainable agriculture. With the looming impact of climate change and outbreaks of new strains of pests, the work of FAO has become even more complex, making it an important knowledge partner to assist the country with informed decision-making, and going beyond the realm of food production, concentrating on providing technical assistance for incorporating best practices to generate agricultural outlook and facilitating adoption and promotion of improved livestock management practices. At the same time, India also adds great value to FAO's work, providing technical expertise and contributing with development lessons learned from programmes implemented over the years.

Agriculture is the mainstay of India's economy, contributing to 18 percent of India's GDP and providing a source of employment to more than 47 percent of the population of which more than 70 percent are in the rural areas of India. A number of sectoral reforms have been fast tracked to increase the sector's productivity, increase the content of food processing and shift workforce from agriculture to manufacturing. The government's emphasis on developing new technologies, integrated farming systems, agriculture extension programs, research and international cooperation has helped the sector to

take-off. These policy initiatives in the last three years have led to record food grain production this year. The Indian government's main aim is to double farmers' income by 2022 by solving the twin problems of maximizing efficiency and ensuring equity in a sustainable manner.

World Food Day and Commitment to Sustainable Development

FAO celebrates World Food Day each year on 16 October to remind and reiterate its mission of:

- Encourage attention to agricultural food production and stimulate national, bilateral, multilateral and non-governmental efforts to this end;
- Encourage economic and technical cooperation among developing countries;
- Encourage participation of rural people, particularly women and the least privileged categories, in decisions and activities influencing their living conditions;
- Heighten public awareness of the problem of hunger in the world and strengthen international and national solidarity in the struggle against hunger, malnutrition and poverty;
- Promote the transfer of technologies to the developing world;



In September, 2015, all United Nations Member States approved the 2030 Agenda for Sustainable Development. The eradication of hunger and all forms of malnutrition (Sustainable Development Goal number 2) was defined as a cardinal objective of the Agenda, a sine qua non condition for a safer, fairer and more peaceful world.

The theme for the year 2018 **“Our actions are for future-A zero hunger world by 2030 is possible”** is in accordance with commitment to Sustainable Development Goal, to achieve Zero Hunger by 2030. This year during the official celebration of World Food Day in Rome, the headquarters of FAO was graced by two special guests, Queen Letizia of Spain and King Letsie the Third of Lesotho. FAO declared its promise to continue and win the battle against hunger.

There was unanimous agreement that ‘Hunger is certainly the worst manifestation of malnutrition that a human being can face’. However, Sustainable Development Goal number 2 is not limited to the battle against hunger. The focus is on ‘Zero Hunger concept’ aimed at not just feeding but nourishing people. The aim would be to provide everyone with the necessary nutrients for a healthy life.

It is well accepted that Governments have the most fundamental role in achieving ‘Zero Hunger’ by ensuring that vulnerable people have sufficient income to buy the food they need, or the means to produce it for themselves – even in times of conflict. Zero hunger could save the lives of 301 million a year, and help build a safer, more prosperous world for everyone. FAO Director-General José Graziano da Silva was quoted to have said, “The more we concentrate on fresh local foods for our diets, the more we will build a generation free from obesity and overweight,” underscoring that while hunger still needs to be eradicated, other forms of malnutrition linked to inadequate diets also need to be addressed.

Tackling hunger and malnutrition requires investing in local agricultural production to bring greater diversity to people’s diets. Tackling with challenges such as micronutrient deficiencies on one hand and obesity on the other would require multiple stakeholders coming together while implementing different

perspectives and actions. This would also include the adoption of legislation to improve the labelling of products, and also the ban of harmful ingredients from our food; the introduction of nutrition in the primary school curriculum and other similar policies.

World Food Day in New Delhi, India

In India, the three United Nations organizations, the Food and Agriculture Organization, International Fund for Agricultural Development and the World Food Program along with other strategic partners came together to mark World Food Day 2018 at the UN House in New Delhi. Through this event, the agencies aimed to increase awareness on Sustainable Development Goal 2-meeting the challenge of zero hunger in the world by 2030. Considering that in India more than 38 percent of children under five are stunted, 21 percent wasted and 58.4 percent children aged 6-59 months are anemic, the theme of the event was ‘Sustainable Solutions to Food and Nutrition Security’ for achieving Agenda 2030 in India. Hunger is a problem of rightful distribution, of both quantity and quality. Nutritious food



in the right quality has to reach out to everyone.

The event highlighted the progress made by India in terms of prioritizing agriculture and steps taken to ensure food and nutrition security of everyone, and also highlighted the issue of malnutrition and the role of agriculture in fighting malnutrition and climate change. Zero Hunger is at the heart of FAO’s mandate and FAO in India is taking steps to promote sustainable agro-ecological practices in agriculture.

Launch of Green Agri Project in India

The Government aims to transform

India’s agricultural sector to contribute to the achievements of global environmental objectives, and has launched a new project in association with FAO, India office known as ‘Green-agriculture: transforming Indian agriculture for global environmental benefits and the conservation of critical biodiversity and forest landscapes’. A US\$ 33.5 million grant has been provided from Global Environment Facility (GEF).

The Ministry of Agriculture and Family Welfare (MoAFW) and the Ministry of Environment, Forest and Climate Change (MoEFCC), proposes to address the challenges in collaboration with GEF-FAO and other key players within the next seven years (2018-2025). The project will address policy and practice of agriculture in India by strengthening agro-ecological practices, including support of food production and food security and nutrition. The objective is to bring about transformative change in the farm sector through conservation of biodiversity and forest landscapes. The project is being implemented in five landscapes in the states of Madhya Pradesh, Mizoram, Odisha, Rajasthan and Uttarakhand.

The project aims to achieve critical results- a national and five state level platforms institutionalized to mainstream environmental concerns into agriculture sector, 49 MT carbon sequestered GHG reduction, 104,070 hectares under sustainable management practices and eco-restoration of 1.8 million hectares of priority biodiversity landscape and replicable models and piloting new sustainable business models. Any effort to increase farmers income and food production should happen within the framework of sustainable management of natural resources to avoid further depletion of water tables, biodiversity and habitat for wild species, and land and soil degradation which have contributed to the environmental crisis India is facing today.

Gol requests FAO to declare the upcoming year as “International Year of Millets”.

Continuing its efforts to get ‘millets’ a global recognition among consumers, India has requested FAO, proposing declaration of the upcoming year as “International Year of Millets”. Recognizing millets’ anti-diabetic properties, a notification called it a



“powerhouse of nutrients” and identified several varieties of millets for promotion. The millets in the category of “Nutri-Cereals” include Sorghum (Jowar), Pearl Millet (Bajra), Finger Millet (Ragi) Foxtail Millet (Kangani/Kakun) and Buckwheat (Kuttu) among others.

Sikkim wins FAO's Future Policy Gold Award

This year, Sikkim won FAO's Future Policy Gold Award for its achievement in becoming the world's first totally organic agriculture state. Sikkim is the first organic state in the world. All of its farmland is certified organic. The state has totally banned the sale and use of chemical pesticides. Sikkim sets an excellent example of how other Indian states and countries worldwide can successfully upscale agroecology. Nicknamed the “Oscar for best policies”, the award was co-organized with the FAO by The World Future Council and IFOA - Organics International that recognizes “the world's best laws and policies promoting agroecology. The transition has benefited more than 66,000 farming families.

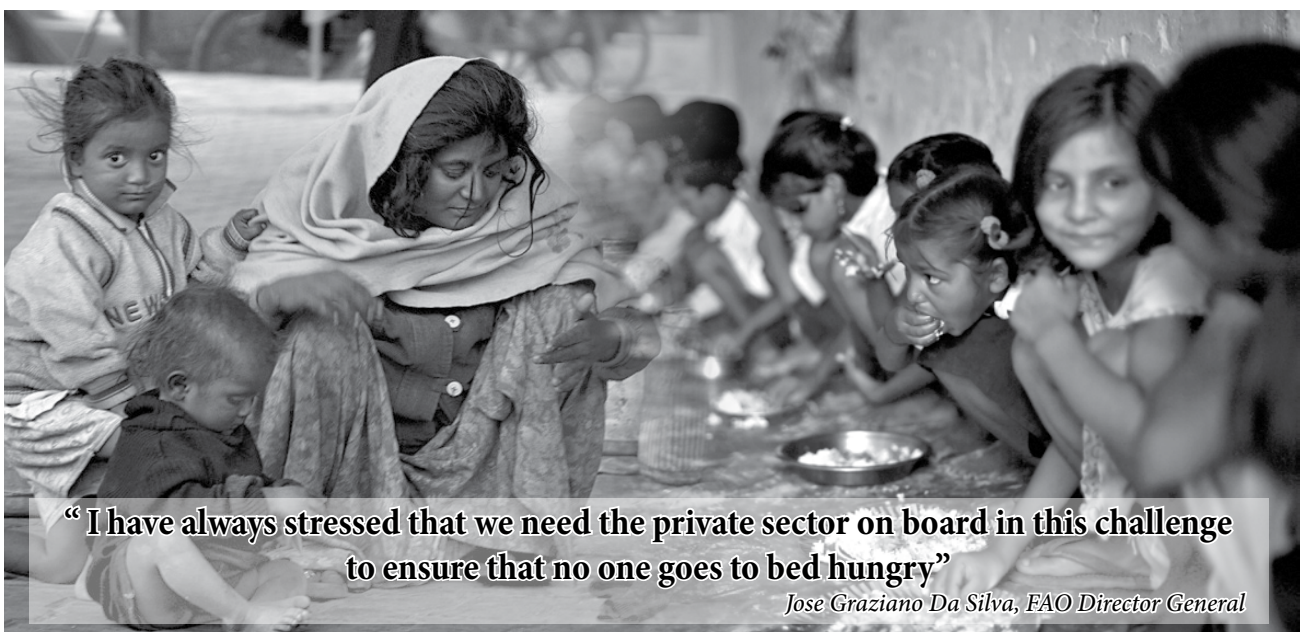

- CERF funding for Kerala: FAO along with UNDP is providing time-critical saving of livestock emergency employment, agriculture, and livelihoods recovery for communities affected by floods in Kerala. The two rounds of flooding from June to August 2018 coupled with sudden release of huge volume of waters from the dams in the state has directly impacted 323,833 farmers, resulted in 59,321 hectares of cropped area being affected and amounting to a loss of US\$ 202 million.

For FAO, this CERF project funds will be used for life saving and time critical activities like technical assistance for safe disposal of, carcass, disinfecting cattle and poultry sheds, enhanced surveillance of potential zoonotic and

other diseases “outbreaks, field testing kits for livestock disease surveillance with capacity to respond when necessary, provision of vitamin/mineral supplements, and capacity building on using innovative livestock and poultry shed design (to ensure that rebuilding of damaged livestock and poultry sheds is future hazard-proof keeping in mind the returning monsoon” due from November to January) as well as technical assistance in clearance of flood-debris and sludge from agricultural lands, undertaking land repairs, distribution of vegetable seeds coupled with training on use of distributed seeds in a disaster-climate smart agricultural practices manner.

These activities will not only minimize adverse coping actions by smallholders but also will enable them to make use of the next agricultural season and saving their livestock due to the enhanced surveillance mechanism. This CERF project will target 30,000 marginal and smallholder livestock and poultry keepers, landless households and farmers including women farmers and members of the primary milk cooperative societies at the community level. This proposal for immediate livelihoods recovery has a clear complementarity with the transitional shelter. Sizeable resources have been allocated for the development of Communication products for the Government of Kerala. The effort of the project will be to ensure that the interventions contribute to the longer-term Reconstruction plans of the Government of Kerala.

Policy Pronouncements and Developments

World Bank Group announces US\$ 200 billion for Climate Action

The World Bank Group announced a major new set of climate targets for 2021-2025, doubling its current 5 year investments to around US\$ 200 billion in support for countries to take ambitious climate action. The new plan significantly boosts support for adaptation and resilience, recognizing mounting climate change impacts on lives and livelihoods, especially in the world’s poorest countries. The US\$ 200 billion across the Group is made up of approximately US\$ 100 billion in direct finance from the World Bank, and approximately US\$ 100 billion of combined direct finance from the International Finance Corporation and the Multilateral Investment Guarantee Agency and private capital mobilized by the World Bank Group. A key priority is boosting

support for climate adaptation, recognizing that millions of people across the world are already facing the severe consequences of more extreme weather events. By ramping up direct adaptation finance to reach around US\$ 50 billion over FY 2021-25, the World Bank will, for the first time, give this equal emphasis alongside investments that reduce emissions.

GOI's Action against Fugitive Economic Offences and Asset Recovery

At the second session of the G-20 Summit on November 30, 2018, Prime Minister, Mr. Narendra Modi suggested the following nine point agenda to G-20 for action against fugitive economic offences and asset recovery:

- Strong and active cooperation across G-20 countries to deal comprehensively and efficiently with the menace fugitive economic offenders.
- Cooperation in the legal processes such as effective freezing of the proceeds of crime; early return of the offenders and efficient repatriation of the proceeds of crime should be enhanced and streamlined.
- Joint effort by G-20 countries to form a mechanism that denies entry and safe havens to all fugitive economic offenders.
- Principles of United Nations Convention against Corruption (UNCAC), UN Convention against Transnational Organized Crime (UNOTC), especially related to “International Cooperation” should be fully and effectively implemented.
- Financial Action Task Force (FATF) to establish international co-operation that leads to timely and comprehensive exchange of information between competent authorities and FIUs.
- FATF tasked to formulate a standard definition of fugitive economic offenders.
- FATF to develop standardized procedures related to identification, extradition and judicial proceedings for dealing with fugitive economic offenders to provide guidance and assistance to G-20 countries.

- Common platform to be set up for sharing experiences and best practices including successful cases of extradition, gaps in existing systems and legal assistance.
- G-20 Forum to consider initiating work on locating properties of economic offenders who have a tax debt in the country of their residence for its recovery.

Update on PMI

Growth in manufacturing activity in India hit an 11-month high in November as new orders and output rose at a slower pace, according to purchasing managers’ index (PMI). The PMI in November continued its northward climb for the third month, going up to 54 from 53.1 in October. A reading above 50 shows expansion in the sector. The boost in output came from a surge in new orders, that rose at the second-fastest rate in over two years. Companies suggested that marketing efforts bore fruit, while stronger demand too boosted sales. Intermediate goods makers also fronted the upturn. Growth of new export work quickened to the fastest in just under four years, as producers reportedly received bulk orders from clients in key export destinations. Consequently, manufacturers increased production, the rise led by intermediate goods firms, although robust growth was also seen in the consumer and capital goods categories. The expansion in total new orders was supported by greater sales to international markets. Growth of new export work quickened to the fastest in just under four years, as producers reportedly received bulk orders from clients in key export destinations. Meanwhile, manufacturers continued raising their pre-production inventories as firms stepped up input buying. Firms continued to raise staff levels, even as recruitment slowed in November. The increase in employment softened slightly since October, but was among the fastest seen in six years.

Update on Blue Economy

Blue Economy is very crucial for India’s economic development as quoted by Union Minister for Shipping, Road Transport & Highways, Water Resources, River Development and Ganga Rejuvenation, Mr. Nitin Gadkari. According to Minister, Gadkari, India has a strategic location in the Indian Ocean region, and on this basis, it



endorses the growth of the Blue Economy in a sustainable, inclusive and people centred manner through the framework of the Indian Ocean Rim Association (IORA). India is developing its maritime infrastructure as well as its inland waterways and coastal shipping through the launch of the ambitious "Sagarmala Programme" which will revolutionize maritime logistics and port led developments in the country. The Sagarmala programme has identified 600 plus projects entailing investment of around US\$ 120 billion by the year 2020. This will save the country nearly six billion dollars per annum in logistics costs besides creating 10 million new jobs and boosting port capacity by 800 Million Metric Ton (MMTPA) per Annum to an overall 3500 MMTPA. The Coastal Economic Zones (CEZs) are being developed under Sagarmala with a proposed investment of US\$ 150 million per location. CEZs will become a microcosm of the blue economy wherein industries and townships that depend on the sea and contribute to global trade through sea connectivity are envisaged.

NPCC is now a Miniratna

National Projects Construction Corporation Limited (NPCC) has been conferred with the status of Miniratna : Category -I by the Indian government. The empowerment of Miniratna Status to NPCC will help the company in taking speedy decisions by enhancing the delegation of powers to the Board. NPCC has also been awarded ISO 9001:2015 Certification. The Corporation, incorporated in 1957, is a premier construction company having mandate with creation of infrastructure to provide impetus for economic development of the country. The Corporation is making continuous profit since 2009-10, having positive networth for the last six years and has ambitious business plan with enhanced order book position of Rs. 11833 crores.

First containerised cargo on an inland waterway received at Varanasi

Prime Minister Narendra Modi recently dedicated the multimodal terminal on River Ganga to the nation and received the first containerised cargo that had sailed from Haldia port, at Varanasi. The multimodal terminal on National Waterway-1 (NW-1) for transporting containerised cargo between Varanasi in Uttar Pradesh and Haldia port in West Bengal is expected to provide a significant push to export trade from eastern India, especially from Kolkata and its catchment areas. Haldia port would be able to strengthen its position as a viable transshipment port in the South East Asia region, due to burgeoning and potential trade transactions between India and Bangladesh through multimodal connectivity, where this port would play a pivotal role.

Prime Minister, Modi seeks tech ideas

to break into top 50 of doing business ranking

Hon'ble Prime Minister, Mr. Narendra Modi has launched a grand challenge to further improve India's position in the World Bank's ease of doing business ranking to the top 50 by using cutting-edge technology to reform government processes. At a meeting with top industry officials and policymakers to discuss the ease of doing business ranking, in which India jumped to 77th position this year, Hon'ble Prime Minister has sought input based on areas such as artificial intelligence, internet of things, big data analytics and blockchain to streamline and speed up processes to improve overall business environment in the country.

RBI to extend timeline for banks to meet capital norms 'credit negative': Moody's

Moody's Investors Service said RBI board's decision to extend the timeline for banks to implement Basel 3 guidelines is "credit negative" for public sector lenders. Also, the decision to restructure stressed micro, small and medium enterprises (MSME) loans of up to Rs 25 crores also has the potential for having negative implications for the credit profiles of Indian banks.

Government authorises PSU bank chiefs to block wilful defaulters' exit from India

The government has empowered heads of public sector banks to directly request the authorities for issuance of look-out circular against wilful defaulters and prevent them from fleeing from the country. The recommendations were a part of the committee headed by Financial Services Secretary, Rajiv Kumar.

SEBI unveils rules for reclassification of promoter as public investor

In a notification dated November 16, 2018 the Securities and Exchange Board of India (SEBI) has come out with new rules for re-classification of a promoter as a public investor, wherein an outgoing promoter will have to relinquish special rights as well as control over the affairs of the listed firm and not be allowed to hold over 10 per cent stake. Besides, the promoter would not be allowed to have any representation on the board of directors or act as a key managerial person in the listed entity. Furthermore, the promoter seeking re-classification must not be a wilful defaulter or a fugitive economic offender.

Protocol amending India-China DTAA

The India government and the People's Republic of China government have

amended the Double Taxation Avoidance Agreement (DTAA) for the avoidance of double taxation and for the prevention of fiscal evasion with respect to taxes on income, by signing a Protocol on November 26, 2018. The Protocol updates the existing provisions for exchange of information to the latest international standards. Further, the Protocol incorporates changes required to implement treaty related minimum standards under the Action reports of Base Erosion & Profit shifting (BEPS) Project, in which India had participated on an equal footing.

GOI and ADB sign US\$85 Million Loan to Support Odisha Skill Development Project

The GOI and Asian Development Bank (ADB) signed a US\$ 85 million loan on December 3, 2018, to improve the skill development eco-system in Odisha and establish an advanced skill training center, the World Skill Center (WSC), in Bhubaneswar. The project will improve the quality of the State's TVET programs by making them relevant to industry and demand driven, and will impart advanced occupation-ready skills training aligned with international standards. It would also complement the efforts to target the employment needs of the emerging sectors in India and globally. The project will engage Institute of Technical Education Services (ITEES), Singapore, to support Odisha Skill Development Authority in setting-up and operationalizing WSC. The project will help over 150,000 people learn skills in priority sectors, including manufacturing, construction and services for formal employment. WSC will deliver eight training courses for 13,000 full-time students, provide training for 5,000 teachers, and train 1,000 assessors. It will improve the overall eco-system of skill development in Odisha by providing integrated services through an entrepreneurship incubation center, a career counseling and placement center, a curriculum design and development center, and education technology deployment center.

Quadracycles as Non Transport Vehicles

The Ministry of Road Transport and Highways has notified the insertion of the item 'Quadracycle' as a 'non transport' vehicle under the Motor Vehicles Act 1988. A Quadracycle is a vehicle of the size of a 3-wheeler but with 4 tyres and fully covered like a car. It has an engine like that of a 3-wheeler. This makes it a cheap and safe mode of transport for last mile connectivity. Quadracycles were only allowed for transport usage under the Act, but now has been made usable for non transport also.

She highlighted that such conclaves help both the government and industrial units to discuss the problems and issues with each other.

Mr. Vikram Sahgal, Chairman, Chandigarh Chapter of PHDCCI talked about the contribution and role of MSMEs in the growth of the country and also pointed out some of the problems which MSMEs are facing.

He further said that merely policy framing will not work; departments have to work with MSME units so that the policies of the Government reach to the grass root levels.

Mr. R.S. Sachdeva, Chairman, Punjab Chapter, PHD Chamber proposed the vote-of-thanks to the guests.

Mr. Kuldeep Gupta, Director, Shanker Timber Industries Pvt Ltd, Jammu and Co-Chairman, Jammu Region, PHDCCI; Dr. R S Sharma, Director Industries, Jammu; Mr. Mushtaq Ahmed Chaya, Founder & Chairman, Grand Mumtaz Group of Hotels and Resorts, Srinagar and Chairman, Kashmir Region, PHDCCI; Ms. Anju Bajaj, Proprietor, P 'n' A Industries, Delhi; Er. Bilal Bhat, Director Industries, Kashmir and Mr. Bilal Ahmed Kawoosa, CEO, Kashmir Silk Producers Co-operative Ltd, Srinagar

Mr. CM Krishna, Honorary Advisor, PHDCCI informed that Industry is entering into fourth revolution of Industrialization which is known as Industry 4.0 challenges. We are entering into an era, where machines will be communicating with themselves to perform production activities.

Mr. Mukul Bansal, Chairman, Banking and Financial Services Sub Committee, Punjab State Chapter, PHDCCI chaired the session with the remark "MSME is in Pain" and we have to make them happy. We cannot increase our geographical area, nor can we decrease our population. So we have to generate resources through manufacturing of goods and services.

Mr. Arvind Mehan, Director, NCI India Pvt. Ltd., Chandigarh stated that due to increase in the cost of production they have shifted from manufacturing to service oriented industry. Now they are getting their products being manufactured from other units and supplying them under their brand name to the market.

Mr. Ramesh Bhatia, Owner, Expo Impo Corporation, Chandigarh stated that industrial policies must be prepared with due discussions with industry.

Mr. Harjeet Singh Sandhu, Director, Industries, Chandigarh gave the perspective of the Department. He said that the industrial area of Chandigarh was designed for Industrial activities only and that also for MSME units. He said due to the infrastructural problems B to C industry is not possible. Still, the Department is working on different ways and means to provide help to the industrial units.

Mr. Lokesh Jain, Director, Munak Enterprises, Panchkula highlighted the

problem of electricity in the Panchkula District. He pointed out HSIIDC has developed a new industrial area at Barwala in Panchkula District, which doesn't have any service facilities. There is no bank in this newly developed Industrial Area.

Mr. Ashwani Gupta, Addl. Director Industries & Commerce, Govt. of Haryana stated that they are working towards the digitalization of Industrial clearances. Online single window clearance system is being started in the State.

Mr. Anupam Katiyar, Sr. Engineer, Dakshin Haryana Bijli Vitran Nigam Ltd. said that the department is working towards the improvement of the Electrical Infrastructure and in the future the quality of electricity will be improved.

Mr. Ramesh Garhiya, Sr. Scientist, Haryana Pollution Control Board mentioned that in the industrial areas CETP (Common Effluent Treatment Plants) is not available and it is the duty of the Industry to treat their effluents at their unit level, so that it should not come out of the factory untreated.

Mr. Rajeev Ghai, Managing Partner, Ghai Industrial Timbers, Kashipur & Mr. Raj Arora, Founder Chairman, Safeguard Industries Pvt Ltd., SIDCUL, Haridwar mentioned that up-gradation of Infrastructure sector is needed.

CA. Verendra Kalra, CA Verendra Kalra & Company, Dehradun informed that MSME loans never become NPAs and MSME units must be bringing into minimum net of compliances so that they can concentrate on running their units.

Mr. Bilal Ahmed Kawoosa, CEO, Kashmir Silk Producers Co-Operative Ltd, Srinagar laid emphasis on certain social

security schemes for Entrepreneurs.

Er. Bilal Bhat, Director Industries, Kashmir (J&K) & Dr. R.S. Sharma, Director Industries, Jammu both were of the view that Government policies must be implemented in a proper manner to benefit the industry.

Mr. Mushtaq Ahmed Chaya, Chairman, Kashmir Region, PHD Chamber said that Tourism is a major industry in J&K and the Government is promoting it in the right direction.

Mr. Kuldeep Gupta, Co-chairman, Jammu Region, PHD Chamber mentioned that in Jammu, the MSME manufacturing units are working and officers in the region are very cooperative with the MSME units.

Mr. Yogesh Sagar, President, Mohali Industries Association said that MSME department had supported them and they got their funds also released for the same in due time.

Mr. Surinder Rana, GM, State Bank of India and Mr. Saurabh Bajpai, AGM, Small Industrial Development, Bank of India informed that banks have surplus funds to finance MSMEs and a 59 Sec loan sanction policy has been announced by the Government for MSME units.

Mr. Bhupesh Garg, Joint Secretary, Derabassi Industries Association raised issues in getting loans from the financial institution and the policies framed by the government for MSME units are not being implemented at the ground level.

Ms. Anju Bajaj, Proprietor, P 'n' A Industries, Delhi chaired the technical sessions. She added that the Government is providing extra facilities and subsidies to women entrepreneurial units and we must take the advantage of the same.

Skill Development Training Centre in Sarai Kale Khan, Delhi

PHD Family Welfare Foundation in association with the PHD Skill Development Committee and Delhi Urban Shelter Improvement Board has been running a Skill Development Training Centre since October 10, 2018 at Sarai Kale Khan night shelter, Delhi. A total of 31 beneficiaries enrolled for both the courses. Apart from training, the PHDFWF has been organizing motivational talks and general awareness camps under the project. The project aims to give the beneficiaries an opportunity to come to the mainstream to make them self-reliant so that they can earn their livelihood.



PHDFWF- SETH MADANLALL PALRIWALA FOUNDATION MOBILE MEDICAL VAN

During the month, 16 free health check up camps were organized in the different rural areas of Haryana, Uttar Pradesh and slums of Delhi. Free diagnostic care, clinical services and medicines were provided to the patients. Around 1395 patients benefitted from these camps.



PHDFWF-WRG Skill Development Training Centre in Rangpuri Pahari, Vasant Kunj

PHDFWF has been running a Skill Development Training Centre in Rangpuri Pahari resettlement colony, Vasant Kunj, New Delhi. The centre is providing training in Computer Education, Tailoring & Embroidery, English speaking classes. In all, 65 trainees are availing training in all the three courses.



PHDFWF- Jaquar Foundation Mobile Medical Van (Gurugram, Haryana)

During the month, 16 free health check-up camps were organized in different villages of Haryana adopted by Jaquar Group. Free diagnostic care, clinical services and medicines were provided to the patients. Around 850 patients benefitted from these camps.



PHDFWF- Jaquar Foundation Mobile Medical Van (Bhiwadi, Rajasthan)

During the month, 20 free health check-up camps were organized in different villages of Haryana adopted by Jaquar Group. Free diagnostic care, clinical services and medicines were provided to the patients. Around 1270 patients benefitted from these camps.



PHDFWF-FENA Skill Development Training Centre

Presently, 110 girls and women are undergoing training in tailoring and beauty culture at Tekhand village, Okhla Phase-I. The centre is being supported by Fena Foundation. On completion of the respective courses, exams were also conducted and certificates were awarded to the trainees.



PHDFWF-ITE Foundation Trust-Skill Development Centre, Noida

Presently, 53 trainees are availing training in tailoring and beauty culture at the centre. The trainees are making different embroidery designs on fabrics and earning their livelihood. One awareness generation programme was also organized during the period under this project.



Hindustan Tin Works Skill Development Training Centre, LalKuan, Badarpur

PHDFWF has been running a Skill Development Training Centre in LalKuan, Badarpur with the financial support from Hindustan Tin Works Ltd. The centre was earlier there in Mangwaki village, Pataudi which has now been shifted to this new location. Training in computer education & beauty culture is being provided in the centre.

PHDFWF-DSACS Target Intervention Project on HIV/AIDS

6 ICTC, 95RPR, 4 review meetings, 8 demand generation meetings and 2 DIC meetings were also conducted. Around 350 patients attended the STI clinic services, 21 PT and 7STI patients were identified under this project during the month.

PHDFWF-Aruna Abhey Oswal Trust –Mobile Medical Van

PHDFWF is running a mobile medical van in association with the Holy Family Hospital donated by Aruna Abhey Oswal Trust. Free health check-up camps are being organized in Okhla resettlement colonies, Jamia Nagar & IKV centres on a regular basis.

PHD RURAL DEVELOPMENT FOUNDATION (PHDRDF)

PHD Chamber strongly believes in its social responsibility being an important part of business philosophy. The Chamber is extending its contributions to the community through Corporate Social Responsibility (CSR) initiatives by PHD Rural Development Foundation as its social arm. The initiatives are designed to ensure that every corporate donor embodies the principles of CSR as per Section VII of Company's Act 2013. The Foundation takes appropriate initiatives in the areas of Healthcare & Sanitation, Education, Skill Development, Women Empowerment and Water Conservation Harvesting and seeks to empower individuals and community at large by providing them with the support they need to affect changes in their own environment for social and economic development.

PHDRDF SCHOOL DEVELOPMENT

PHDRDF has been actively working towards improving quality and standard of school education and literacy by supporting the existing Government schools in different states.

A. PHDRDF- Hindustan Tin Work Ltd (HTWL)

HTWL has been working towards education as a part of their CSR activity. The Government School at Hassanpur, Sonipat has been adopted by the company and is being upgraded continuously. Efforts have been made to provide drinking water & sanitation facilities in this school along with provision of a library, science laboratory and play area for nursery students. The developments initiated in the previous phase had a very positive response and enrollment of the school increased by 25 percent through the development activities. The school infrastructure is now being upgraded by renovating the playground and assembly area, provision of a proper gate for security and other basic infrastructure support for students like providing benches, books, bags and notebooks at the beginning of the session.

B. PHDRDF- Charities Aid Foundation (CAF) India -HDFC ERGO

CAF India partnered with PHDRDF for their 'Gaon Mera' Project to re-construct the Government Primary School building at Raman Village of Kullu District, which is almost an 80 year old building. The school building has been completed and the school is ready for inauguration. The school has 6 class rooms (Nursery to 5th), a dining room, computer room, community hall, staff room, store room toilet and a kitchen. The rooms have wooden cladding on the walls inside to insulate the rooms from the extreme cold climate. BaLA (Building as a Learning Aid) work has also been done in the school to promote quality education and learning. PHDRDF has also provided the school with utility items like – a printer, scanner, kitchen utensils, water RO filter, school bags, water bottles, stationery, uniform, shoes, game equipments, etc for the students. The school has now been handed over to the headmaster as per the request of the donor.

C. PHDRDF- Junior Chamber International Japan (JCI) & Japan Water Forum (JWF)

PHDRDF with the support from Junior Chamber International Japan and Japan Water Forum is implementing 'Smile by Water Project'. As a part of the project, community drinking water facility has been established in two villages, one in Mewat village Jalalpur in Tauru Block and another in Pataudi block village, Ramnagar. Besides this, new toilet blocks have been constructed and existing toilet facilities have been refurbished in three Government schools of Sohna. Behaviour change sessions are being undertaken regularly with the school children through the fun-way learning method. For behavior change, walls in three schools have been painted with pictures illustrating good habits and save water. Drawing competitions, Eco Rally, animated audio visual presentations and educational games are also being conducted. The project has been duly completed and handed over to the school authorities and people of the community.

D. PHDRDF- TEVA API India Limited

PHDRDF and TEVA API India Ltd have initiated a partnership for a project on "Aadharsh Vidyalaya- Integrated Development of Government Schools in Gajraula, Uttar Pradesh and Malanpur, Bhind" in Madhya Pradesh. Two schools have been adopted by TEVA to transform into model schools with upgraded infrastructure facilities, quality education & training in soft skills including WASH. The work in the two schools is under progress.

E. PHDRDF- Peter Und Luise Hager Stiftung (Hager Foundation)

PHDRDF and Hager Foundation, Germany have come together for holistic development of government schools in 5 villages of Sikar District in Rajasthan, through quality education which includes WASH awareness, infrastructure and healthcare under the project on "WASH and Quality education in Government Schools in Sikar". During FY 2018-19, activities were initiated in government schools i.e. Govt. Senior Secondary School, Toda, Govt. High School, Bhojmaid & Govt. Upper Primary School, Kalakota, Govt. Besides this, RDF has also made provision of a regular English Teacher in these schools for the session 2018-19. The students appeared for the regular test for computers and English and have performed well. Upper Primary School, Badan Singh Ki Dhani and Govt. Upper Primary School, Saidala schools have been upgraded with facilities of well-equipped Computer Labs along with a Computer teacher.



PHDRDF HEALTHCARE INTERVENTION

PHDRDF has been actively conducting free health camps for the low-income population in various geographical locations across the country to increase access to healthcare. A team of a qualified Doctor, ANM, Lab Technician and project coordinator are present for each camp and are responsible for its success. Emphasis is given on generating awareness among the community on sanitation & hygiene, child & maternal health, waterborne diseases, communicable diseases and other geography-based medical problems.

A. PHDRDF- Sekisui-DLJM Pvt Ltd

SEKISUI DLJM Pvt. Ltd. collaborated with PHDRDF to undertake their CSR activities during this year. A project on "FREE MOBILE HEALTH CAMPS" in Greater Noida was initiated on October 12, 2018 with a flag off ceremony. The inauguration ceremony was organized in the premises of SEKISUI DLJM Pvt. Ltd. in the presence of Mr. Ryosuke Kusaka, CEO, SEKISUI DLJM, Mr. Shripal Jain, Director, SEKISUI DLJM, Mr. Atul Tyagi, Sr. Vice President, SEKISUI DLJM, Dr. Kadambari, Chief Executive, PHDRDF along with representatives from SEKISUI DLJM Pvt. Ltd. & PHDRDF. The Health Camps will be covering 4 villages i.e. Maycha, Chindabali, Fazyalpur & Shahpur in Greater Noida, UP. During the project, a total of 80 health camps will be organized and approx. 8,400 patients will benefit. The healthcare program will focus on

primary preventive, clinical and diagnostic medical care in which generic health and eye screening camps, women & child care camps and health awareness camps will be organized free medicines, free blood tests and distribution of free spectacles. During the period, a total of four Generic Health Camps and two Women & Child Care Camps were organized and a total of 621 patients benefitted. The patients were provided with free medical counselling, ECG, blood sugar and Haemoglobin test facilities.

B. PHDRDF- DIPTY LAL JUDGE MAL PRIVATE LTD.

Dipty Lal Judge Mal Private Ltd. collaborated with PHDRDF to undertake their CSR activities during this year. A project on "FREE MOBILE HEALTH CAMPS" in Noida has been initiated. The Health Camps will be covering 3 villages i.e. Kulesara, Salarpur and Suthiyana in Noida, UP. During the project, 80 health camps will be organized and approx. 8,400 patients will benefit. The healthcare program will focus on primary preventive, clinical and diagnostic medical care in which generic health camps, eye screening camps, women & child care camps and health awareness camps will be organized with free medicines, free Blood Tests and distribution of free spectacles. The patients were provided with free medical counselling, ECG, Blood Sugar and Haemoglobin test facility. During this period, a total of 04 Generic Health Camps and two Women & Child Care Camps were organized and a total of 615 patients benefitted.



C. PHDRDF- Dhampur Sugar Mills Ltd.

Project on "FREE MOBILE HEALTH SERVICES" is being implemented with support from Dhampur Sugar Mills Limited, Asmoli, Uttar Pradesh across 9 villages near Dhampur Sugar Mills Ltd. Asmoli. The objective of the project is to organize Health Camp, Eye Care Camp and Women & Child Care Camp in all selected 9 villages. During this period, a total of 12 Generic Health Camps, 1 Women & Child Care Camp & 1 Eye Care Camp were organized that benefitted 1525 patients. Patients were provided with free medical counselling, ECG, Blood Sugar and Haemoglobin test facilities. The Eye Care Camp benefitted 112 patients and 68 free spectacles were distributed.



D. PHDRDF-BSES Yamuna Power Ltd

BSES Yamuna Power Ltd. collaborated with PHDRDF and to implement a Mobile Health project in Central and East Delhi. The objective of the project is to provide basic health care services to the low-income residential cluster of East and Central Delhi. During the project, 144 health camps will be organized in 16 locations and approx. 17,280 patients will benefit. During this period, a total number of 14 health camps were organized and 1695 patients were provided with free medical counselling and medicines.

PHDRDF SKILL DEVELOPMENT

PPHDRDF has been undertaking skill development programs with various corporate organizations with an aim to enable the underprivileged youth to be economically independent. These programs include training in: stitching & tailoring, beauty culture, computer literacy including tally software, spoken English language, soft skills etc.

A. PHDRDF- Donaldson India Filter Systems Private Limited

With support of Donaldson Filters India Pvt Ltd and under PHD Rural Development Foundation, Donaldson Skill Development Center has been functioning for the past five years in village Mohammadpur Gurjar in Sohna block of Gurugram district. Training in two courses namely stitching & tailoring and beauty culture is being provided to the ladies and adolescent girls in Mohahammadpur Gurjar and other 6-7 nearby villages i.e. Sohna Dhani, Hariyahera, Raiseena, Samp ki Nangli etc. From January 2016 till June 2018, a total of 146

girls, 69 girls in beauty culture and 77 in stitching & tailoring have successfully passed out from this training Center.

Certificates were distributed to 146 girls on October 16, 2018 by Mr. Viraj Kadam, Managing Director, and Ms. Margaret (Director – HR for Asia Pacific, Donaldson), Mr. Sunil Gupta, Financial Controller, Ms. Sudha Gupta (Director HR) Mr. Manoj Pandey (Sr Manager – HR) and Dr Kadambari (Chief Executive), Ms. Anjana Kumar (Sr Manager), Mr. Sandeep Kumar (Project Manager) and Ms. Apurva Sharma (Asst Manager) from PHDRDF.



B. PHDRDF-TCI Foundation

PHDRDF and TCI Foundation have partnered for the project titled “Enterprise Development - Low Cost Sanitary Napkin Production Enterprise by Women Self Help Group” which aims to address the dual purpose of economic empowerment for women and provide low-cost sanitary napkins to rural women and adolescent girls in and around Jamhar Village, Khunti District of Jharkhand through development of manufacturing low-cost sanitary napkins. A three days training for manufacturing sanitary pads was conducted, in which a specialized trainer trained the women. Eight women are engaged for the project and are being enrolled in women SHG model. After training, women have started manufacturing these pads independently.



PHDRDF WATER MANAGEMENT

PHDRDF has been constantly working towards recharging of ground water table through construction of Rain water harvesting structures.

A. PHDRDF-Coca Cola Foundation

PHDRDF and Coca Cola Foundation, Atlanta have come together to promote sustainable solutions for water resource management with surface water conservation and ground water recharge through construction of six check dams in Indore, Dhar and Hoshangabad districts of Madhya Pradesh. Three check dams have been duly completed and filled with water during the monsoon season. The dams still contain water even after more than two months of receiving water. The villagers are very happy with the amount of water being contained in the dams and have been appreciative of Coca Cola Foundation for supporting the project. These check dams will hold 457,950 cu mts of water and will impact 7800 people.

B. PHDRDF – HEG Ltd

An Agreement has been duly signed with HEG Ltd to construct a check dam, namely Bainada Wala in Alwar at Rajasthan. The dam will impact 850 acres of land. The work for the dam was initiated in the month of November 2018. The check dam will benefit around 2835 people in one village including 350 households. Water holding capacity of check Dam will be 50,000 cubic meters.

C. PHDRDF- SS Kothari Mehta & Co.

SS Kothari Mehta & Co. has been a trusted partner of PHDRDF for more than a decade and has been continuously contributing towards water harvesting projects. A check dam, Dantodi Wala at Alwar has been sponsored to be constructed this month. The check dam will have a water holding capacity of 1,68,000 cubic meters and will benefit 4500 people.

D. PHDRDF – Hero Future Energies Ltd

PHDRDF and Clean Wind Power, Group company of Hero future Energies Ltd have come together to construct water harvesting structures in district Pratapgarh of Rajasthan. Two check dams are being constructed in Pratapgarh in the vicinity of their manufacturing unit. These check Dams will benefit around 6027 people in three villages. Construction of check dam ‘Dojda Wala’ is in full progress. Water holding capacity of the check Dam will be 46,800 cubic meters.

PHD Chamber hails sharp jump in EODB rankings

Sharp jump in ease of doing business rankings to the level of 77 from 100 is highly inspiring and more than the expectations, said Mr. Rajeev Talwar, President, PHD Chamber of Commerce and Industry in a press statement issued here on Thursday. The reform measures undertaken by the government have started paying off and fruitful outcomes are visible now, said Mr. Rajeev Talwar. India has improved by 65 spots during the last 4 years from 142nd rank in 2014 to 77th rank in 2018.

We appreciate the work undertaken by the government due to which India is one of the economies to make to the list of top 10 improvers for the second consecutive year, said Mr.

Talwar. The improvement in ease of doing business would attract investments in the economy. Foreign investments are expected to increase significantly in the coming times, said Mr. Rajeev Talwar.

India is going to become a US\$100 billion investment destination in the next very few years, said Mr. Talwar. India attracted US\$62 billion in FY2018. The improvement in World Bank's Ease of Doing Business rankings has been observed primarily due to significant improve-

ment in dealing with construction permits with improvement of 129 spots from 181th rank in 2017 to 52nd rank in 2018 and Trading across borders with improvement by 66 spots from 146th rank in 2017 to 80th rank in 2018, said Mr. Rajeev Talwar. The implementation of GST and Insolvency and Bankruptcy Code along with improvements in registering for new electricity connection, upgradation of port infrastructure, among others have yielded positive results and facilitated the country to improve in various parameters, he said. Going ahead, given the ongoing reform momentum, we expect India to rank at around 25 on the Ease of Doing Business Index in the next two years, said Mr. Rajeev Talwar.

Freight surcharge bolt from the blue for Punjab industry

High input cost sounds death-knell for SMEs of state

CHANDIGARH, NOVEMBER 16

The state government's move to impose surcharge on freight has come as a bolt from the blue for small and medium enterprises (SMEs) of landlocked Punjab, particularly Jalandhar, which is on the verge of extinction because of several cost disadvantages.

The industry, which faced the double whammy of demonetisation and ill-planned GST in 2016 and 2017, respectively, has lost its competitiveness because of high input costs and exorbitant freight rates. Jalandhar-based manufacturers said, Jalandhar, which is famous for sports good manufacturing, rubber-chappal industry, pipe fittings, nut-bolt, auto parts, hand tools, valves and cocks industries, is fast losing its sheen.

Cash-strapped Punjab has recently imposed a 10% surcharge on freight charges for transporting goods in the state. This is likely to add to the woes of the industry, they said.

Punjab is a landlocked state and heavily dependent on logistics service providers. Industrialists say their margins are squeezed because of high freight charges — first to



import raw materials from different states and then to transport finished goods to different markets.

"The state is far away from ports. The surcharge will increase the transportation cost. The manufacturing sector will lose their share not only in domestic but also in international markets," PHD Chamber chairman (Punjab) RS Sachdeva said.

The industry faces double freight burdens, which makes it uncompetitive, Jalandhar Chamber of Industries general secretary Chhagan Singh Maing said. Earlier, the transportation charges were not high, but now the prices have skyrocketed which is troubling the industries," IIS Chiketa of the All India Rubber Industry Association said.

Besides freight charges, the industry is facing other troubles for decades. It imports almost all raw materials. Even workforce comes from other states. These factors add to the input costs. Jalandhar imports raw rubber from Kerala. Pig iron and steel are imported from Bhadrachalam and Orissa to manufacture nut-bolt, motor parts, hand tools and gym equipment from

Bharuch. Orissa is imports gun metal from Europe for manufacturing valves and cocks and bath fittings. Major items for making sports goods are imported from China while furnace oil comes from Jamnagar. The industry is largely dependent on the migrant labourers from UP and Bihar.

Industrial sources said small and medium enterprises have been pulling on somehow, but growing burden of input costs and government levies has pushed the industry on the verge of extinction.

Govt actively pushing for air freight stations: Civil Aviation Ministry



NEW DELHI: The government is actively pushing for establishment of air freight stations as it looks at ways to reduce costs involved in air cargo operations, a senior official said Tuesday.

The Civil Aviation Ministry is expected to soon come out with an air cargo policy that would seek to address various problems faced by the industry players.

"We are actively pushing for establishment of offsite Air Freight Stations. This is against financial interests of the airport operators... but that is the way forward... We are committed to making air cargo affordable," Civil Aviation Secretary R N Choubey said here.

Air Freight Station (AFS) is an off-airport common user facility that offers service for handling and temporary storage of import and export cargo.

Noting that the air cargo policy would have answers to many problems faced by the industry, he said the ministry would try to transfer many functions related to air cargo operations offsite since space at airports is expensive.

Speaking at the event, Civil Aviation Minister Suresh Prabhu said air cargo has huge

potential in the country.

An integrated logistics policy is also being worked out and would be announced soon so that cargo moves in an efficient manner, he added.

While the country's domestic aviation market is one of the fastest growing in the world, air cargo operations have been relatively sluggish. Against this backdrop, the ministry is working on ways to bolster the air cargo sector.

AFS, the counter part of Inland Container Depot (ICD) for maritime cargo, would also help in de-congesting air cargo terminals at various airports.

They were speaking at an air cargo summit organised by the PHD Chamber of Commerce and Industry. A report by Auctus Advisors was released.

Total air cargo at all Indian airports during 2016-17 and 2017-18 witnessed a growth of 10.1 per cent and 12.7 per cent, respectively with 3.35 million metric tonnes cargo traffic in financial year 2018, as per the report.

International cargo contributes about 60 per cent of the country's total cargo industry with "double the growth rate as compared to domestic cargo business," it added. PTI

Issue bonds to generate funds, Puri tells corpns

New Delhi: Union housing and urban affairs minister Hardeep Puri advised the municipal corporations of Delhi, two of which are perennially short of money, to issue municipal bonds as a source of revenues. Speaking at an event on making Delhi smarter, organised by the PHD Chamber of Commerce and Industry, on Saturday, Puri said municipal bonds are suitable tools for raising funds.

At the 'Dilli: Kal, Aaj Aur Kal - Towards a sustainable and smarter Delhi' event, the minister announced the sanctioning of multiple projects, including decongestion and solid waste management, involving an estimated investment of Rs 2,586 crore. He also said, "The Centre is trying its best to approve the Phase IV of the Delhi Metro construction and persuading Delhi Government on this and hope that progress in this direction will be forthcoming."

Deputy CM Manish Sisodia stressed on the need to have in Delhi a single governing authority because converting the capital into a smarter city would not be possible unless there was coordination among the several regulatory agencies. He alleged that the problems facing the national capital were born of "dry politics done with malice", reiterating the Aam Aadmi Party government's longstanding complaint that the central government is always obstructing work in the city.

"This needs to be checked with the cooperation of public and private institutions so that the prevailing status quo is challenged and replaced

with a responsible and accountable system, even if it be the office of the lieutenant governor," Sisodia said, alluding to a three-year standoff with the LG that only calmed down a bit after the Supreme Court upheld the state's primacy in governance.

"Smart governance is the core solution for developing a smart city in which a single authority is put in place to take decisions without any political tilt will in providing better life and better living to its citizens," Sisodia declared. "Multiple agencies and several regulatory bodies in Delhi such as DDA, Delhi Police, LG's office, municipal corporations and host of other such bodies have been taking decisions for the people of Delhi on the town whims and fancies, resulting in chaos for the capital."

As industry minister Satyendra Jain pointed out that the national capital had no dearth of smart people, Sisodia said, "There is hardly any coordination among civic agencies for the welfare of Delhiites and each agency attempts to rule Delhi on its own. In such circumstances converting the present landscape of Delhi into a smarter city will not be possible. Smart governance will need the multiple authorities to cease to seek to govern Delhi and shed their political malice."

Other speakers also stressed on minimum governance as well as minimising the involvement of multiple agencies. PHDCCI vice-president D K Aggarwal urged the civic authorities to take a holistic approach to making Delhi smarter so that the Indian capital became an ideal place to live in and offered a better traffic system, cleaner air and better civic amenities.

More stubble burning this year compared to last year: EPCA chairperson

MORE CASES OF stubble burning in the neighbouring states were recorded this time as compared to last year despite a strict enforcement, Supreme Court-appointed EPCA chairperson Bhure Lal said on Friday as he stressed on the need to bring a change in the mentality of people so that they look at the alternatives to this practice.

Speaking at a workshop on Bulk Utilisation of Crop Residue for Economic and Environmental Sustainability organised by the PHD Chamber, he noted that paddy straw can be a very rich source of fertilisers and its best utilisation would be to merge it with soil.

Stubble burning in neighbouring Punjab and Haryana is one of the major causes for poor air quality in Delhi. The air quality in the national capital last Thursday went off the charts as smog caused due to bursting of firecrackers engulfed the city. The air quality index (AQI) was recorded at a high 642.

The Environment Pollution (Prevention and Control) Authority (EPCA) chairman pointed out that despite the fact that "enforcement was strict this time, more stubble burning was recorded this year as compared to last year."

Lal said it had been seen that the younger generation was ready to look for alternatives, but the older generation still wanted to stick with stubble burning. "It takes a period of

45 days for paddy straw to decompose completely and then be used as fertiliser, but farmers usually have just 25 days," he said. "If we succeed in reducing this period of 45 days to 25 days, our problems related to stubble burning will be solved," the EPCA chairman said. "Subsidies have been granted but still the practice of stubble burning is prevailing," he said, warning that this trend must change otherwise it would be "difficult to breathe".

Stubble burning in neighbouring states combined with other factors in Delhi such as vehicular emissions, industrial pollution and smoke from firecrackers around Diwali plague the national capital's air quality every year.

This year too, the pollution level spiked to "severe-plus emergency" level due to rampant burning of firecrackers leading to the formation of blanket of smoke across Delhi.

V N Kale, Additional Commissioner in the Agriculture Ministry, who was also present on the occasion, however, had said last year that out of 20 million tonne of paddy straws, about 17 million tonne was burnt, but this year it was around 13-15 million tonne.

In a letter to the Central Pollution Control Board (CPCB), Lal had on Wednesday recommended implementation of either the odd-even scheme or a complete ban on non-CNG private vehicles if the air pollution level in Delhi increased again.

IIP growth falters as inflation eases

Industrial production slows to 4.5%; slowing price growth in food, housing cools inflation to 3.31%

Growth in industrial activity as measured by the Index of Industrial Production slowed marginally in September to 4.5% due to slowing growth in the manufacturing and capital goods sectors, official data released on Monday showed.

A separate data release also showed that consumer inflation, as measured by the Consumer Price Index, eased in October to 3.31% due to slowing price growth in the food, housing, and footwear segments.

IIP growth slowed from 4.67% in August. (August's IIP growth was revised from the provisional 4.3% released earlier.) Growth in manufacturing eased to 4.62% in September from

previous month. The capital goods sector, however, saw growth slowing to 5.76% from 9.34%. Growth in infrastructure and construction sped to 9.5% in September from 7.95% in August.

Easing inflation

Consumer inflation eased in October from 3.7% in September. Inflation in the food and beverages segment contracted 0.14% in October compared with growth of 1.0% in September.

"The October CPI print surprised positively as it was much lower than our and the street expectations," B. Prasanna, group executive and head - Global Markets Group at ICICI Bank said in a note.

"It continued to be aided by the food component which shrunk on a sequential basis

underscored by components such as fruits, vegetables and pulses. The earlier fears of Minimum Support Price hikes feeding through to CPI have been allayed."

The clothing and footwear category saw inflation easing to 3.55% from 4.64% over the same period. Inflation in the housing segment slowed to 6.55% from 7.07%.

"Benign inflation and a strong footing in industrial development are expected to boost investor sentiment and increased FDI and FII inflows in the coming months," Rajeev Talwar, president, PHD Chamber of Commerce and Industry said. "Stability in inflation would strengthen the macroeconomic environment and pave the way for soft monetary policy regime, going forward."

भारत से चीन के अंगूर निर्यात में 200 प्रतिशत वृद्धि की आस

पिछले साल की तेज गिरावट के कारण भारत चीन के आयातकों की सीधी भागीदारी के जरिये चीन में अपना अंगूर निर्यात 200 प्रतिशत तक बढ़ाने की उम्मीद कर रहा है। 2017-18 में भारत से चीन का अंगूर आयात तकरीबन 50 प्रतिशत लुढ़कर 607 टन (12.9 लाख डॉलर मूल्य) हो गया था जबकि पिछले साल यह 1,123 टन (25.9 लाख डॉलर मूल्य) था। हालांकि यह गिरावट गुणवत्ता में कमी और पिछले वित्त वर्ष में भारत से चीन को भेजी जाने वाली खेप में देरी के कारण आई थी।

पीएचडी चेंबर ऑफ कॉमर्स एंड इंडस्ट्री के सहयोग से कृषि एवं प्रसंस्कृत खाद्य उत्पाद निर्यात विकास प्राधिकरण (एपीडा) ने आज एक अनुमान जताते हुए कहा कि 2020 तक मूल्य और मात्रा दोनों ही रूप में चीन को किए जाने वाले भारतीय अंगूर के निर्यात में 200 प्रतिशत की वृद्धि होगी।

एपीडा के चेयरमैन पवन के बड़ठाकर ने यहां आए चीनी आयातकों और क्रेता-विक्रेता मुलाकात के दौरान कहा, 'हमने चीन के सरकारी अधिकारियों के साथ कई बैठकें आयोजित कीं जिसके बाद वे महाराष्ट्र के नासिक में अंगूर के बगीचों और पैक हाउसों



का दौरा करने के लिए सहमत हो गए। पूरे विश्व से 54 कंपनियों के 100 से ज्यादा प्रतिनिधियों के साथ-साथ चीन की ओर से 19 कंपनियों के 25 प्रतिनिधियों ने हिस्सा लिया।

दिलचस्प बात यह है चीन की फाइटोसैनिटरी एजेंसी ने भारत से किए जाने वाले अंगूर निर्यात के मूल्यांकन और मंजूरी के लिए भारत में यंजीकृत पैक हाउस और अंगूर के बगीचों की सूची मांगी है। यहां जारी बयान में कहा गया है कि एपीडा अपने निर्यात बाजार का चीन में विस्तार करने का प्रयास कर रहा है। अंगूर उत्पादन करने वाले राज्यों और राष्ट्रीय अंगूर अनुसंधान केंद्र के सहयोग से एपीडा के जरिये वाणिज्य और उद्योग मंत्रालय के सामूहिक प्रयास से अंगूर की गुणवत्ता में सुधार की कोशिश की जा रही है। केंद्र और राज्य सरकारों की प्रचार योजनाओं से भारतीय अंगूर और अन्य उष्णकटिबंधीय फलों के निर्यात को बढ़ावा मिलेगा।

The Capital cannot become a smart city till 'fighting' among multiple agencies stops, Deputy Chief Minister Manish Sisodia said at an event here on Saturday.

Organised by the PHD Chamber of Commerce and Industry at the NDMC Convention Centre here, Mr. Sisodia called for 'clarity' in the Capital's governance. Delhi Industries Minister Satyendar Jain was also present at the event.

There was, Mr. Sisodia argued, "total confusion" in Delhi owing to the multiplicity of agencies. "Until and unless we make our governance system smarter, no technology can help us," he said.

Chaos prevails

"We have a Delhi that belongs to the DDA, a Delhi that belongs to L-G sahib, one Delhi that is of the Delhi Police, one Delhi that belongs to the NDMC. You need to bring clarity for becoming a smart city," he said further. The Deputy Chief Minister said multiple agencies taking decisions for the people of Delhi resulted in "chaos".

"There is hardly any coor-

dination among these agencies for the welfare of Delhiites and they are fighting among themselves. In such circumstances, converting the present landscape of Delhi into a smarter city would not be possible," he said.

Smart governance

Mr. Sisodia said smart governance is the core solution to develop a smart city in which a single authority is put in place to take decisions without any political ill will to provide a better life to citizens.

Mr. Jain concurred with Mr. Sisodia and accused the Delhi Development Authority and the Municipal Corporation of Delhi of being corrupt adding that the current system had become quite opaque and there needed to

be transparency.

Meanwhile, the Delhi government has started a scheme wherein resident welfare associations will be given ₹1.8 lakh per acre for the upkeep of parks, Mr. Jain said at the event.

He said forms for the same can be downloaded from the website of the Environment Department, and after filling them, the RWAs can contact local MLAs.

"The funds will be given to the resident welfare associations (RWA), irrespective of the parks belonging to any civic agency," Mr. Jain said. (With PTI inputs)

Delhi govt to float tender in Jan to buy 1,000 electric vehicles

NEW DELHI: The Delhi government will float a tender in January to procure 1,000 electric vehicles, Delhi Transport Corporation's (DTC) Managing Director Manoj Kumar said on Thursday.

"These vehicles would be procured by the Delhi Integrated Multi-Modal Transit System (DIMTS) and would begin to ply on the Delhi roads by June next year," he said.

He was speaking at a conference "Transforming Urban Mobility in India and Role of Electric Vehicles" under the aegis of the PHD Chamber of Commerce and Industry (PHDCCI) here.

Kumar pointed out that the cost of electric vehicles is "on a higher side" and requested the manufacturers to lower the prices so that more e-vehicles



could be brought in.

"In 2016, the DTC ran a few e-buses on a trial basis, with each costing Rs 2.5 crore, as against a usual CNG bus of Rs 45 lakh. "We request the manufacturers to cut some cost so that more e-vehicles could be plied not only on Delhi roads but also in other states so that air pollution is contained," Kumar said.

Similarly, he said, charging facilities should be widely available so that recharging the e-vehicles does not become a

problem or inconvenience for both operators and users.

The announcement by DTC managing director came just two days after the Delhi government released its draft "Electric Vehicle Policy 2018" with the aim to ensure adoption of 25 per cent e-vehicles among new registrations by 2023. The policy has committed to strengthening the infrastructure for "battery charging and swapping" to provide access within a 3-kilometre range from anywhere in Delhi.

Roundtable on Review of Master Plan for Delhi 2021



Urban Planning should be futuristic to deal with the challenges of high growth rate and rising population, said Mr. Kamal Nath, Union Minister for Urban Development, at the Round table on Review of Master Plan for Delhi-2021, organized by the PHD Chamber on March 29, 2012 at PHD House, New Delhi.

While inaugurating the round table, Mr. Nath said, "Addressing urbanization effectively is a huge challenge as the pace of migration to urban areas is very high. Delhi's population is 16.7 million. We have to look at ground realities and effectively manage future aspirations of all stakeholders. We need a futuristic plan for the future. A high-level committee will examine Delhi Development Authority's (DDA) proposals for Delhi Master Plan before the Urban Development Ministry takes it up."

Mr. G S Patnaik, Vice Chairman, DDA said that the DDA is working on plans to promote green buildings and green zones and is working on high-density residential areas.

Chamber in his welcome address said, "DDA has done a good job. We should adopt best practices from around the world. Policy action on the urban development front has been reactive rather than proactive. We should frame effective policies to create a good living experience".

Mr. Rajnish Goenka, Chairman, Delhi and NCR Committee, said, that industrial areas should be upgraded and industrial units should be encouraged to shift to NCR.

Mr. Rajeev Talwar, Chairman, Housing and Urban Development Committee, PHD Chamber said that in the next 30 years, urban population is expected to double. Around 50 percent of the urban population lives in slums. The focus is on housing and commercial sectors for which private sector should be encouraged and DDA's role should be confined to being a planning and a regulatory body.

Senior officials from DDA and DSIIDC made a number of technical presentations during the session.
