#### MESSAGE



#### Friends,

#### "Agricultural science has enormous potential to increase the yields of small farmers and lift them out of hunger and poverty." Bill Gates.

The farmer is an integral part of rising India and the agriculture sector. one of PHD Chamber's thrust areas, opens doors for national prosperity, providing food security, eradicating poverty and improving the livelihoods of our populace. Acknowledging that India's soul resides in her villages, more than 58 percent of rural households depend on agriculture. The sector contributes 15-16 percent to India's GDP. Substantiating this, last month, PHD Chamber partnered with the Haryana Government to organize the Fourth Agri Leadership Summit, 2019 at Ganaur, (Sonipat), wherein Hon'ble President of India, Mr Ram Nath Kovind was the Chief Guest for the valedictory session. The Hon'ble President called for positioning farming in the agricultural value chain as well as giving it its due credit in the wider entrepreneurial context.

The Summit deliberated on the government's schemes to promote agriculture, horticulture and livestock sectors in the state of Haryana, by displaying innovative and novel technologies for the benefit of farmers and attracting investments in agro-related industry.

The Chamber applauds the initiatives taken by the government in the last four and a half years to fast track the progress of the farm sector. Reforms in the areas of irrigation, insurance, soil health, market, credit and farm infrastructure have resulted in record production of foodgrains and horticulture crops in the current year. The Indian food processing industry accounts for 32 percent of the country's total food market and is ranked fifth in terms of production, consumption, exports and growth. India is among the top 15 exporters of agricultural products in the world with agricultural exports aggregating at US\$ 38.21 billion in FY 2017-18.

I am heartened to commend Prime Minister, Mr. Narendra Modi's mantra of "Sabka Saath, Sabka Vikas" that has been reflected in this year's Interim Budget 2019, reaffirming the government's commitment to focus on famers' welfare. The historic programme, "Pradhan



Mantri Kisan Samman Nidhi" assuring an annual income of Rs. 6,000 to 120 million small and marginal farmers, having cultivable land upto 2 hectare is a creditable measure. Other programs taken to address risks related to price and yield, such as PM Kisan Samman Nidhi, crop insurance, Soil Health cards, electronic-National Agriculture Market, up-gradation of rural haats and fixing the Minimum Support Price are likely to benefit the hardworking farmers. Here, I would like to comment that with men migrating to urban areas, 'feminization of agri sector' is taking place, with women performing multiple roles as cultivators, entrepreneurs and labourers.

I concur with the government's Agriculture Export Policy announced in December 2018, which strengthens the vision of doubling of farmers' income to US\$ 3,420 per household by FY 2022. Exports are expected to increase to US\$ 60 billion by 2022 and US\$ 100 billion in the coming decade which will help to integrate farmers with the global value chain, by diversifying the export basket and promoting high value products. Another notable proposal announced recently is the setting up of a corpus fund of Rs. 2,000 crores by NABARD for development and upgrading of agricultural marketing infrastructure in rural and regulated wholesale markets. I also applaud the government's proposal to launch an index to rank States on the basis of ease-of-doing-agri-business which will help in fostering agriculture among States by promoting a competitive spirit.

I must highlight the infusion of digital technologies in the farm sector that is transforming the entire input supply chain, crop management cycle, storage and market access. Initiatives taken by Agriculture Universities and the Indian Council of Agricultural Research in digital and artificial intelligence are plaving a vital role in agri research. Lab-to-Land programs are being disseminated to make technologies accessible to farmers. Also, a number of agri-innovation startups are coming up for accelerating modernization by bringing in applications in precision agriculture and creation of digital platforms. The AGRI-UDAAN programme of mentoring start-ups is helping to connect them with potential investors. The Ministry of Commerce and Industry's policy of allowing 100 percent FDI in marketing of food products and in food product e-commerce under the automatic route is a welcome initiative for foreign investors.

To enhance agriculture productivity, there is a need to focus on R&D for judicious water management, upgradation of irrigation facilities, storage infrastructure as well as to promote participatory farming. I firmly believe that efficient supply chain management, building more integrated markets and resolving market distortions will not only boost the food processing sector but also help in providing better prices to farmers' and enhance their income. Further, a diversified cropping pattern would mitigate the risks such as harvest losses and price shock. Bridging the urbanrural divide, promoting investments in modernizing agriculture, harnessing technology, empowering woman and creating jobs for rural population will all help in making agriculture a viable activity, eradicating hunger and malnutrition and thereby ensuring "food for all."

I must say with India on the rise and for New India to become a reality at the earliest, the government should modernize farming and position it as a profitable opportunity so that it attracts our youth.

With elections around the corner, I sincerely hope that the political parties develop election manifestos that focus on building a superpower India in which the government, industry and people are equal stakeholders, aiming at inclusive growth and sustainable development. With this, I would rest my thoughts with a quote by Thomas Jefferson, "Agriculture is our wisest pursuit, because it will in the end contribute most to real wealth, good morals and happiness."

nder the aegis of the Government of Haryana, the Agri Leadership Summit 2019 was held, February 15-17, 2019 at India International Horticulture Market, Ganaur, Sonipat. PHD Chamber was the Institutional Partner of the Government of Haryana for the Summit. Further, two Knowledge Reports prepared by PHD Chamber viz. "Progressive Haryana: The Agriculture Hub of India" and "Progressive Haryana: Economic Profile" were released during the Summit.



Eminent dignitaries who participated in the Inaugural Session included Chaudhary Birender Singh, Union Steel Minister; Mr. O P Dhankar, Minister of Agriculture & Farmers' Welfare, Haryana; Ms. Kavita Jain, Minister of Women & Child Development, Haryana; Mr. Manish Grover, Minister of State Cooperation, Haryana; Mr. Nayab Saini, Minister of Labour and Employment, Haryana; Mr. Ramesh Kaushik, Member of Parliament, Ms. Navraj Sandhu, Additional Chief Secretary, Agriculture and Farmers' Welfare Department, Government of Haryana; Mr. S C Gulati, Additional Chief Secretary, Department of Animal Husbandry, Government of Haryana and Ambassadors and Diplomats from various countries.

Mr. D K Aggarwal, Senior Vice President, PHD Chamber addressed the Inaugural Session and appreciated the Haryana Government's efforts towards promoting diversification in the farm sector, improvement in Research & Development and upgrading agri-infrastructure as per international standards to harness the emerging opportunities in the agri sector. He said that the state's cropping and irrigation intensity are significantly high at 182 percent and 188 percent respectively which is a good indicator and can further be broad-based.

The session on 'International Cooperation' witnessed participation from countries such as Brazil, Rwanda, Namibia and Mauritius where the diplomats from these respective countries shared their best practices and investment opportunities which can be experimented by farmers of the state.



During the Agri Leadership Summit, 8 parallel thematic-seminars were organized focusing on different thrust areas concerning agriculture and allied sectors. These sessions were aligned with the Theme of the Day. On day one, the theme "Innovation & Entrepreneurship" was featured whereas on the second day, "Kheti Plus" was the theme with representations from allied agri sectors such as Poultry, Animal Husbandry and Fisheries. On the concluding day, the theme "Direct Marketing & Agri Service" was discussed with emphasis on making agriculture sustainable and profitable.

Prominently, the sessions dealt with Crop Technologies and Agri Business, Agri Industries, Livestock Business – An Untapped Potential, Increasing Business Opportunities for Women, Doubling Income through Livestock Productivity, Haryana – The Next Destination for Aquaculture, Agri Business and Youth in Horticulture and Farmer Producer Companies – Way Forward for Direct Marketing.







The sessions witnessed the participation of a large number of farmers, sector experts, policy-makers, industry stakeholders, diplomats and media. Experts advised the farmers on various technical know-how and methods to increase their agricultural productivity, strengthen marketing & sale of agri-products and enhance their level of incomes.

Apart from seminars, interactive sessions or "Goshthis" were also organized on themes such as New Technology Trends and R&D in Agriculture, New Technologies in Agriculture and Food Processing, Farmer Interest Leadership, Farm Sector Innovation and Entrepreneurship and Role of Media in Agriculture.

All the Goshthis witnessed impressive



participation from the farmers, government officials and private players operating in the sector. Farmers used the platform to share their concerns and how they could



apply state-of-the-art technology in their farm and improve productivity.

The Valedictory Session of the Agri Leadership Summit 2019 was graced by Mr. Ram Nath Kovind, Hon'ble President of India who appreciated the people and the Government of Haryana for making efforts for the overall development of the State, including enhancing Ease of Doing Business and improving social indicators.

Mr. Manohar Lal Khattar, Hon'ble Chief Minister of Haryana in his remarks stated that the Government of Haryana has been organizing this Summit with the aim to double the income of farmers by 2022, improving agricultural productivity and strengthening market linkages between farmers and markets. He made an observation that the Summit offered an excellent platform for farmers to gain expertise on how to enhance their agriculture productivity.

Mr. O P Dhankar, Hon'ble Minister for Agriculture and Farmers Welfare, Haryana stated that the key objective of the Summit was to promote growth and development of farmers of the State. He appreciated the efforts taken up by the farmers for making significant contribution in the national agri basket. He gave a brief overview about cattle exhibition displayed at the Summit that showcased the hard work and commitment contributed by the farmers of the State. He expressed happiness that many farmers from the State have received Krishi Ratan Award.



Remarkably, each day of the Summit witnessed the presence of dignitaries and over 60,000 farmers from across the state and outside.

The Summit held special importance to the concerned departments like Agriculture & Farmers' Welfare, Animal Husbandry & Dairy, Fisheries, Agriculture Marketing Board and other organizations that have direct bearing on the farm sector. The Summit offered a platform for the various State Government Departments and Cooperative Institutions to exhibit their products and share plans related to agriculture and allied sectors in a most productive way.

In the Agri Leadership Summit 2019, the Government of Haryana honoured the farmers with "Haryana Kisan Ratna Samman" to encourage them for their exemplary achievements and for continuous innovatiion. The award had a cash prize of Rs. 5 lakhs and a citation was given to farmers for their outstanding contributions in the field of agriculture development.

Mr. O. P. Dhankar encouraged the farmers to learn from other farmers who are doing good work. Mr. Dhankar mentioned the various important initiatives that have been taken by the government in the last four years such as allocation of Rs. 3,640 crores to farmers affected by natural calamities, organization of programs like Agri Leadership Summit and encouraging farmers for their outstanding contribution through awards and other means. He also persuaded the farmers to undertake direct marketing of their farm produce and get the maximum returns possible. He shared that the government has built the largest Mandi in Ganuar and is now building a new Mandi for flowers in Gurugram.

The 1st Agri Leadership Summit was organized in 2016 at Gurugram, the aim was to appreciate the State's strong position in agriculture and allied sectors and to create a further roadmap of development. Subsequently, 2nd and 3rd Agri Leadership Summits were organized in 2017 and 2018 at Faridabad and Rohtak respectively.

The 4th edition of Agri Leadership Summit was structured in such a way that key attributes and people concerning agriculture and allied sectors came in prominence.



## **PHDCCI** facilitates largest number of centres for video conference with Dr Suresh Prabhu, Union Minister of **Commerce and Industry and Civil Aviation**



HD Chamber organized an Interaction with Mr. Suresh Prabhu, Union Minister of Commerce and Industry and Civil Aviation, through video conferencing on February 18, 2019, at 14 locations, namely New Delhi; Chandigarh; Jaipur, Rajasthan; Lucknow, Uttar Pradesh; Ranchi, Jharkhand; Raipur, Chhaitsgarh; Bhopal, Madhya Pradesh; Guwahati, Assam; Cochin, Kerala; Hyderabad, Telangana; Patna, Bihar; Dehradun, Uttarakand; Baddi, Himachal Pradesh; and Srinagar, Jammu & Kashmir.

Dr. Suresh Prabhu addressed and interacted with the representatives of industry and trade associations and export promotion organizations through a video conference and shared his vision for industry and trade in India. He emphasized that this was the first ever direct interaction with trade and export bodies on this scale by the Ministry of Commerce and Industry. Dr Suresh Prabhu said that the government's duty is to help industry to grow and facilitate business by simplifying regulations. The Minister referred to the

jump made by India to 77th position in the Ease of Doing Business Ranking. He emphasized that it is the target of the government to take India into top 50 rankings for which it is constantly making endeavors. In this regard, a pan India exercise was conducted to understand the problems and parameters affecting Indian businesses.

Dr. Prabhu stressed on improving the Ease of Doing Business for each district in India and further said that the benefits of the schemes and initiatives should percolate down to the ground level. He mentioned that with improvement in EODB in each district, the standard of living and income of people in that district improves, and with it their demand increases and simultaneously the revenue of that district also increases. He opined that to achieve the aim of double digit GDP growth of India, GDP growth rate of each district must increase by 3-4%.

The Minister mentioned that the strategy has been changed to increase

overall economic growth of India and that depends on both internal trade and external trade and assured that the two ministries involved are working together in a holistic way.

He also highlighted that India received highest ever foreign direct investments (FDI) in recent years and now their target is to bring in FDI aggregating US\$ 100 billion in the country. This would help to create new technology and new job opportunities, new small and medium commercial enterprises, among others.

Dr Prabhu mentioned about the Government's vision on 'Make in India.' He pointed out that many initiatives have been taken in the defence sector along with startups. He said that the 'Startup India' programme has been very successful so far and planning is underway to expand it further by removing all the hurdles.

The Minister stressed that in India, small industries, self-help groups, among others face the problem of lack of market, for which government has planned to



launch an initiative that will provide women organizations, artisans, among others to offer their products on GEM platform.

He also discussed about the two convention centers, at Dwarka and ITPO, that the government has started to attract people to come to India. He further spoke about the plan to modernize leather and footwear industry of India, that would include skill development and setting up of plants so that employment can be created in this sector.

The Minister further emphasized on the government's efforts to address the challenges under GST especially for MSMEs that have been successfully addressed. Dr. Suresh Prabhu said that exports have been growing for the last three years and reached the highest level of around US\$ 314 billion this year. He stressed that India is able to achieve this level when the rest of the world is suffering from global challenges and reduced trade.

Dr Suresh Parbhu also discussed the agriculture export policy and spoke about

the government's plan to take agriculture exports to the level of US\$ 100 billion. He also mentioned that the government is trying to setup 15 international offices that would be closer to market places and would promote businesses.

He further discussed about the government's strategy to take India to the level of US\$ 5 trillion economy that would include US\$ 3 trillion from manufacturing, US\$ 1 trillion from agriculture and US\$ 1 trillion from services. He further said that a separate department has been created for logistics to remove the logistics related problems in the ministries. The government is working on increasing the market access, bilateral deals, SOPs, among other important areas.

Dr. Suresh Prabhu urged industry representatives and government to work together to take India to the level of US\$ 5 trillion economy and requested industry representatives to engage with the government closely and work as a team.

#### Plan for \$100 billion FDI inflow

Hon'ble Commerce and Industry Minister, Mr. Suresh Prabhu said that the government is working on a blueprint to increase FDI inflows to \$100 billion through a targeted approach. He was quoted to have said, "We have removed almost all sectoral restrictions. I have asked Invest India to identify those who can get that amount. I am getting research done on companies who have the cash, where they will invest, what is the sectoral intent and I am personally talking to Fortune 500 companies and requesting them to come. We will make sure that we will take it to a new level." In 2017-18, FDI flows into India were estimated at over \$61 billion.

The session was attended by delegates from the Banking Sector, NBFCs, Fin Tech Companies, Entrepreneurs, Proprietary Firms and MSMEs.

Chief Guest, Mr. B Sankar, General Manager, NW-4 Delhi Circle, State Bank of India stated that MSME sector is the backbone of the Indian Economy and there has to be a sense of ownership in running MSME enterprises if the sector has to remain competitive globally and domestically. He further added that MSMEs should strive for digitisation in all areas of their operations with 100 percent cashless transactions.

Mr. Anil Khaitan, Immediate Past President, PHD Chamber mentioned that MSMEs should not be penalized for wrongdoings of few individuals who have defrauded the banking system. He said access to credit to MSMEs is vital for employment generation and economic development of the country.

Mr. Jyoti Prakash Gadia, Chairman, Banking, Financial Services and Insurance Committee, PHD Chamber elaborated that MSMEs should avail the benefits of digitization and GST, shift from informal source of funding to formal source of funding and identify the right instrument and right institution for their funding requirements. He further suggested that cost of funds for MSMEs should come down; there should be relaxation in norms for ECBs for raising working capital funds, collateralized lending, restructuring scheme, one-day default scheme and mechanism to protect MSMEs from large buyers such as government agencies from delayed payments.

The technical panel discussion focused on alternative financing mechanism for MSMEs, NBFCs and their diversifying role, Trade Receivables Discounting System and Digitization. The Economic Affairs Committee of PHD Chamber organized the 2019-20 Budget Viewing session on February 1, 2019 at PHD House, New Delhi. The session was addressed by Mr. Ajay Shankar, Former Secretary, DIPP and Dr. C S C Shekhar, Professor of Agriculture, Institute of Economic Growth, University of Delhi and the leadership of PHD Chamber.

Mr. Gopal Jiwarajka, Former President, PHD Chamber said that GDP growth in India was coming majorly from the services sector which is good but not adequate. He stressed that the country needs large job creation and for jobs to grow, it is important for agriculture and manufacturing sectors to grow.

Mr. Sharad Jaipuria, Former President, PHD Chamber said that the budget should focus on the rural sector and on creating employment for the growing population of the country.

Ms. Sushma Berlia, Former President, PHD Chamber expected the government to focus on health & social sector and the agriculture sector.

Mr. Ajay Shankar, Former Secretary, Dept. of Industrial Policy and Promotion said that the right approach is to learn from China as India needs to see what works for its economy without any prior commitment. He suggested that there is a need to check how to get rid of poverty, create jobs and bridge the gap between India and China.

Subsequently, the Interim Budget presented by Mr. Piyush Goyal was viewed

by the speakers and participants. After viewing of the Budget Session, speakers gave their views on the Budget.

Dr. C S C Sekhar, Professor of Agriculture, Institute of Economic Growth, University of Delhi expressed that the budget was balanced across all sectors and has a positive effect on the economy. He opined that the direct transfer of Rs. 6000 annually to farmers is appreciable. He suggested that there should have been some provisions for agricultural labourers. He mentioned that the formation of a separate department of Fisheries and increased allocation for the fisheries sector was an important step taken by the government. He indicated that direct tax proposals would increase disposable income of consumers, increase consumer demand and boost the economy.

Mr. Anil Chopra, Chairman, Direct Taxes Committee, PHD Chamber appreciated the government's announcement regarding rationalization of direct tax, increased compliance, online scrutiny, instant rebates, among others. He opined that the benefit of rollover of capital gains from investment in two residential houses for a tax payer having capital gains up to Rs. 2 crore is a good measure.

Mr. Anil Khaitan, Immediate Former President, PHD Chamber expressed that the 10 year vision provided by the government in the budget will give right direction to the economy. He further mentioned that the budget was all-round holistic and supported the motto of Hon'ble Prime Minister - 'Sabka Sath, Sabka Vikas.'

Mr. Rajeev Talwar, President, PHD Chamber expressed that the budget focused upon almost all sections of the economy such as rural, defence, middle and salaried class, among others. According to him, this budget may be called green budget for the people and the government. He praised the government for increase in outlay for education, benefits to middle class population in form of tax exemption, exemption of income tax on notional rent from one to two houses, benefits for unorganized sector and senior citizens, among others. He said that the proposal of rollover of capital gains from investment in two residential houses would keep the prices of property down and thereby increase investment by young generation in the housing sector.

Mr. D.K. Aggarwal, Senior Vice President, PHD Chamber appreciated the announcement of tax exemption on notional rent on second house and full tax exemption on income upto Rs 5 lakh. He highlighted that direct transfer of Rs 6000 per annum to farmers would help relieve farmers' distress as this would directly go into their bank account.

Mr. Sanjay Aggarwal, Vice President, PHD Chamber appreciated the government's announcement for making one lakh villages into Digital Villages over the next five years.

# Seminar on Resolution Plan under the Insolvency and Bankruptcy Code, 2016

PhD Chamber in collaboration with the National Company Law Tribunal and Appellate Tribunal Bar Association (NCLT &AT BAR), Society of Indian Law Firms (SILF) and The Bar Association of India organized a seminar on 'Resolution Plan under The Insolvency and Bankruptcy Code, 2016 and Issues Arising There from' on February 1, 2019 at PHD House, New Delhi.

The session was addressed by Hon'ble Mr. Justice S. J. Mukhopadhyay, Chairperson, National Company Law Appellate Tribunal; Hon'ble Chief Justice (Retd.) Mr. M.M. Kumar, President, National Company Law Tribunal and Mr. Virender Ganda, Senior Advocate and President of the National Company Law Tribunal and Appellate Tribunal Bar Association.

Hon'ble Chief Justice (Retd.) Mr. M.M. Kumar, President, National Company Law Tribunal emphasized that the resolution professionals have a greater role to play and seek solutions for the cases referred to NCLT so that these are resolved with with utmost sincerity. He pointed out that the Hon'ble Supreme Court and the RBI have often recalled the contribution of National Company Law Tribunal in settling corporate cases, referred to it with such meticulousness that as a result huge amount of money came back to the banking institutions. Ever since, the Insolvency and Bankruptcy Code, 2016 came into being, intensive efforts have been made for cases referred to NCLT and adjudicating authorities to find resolutions and liquidation has never been the objective.

Justice Mr. S. J. Mukhopadhaya, Chairperson, National Company Law Appellate Tribunal asked the resolution professionals to perform their assigned duties with diligence and required detailing so that such professionals not only render required help for carving out resolution but also help adjudicating authorities in pronouncing their judgement. Justice Mukhopadhaya stressed that the role of resolution professionals as well as the Committee of Creditors and other such stakeholders becomes critical and important. He hoped that the resolution professionals will be making such diligence as this would lead to seeking a resolution rather than liquidation.

A panel discussion was also organized which was moderated by Mr. Virender Ganda, Senior Advocate. Mr. Sanjeev Krishan, PWC and Mr. Atul Sharma, Managing Partner, Linklegal India Law Services addressed the participants. While the former delved into the commercial aspects of the resolution process, the latter emphasized on the practical problems being faced in the corporate insolvency resolution process. Mr. Sanjeev Krishan opined that trading in debt might be the right way to go forward in resolving corporate insolvency. He illustrated that there has only been one case till date, where the financial creditor has been backed by the financial investor. He brought forward the practicality that even if there have been numerous cases where the corporate insolvency resolution process had been successfully initiated, most of them have somehow continued to remain in legal entanglements for a long time to come. Consequently, such corporate debt had been liquidated. A commonality between the speeches of Mr. Sanjeev Krishan and Mr. Atul Sharma was that both of them marked out the resolution process to be essentially a merger and acquisition process.

Around 230 delegates comprising of Senior Advocates, Advocates, Insolvency Resolution Professionals/ Resolution Professionals and other stakeholders attended the seminar.

The Roads, Ports and Other Infrastructure Committee, PHD Chamber organized its fourth 'Multimodal Transportation Conclave-2019'on January 24, 2019 at PHD House, New Delhi which was attended by more than 150 delegates from industry and other stakeholders.

Chief Guest, Ms. Leena Nandan, IAS, Additional Secretary, Ministry of Road Transport and Highways informed that the Centre in collaboration with all States and UTs is trying to develop the land parcels owned by the State Transport Corporations as 'Bus Ports' which could be used by other stakeholders to smoothen the passenger traffic movement. The experiment is based on the facilities created at different Airports which are used by all entities either for passenger movement or for cargo movement. Mr. Manoj Kumar, IAS, Managing Director, Delhi Transport Corporation, Govt. of NCT of Delhi said that to make sure that the safety of its commuters is ensured completely, 3900 DTC buses are to be fitted with GPS technology latest by March 2019. Currently, 1600 DTC buses are well facilitated with GPS facilities. He further informed that the DTC has undertaken a pilot project according to which route rationalization plan for the Najafgarh region will be achieved within the deadline of next few months in which not only DMRC but also other stakeholders like Gramin Sewa and the like are equally involved.

Mr. Pawanexh Kohli, CEO, National Centre for Cold-Chain Development (NCCD), stressed on the fact that the Indian Cold Chain industry is poised for a healthy growth in future & the Industry is evolving at a faster speed in India due to shift in focus from increasing the production to better storage and transportation facility of the commodities.

Mr. D.K. Aggarwal, Senior Vice President, PHD Chamber mentioned that more and more players from variant sectors are relying on multimodal transportation and the potential for the logistics sector is enormous. But what is required on war footing is to plug the infrastructure gaps. 

In fact, investment in waste management is paying off. If you have plants in your campus, you buy manure with the waste generated by your unit, you will not have to spend for manure".

Chief Guest, Mr. Rajeeva Swarup, IAS, Additional Chief Secretary, ACS, Home, Home Guard, Jail & Rajasthan State Investigation Bureau asserted that we should take responsibility for the waste we generate as the first point of onus in waste management is of the person who generates the waste.

Guest of Honour, Mr. Gaurav Goyal, Managing Director, RIICO assured that RIICO will provide technical assistance to industrial units in its zone to upgrade common affluent treatment plants (CETPs) and provide land as well to set up new ones to check pollution. Mr. Goyal also stated that if required, RIICO would also help in research and development for developing new technologies to address the problem of pollution. He further added that RIICO will lay out pavements and repair old ones in partnership with the industrial units to improve the infrastructure. These pavements would be planted with trees to check air pollution in industrial areas and developing and maintaining parks will also be given priority, he reiterated.

Other speakers included Ms. Alamitra Patel, Member, Supreme Court, Solid Waste Management Committee; Mr. Dalip Singh, Rajasthan High Court Retired Judge and National Green Tribunal Judicial Member; Mr. Ulhas Parlikar, Global Advisor Waste Management and Dr Vivek Agrawal, Chairman, WGCCT, International Solid Waste Association.

Ms. Almitra Patel, Member, Supreme Court Committee on SWM focused on Solid Waste Management in the textile industry. She said that finely-shredded thin carry-bags, multi-films and thermo Cole that is usually burnt by industries can be sprinkled onto heated stones in a hot-mix plant. They soften and give the stones a good coating to which tar (asphalt, bitumen) bonds very firmly. Road life is more than doubled and costs are also less as 8% by weight of bitumen can be replaced by shredded plastic. "Waste is not Waste - It is an Unutilized Resource', said Former Judicial Member of National Green Tribunal, Retd. Justice Dalip Singh.

RIICO envisaging to achieve the target of "Zero Landfill" by the year 2020 unveiled its plans at the conference. The conference also pitched for a different approach towards sustainable development.

The event saw active participation of the Rajasthan State Pollution Control Board and RIICO officials.

# Connecting with Indian Diaspora & Leveraging their Strengths

He highlighted that MSME business has grown as midsized Banks, like RBL has reached out to remote areas to finance the MSMEs. He also mentioned that the government has taken a lot of initiatives for finance & skill so that Micro units can grow into Small, Small to Medium and Medium to Large. He further mentioned that Indian Diaspora should connect with MSMEs and for this RBL Bank is ready to make a connect.

Mr. Subramaniam Krishnan, Partner-PE & FS, E&Y in his address highlighted that MSMEs play a big role. He mentioned that various tax and regulatory aspects have benefitted the MSME sector. 



he journey of Indian economy has been promising as the economic growth trajectory increased steadily during 1960s to 1990s to fast in 2000s and fastest in the 2010s. The advent of economic reforms has not only enhanced the socio-economic growth and development, but also provided a conducive and promising business environment.

#### **Trends in GDP Growth Rate**

The GDP growth trend of Indian economy has shifted from steady to fast and now to fastest in the world economic system. From 1960s and 1990s, the average growth rate of GDP has been steady at 4.6%. In 2000s, GDP recorded fast growth at the rate (average) of 7.2%. In 2010s, especially, over the last five years, spanning from 2014 to 2019, the average growth rate of GDP in India has been the fastest at 7.7%. This has made India the fastest moving emerging economy in the world economic system. The macro-economic environment has improved significantly during the last few years. Inflation is contained, fiscal consolidation is on the right path and foreign investment flows are growing year after year.


During the last few years, the government has undertaken a plethora of reforms and corresponding budgetary allocations for each and every segment of the population to facilitate all-inclusive growth and sustainable development of the economy. According to the IMF, India is a bright spot in the global ecosystem and India's growth is looking very lucrative in the coming years. India's growth has surpassed many emerging and developing economies. Recent IMF data suggests that India is the fastest growing economy in the world and this trend will continue in 2019 and 2020 also. Recently, NITI Aayog expects India to grow at 9-10% by 2022-23 which would raise the size of the economy in real terms from USD 2.7 trillion in 2017-18 to nearly USD 4 trillion by 2022-23.

### Incomes Improved and Inflation Contained

During the last five years, the Indian economy has witnessed remarkable improvement in macro-economic environment with lead indicators improving significantly. The real GDP growth increased from 6.4% in 2014 to 7.2% in 2019. Percapita income at current prices has exhibited an increasing trend from Rs. 79,118 in 2014 to Rs. 1,25,397 in 2019. Overall inflation has been contained over the last few years as the WPI inflation decreased from 5.2% in 2014 to 4.4% in 2019 and CPI inflation dipped from 9.5% in 2014 to 3.3% in 2019.

Exports have steadily increased from 7.8% in 2014 to 12.1% in 2019 and the total trade of the country has improved from USD 764.5 billion in 2014 to USD 769.1 billion in 2018. The fiscal deficit as share of GDP declined from 4.5% in 2014 to 3.3% in 2019. Further, India recorded a consistent increase in foreign inflows over the last few years. FDI inflows have increased from USD 36.0 billion in 2014 to USD 61.9 billion in 2019.

Going ahead, according to advanced estimates of Government of India, the industrial growth is expected to increase from 3.8% in 2014 to 7.8% in 2019, while services growth is also expected to show a consistent growth, increasing from 7.7% in 2014 to 7.9% in 2019. The agriculture sector is expected to grow by 3.8% in 2019. The

growth of public consumption has increased from 0.6% in 2014 to 9.2% in 2019. GFCF grew from 1.6% in 2014 to 12.2% in 2019. Other factors that put India on an upward growth trajectory are forex reserves that increased to USD 393.2 billion in 2019 from USD 304.2 billion in 2014; BSE Sensex increased to 35749 in 2019. The average crude oil price (Rs./1BBL) decreased to Rs 4497.1 per barrel in 2019 from Rs 5982.3 per barrel in 2014. The Reserve Bank of India reduced repo rate to 6.5% in 2019.

On the global charts, the Indian economy is looking remarkably attractive in comparison to its performance in the last five years. The improvement in the Ease of Doing Business from 142nd in 2014 to 77th in 2019 is a significant outcome of the diligent efforts of the government towards improving business environment in the economy. Improvement in World Bank's Ease of Doing Business rankings have been observed primarily due to significant improvement in dealing with construction permits with improvement and trading across borders. India ranked 44 out of 160 in the Logistics Performance Index in 2018. India improved to 58th rank out of 140 economies in the Global Competitiveness Index.

India has demonstrated sizeable improvements over the years. India has been able to accelerate on the pathway to innovation due to quality of its research institutions. India has been consistently climbing up its Global Innovation Index (GII) ranking since 2015. The Global Innovation Index (GII) rankings put India at 57th position in 2018. India improved in four out of the seven GII pillars: Institutions, Human capital and research, Market sophistication, and Creative outputs. The improvement in rankings is a result of shift to ease of paying taxes and to an improvement in ease of resolving insolvency.

#### Conclusion

Going ahead, the economy needs further bold measures to boost the investment environment and to trigger demand growth to the next level. Though lot of reforms have been announced across sectors and segments, structural reforms are required in the land and labour laws along with a dedicated approach for skill development.

Health and education system needs to be focused with the longer-term approach as strong education sector would help the growing population not only to find better standards of living but also enhanced competitiveness of the workforce at the domestic level and in international markets.

Inclusive health facilities would place India in a better position for inclusive growth and development of the nation. Shifting disguised unemployment from the basic agriculture sector towards the food processing and value added activities and other growing sectors such as housing and construction sector, MSMEs, among others, would open up great avenues for the job creation for the growing young population in the coming times.

# CONSTRUCTION ARBITRATION: Claim preparation is critical and vital

The infrastructure and construction sector in India is progressing rapidly with many ongoing large scale construction projects receiving huge investments. The importance of construction sector cannot be denied from the fact that its contribution to GDP of India is around 1.4% which is next highest to agriculture. It employs around 40 million of work force. This sector has operational budget of around 1,75,000 crores per annum.

Due to multi - party nature, the projects are becoming more risky. There are many risks in the large and mega construction projects in any country in general and in India in specific. One of the identified risk is delay of the projects due to various reasons of delays, therefore, the disputes in the construction sector are on rise. These disputes finally land in demands of extension of time of project without imposition of any liquidated damages (LD) and penalties and brings claims and counter-claims from contractors to employers and vice-versa and that begins the battle of conflicts and disputes. In view of above, the preparation of claims and counter claim is one of the most critical and vital activity in the arbitration.

Although there is no standard format or set formula for preparation of claims/ counter-claims by the party(ies) in construction arbitration - as every project is unique and involves different variety of disputes but below mentioned steps and factors can be considered as a general guidance for preparation of claims / counter claims by domain experts of the contractors as well as the employers -

# A. Preparation of claims by the contractors:

Again there is no standard formula or format to indicate the heads under which claim can be prepared. However the following can work as an overall guide:

- Complete cost incurred in organizing the project by the contractor during the entire duration of the delay in the project.
- ii) Cost incurred for the extra engineering hours during the entire duration of the delay in the project.
- iii) Cost incurred for the extra hours in procurement during the entire duration of the delay in the project.
- iv) Cost incurred in supervision of site during the entire duration of the delay in the project.
- v) Cost incurred with regard to additional insurance, premiums and maintaining/ extension of the financial BG's and LCs for the delayed period of the project.
- vi) Cost of the overhead of the contractor's company during the entire duration of the delay in the project.
- vii) Cost of the price variation as per the price variation formula mentioned in the contract for labor, supplies and applicable items during the entire duration of the delay in the project.
- viii) Cost relating to payment of extra taxes, duties and levies by contractor, if any for during the entire duration of the delay in the project.

- ix) Cost with regard to extra resources for accelerating the project during delayed period.
- x) Cost with regard to arears or pending amount/invoices/bills with the employer during the entire duration of the delay in the project.
- xi) Interest on the payment not received, arrears, late payments with bank rate of cumulative interest.
- xii) Payment of cost of items which were not originally in the scope of work of the contractor but were supplied as per requirement of the employer and were not paid.
- xiii) Cost relating to extra scope of work which was not originally part of the contract but executed by contractors on the subsequent request of the employer.
- xiv) Additional claims/prolongation claims based on specific criteria and conditions of contract of particular project executed by contractors.
- xv) Prolongation cost incurred by contractor due to delay in completion of the project.
- xvi) Overhead of the contractor's organization proportionate to the cost of the project is to be claimed which can be based on actual amount as per records. Otherwise it can be calculated based on some standard formula that has been accepted as one technique to determine overheads internationally. For example Eichley formula can be used to determine overheads.

- xvii) Change orders which have not been paid by the employer will have to be evaluated.
- xviii) Any exceptional claim which is unique to the project as per execution situations and contract conditions/breaches/ violations will have to be considered.

While preparing the claim by contractors under various heads as above the accepted item rate / data either available in contract or available as per National / International standard norm of rates will be considered for computing the claims. Abnormally high rates, exaggerated values, unrealistic prices and item rates which cannot be justified, should not be used for computation of claim amounts. Basis and system of calculation of various claim amounts must be explained in justification notes to make the claims more scientific, realistic and logical.

#### B. Preparation of Counter-claim by the employer:

It may be pertinent to note that any consequential damages and claims due to delay in the project are normally not allowed and are not normally tenable in the construction/project contract except the Liquidated Damages (LD) for delay in the completion of the Project.

The possible heads of claims may vary from one contract to another depending on its conditions. The possible heads are as follows:

- i) Recovery of the amount for opportunity loss for the delayed period, if allowed by the contract.
- ii) Extra counter-claims based on specific criteria adopted by employer as per contract condition.
- iii) Recovery of the LD amount from contractors by the employer for delayed period of the project.
- iv) Recovery of the LD amount for failure in Performance Guarantee (PG) parameters as specified in the contract.
- Recovery of the amount for items not supplied as per specification and scope in the contract in terms of quantity and quality.
- vi) Recovery of the amount for the jobs which could not be completed as per scope of contract by contractors. These jobs may either still be pending or may have been executed by employer at risk and cost of the contractor.
- vii) Recovery of any consequential losses incurred by the employer

due to any act of contractors as per specific provisions of contract.

- viii) Costforanyitem which is repeatedly failing and non-performing as per mentioned rating causing production loss and have not been replaced by the contractor in spite of at least three reminders during defect liability period can be claimed.
- ix) Cost for items and erection work which were inferior in quality and needs replacement/substitution based on past performance records and which have not been remedied by the contractors can be claimed.

#### C. Consideration of following points by the Arbitral Tribunal for giving an arbitral award:

- Arbitral Tribunal is required to go in details of Delay Analysis Report ( DAR )of the contractor and employer.
- ii) It also needs on the type of delay and the party responsible for it is based on the DAR and evidences submitted by the contractor and employer in support of/against it.
- iii) Arbitral Tribunal can classify delays of the project in basic four categories. The four categories are as follows:

#### a. Critical delay:

There are delays on critical path and are excused by single party and are compensable. Such delays can be attributed wholly to the employer or to the contractor. It is also possible that some part of such delays may be attributable to employer and some part to the contractor at different stages of critical path.

#### b. Concurrent delay:

These delays are caused by the contractor as well as by the employer and are excused by both the parties.

Such delays are excusable but non-compensable.

#### c. Non-critical delays:

These delays do not delay the project and are non-excusable and non-compensable.

#### d. Force Majeure delays:

Such delays are nor attributable to contractor or to the employer as these happen due to reasons which are beyond their control.

After the Arbitral Tribune classifies the delays and places them in a particular category, then the total picture of delay becomes very clear from the angle of how much delay is by employer, how much delay is by the contractor, how much is concurrent and how much is under force majeure category.

From the above, following conclusions can be drawn by the arbitral Tribunal:

- i) Quantum of delay attributable to the employer;
- ii) Quantum of delay attributable to the contractor;
- iii) Quantum of extension of time a contractor is eligible along with eligibility of claims;
- iv) Quantum of extension of time contractor is eligible without its eligibility of claims.

#### E. How much extension of time contractor is eligible with eligibility of claims?

Once the Arbitral Tribunal is clear as to how much extension a contractor is eligible against the delay then it becomes clear to determine as to what claims are to be awarded to contractor by employer and how much should be the amount of each claim as calculated based on the granted extension of the contract.





# Policy Pronouncements and Developments

#### Recommendations of the 33rd GST Council meeting

o boost the residential segment of the real estate sector, at the 33rd GST Council Meeting held recently, it was recommended that GST shall be levied at an effective GST rate of 5% without ITC on residential properties outside affordable segment and 1% without ITC on affordable housing properties. The new rate applicable from 1st of April, 2019 shall be for a residential house/flat of carpet area of upto 90 sqm in non-metropolitan cities/towns and 60 sqm in metropolitan cities having value upto Rs. 45 lacs (both for metropolitan and non-metropolitan cities). Metropolitan Cities include Bengaluru, Chennai, Delhi NCR (limited to Delhi, Noida, Greater Noida, Ghaziabad, Gurgaon, Faridabad), Hyderabad, Kolkata and Mumbai (whole of MMR). Intermediate tax on development right, such as TDR, JDA, lease (premium), FSI shall be exempted only for such residential property on which GST is payable. Advantges include: Buyer of house gets a fair price and affordable housing gets very attractive with GST @ 1%; Interest of the buyer/consumer gets protected; ITC benefits not being passed to them shall become a non-issue; Cash flow problem for the sector is addressed by exemption of GST on development rights, long term lease, FSI, etc. Unutilized ITC, which used to become cost at the end of the project gets removed and should lead to better pricing. Tax structure and tax compliance becomes simpler for builders.

# India's Inc. debt levels to triple by next year

**G**lobal Rating agency Standard and Poor's fin a report titled "Indian Corporate 2019 Outlook--Time For Caution." warned that revenue growth of India's rated companies is likely to slow down in the next 18-24 months. It cautioned that global risks such as stability of commodity prices as well as demand from the US and China will have a greater bearing on Indian companies rather than domestic demand in the next year or two. Elections may pose additional risks for Indian corporates. Change of administration may trigger expansionary government spending which may push up borrowing costs or even raise inflation. The revenue environment for rated corporates is facing increasing global risks such as China's slowdown, trade war escalation, or a disorderly Brexit, the

report said. The capital expenditure will be concentrated in few companies in fiscal years 2020 and 2021 for either one-off capacity building or defending market positions against disruptive trends. A gradual taper down of capital expenditures for rated companies in aggregate is likely to turn discretionary cash flows positive for the first time in three years. Over the decade from FY 2011-FY2020, rated corporates will double their aggregate EBITDA but this will be accompanied by tripling of debt.

#### GS1 India and GeM sign MoU to Empower Buyers to make Informed Choice

**G**S1 India, a standards organization set up by the Ministry of Commerce & Industry signed a MoU with Government e-Marketplace (GeM). This will enable GeM's buyers and vendors to access rich, accurate and standardized information on attributes of thousands of products across categories, empowering them to make more informed decisions. GeM will access product data from GS1 India's DataKart, the National repository of information on attributes of millions of retail products in the country. The categories get populated directly by manufacturers and brand owners. Every data will undergo validity checks based on globally accepted GS1 standards prior to being published for access by buyers.

#### Proposal to encourage investments in Start-Ups cleared

Union Minister of Commerce & Industry and Civil Aviation, Dr Suresh Prabhu cleared a proposal aiming at simplifying the process of exemptions for Start-ups under Section 56 (2) (viib) of Income Tax Act. With this notification, the definition of Start-ups will be expanded. Now an entity will be considered as Start-ups upto a period of ten years from the date of incorporation and registration in place of the earlier duration of seven years. Similarly, an entity will continue to be recognized as Start-ups, if its turnover for any of the financial years since incorporation and registration has not exceeded Rs. 100 crore in place of Rs. 25 crore earlier.

#### Ease of Doing Agri-Business Index

The government has been reorienting the agriculture sector by focusing on an

income-centeredness which goes beyond achieving merely the targeted production. The income approach focuses on achieving high productivity, reduced cost of cultivation and remunerative price on the produce, with a view to earn higher profits from farming. To ensure that the reform agenda of Government is implemented by all States/UTs, a need was felt to develop a competitive spirit between the States. Keeping this in mind to rank the States through Ease of Doing Agri-Business Index, a concept note along with parameters for developing an Index has been circulated to all States/UTs inviting their views. The concept is to consider farming not solely as a production oriented activity carried out to achieve food security for the country, but as a business activity carried out by farmer as entrepreneur. The proposed index has taken the aspects of increasing production/productivity, increasing price realization of agri produce and decreasing input costs of production, risk mitigation and investment related attributes. Agriculture being a State subject, the State Governments undertake development of perspective plans and ensures effective implementation of the programs. The index will help in fostering agriculture among States by promoting a competitive spirit amongst the States.

#### Agro Meteorological Advisories

About 5.13 crore farmers are receiving Agro meteorological advisories through m-kisan portal (https://m-kisan.gov.in). 25 centres of All India Coordinated Research Project on Agrometeorology located in State Agriculture Universities, distributed across the country have made efforts to issue Agromet advisories through Radio, TV and Newspapers in local languages. The Indian Council of Agricultural Research and India Meteorological Department have jointly planned to augment the Agromet Advisory System network to subdistrict-block level. Under this plan, 200 Krishi Vigvan Kendras including the 110 Aspirational districts have been identified for setting up of District Agro-Met Units to provide Agromet services to farmers. The initial fund of Rs. 2.4 crores (@ Rs.1.2 lakh per unit has been sanctioned for establishing the facilities to start the advisory services. Further, several awareness campaigns have been undertaken to encourage farmers to register themselves on m-kisan portal and receive crop and weather specific advisories. Many farmers have registered through Kisan Call Centre



also. Extension workers explain the process of registration and benefits of getting registered to the farmers thereby helping farmers to receive crop and weather based advisories.

#### Cabinet approves MoU between India and Maldives for Establishing Mutual Cooperation to Improve the Ecosystems for Agribusiness

The Union Cabinet accorded ex-post facto approval to the MoU between the Ministry of Agriculture and Farmers' Welfare, India and the Ministry of Fisheries, Marine Resource and Agriculture, Maldives signed in December, 2018 during the State visit of President of Maldives to India. The MoU for establishing mutual cooperation to improve the ecosystem for agribusiness provides for cooperation in the fields of agriculture census, agribusiness, Integrated Farming System, Irrigation, improved seeds, Soil Health Management, research, capacity building of local agribusiness, enhancing knowledge of entrepreneurs in the areas of food security and nutrition, developing climate resilient agriculture system and establishing facilities to test pesticide residues.

#### Cabinet approves introduction of National Institutes of Food Technology, Enterpreneurship and Management Bill, 2019

The Union Cabinet has approved the introduction of National Institutes of Food Technology, Entrepreneurship and Management Bill, 2019. The objective of the bill is to confer the status of Institutions of National Importance to National Institute of Food Technology, Entrepreneurship and Management at Kundli, Harvana, and the Indian Institute of Food Processing Technology at Thanjavur, Tamil Nadu. The legislation would provide for functional autonomy to the institutes to design and develop courses, undertake research activities and leverage enhanced status in their academic pursuits, so that they become world class institutes. The institutes would implement the reservation policy of the government and would also undertake special outreach activities for the benefits of concerned stakeholders. It would enable the institutes to provide world class teaching and research experience by adopting innovative practices.

#### Online Awareness Course for Exporters

Union Minister of Industry and Civil Aviation, Mr. Suresh Prabhu chaired a meeting of the Board of Trade (BOT). On this occasion, he launched a new online "Anytime-Anywhere" export awareness course to train, mentor and hand-hold potential exporters so as to help them to tap international trade opportunities. This Online Course has been funded under the 'Niryat Bandhu' scheme of Directorate General of Foreign Trade (DGFT) and is in collaboration with the Indian Institute of Foreign Trade, New Delhi. On successful completion, a Certificate in Export Import Management under Niryat Bandhu Scheme will be awarded to participants.

# Cabinet approves MoU between India and Argentine in tourism

The Union Cabinet has approved the signing of MoU between India and Argentine in the field of Tourism. The signing of MoU between India and Argentine in the field of tourism will help the two parties in creating an institutional mechanism for enhancing cooperation in the tourism sector.

#### Government may exempt DPIITcertified startups from angel tax

The government is considering giving complete exemption to startups from angel tax once they are certified by the Ministry of Commerce and Industry, a move aimed at helping budding entrepreneurs. The consideration assumes significance as several startups have claimed to receive angel tax notices, impacting their businesses.

# Increased exports in India can improve jobs and raise wages

report titled "Exports to Jobs: Boosting Athe Gains from Trade in South Asia" jointly produced by the World Bank and the International Labour Organization shows that increasing exports can lead to better jobs and higher wages in India, including more formal jobs for youth and women. Labor market policies can help different groups of workers acquire the right skills and ensure that the gains of increased exports are shared more broadly across society. The report shows that increasing exports would boost average wages. The biggest beneficiaries of the wage gains would be the high-skilled, urban, more experienced, and mainly male workers. For low-skilled workers, the shift would result in an increase in formal jobs. The research report looks at how alobalization might contribute to local jobs and wages. The report also provides options on how to expand and widely share the benefits of higher exports. Improving workers' skills, getting women and youth into more jobs, and addressing distortions that make labor mobility costly are some of the recommended policy actions.

#### Promulgation of Aadhaar and Other Laws (Amendment) Ordinance, 2019

The Union Cabinet has approved the promulgation of an Ordinance to make amendments to the Aadhaar Act 2016,

Prevention of Money Laundering Act 2005 & Indian Telegraph Act 1885. The amendments would enable Unique Indentification Authority of India to have a more robust mechanism to serve the public interest and restrain the misuse of Aadhaar. Subsequent to this amendment, no individual shall be compelled to provide proof of possession of Aadhaar number to undergo authentication for the purpose of establishing his identity unless it is so provided by a law made by Parliament.

#### National Mineral Policy, 2019 approved by Cabinet

he Union Cabinet approved the National Mineral Policy 2019 that will ensure more effective regulation. It will lead to sustainable mining sector development in future while addressing the issues of project affected persons especially those residing in tribal areas .The aim of the policy is to have a more effective, meaningful and implementable policy that brings in further transparency. better regulation and enforcement, balanced social and economic growth as well as sustainable mining practices. The policy includes provisions which will give boost to the mining sector such as introduction of Right of First Refusal for RP/PL holders: encouraging the private sector to take up exploration; auctioning in virgin areas for composite RP cum PL cum ML on revenue share basis; encouragement of merger and acquisition of mining entities and transfer of mining leases and creation of dedicated mineral corridors to boost private sector mining areas. The policy also proposes to grant status of industry to mining activity to boost financing of mining for private sector and for acquisitions of mineral assets in other countries by private sector.

#### New Facility for Public Viewing of Train Charts and Vacant Berths

To enhance travel experience and bring greater transparency for Indian Railway passengers, the government has launched a new facility for Public Viewing of Train Charts and Vacant Berths. The information about occupancy in trains as per Passenger Reservation Charts will now be available for public view on the internet through IRCTC website (www.irctc.co.in). Complete information of vacant berths from train source as well as intermediate locations will be available to the user. Prospective customer can use the information for online booking of vacant berths or through TTE as per business rules. This feature is available in web as well as mobile version. The system displays coach layout of 9 classes used in the reserved trains of Indian Railways and more than 120 different coach layouts have been incorporated.

Mr. Rajiv Tiwari, President, National Chamber of Industry and Commerce, Agra welcomed all the dignitaries and guests on the dais. Ms. Sunita Prajapati, Deputy Secretary, PHD Chamber delivered the opening remarks and spoke about the concerns of industries related to GST. Mr. Himanshu Chadha, Senior Associate, NITYA TAX and Mr. Alok Farsaiya, Chairman – GST Technical Awareness Cell, National Chamber of Industry & Commerce, Agra were the speakers at the seminar. The speakers discussed about the changes proposed at the 31st GST Council meeting and CGST Laws effective from January 1, 2019 and February 1, 2019 respectively.

The speakers highlighted key changes such as non-issuance of an e-way bill on failure of furnishing return for two consecutive tax periods (applicable from a notified date), extension in filing GSTR-1, GSTR-3B and ITC-04 till March 31, 2019, claiming input tax credit pertaining to fiscal year 2017-18 before April 20, 2019 and liability to pay GST under reverse charge mechanism by the recipient on security services received from non-body corporates. Further, the speakers also deliberated upon the issue of credit utilization mechanism and its impact on business by paying GST in cash even though there is credit ledger. The discussion moved towards credit restriction on motor vehicles (having approved seating capacity less than 13 persons), insurance, repair & maintenance of services received thereon. Moreover credit on canteen services, water, and insurance is allowed if the same is bound to be provided.

Lastly, speakers shared their insights on the complexities faced and the efforts required by businessmen while preparing the Annual return.

During this month, 146 ICTC, 69 RPR, 4 review meetings, 8 demand generation meetings and 2 DIC meetings, were also conducted. A total of 345 patients attended the STI clinical services. 



#### Budget for Poor, Farmers, Middle Class and Youth



While congratulating the Prime Minister of India Narendra Modi, Finance Minister Arun Jaitley and Interim Finance Minister Piyush Goyal, Mr Rajeev Talwar, President, PHD Chamber of Commerce and Industry, said in a press statement issued here on Friday, that this Interim Budget is the budget for all the citizens of India as it has focused on the livelihood of the poor, addressing the distress of the farmers, increasing the income level of the middle class, reforms in the promising housing and construction sector and creating employment for the

Increase in investment in one residential house to two residential houses with the benefit of rollover of capital gain tax upto Rs 2 crore, once in a lifetime is a great reform for the hous-ing and construction sector. This would enhance the employment opportunities for the unskilled, semi-skilled and skilled workforce in the country, said Mr Rajeev Talwar.

Extension in the period of exemption from levy of tax on notional rent, on unsold inventories, from one year to two years, from the end of the year in which the project is completed is encouraging as it will give an impetus to the real estate sector, said Mr Talwar. Increase in allocation to Rs. 64,587 crore for capital expenditure in railways would not only modernize the railways but would give an impetus to Make in India and create employment opportunities, said Mr Rajeev Talwar. Digitalization of one lakh villages in the next five years would enhance speed of the economy and spread awareness of the policy environment at the grassroot level, added Mr Talwar. The increased allocations for MGNREGA to Rs. 60,000 crores in 2019-20 would enhance rural employment and rural demand, said Mr Rajeev Talwar.
