## PRESIDENT'S MESSAGE

Friends,

As we step into the New Year 2021, I take this opportunity to wish our members a very happy and healthy New Year. We look forward to a year of hope and prosperity after the worldwide challenges we faced last year, due to the COVID-19 pandemic. As Socrates once said, "The secret of change is to focus all of your energy, not on fighting the old, but on building the new." The New Year gives us an opportunity to start afresh with renewed optimism, confidence, and enthusiasm, to focus on the priorities COVID brought to the fore and aspire for a healthier, more harmonious and progressive society. To realize our aspirations for India, we must work, united. The Chamber and I are eager to plan new strategies, advocating constructive policies and ideas to the government, for creating conditions for India to become a prosperous and sustainable nation and achieve the US \$ 5 trillion target in the next few years.

Recovering from the daunting impact of COVID-19, the Indian economy has exhibited stronger-thanexpected pick up in recovery over the past two months. The policy measures undertaken by the government during the last nine months enhanced economic activity to a significantly higher level. PHDCCI's GPS Index shows that GST collections, passenger vehicle sales and SENSEX were at a 33 months high in December 2020, indicating India's attractiveness to foreign funding agencies. Strong boost was observed in recent months in the production of cement, steel, consumer durables and capital goods from the lows of April 2020. I must highlight that the comfortable external balance position of India supported by surplus current account balances, resumption of portfolio capital inflows on the back of robust FDI flows and build-up of foreign exchange reserves are also comforting factors. Further, the Chamber's EBM Index (Economic and Business Momentum Index) forecasts a higher growth trajectory in FY 2021-22, reaching 7.7%.

I laud India's leadership for taking decisive action as the country gets set to begin the world's largest vaccination drive against the Coronavirus. India's drugs regulator has approved the Oxford COVID-19 vaccine Covishield, manufactured by the Serum Institute, and indigenously developed Covaxin of Bharat Biotech, for restricted emergency use in the country.







I am of the view that though the economy has exhibited strong signs of recovery in recent months, however, to sustain the momentum, there is a need to lower interest rates for consumers and businesses, lesser compliances for MSMEs vis-à-vis ease of doing business and reduction of taxes, to increase the personal disposable income of the people. I also suggest that the value chains of MSMEs should be enhanced, making them more structurally competent, thus contributing to the country's overall export growth momentum.

I also opine that the financial sector's focus should be on ensuring hassle free disbursements of loans vis-à-vis enhanced liquidity MSMEs, especially in rural sectors. The Government's encouragement of India's participation in global value chains through productionlinked incentives (PLI) for targeted sectors is a noteworthy initiative. The Chamber appreciates the provision of Rs 1.46 lakh crores under Production Linked Incentive (PLI) Scheme for 10 champion sectors as it will help link India to global economies, encourage exports, give companies a competitive edge in the international market and make India a global manufacturing hub. These reforms aim to have a multiplier effect on the economic growth trajectory through enhanced demand, job creation, increased private investments, escalated exports and growth of sectors that have strong backward and forward linkages.

The Union Budget 2021-22 is being presented next month at a very crucial time when the Indian economy is on the recovery path. A 10-pronged strategy has been proposed by the Chamber to Hon'ble Finance Minister, Ms. Nirmala Sitharaman, which includes refueling consumption and demand, encouraging private investments, front loading of infrastructure investments, establishing Development Funding Institutions to fund industrial investments, infrastructural strengthening MSMEs, reducing the costs of doing business, ease of doing exports, increasing tax to GDP ratio, focus on agriculture and rural sector and reforms in social infrastructure.

Robust growth of infrastructure is the key ingredient to realize the vision of Aatmanirbhar Bharat. This

will also have a far-reaching impact on generating demand in the economy and thus help in mitigating the effect of COVID-19. The Government should consider raising investment funding for the National Infrastructure Pipeline through borrowings from overseas markets by issuance of overseas bonds both in Rupee and Forex denominations as also by attracting FDI into the DFI by inviting reputable Sovereign Funds and large pension funds etc through an SPV that could act as a mega Development Financial Institution.

We all would agree that special support to the Tourism industry is also the need of the hour as this sector witnessed massive distress over the past year.

Focus needs to be increased on export competitiveness and better connectivity with the Global Value Chains. Time is most opportune for India to capture a bigger share in the world economic system. Furthermore, focus should be on building the value chains within the country instead of importing components. This will increase our economies of scale, reduce costs, ensure quality & dependability, increase traceability and help in maintaining speed of delivery.

I opine that at this juncture, there is an urgent need to resolve the issues related to the new farm laws through open dialogue between the farmers' organizations and the government. An important point to note is that the initiatives announced for the development of the agriculture sector including Soil Health Card Scheme, National Agriculture Market (e-NAM), Pradhan Mantri Fasal Bima Yojana, Pradhan Mantri Krishi Sinchai Yojana, Micro Irrigation Fund, schemes for livestock & fishermen, among others are highly commendable and should be conveyed in the right spirit to the farmers and their associations through awareness building. Further, recent reform measures for agriculture sector including removing the norm for farmers to sell agricultural produce only to licensees of the amendment of Essential Commodities Act, agriculture marketing reforms, and promotion of herbal cultivation will help to double the farmers' income.

We need to become a global factory in every vertical and have a youthdriven workforce that is passionate towards building a prosperous nation. India has an abundance of natural and food resources to cater to national and international demands. We need to create opportunities for employment & entrepreneurship and skill development among the working citizens and make sure their capabilities are utilized to the best.

Implementation of digital platforms such as Aarogya Setu and e-Office backed by robust ICT infrastructure has helped the country reduce hardships caused by the pandemic. From judiciary and education to tele-medicine, many sectors have switched to the virtual mode. The government is using information technology as one of the most vital tools to deliver a variety of services to its citizens and to keep the wheels of the economy whirling.

I can't emphasize enough the need for robust health systems and increased spending in this sector to build hospitals, manufacture and procure medical equipment, also increase the number of medical colleges across the country and other such reforms. COVID-19 made us all realize that health is our foremost priority, and thus my gratitude to the medical professionals and allied services who have been our heroes, working tirelessly throughout the pandemic, ensuring the safety and health of us and our loved ones.



We all must remember that 2021 is essentially all about rebuilding and strengthening our economic environment. In words of the famous musician, Price, "Every day I feel is a blessing from God. And I consider it a new beginning. Yeah, everything is beautiful".

Let us hope and pray that the New Year will enable us to overcome the menace of the corona pandemic and move forward in making India a global economic power.

I would like to thank all the industry members and the secretariat for facing the challenges COVID-19 bought and acknowledge the burden PHD Chamber employees shouldered with great professionalism. Hoping each of us will strive to boost healthcare and the economy, and thereby reinvigorate India's development.

### VIRTUAL NATIONAL MINING SUMMIT

he Minerals and Metals Committee of PHD Chamber organized a virtual National Mining Summit on November 18, 2020 on the theme - Reforms for Atma Nirbharta in Mining Sector. Mr. Dharmendra Pradhan, Hon'ble Union Minister for Steel and Oil and Natural Gas was the Chief Guest and Mr. Faggan Singh Kulaste, Minister of State for Steel was the Guest of Honor.

The mining, coal, and petroleum sector has been one of the prime focus sectors in terms of development and reforms in the past few years. Our steel consumption per capita globally has grown over the years and our market has more capability deliberated, Mr. Dharmendra Pradhan, Hon'ble Union Minister of Steel, Petroleum & Natural Gas. The Minister, while talking about reforms, mentioned that the bidding

system has helped in equal distribution of the revenue. He mentioned that we need to exploit, access, and monetize the natural resources at the same time leverage technology, transparent bidding process making India costcompetitive so that raw materials are available with ease. He emphasized that while India is becoming selfreliant, we need to make India a global manufacturing hub for which we need to monetize the mineral resources of the country and make the process more simplified. We need to make this sector more profitable so that business investments can be increased in this sector.

Guest of Honor, Mr. Faggan Singh Kulaste, Hon'ble Minister of State for Steel mentioned that India is a land of resources. While some of the resources are available abundantly, many need the intervention of international markets. Under the visionary initiatives of Mr. Narendra Modi, we are progressing towards making India Atmanirbhar and, for the same, there are a lot of reforms and developments taking place in the mining sector. He said that the government wants the intervention of the private sector in the auctions and India needs to work in the coal sector. He mentioned that the Government is in constant talk in introducing systematic reforms, leverage ease of doing business and making India self-reliant in the times to come.

Mr. Jayanta Roy, Senior Vice President, ICRA while presenting the Knowledge Report talked about the current status of the mining sector, key challenges, recent government interventions, key opportunities, rebooting for reforms 2.0 and changes proposed in the MMDR Act 1957. He



also talked about the importance of the mining sector in the economy, employment generation, and its linkage in other sectors as well. Talking about some of the challenges, he deliberated about the slow regulatory approvals, risk in capital blockage, environmental clearance, limited investments in mineral exploration, sub-optimal investments in technology, and others. He gave a detailed outlook about the key policy changes implemented recently in the mining sector paving way for the betterment of the industry with reforms such as iron ore and. commercial coal mine auctions helping India to step up in the global market.

Mr. Sanjay Aggarwal, President, PHD in his Presidential Address complimented the Government of India for announcing bold structural reforms in the Mining sector that will go a long way in making India 'Atma Nirbhar' in mining, coal, and steel sectors.

He mentioned that the reforms are likely to boost the production of various minerals by introducing competition, transparency, private sector participation, and an increase in foreign investment. The government announced а composite exploration-cum-mining-cumproduction regime under which 500 mining blocks will be offered through the open and transparent auction route through amendments to the Mines and Minerals (Development and Regulation) Act. Mr. Aggarwal emphasized that the Summit aims to bring policymakers and

bureaucrats from Central and State Governments and entrepreneurs on a single platform to deliberate on the benefits of the reforms announced by the Government recently and give recommendations for circumventing challenges posed by the recent disruption in the sector.

Mr. Anil Chaudhary, Chairman, Minerals & Metals Committee, PHD Chamber while giving an industry outlook, its challenges, and way forward, deliberated about the role of mining in the development of the nation. He mentioned that India is blessed with good resources of iron and, it is one of the largest miners of iron. He mentioned that Atma Nirbhar Bharat is a concept that everyone has to carry forward and the mining sector can be one of the major contributors in making India self-reliant.

Mr. Naveen Jindal, Co-chairman, Minerals & Metals Committee, PHD Chamber delivered the vote-of-thanks to all the delegates and talked about the need for stringent policies in the coal sector so that it benefits all and particularly the Industry itself.

The first technical session on Reforms for Atma Nirbharta in Mining Sector: Central Government's Perspective was addressed by Ms. Ravneet Mann, VP, Invest India, who spoke about how the Mining sector would be benefited due to reforms; Mr. VR Sharma, MD, JSPL, spoke about the importance of logistics in the Mining sector and appealed for One Nation, One Electricity Traiff. Mr. Vijay Jhanwar, MD, Vraj Metaliks, informed that when the auction process

started, unrealistic prices were quoted which was not the case in auctions which were carried out in November 2020. According to him, even after reform measures were implemented, various other factors like Centre – State coordination, prompt forest clearances and reduction in steel prices were essential for creating a robust mining and steel sector.

The second technical session on Reforms for Atma Nirbharta in Mining Sector: State Government's Perspective was addressed by Mr. Sameer Visnoi, IAS, Director, Geology and Mining, Government of Chhattisgarh, who stated that reforms were required on the procedure for giving forest clearances and suggested that various approvals should be granted to the winners of auction process promptly. Mr. Surender Kumar, IAS, Principal Secretary, Steel & Mines, Government of Orissa advised that the policymakers should take a long- term view of Atma Nirbharta (like if a mineral resource is required till next 50 years, it should be optimally mined so that India does not have to import it till 2070). He suggested that we should consider utilizing low grade minerals also by using technology.

The Summit was moderated by Dr Yogesh Srivastav, Principal Director and Mr. Rakesh K Gupta, RD, PHD Chamber. The summit was sponsored by JSPL and SAIL and supported by Invest India. ICRA was the Knowledge Partner.







INTERACTIVE SESSION WITH MS AILEEN NANDI, MINISTER COUNSELOR FOR COMMERCIAL AFFAIRS, EMBASSY OF UNITED STATES OF AMERICA

s. Aileen Nandi, Minister Counselor for Commercial Affairs, Embassy of United States of America interacted with the members of the Managing Committee of PHDCCI on December 16,2020.

Mr. Sanjay Aggarwal, President, PHDCCI introduced Ms. Aileen Nandi, assumed the position of Minister Counselor for Commercial Affairs, US Embassy in December 2018. She manages Commerce Section's seven offices throughout the country with a staff of 70 people including colleagues from the U.S. Patent and Trademark Office, the Bureau of Industry & Security and the U.S. Trade and Development Agency and oversees U.S. commercial policy engagements with the Government of India. Ms.

Nandi has extensive India expertise, with previous stints as Principal Commercial Officer in Kolkata and Chennai.

The President highlighted that PHDCCI had released a Research Paper titled "The Future of Expanding India-USA Bilateral Relations; Strengthening bilateral ties through Free Trade Agreement" which brought to the fore ever-expanding complementarities and synergies between India and the US.

Ms Aileen Nandi expressed her gratitude for the opportunity to interact with the members. She spoke on the topic," US Trade and Commerce: The New Horizon" which assumes significance in light of the President elect of US, Mr. Joe Biden. Ms Nandi highlighted that India-US have strong relationship from the past and will continue to have it. The strong people-to-people ties between the countries, reflected by a four million strong Indian American diaspora are a tremendous source of strength for the partnership.

She highlighted that India and US cooperate closely at multilateral organizations including the United Nations, G-20, ASEAN Regional Forum, International Monetary Fund, World Bank and World Trade Organization. She appreciated India's growth in Aerospace Defence, Health Sector, Cyber Security which are tremendously contributing to the success story of the country. She highlighted that even though the pandemic has slowed down the process, however every crisis brings opportunities. In order to realise the full potential of relations, the two governments will strive to complete the unfinished agreements and set the course for a Comprehensive Strategic Global Partnership. She also mentioned that One Physical Summit is being planned in June 2021 as the vaccination will be rolled out till then and people will not be scared to meet in person.

Mr. Pradeep Multani, Senior Vice President, PHDCCI proposed a hearty vote- of- thanks to her.





### **VIRTUAL NATURAL GAS CONCLAVE**

he Hydrocarbon Committee of PHDCCI organized a Virtual Natural Gas Conclave on November 3, 2020. Mr. Tarun Kapoor, Secretary, Ministry of Petroleum & Natural Gas was the chief guest at the conclave.

Mr. Sanjay Agarwal, President PHDCCI in his welcome address gave an overview of the current Gas Market and highlighted that power, fertilizer, industrial, and CGD sectors are expected to have the highest contribution in the demand for Natural Gas and thus help future growth.

Mr. V.K Mishra Co-chairman, PHDCCI & Director Finance, Petronet LNG gave the Industry perspective and highlighted the various endeavours taken by the Government to increase India's contribution to its energy basket. He concluded his remarks by emphasizing on having Natural Gas under the GST ambit.

Chief Guest, Mr. Tarun Kapoor, Secretary, Ministry of Petroleum & Natural Gas talked about various opportunities for manufacturers in the Indian Gas Network. He further advised that industries that use other fuel can shift to Gas and help India take a step closer towards a Gas based Economy. He further spoke about various policy reforms/frameworks that are in process for buying and selling Natural Gas. He also spoke about TSO, various Gas Networks, Domestic Gas production, Gas Pricing and said that switching from fuels will be good for all Industries and the Environment.

Rajeev Kumar Mr. Mathur, Executive Director Corp Affairs/AM, GAIL discussed the need to increase per capita energy consumption that will help India to become a gas-based economy. He stressed on the fact that Natural Gas is a fuel of choice and needs to be pushed. He also talked about the various new infrastructures, distribution networks, pipelines, investment opportunities, expansion of CGD sector and how third party access to pipelines will be beneficial. He concluded by saying that new fields under OALP have given a lot of market and pricing freedom.

Mr. A K Jana, Managing Director, Indraprastha Gas Limited mentioned that targeting the transport system will help to increase the consumption of energy and strengthening infrastructure will help to increase energy production. He also emphasized replacing LNG with many energy resources that will help to increase India's energy mix.

Mr. Nakul Raheja, Country Head, Shell Energy India deliberated the need to secure more energy and at the same time look at the consumption of cleaner energy to tackle climate change. He mentioned that gas can make a difference in climate issues and needs to focus to strengthen its growth in sectors like power, industries, and transportation. He also mentioned that gas plants are quicker and cheaper to build and globally, gas plays a pivotal part in the power mix.

Mr. Pawan Kumar Tibrawala, Cochairman, Hydrocarbon Committee PHDCCI delivered the formal vote-of-thanks to the delegates.

The session was moderated by Dr Ranjeet Mehta, Principal Director, PHDCCI and was attended by many industry stalwarts from India and abroad.















## WEBINAR ON HEALTH CONCERNS OF MSME IN PRESENT ENVIRONMENT

he MSME Committee of PHDCCI in association with HopeQure Wellness Solutions organized a webinar on 'Health Concerns of MSME in Present Environment' on November 5, 2020. The objective of the webinar was to learn how to handle anxiety caused due to the pandemic and handle depression during the ongoing pandemic and discuss business reviving strategies.

Mr. Mohit Jain, Chairman, MSME Committee, PHDCCI said that India will suffer from a massive mental health crisis due to unemployment, alcohol abuse, economic hardship, domestic violence and indebtedness. While this will affect most of the population, it will disproportionately affect the poor, most vulnerable and the marginalized groups.

Mr. G L Agarwal Founder, Social Action Foundation shared the challenges faced by MSMEs due to changing business scenarios.

Mr. Vivek Sagar, MD & CEO (HopeQure), India talked about the corporates employee wellness Program for management that helps employees in improving their productivity. He said according to the World Health Organisation reports, each year India contributes to around 2.2 lakh cases of suicides.

Dr Amandeep Goyal, MD & Psychiatry said the need of the hour is to sensitize and educate individuals about the signs and symptoms of mental illness while normalizing the idea of seeking support for themselves and their loved ones.

Dr Pinky Goswani, Senior Clinical Psychologist said that open discussions and dialogue with the general public are needed on the subject, which will in turn help create a more inclusive environment for people with mental illness.

Mr. D P Goel, Co- chair, MSME Committee, PHDCCI said that we need to teach our youth that having a mental health issue is as normal as having a cold. They need to talk freely and support their peers.

Dr Ranjeet Mehta, Principal Director, PHDCCI stated that approximately 125 million Indians are affected by mental health issues, including 56 million suffer from depression and 38 million suffer from anxiety disorders.





### E-CONCLAVE ON DECODING LABOUR CODES

HDCCI organized an E-Conclave on 'Decoding Labour Codes' on November 6, 2020 to sensitise Industry and deliberate on key features of the three labour codes and its coverage and applicability & Compliances and Statutory Provisions for Employers under the Codes on the Industrial Relations Code, 2020; the Code on Social Security Bill, 2020 and the Occupational Safety, Health and Working Conditions Code, 2020. The government plans to bring into effect new labour laws across the country from April 1, 2021.

Mr. Sanjay Aggarwal, President, PHDCCI in his presidential address said that labour reforms introduced are comprehensive and progressive, marking a huge step forward in the IR ecosystem of our country. He further said that these reforms are meant to enhance the employment

landscape, in addition to giving a fillip to investments and sustainable growth. He asserted that in this new regime the Central Government, State Governments, Trade Unions and Employers need to play a crucial role, ensuring Social Security of workers and the Sustainability of Businesses and Jobs.

Mr. Ravi Wig, Mentor, HR & IR Committee, PHDCCI deliberated on the industrial relations legacy of India and said that for going forward, we have to understand our rich and diverse working culture of the past. He asserted on the idea of Udhyog Parivar, wherein workers and employers should be considered as the part of one family for harmonious industrial relations.

Mr. R P Singh, Chairman, HR & IR Committee, PHDCCI supported

the concept of Udhyog Pariwar and complimented the government for consolidating central labour laws into labour codes to reform the archaic labour laws and to facilitate the ease of doing business in India.

Mr. Alok B. Shriram, Past President, PHDCCI said that reforms introduced in the three labour codes are progressive and emphasized that for the new Codes to make the most impact on job creation, it is essential for State governments to ensure their effectiveness.

Mr. Anil Khaitan, Past President, PHDCCI supported the legislation and said that the multiplicity of trade unions in one factory should be banned; there should be the concept of one factory-one trade union.

The technical presentation on the three labour codes was given by Mr. Harvinder Singh, Advocate- Labour Laws Advisor and Ms. Raavi Birbal, Advocate- Supreme Court of India.

The session was moderated by Dr Jatinder Singh, Director, PHDCCI.



















### DIGITAL HEALTH: THE FUTURE, SERIES III ON MOBILE DIGITAL HEALTH DEVICES: THE COVID-19 PANDEMIC IMPACT AND MOBILE DIGITAL HEALTH ROADMAP

HDCCI organized a webinar on "Digital Health: The Future, Series III on Mobile Digital Health Devices: The Covid-19 Pandemic Impact and Mobile Digital Health Roadmap" on November 11, 2020.

Mr. Pradeep Multani, Senior Vice President, PHDCCI welcomed all the esteemed panellists and talked about the global healthcare emergency due to COVID-19 which has exposed the gaps in handling Pandemics even in the most advanced economies of the world. Mr. Multani said that the wearable medical device market is expected to reach more than US\$ 27 million by 2023, a spectacular jump from almost US\$ 8 million in 2017. Mr. Multani further added that numerous apps are now available to assist Healthcare Professionals (HCPs) with many important tasks, such as information and time management; health record maintenance and access; communications and consulting; reference and information gathering; patient management and monitoring; clinical decision-making; and medical education and training. However, lack of standards and regulations, limited guidance from physicians in selecting

healthcare apps, and resistance from traditional healthcare providers are some of the key factors restraining the growth of the market.

Dr N. Subramanian, Chairman, Health Committee, PHDCCI & Director, Medical Services, Indraprastha Apollo Hospitals talked about the benefits and role of Digital Health / Tele-Health technology in several consultations, medical education, cross consultations and many more. Dr Subramanian informed that the first tele health centre was established in Aragonda in the year 2000 and after that there was not much improvement but as the pandemic affected the world, controlled centres were set up in the remotest parts of India. He further said that WHO has recognized the health hazards of healthcare workers and adopted the tele-health technology. He further said that tele-health significantly addressed the major healthcare challenges like accessibility, availability and affordability. Dr Subramanian shared that the expenditure of USD 45 trillion arising from only treatment of the Non-communicable diseases can be minimized by the use of digital health technologies.

Mr. Levi Shapiro, Founder, Health Israel, talked about the major healthcare challenges that arose in 2020 and particularly COVID-19 which has obscured many longterm structural needs in the health sector. Mr. Shapiro talked about how the Healthtech investment transformed during these times from telemedicine to software applications to personalised medicines using AI and Big data. He mentioned that Covid has been very beneficial for Digital health Start-ups, where the total funding reached an all time high with telemedicine funding getting a three times boost. Mr. Shapiro talked about the ecosystem provided to health tech start-ups and the Israel advantage from prototype to commercialization.

Dr Jitendar Sharma, Managing Director, AMTZ said that mobile digital health is not a product, it's a process. Dr. Sharma said mobile digital health is a spectrum through which multiple products can be fitted which leads to a desired outcome. Dr Sharma talked about three baskets of digital health innovation starting from traditional & evolving telemedicine program to



smart wearables to the penetration of mobile health in medical equipments. He shared the details of EMRAI (Electronic Medical Records Alliance of India), which consists of two parts, the provider and service user part for accessing the patients records. Dr Sharma mentioned that there is a need for creating a platform so that it becomes easier for any hospital for getting the records of the patients for which small hospitals in rural areas need to adopt the electronic medium.

Dr Sharma also mentioned that EMRAI has been supported by Ministry of Electronics and IT and also created a Centre of Excellence at AMTZ and are happy to associate with PHDCCI.

Dr Deep Goel, Senior Director, Dr. B L Kapur Memorial Hospital talked about role of digital health and Artificial Intelligence combining together with Digital Health and it could benefit in various ways especially in rural areas, where these services are not available. Dr Goel also talked about critical care and home care, where the Digital Health could be very beneficial for better output. He also talked about the new applications and products like smart bedsheet which can seamlessely record patient data like BP, Heart rate, etc and transfer it to the monitor, which lessens the doctor / nurse visit to the patient.

Dr Goel expressed that teleconsultation is the future for India and combining it with AI can be another game changer but a lot needs to be done to make it useful and easily available for every common person. Dr Goel also talked about personalized treatment of a disease for a particular person which can be possible with Mobile AI devices including robotic surgery. Dr Goel further shared that the digital health future is exciting and there's a need for creating opportunities for making a better life of a common man by improving primary and secondary health care needs.

Dr Harvinder Popli, Co-chair, Health Committee, PHDCCI & Director, School of Pharmaceutical Science, DPSRU delivered the vote-of-thanks to all the panellists and also talked about the release of Digital Health guidelines by MoHFW, Govt. of India & WHO guidelines on Health.

The session was moderated by Mr. Vivek Seigell, Principal Director, PHDCCI and he shared the PHDCCI support of playing a critical role to create the Centre of Excellence for Digital Health with AMTZ at Vizag.

### ECONOMIC REFORMS AND POST COVID-19 GROWTH

HD Chamber organized an interactive session on 'Economic Reforms and Post COVID-19 Growth' on November 18, 2020.

Dr Arvind Virmani, Renowned **R**conomist and Chairman, EGROW (Foundation of Economic Growth and Welfare), said that the economic growth trajectory is expected to be strong and positive in the coming quarters on the back of recent Government reforms. These reforms show the Government's intent to re-accelerate GDP growth and put India on a significant position in the world economic system. Dr Arvind Virmani discussed about the history of economic reforms since 1980s. He highlighted a few noteworthy economic reforms undertaken by the Government including GST implementation, reforms in Insolvency and Bankruptcy Code (IBC), reforms in natural resources sector, emphasis on digitization, among others. He characterized the recent Government reforms, including corporate tax rate cut, increase in private competition, strategic industry policy framework, new education policy, among others as big bang reforms.

With regard to the difficult times amidst COVID-19, he suggested a few potential reforms for 2021, such as simplification of GST, rationalization of direct tax code, preference to direct cash transfer schemes, focus on

ease of doing business, strengthening financial sector, among others. He was of the view that factors such as de-globalisation, supply chain diversification, need for dualistic trade policy, digitization, etc. reflect a huge opportunity for India to emerge as a strong global player.

Mr. Sanjay Aggarwal, President, PHDCCI, appreciated the government for undertaking proactive and fast track measures to safeguard its people, economy, trade and industry against the wild tide of pandemic COVID-19. He mentioned that the series of stimulus announcements by the Government under the AatmaNirbhar Bharat Abhiyaan 1.0, 2.0 and 3.0 along with the measures undertaken by the RBI has taken the total stimulus package to the level of around Rs 30 lakh crores. Mr. Aggarwal stated that the recovery in the key economic and business indicators on the back of string of economic reforms announced by the Government in the last 7-8 months, has instilled expectations of a strong, sustainable and even positive growth in Q3 FY2021 with robust resumption of the lost economic activity. He concluded by suggesting that there is a need to enhance the share of actual cash benefit of the stimulus and infrastructural investments by the Government.

Dr Charan Singh, Renowned

Economist, Non-Executive Chairman of Punjab & Sind Bank and Chief Executive, EGROW, said that MSMEs have a significant role to play in the coming times and therefore, they need to be facilitated effectively. He advocated that government should plan and execute establishment of India Institute of Entrepreneurship on the same lines as Indian Institute of Management to tap young demography of India to start their enterprises. He stated that nonbanking financial institutions (NBFCs) have a crucial role in supply chain of finances. He emphasized that there is a need to have an alternative for China at the global front. He suggested that India should work on attracting foreign companies into the country and in this regard, Indian embassies in various countries should be vocal about potential of India. He highlighted the importance to create clusters, especially in the North and North-east India to cater to USD 5 trillion economic size in times ahead.

Mr. Pradeep Multani, Senior Vice President, PHDCCI, said that the Government along with RBI has announced various bold monetary and fiscal measures in a calibrated manner to help the country fight against COVID-19 and support the robust resumption of the lost economic activity. He emphasized that focus is required on enhancing ease of doing business in the country. In the post-COVID scenario, there would be noticeable changes in the global supply-chains and India should focus on capturing a significant share in the world economic system.

Dr S P Sharma, Chief Economist, PHDCCI stated that the COVID-19 pandemic has affected the whole world ecosystem. At this juncture, there is a need to discuss the economic reforms undertaken by the Government in recent times as well as in last few years to see how the country's economic trajectory will transit from slow to fast to fastest in the coming times.





## SESSION WITH THE HON'BLE MEMBERS OF PARLIAMENT ON 'ATMANIRBHAR BHARAT'

he Parliamentary Forum of PHDCCI organized an interactive session with the Hon'ble Members of Parliament on 'Atmanirbhar Bharat' on November 19, 2020.

through Ayurveda immunity boosting measures.

Mr. Arvind Varchaswi, Chairman, AYUSH Committee, PHDCCI in his welcome address talked about integrating modern medicine with Ayurveda & Homeopathy systems of medicine along with role of our traditional healthcare systems including Yoga. 

Mr. Khaitan added that 5G will be a key driver for the Indian industry towards a better future and will help drive sustainable economic growth and define India's next decade of innovation. 5G could be critical in enabling businesses to maintain operations and remain resilient & agile in the phase of any future destruction.

Mr. S.K Gupta, ITS, Secretary, Telecom Regulatory Authority of India



(TRAI) deliberated that 5G is a very important technological development and a combination of Artificial Intelligence, Internet of Things, cloud services and data explosion. He spoke about how telecom has become a vital backbone of our economy and even the development of a country's GDP depends on it. Fast deployment of 5G is required and enhanced mobile broadband and latency applications etc. will lead to better adoption as people are more than ready for it.

Throwing light on some of the challenges and precautions that we need to take in order to adopt 5G, Mr. Gupta further added that data privacy and data security are needed to be taken care of so as to avoid misuse of data. In order to be ready for 5G, we need to work on proper optical fiber connectivity and bandwidth. He also mentioned that 5G would be a collaborative effort of system integrators, device manufacturers, OEMs, TSPs, ISPs, etc.

Mr. Amit Marwah, Head of Marketing & Corporate Affairs, Nokia India spoke on how this year has given a new meaning to data growth

and on the impact of COVID-19 on 2020 network traffic trends. He also elaborated on how homes & business are connected with 5G by getting home broadband for gaming and HD videos, serving 'ultrabroadband' to areas where fiber-tothe-home (FTTH) is uneconomical and connecting small and medium businesses with guaranteed reliability for business-critical applications. He also mentioned as to how automation and robotics driven use-cases are emerging from the pandemic in the field of manufacturing, healthcare, retail, autonomous vehicles and video analytics. He said that 5G technology will lead to acceleration of Industry

Mr. Pradeep Multani, Senior Vice President, PHDCCI in his presidential remarks deliberated about the need for ease of doing business which would be a major step towards Atmanirbhar Bharat. It would help in Make in India, attract FDI, generate employment and double farmer's income. He suggested some steps for the same, which included single window clearance; reduction in the number of government departments; one-time registration for license; cost aspect reduction and an efficient & speedy justice system. He also spoke about the efforts of the Delhi government in converting parali burning into compost and fertilizers, which have also helped in reducing the pollution levels.

Talking about the effect of COVID-19 on Delhi, Mr. Gupta mentioned that the Delhi government has been putting a lot of efforts to deal with the pandemic. It helped in setting fixed rates in the hospitals for COVID patients, opened plasma hospitals, got more beds available in the hospitals, met all the medical facilities and took every possible measure and precaution to fight with the pandemic. He said that we need to realize that the pandemic is a global crisis and the entire nation needs to come together to fight with it.

He also said that for the smooth

functioning of the industry, the Delhi Government has eliminated inspector raj system so that the industry does not have to go to 30-40 departments for approvals. This has also led to an increase in the revenue of businesses as well. Mr. Gupta added that vocal for local can only be adopted with the help and support of the industry and the whole country has to unanimously work towards building an Atmanirbhar Bharat.

Mr. Ram Kripal Yadav, , Member of Parliament, Lok Sabha, Pataliputra, Bihar, BJP while discussing the initiatives undertaken by their government in Bihar, mentioned that Bihar has progressed a lot in the last decade. Reforms have been undertaken in sectors like infrastructure; water; electricity and

agriculture, which have improved the condition of the state manifold. He also said that unemployment is a sector which is being worked upon and that will automatically improve the economy as well. With the efforts of government and ministries, Bihar will find solutions to its problems and accelerate its development in the times to come.

Mr. Rakesh Gupta, Chairman-Parliamentary Forum while moderating the interaction with the MPs, deliberated about the effects of pollution in Delhi and how the pandemic is affecting the economy.

### AIR QUALITY OF DELHI NCR AND DEVELOPMENT OF AIR QUALITY STANDARDS

PHD Chamber organized an interactive video conference on 'Air Quality of Delhi NCR and Development of Air Quality Standards' with Dr Rakesh Kumar, Director, National Environmental Engineering Research Institute (NEERI) on December 1, 2020. The webinar was

moderated by Dr Ranjeet Mehta,

Principal Director, PHD Chamber.

Mr. Sanjay Aggarwal, President, PHD Chamber in his welcome address deliberated on the poor air quality in the country and mentioned that a majority of the polluted cities are from India. He suggested that industries and plants should adopt renewable sources of energy like wind, solar, hydro, etc. and reduce the usage of non-renewable sources of energy. One should abide by the 3R's (Reduce, Reuse and Recycle) to have a greater impact globally, underlined Mr. Aggarwal. He also mentioned that the focus of India, particularly Delhi and other polluted cities, should be on e-vehicles to reduce air pollution.

Dr J P Gupta, Chair, Environment

Committee, PHD Chamber highlighted that the causes of air pollution in Delhi have been wide-ranging like stubble burning, pollution by BS6 vehicles, power plants, constructional and industrial activities and steps have to be taken to curb it.

Rakesh Kumar, Director, National Environmental Engineering Research Institute (NEERI) gave a comprehensive presentation on air pollution with special focus on Air Quality of Delhi-NCR. He discussed factors responsible for it. Some of them were emissions from construction industries, crematoriums, tandoors, stoves, motorized traffic, industries and factories, open burning of biomass, DG sets, stubble burning and dust particles. He also mentioned that road and construction dust are the dominant sources of PM10 in the city which can be controlled by a combination approach: Mechanical and Sprinkling mixed with dust suppressants.

Talking about the initiatives taken by NEERI towards cleaner air and

reduction in the pollution level, Dr Rakesh Kumar apprised that NEERI has installed an Air Pollution Control system for Crematoria in Nigam Bodh Ghat. NEERI has also installed Wind Augmentation Purifying Units in traffic junctions which collects and purifies the particulate matter. Another great initiative taken by NEERI is Smart Tree-Green pillar, which is an organic light tower of metal framework covered with living plants such as money plant, crassula plant, orchids flowering plant, etc. with a controlled system of drip irrigation so that there is no wastage of water and provides a mist cooling system. These initiatives by NEERI have to be made popular in all the cities to have greater impact in reducing the air pollution, said Dr Rakesh Kumar.

Dr J S Sharma, Co-chair, Environment Committee, PHD Chamber delivered the concluding remarks and thanked Dr Rakesh Kumar for his insightful and informative presentation and all the esteemed panellists and participants.













### E-INVOICING - PREPARATION, CHALLENGES & RESOLUTION

whith the objective of reviewing industry's preparedness and dispelling apprehensions on the new system of E-Invoicing under GST which shall be applicable w.e.f. January 1, 2021, the Indirect Taxes Committee of PHD Chamber organized a webinar on 'E-Invoicing – Preparation, Challenges & Resolution' on December 4, 2020.

Welcoming the delegates, Mr. Sanjay Aggarwal, President, PHD Chamber lauded the Government for ushering the new system of e-invoicing, which will do away with monthly filing of Goods and Services Tax returns. E-invoicing will provide better taxpayer services by restraining multiple reporting and smoothening filing of GST returns.

Mr. Bimal Jain, Chairman, Indirect Taxes Committee, PHDCCI presented the theme for the webinar. He apprised that presently e-invoicing is mandatory for Registered Persons with turnover of Rs. 500 crore or more. From January 1, 2021 it will be compulsory for Registered Persons having turnover of over Rs. 100 crore, and from April 1, 2021, it will be mandatory for all. He mentioned that E-Invoicing system will boost the automation of the GST return filing

process and will provide a direction for Ease of Doing Business and facilitate compliance by taxpayers.

Mr. Puneet Bansal, Managing Partner, Nitya Tax Associates gave a detailed presentation on Challenges in e-invoicing system. He highlighted that from January 2021, E-Invoicing will be applicable on taxpayers with aggregate turnover exceeding Rs. 100 crores and will cover large base taxpayers considering inclusion of stock transfer. He stated that ERP integration and technology upgradation is a major challenge for the government. He apprised on the possible issues that may arise for the supplier on the date of issuance of e-invoice if IRN is not generated within 30 days. Other issues pertaining to ERP integration & technology upgradation; cancellation of e-invoice post 24 hours of generation; autopopulation of details of E-invoice in GSTR -1 and manner of availment of Input tax Credit were deliberated upon.

Ms. Geetika Shrivastava, Executive Partner, Tattvam Advisors made a presentation on the process of generating e-invoice Online and Do's and don'ts for the taxpayers while generating the Invoice. She explained

the process of online generation of e-invoice through the GST E-Invoice system including login, generation, cancellation, bulk generation of e-invoices, process to generate IRN among others.

Mr. N K Gupta, Executive Director, S S Kothari Mehta & Co. made a presentation on the importance of e-invoicing and repercussions for not adhering to E invoicing protocols. He apprised that the new system of e-invoicing will replace manual and periodic reporting of forms; Tax collection and refund can be done seamlessly and will reduce the need for post audit systems.

Mr. Kapil Sharma; Partner and Mr. Gagan Gugnani, Senior Associate, Lakshmikumaran & Sridharan made a presentation on e-invoicing - way forward for ease of business for tax payers and experience world wide of e-invoicing. They shared the features of e-invoice worldwide including the approach, fines & penalties, integrity & authencity and the drawbacks observed across the countries. They mentioned that many countries across the world have adopted standards for e-invoice which are like PEPPOL, UBL-TR, SUNAT etc. (based on Universal Business Language) and Indian schema is based on PEPPOL standard.

Mr. Ashish Chaudhary, Cochairman, Indirect Taxes Committee, PHDCCI delivered the vote- of –thanks to the esteemed speakers.

Mr. Mahendra Rustagi, Cochairman, Environment Committee, PHD Chamber while welcoming Prof Dinesh Singh stressed on the importance of respecting and protecting the environment and also ensure that we do not pollute or damage it.

Prof. Dinesh Singh, Former Vice Chancellor, Delhi University in his key note address deliberated on the dangerous aspects of Climate Change by citing that Greenland is losing ice very rapidly into the Arctic Ocean causing the water level of the oceans to rise. He further highlighted that many Islands have been submerged due to rising sea levels.

He emphasized that the temperatures are rising at a shocking rate in the Polar Region due to the heat absorbed by the water. He further talked about the concept of atmospheric reverse wherein the heat trapped in the atmosphere heats up the oceans which further vaporises the water, which further causes tropical storms damaging the environment even more.

Talking about the recent bush fires, he said that an alarming rate of tree cover loss is taking place which is destroying the tropical forests and is almost equivalent to losing a football field sized area every second.

He also highlighted the harmful effects of plastic on the environment. Tons of plastic is turning up in the oceans which is harming the marine life severely due to the microfibers present in plastic.

Sharing some positive points, Prof. Dinesh Singh said that India has not lost a single species of wildlife and the forest areas have also not declined. He concluded by saying that one must make conscious efforts to preserve the heritage and contribute by helping in maintaining the ecological balance.

Mr. Vijay Kumar V, Managing Director & CEO, NCDEX mentioned the importance of governance and public private investment in the agriculture sector. He stated that connectivity of market should be encouraged enabling a direct link to farmers, multi-

players and industry stakeholders.

Mr. Sanjay Sacheti, Country Head-India Region, Olam Agro India Ltd. stated that the New Farm Bill, 2020 will improve competitiveness of India as an exporting country. He urged the government to ensure awareness programmes so that farmers get educated about the New Farm Bill, 2020 for better implementation.



capital funds for long-term loans.

Dr HP Kumar , Former CMD,NSIC and Advisor, PHD Chamber detailed how to avail credit facility from the government for MSME sector and explained the difference between financing and credit facility. He mentioned the four factors of financing:-(Adequacy of credit facility, timely availability of credit facility, should be economical and should possess easy terms and conditions).

Mr. Vishwa Mohan Jha, Director, MSME DI, Patna, explained the schemes and credit facilities floated by GOI during the Covid-19 for the MSME Sector. Mr. Jha also apprised the participants the importance of Udhayam Registration and how it is mandatory to register to avail the facilities of Government schemes and loans sanctioned for the MSME sector. He also shared the status of MSME sector in Bihar, where the state is ranking number one in MSME registration but still the state lags behind. He underlined that to become more competitive in the global market, all MSMEs need to upgrade technology and quality. He explained how Champion Desk of MSME is working efficiently for helping the MSME sector.

Ms. Kajal Shrivastava, Divisional Manager, MSME Incharge, Canara Bank, spoke about the bank's perspective in disbursing loans to the MSME sector. She also explained the participants what the bank expects from customers while lending loan to industry and entrepreneurs. To run a business, the bank is providing finance, working capital for day-to-day running of business and term loan for upgrading machines. She emphasized that to get one's project financed, the customer needs to have their civil score clear as today the banks are very cautious in recovery.

# PROSPECTS AND CONSTRAINTS IN AGRI STARTUP IN DAIRY SECTOR

he Bihar Chapter of PHD Chamber in association with NABARD organized a webinar on "Prospects and Constraints in Agri Startup in Dairy Sector" on August 27, 2020 in a bid to double the farmer's income by 2022. Bihar is rich in agricultural entrepreneurship and Start-Ups hold the key of harnessing potentialities in Bihar by employment for the youth.

Chief Guest, Dr Rameshwar Singh, Vice Chancellor, Bihar Animal Sciences University, Patna said that NABARD has been a big supporter of Technology Business Incubators (TBISs) for the institute which plays a catalyst role in developing Startups in the dairy sector. There is a lot of scope of allied activities and making a wide range of dairy products.

He called for the need to work on better breeding of animals as Bihar has a lot of cattle and exotic breeds. Dr Singh suggested processing, dairy services, breeding services and fodder production are some of the areas in dairy sector which the youth can explore as there are many prospects in these areas.

Mr. Arun Raste, Executive Director of National Dairy Development Board, (NDDB) emphasized how ration balancing is necessary for animal dieting which can reduce cost and maintain the health of animals. NDDB is also promoting use of ethnoveterinary medicine or Pashu ayurveda (Ayurvedic Veterinary Medicine) to help control animal diseases. The Executive Director informed that even repellents can also be made from it and Semen station is being created and Enterprises can be started to train about artificial insemination.

Mr. Sudhir Kumar, Managing Director, Jharkhand Milk Federation highlighted how COVID-19 has led to the dairy sector making more profits and better livelihood for the farmers. He stated that Off-farm activities have huge scope of employment in this sector, i.e milk aggregator or collector, milk tester for checking of

adulteration, etc. He also suggested that the upcoming start-ups can divide the dairy sector into categories of aggregator and milk production. Rearing centre is another option for Start-ups.

Dr Ravindra Kumar Sohane, Director Extension Education Agriculture University, Bihar emphasized on using local based items to feed the animals by reducing cost of production. He mentioned that the Dairy Entrepreneurship Development being implemented Scheme is by NABARD for generating selfemployment opportunities in the dairy sector. The constraints in the sector are requirement of high capital and investment by the farmers, manpower and labour and lack of required knowledge in this sector. There is also a provision of Agriculture Entrepreneurship Orientation Programme (AEOP) and Start-up Agri-Business Incubation Programme (SAIP) to help entrepreneurs to set up Start-ups.

Dr Pankai Kumar, Deputy Director Training-Bihar Animal Sciences University in his technical presentation explained that there are four components for effective dairy farming, viz improved feeding, management, breeding, farm health & vaccination. He suggested entrepreneurs to focus on reducing cost for profit maximization in the dairy sector because the margin in milk and its products are stable. He said this can be achieved by preparing a complete mix of cattle feeds, it can be produced at own farm rather then buying from the market.

Mr. Santosh Kumar, Director, Anand Sagar Natural Dairy shared details about the Community Dairy Farming and emphasized on using of modern techniques like AI, Data Mining and Block chain for upgrading the sector.

Ms. Ajanta Bhumij, Director Ajanta Dairy Farm P Ltd. shared her success story on how she made her dairy business profitable.

Dr Yogesh Srivastav, Principal Director, PHDCCI delivered the welcome remarks. Mr. Mantosh Singh, Resident Director, Jharkhand State Chapter, PHDCCI delivered the formal vote- of- thanks to the guests. The session was moderated by Ms. Leena Lall, Resident Manager, Bihar State Chapter, PHDCCI.







# INS & OUTS VIRTUAL SERIES: INAUGURAL SESSION ON REVAMPING URBAN INFRASTRUCTURE TO REVIVE INDIAN ECONOMY

he Chandigarh Chapter of PHDCCI in collaboration with the Indian Institute of Architects organized the inaugural session of Ins & Outs virtual series on the theme 'Revamping Urban Infrastructure to Revive Indian Economy' on October 19, 2020.

entertainment.

He further explained that the Smart City concept is built on the fundamental of achieving more from less and for that inclusion of technology from construction to IT / ITES is a must. He informed that the goal of the Government is to improve the quality of life of all the citizens through schemes like housing for all, affordable rental complex and Amrut.

Ar Habeeb Khan, President, Council of Architecture, Government of India mentioned that our urban infrastructure needs to be strengthened to improve the quality of life of people but at the same time rural areas need massive investments in infrastructure to revive the rural economy where 65-70 percent of our population lives.

Talking about urban planning of Chandigarh, Ar Kapil Setia, Chief Architect, Chandigarh Administration mentioned that this city was built in a way that it met the aspirations of the people in every area of life. Urban

Planning in Chandigarh is done with active participation of the people living in the city, he further added.

While moderating the session, Mr. Puneet Narang, Partner, KPMG posed questions related to financing of projects, changing expectations from urban local bodies, IT / ITES changing the way of living in both urban and rural areas and changing requirements of the people. He said that the pandemic has given an opportunity to the urban planners to introspect and look for long term solutions to cope with these kind of situations in a better way.

## LOGISTICS & WAREHOUSING MANAGEMENT - STREAMLINING DEMAND & SUPPLY

he Chandigarh Chapter of PHDCCI organized a Virtual Session on Logistics & Warehouse Management on the theme Streamlining Demand & Supply on November 6, 2020.

Chief Guest, Mr. Pawan Kumar Agarwal, IAS, Special Secretary (Logistics), Ministry of Commerce and Industry, said that COVID-19 pandemic underlined the importance of this sector. He informed that a separate Department of Logistics was created three years back by the Government of India and now they are focusing on integrated and structured development of logistics sector for its transformation. He informed that the Government is working on the National Logistics Policy, which aims to promote seamless movement of goods across the country.

Listing the hurdles in development of logistics sector in the country, he mentioned that poor definition and lack of understanding, absence of rules and regulations, non-standardization of logistics assets, lack of trained manpower and trust

deficit in transporters act as barriers to development of logistics sector in the country.

Mr. Agarwal stated that multimodal transportation, national logistics law to standardize documentation, liabilities transporters, packaging laws and digital transformation are required for boosting the logistics sector. He added that use of inland water wavs and containerization for domestic transportation will go a long way in cutting the logistics cost.

Mr. Agarwal also stressed the need for clean and green logistics by use of alternate fuels in transportation. He also emphasized on the need for specially trained workforce to handle the logistics efficiently.

Mr. Vivek Pratap Singh, IAS, Managing Director, Conware & Punjab State Warehousing Corporation, Director, PLIL stated that at present they are mainly catering to the agriculture sector but would like to move out to other sectors depending on the demand of the area. He said

that Punjab Government is willing to collaborate with private companies to build joint ventures to boost logistics sector in the State.

Mr. Sumit Sharma, Co- Founder, GoBOLT in his opening remarks said that the warehousing and logistics sector in India is projected to attract an investment amount of nearly US\$ 10 billion over the next 4-5 years.

Welcoming the speakers and participants, Mr. Madhu Sudan Vij, Chairman, Chandigarh Chapter, PHDCCI underlined that the objective of the program is to find synergies between the demand from industry and strategies adopted by the Center and State governments to fulfil the same. ## NEW LABOUR CODES: INTERPRET AND IMPLEMENT

he Haryana State Chapter of PHD Chamber organized a video conference on 'New labour Codes: Interpret and Implement' on November 26, 2020. The objective of the program was to apprise industry about new labour codes and how it will affect the industry.

Welcoming the participants, Mr. Pranav Gupta, Chairman, Harvana Chapter, PHD Chamber State mentioned that the New Labour Codes will a go a long way in improving ease of doing business in India and will provide a transparent system to suit the changed business environment. He said that these reforms will lead to reduction in licensing requirements and paperwork as well as costs associated with multiple compliance obligations and their successful implementation will be the key to attracting more foreign investments and to get India's GDP growth trajectory back on track after an unprecedented contraction in Q1 2020-21 due to the extended lockdown under COVID-19.

Mr. Sanjeev Upadhyay, Founder Ubiq Talents apprised that the New Labour Codes will allow industries flexibility in hiring and retrenchment. They will make industrial strikes more difficult by clamping new conditions and also expand the social security net for both formal and informal workers. He said the New Code will also help in speedier adjudication of disputes. Appropriate rules for strikes and lockouts have also been provisioned in the New Code.

Adv Satyaraj Alva, Senior Labour Law Consultant made a detailed presentation to explain the salient features of the New Labour Codes namely Social Security Code, Occupational Safety Code and Industrial Relations Code.

Mr. Harbhajan Singh, Former Director-HR, Honda Motorcycle and Scooters stated that the New Labour Codes provide a balance between interests of employers and employees and it will be the responsibility of States to implement them in letter and spirit. The Wage Code will be applicable to all organized and unorganized


sectors. For Social Security, Gig workers will be registered on the basis of Aadhar Card. There is clarity on retrenchment provisions. He added that the introduction of Fixed Term Employment will boost generation of new employment.

Dr G P Rao, Founder, Good People Relations highlighted that the New Labour Codes have simplified the existing labour laws. The interest of all stakeholders has been taken care of. These will boost Ease of Doing Business in the country and attract new investments. Under the new laws, strike by workers has been made more stringent and flash strikes have been banned. Now the workers can go on strike if more than 50% of the total workers agree to the proposal by giving prior notice. As part of the Social Security, the gratuity amount will be 50% of the gross salary and not the basic pay. For Dispute Resolution, multiple avenues have been provided. The Industrial Tribunal will now comprise equal number of representatives from the management and workers.

Mr. Anuj Aggarwal, Convener, Panchkula Zone, Haryana State Chapter, PHD Chamber & MD, Altruist Technologies Ltd. delivered the vote-of-thanks to the eminent speakers and participants.







#### **TECHNOLOGY TRENDS IN PHARMA INDUSTRY**

He stated that new technology like 3D printing, AI and nano technology are available for up-gradation of pharma sector. He said that barcode technology can be used to check spurious drugs.

Presenting the Government of India perspective, Dr S. Eswara Reddy, Joint Drugs Controller said that as the drug regulations are changing frequently, therefore, technology is





## PROGRAM ON TRADE RECEIVABLES DISCOUNTING SYSTEM



he Haryana State Chapter of PHD Chamber organized a Program on 'Trade Receivables Discounting System' on August 28, 2020 to apprise industry members about the Invoice Discounting Scheme promoted by the Ministry of MSMEs.

Welcoming the speakers and participants, Mr. Mohit Jain, Chairman, Haryana State Chapter, PHDCCI said that MSMEs are the back bone of Indian Economy and despite the important role played by them in the country's overall economic growth, they continue to face constraints in obtaining adequate finance, particularly in terms of their ability to convert their trade receivables into liquid funds. He opined that Trade Receivables Discounting System (TReDS offers a promising platform for solving their working capital issues.

Presenting the industry perspective, Mr. Anil Khaitan, Former,

President and Mentor, PHD-MSME Mentoring & Guidance Centre stated that discounting receivables can be a good source of finance for the cash starved MSMEs, particularly because it is an-off-balance sheet finance. He said that although the Government had mandated all big corporate and Central Government PSUs to register on TReDS platform, but very few have come on board on this platform.

Dr H P Kumar, Former CMD, NSIC and Advisor, PHD Chamber said that although more than 1.3 crore enterprises are registered under GST but the number of companies availing services of TReDS platforms is very low. The reason for this could be lack of awareness. Moreover, the registration fee is very high. Mr. Kumar informed that MSMEs can take assistance from Chamber's PHD-Mentoring and Guidance Centre on various issues ranging from project

conceptualization, training, funding resources, etc.

Mr. Jacob Raphael, COO, M1xchange made a presentation on Registration and Benefits of TReDS Scheme. TReDS is a digital platform that allows small businesses to get access to working capital by auctioning their trade receivables.

Sharing the Government of India Initiatives on TReDS, Mr. Sanjeev Chawla, Director, MSME-DI stated that TReDS is a good mechanism for MSMEs to fulfill their liquidity requirements. The government has launched a CHAMPION Portal to empower MSMEs and address their grievances.

Mr. Lokesh Jain, Chairman, MSME Committee, Haryana State Chapter, PHDCCI delivered the vote- of- thanks to the participants.





#### **EXPORT PROMOTION AND RISK MANAGEMENT**

he Haryana State Chapter of PHD Chamber organized a video conference on 'Export Promotion and Risk Management' on September 25, 2020 to discuss the financial support, risk management and incentive policies of the government for the promotion of exports.

Welcoming the speakers and participants, Mr. Mohit Jain, Chairman, Haryana State Chapter, PHDCCI mentioned that in recent times, India is witnessing slowdown in exports with its traditional partners. Under these circumstances, we need to set in motion strategies and policy measures which catalyze growth of exports in several different sectors as well as in newer markets.

Mr. Anil Khaitan, Former President and Mentor, PHD-MSME Mentoring & Guidance Centre while presenting the industry perspective said that exports are the lifeline of the economy. He lamented that our country has not been able to exploit the full export potential. He added that as a number of risk factors are involved in international trade, therefore, it is important for exporters to have a robust risk management strategy in place.

Briefing about the services offered by PHD Chamber to exporters and

MSMEs, Mr. Saurabh Sanyal, Secretary General, mentioned that PHD MSME Mentoring & Guidance Centre provides capacity building, policy advocacy and virtual incubation services besides helping entrepreneurs for registration on GeM and Udyam portals.

Dr H P Kumar, Former CMD, NSIC & Advisor, PHDCCI mentioned that while India exports over 700 products to 119 countries but the value of exports is very low and does not match the potential that exists in the country. He said that the major reason for low exports is lack of information. He suggested that to jack up exports, relevant information like demand and trends prevalent in various international markets should be made available to exporters through a web portal. He apprised that useful information regarding exports is available on Chamber's MSME portal which can be accessed by the exporters.

Mr. Rakesh Khurana, Regional Manager, NSE informed that MSMEs can raise capital by listing on NSE and create value for their company as well as their investors. Mr. Khurana mentioned that the eligibility criteria for listing on NSE has been simplified and also briefed about the benefits of listing including enhanced visibility and credibility. He also mentioned that the

Governments of Punjab, Haryana, H.P. and Rajasthan offer subsidy to MSMEs for listing on NSE.

Explaining the NSE tools for Forex Risk Management, Mr. Vipul Khujuria from NSE apprised that to protect both importers and exporters from fluctuations in forex value, NSE offers Futures and Options tools.

Mr. Sanjay Kumar, Branch Manager, ECGC made a presentation to highlight the risks associated with international trade and various products offered by ECGC to safeguard the interest of the exporters.

Highlighting the Exports Promotion Schemes of GOI for boosting exports, Mr. Jaipal, Deputy Director, DGFT briefed about the Advance Authorization Scheme and Export Promotion Capital Goods Scheme. ## IMPORTANCE AND SCOPE OF CREDIT RATING FOR INDUSTRY



he Haryana State Chapter of PHD Chamber organized a video conference on 'Importance and Scope of Credit Rating for Industry' on October 22, 2020.

While rating a business, the Rating Agency considers credit history of a company in respect

of long and short term loans, bank guarantees, etc. Exhorting the businesses to get credit rating, he underlined that credit rating will help them not only in getting loans but also in improving management of their company because weaknesses in different aspects of company are highlighted by the Credit Rating Agencies.

Dr H P Kumar, Former CMD, NSIC & Advisor, PHDCCI informed that PHDCCI facilitates its members in getting credit rating and has also initiated a dialogue with major credit rating agencies to reduce the fee being charged by them.

Mr. Abhash Sharma, Director-Head, Mid Corporate, India Ratings made a presentation to highlight the benefits of credit rating for Industry. He said that credit rating is basically the probability of default of a business entity. He said that the rating of proprietorship and partnership goes one notch below the limited companies even when they have the same strengths. He added that credit rating is based on various parameters including liquidity, utilization of bank limits, external liquidity, diverse funding sources, access to capital market, etc. Mr. Sharma informed that in India credit rating has 16 scales that are represented by letters A, B, C and D. The AAA is the highest rating implying that the company is very strong to meet the financial obligations. He added that good credit rating helps the company to improve its corporate image, lowers the cost of borrowing - both from banks and investors and helps in marketing. It also boosts the investor confidence in the company.

Mr. Vineet Kaura, AGM, Commercial Branch, SBI highlighted the importance of Credit Ratings in context with funding from Banks. He mentioned that the credit policy of banks is to identify the risk while extending loan to a company. Credit rating makes it easier for banks to take a decision as credit rating is done by considering the financial management of the company.



He informed that to boost the confidence of his team, his university leveraged technology, started work from home system and initiated the culture of self-monitoring. He further mentioned that their university had launched a campaign for distributing food and sanitizers among the needy which helped in motivating and boosting the confidence of his staff.

Mr. Sandhu urged the business fraternity to adopt value system and ethics in their working. He opined that our country can make great progress if the CSR funds of companies, are sincerely utilized for research and empowerment of people.

He strongly advocated industryacademia interface for proper skilling of students and producing employable workforce. He said that for this purpose, industries should connect with the universities. He informed that Chandigarh University is running an Incubation Centre for supporting new entrepreneurs and start-ups.

Mr. Ankit Kedia, MD, Caremont mentioned that post COVID-19, leadership will be data and empathy backed while preparing business plans and businesses will plan newer ways to face challenges that have been thrown up by the present pandemic. He added that while innovation is important but there is no harm in importing technology and indigenizing the same as this serves as a catalyst and adds to the confidence of the entrepreneurs.

#### EXPORT PROMOTION AND RISK MANAGEMENT

he Punjab State Chapter of PHDCCI in association with the Department of Industries & Commerce, Government of Punjab organized a video conference on "Export Promotion and Risk Management" on August 26, 2020 to discuss issues being faced by exporters during COVID-19 and suggest possible workable solutions.

Mr. R S Sachdeva, Mentor, Puniab State Chapter, PHDCCI while welcoming the distinguished speakers and participants, said that exports from Punjab have been hit due to COVID-19 and exporters need handholding to navigate the current crisis. He added that the State has great export potential and the program has been organized jointly with the Punjab Government to highlight the support available to exporters from Government and Banks.

Chief Guest, Mr. Sibin C, IAS, Director, Industries & Commerce, Government of Punjab informed that "One District One Product (ODOP) Scheme" is being activated to boost exports from Punjab. He informed

that the State is all set to focus on exports under the GOI Atmanirbhar and Make for World Schemes. For implementation of this scheme, District Level Export Promotion Councils are being set up in each district under the Chairmanship of Deputy Commissioners, with representatives from DGFT and Industry Associations. He informed that Punjab is already running cluster development programs for boosting exports.

UK based, Mr. Graham Bonner, Chairman, Gallus Ecom India Pvt. Ltd. apprised that Ecom has a business-to-business portal dedicated to Indian manufacturers and suppliers. Indian businesses can host their goods & services and advertise them on this portal to attract buyers for their products globally. He added that to support the Indian exporters during COVID-19, their company is offering this service free of cost for one year.

Mr. Bonner stated that India has huge resources and has great potential in manufacturing and can easily compete with China. He underlined that excellent quality, competitive pricing and robust supply chain along with good communication are prerequisites for boosting exports.

Dr Manjeet Bhatoya, Deputy DGFT & Indian Trade Service Officer, Directorate General of Foreign Trade (DGFT), Ludhiana gave details of different schemes offered by DGFT for promotion of exports. She gave details about schemes like 'Export Promotion Capital Goods Scheme' under which machinery required for manufacture of export goods, is allowed to be imported, Advance Authorization which allows duty free import of input material for manufacture of export goods, Free sale certificate to facilitate export of medical equipments and drugs. She informed that DGFT also helps in amicable solution of quality disputes between the Indian exporters and foreign buyers.

Mr. Rakesh Suraj, Regional Director (NR), Engineering Export Promotion Council (EEPC) of India made a Presentation to highlight the support offered by EEPC to exporters. He informed that while exports from India have declined in the last few months but in July, they have registered a growth of 8-9% which is a positive sign. He also informed that EEPC maintains sector wise and country wise data of export products and potential markets. This information can be highly useful for exporters. He said that a list of items that were imported





from China and now blocked by GOI is also available with EEPC that can help manufacturers.

Detailing the support provided by ECGC to exporters, Mr. Kuldeep Singh, Branch Manager, Export Credit Guarantee Corporation of India Ltd. (ECGC) informed that ECGC has taken a number of steps like extension of Policy and reduction of 50% fee to help the exporters during the difficult period of COVID-19. He explained that besides providing insurance cover to exporters, ECGC maintains data of buyers and verifies the credit

worthiness of foreign buyers as well as maintains a list of defaulting companies so that Indian exporters can be cautious while dealing with such companies. Mr. Kuldeep Singh mentioned that ECGC also educates exporters on various aspects of export contracts and process for recovering payments from defaulters.

Mr. Vinod Kamra, AGM, State Bank of India informed that SBI has set up a Trade Finance Cell at Mohali which provides e-forex facility to the customers in tricity and surrounding areas. He said that Trade Finance Cell is an online transparent platform where all documents can be submitted online and the rates can be directly booked by the customer himself with the treasury. He informed a similar Cell is also available in Ludhiana.

Mr. Karan Gilhotra, Chairman, Punjab State Chapter, PHDCCI delivered the vote-of-thanks to the guests and hoped that the discussion would help the exporters to enhance exports from the region and contribute to higher economic growth in the coming times.





#### HOW TO PITCH A STARTUP AND PROTECT YOUR IP



Eminent speaker, Mr. Param Kalra, Co-Founder, StartHub Nation, Brio Ventures, Satnam Infosys, Global Shaper explained in detail tips for pitching business ideas/ products to investors with complete pitch deck analysis. The goal of a successful pitch is to have investors begging to invest in your company. When you successfully deliver on what an investor wants, you will have a truly irresistible pitch.

Adv. Geeta Gulati, Trade Marks & Patent Attorney elaborated on the types of Intellectual Property Laws and the need for IP protection before pitching ideas to investors. She mentioned a startup must pitch an idea to an investor, licensee or buyer after they secure patent protection. The reason is that a well prepared patent application would clearly delineate your idea before you pitch your idea. No inadvertent coinventorship situation is created and there is no dispute as to who owns an idea.

Prof. (Dr) P.N. Hrisheekesha, Campus Director, CGC Landran encouraged students to file patent applications to protect their intellectual property.





# INNOVATIVE APPROACH FOR IMPLEMENTING INTEGRATED ENERGY EFFICIENT SOLUTIONS IN INDUSTRIES & FACILITIES

he Punjab State Chapter of PHDCCI organized a video conference on 'Innovative Approach for Implementing Integrated Energy Efficient Solutions in Industries & Facilities' on September 24, 2020 to highlight the economic and environmental benefits of energy efficient technologies.

Mr. Karan Gilhotra, Chairman, Punjab State Chapter, PHDCCI welcomed the speakers and participants and mentioned that saving energy cost by installing better and efficient equipments is the need of the hour as higher energy efficiency reduces operating costs and enhances profitability.

Mr. Mayur Karmarkar, Managing Director, ICA India stated that adopting energy efficient technology is a win-win situation for industry because it not only saves on power cost but also helps in reducing the carbon footprints.

Explaining the energy efficient initiatives & measures adopted by his company to save energy costs, Mr. Ashween Parmar, DGM- Maintenance, Sonalika Group informed that they

have saved hugely by replacing the conventional lights with LED lights and installing energy efficient compressors. He stated that their company started a campaign to educate their workers about the benefits of saving energy and show how they can decrease operating costs.

Delivering the keynote address, Mr. Anil Kumar Choudhary, Head -Operations, Chief General Manager from EESL explained how EESL helps industrial and commercial institutions to identify the type of technology they need to adopt for energy efficiency. He also enlightened participants how EESL helps industries to buy new equipments at a competitive cost. He also explained the Pay-As-You-Save (PAYS) business model of EESL under which upfront payment of equipments is borne by EESL and the company can pay back in easy three year instalments out of the savings from the new technology intervention.

Mr. Vivek Utpal, Senior Manager, EPSL Trigeneration Pvt. Ltd. highlighted that Trigeneration technology involves the combined generation of three types of energy and produces cooling, heat and power simultaneously. He stated that this technology is not only cost effective but also helps in minimizing the impact on environment.

Mr. Abhishek Dhupar, Program Consultant, ICA India stated that his organization is working for improving energy efficiency by encouraging industry to upgrade to better and more efficient IE2 and IE3 motors. He underlined that even a relatively small gain in electric motor system efficiency can result in significant reduction in electricity consumption of individual companies resulting in reduction in input costs and increased profit.

Dr Anant Shukla, AGM, EESL informed about the Super-Efficient Air Conditioning program initiated by EESL under which they help industry and commercial institutions to acquire super efficient ACs at competitive price.

Mr. R S Sachdeva, Mentor, Punjab State Chapter, PHD Chamber moderated the session and posed series of insightful questions to the Panellists.







# CURBING STUBBLE BURNING TO IMPROVE AIR QUALITY IN COVID TIMES



he Punjab State Chapter of PHD Chamber in association with Punjab Pollution Control Board (PPCB) organized a video conference on 'Curbing Stubble Burning to Improve Air Quality in Covid Times' on September 29,2020.

Chief Guest, Prof. Satwinder Singh Marwaha, Chairman, Punjab Pollution Control Board said farmers should not burn crop residue in fields as pollution caused by it may help in the spread of COVID-19.

Prof. Marwaha stressed that maintaining clean environment is the responsibility of every person and it is especially necessary during the COVID-19 pandemic as the smoke helps in spreading the virus. He underlined that stubble burning not only creates pollution but also leads to loss of nutrients and micro-organisms impacting soil fertility. He added that the mandate of PPCB is regulatory and to impose penalty on violators. PPCB has been persuading farmers through campaigns to stop stubble burning.

Prof. Marwaha stated that this year, PPCB has decided to send NSS volunteers to selected hotspots to spread awareness among the farmers.

PPCB has planned to demonstrate experiment of in situ incorporation of stubble by using micro consortia to degrade the crop residue on 500 acres in the four districts of Fazilka, Bathinda, Moga and Ferozepur. He stated that the companies supplying micro consortia have claimed that the degradation period will gradually come down to 15 days over three years period thus solving the issue of farmers.

Appealing to the farmers to curb stubble burning, the Guest of Honor, Dr. J S Mahal, Director of Extension Education, PAU, Ludhiana said that stubble burning cannot be justified. He added that expensive machinery and tools are not necessary for management of crop residue because it can be done easily with the tools available with the farmers.

Earlier, welcoming the Chief Guest, eminent speakers and participants, Mr. R S Sachdeva, Mentor, PHD State Chapter, PHDCCI outlined the objective of the program that is to highlight the need for efficient management of crop residue as burning of the same leads to air pollution impacting both human and soil health.

The Session Moderator, Mr. BM Sharma, Chairman, Agri Committee-Punjab State Chapter, PHDCCI said that curbing stubble burning has assumed more importance in the light of COVID-19 and informed that experts from different parts of India, Canada and US have joined to share their views on this important subject.

Dr V S Hans, Head Renewable Energy Mechanical Engineering, PAU, Ludhiana shared that besides using crop residue as fodder and fertilizer, stubbles can be used in bio gas plants to produce electricity and also to produce bio-CNG in the running of vehicles.

Dr O P Chowdhry, Head-Department of Soils, PAU, Ludhiana said stubble burning not only impacts environment but also affects soil health. Incorporation of crop residue in the soil helps in saving useful microbes, increases water holding capacity of soil and increases soil fertility.

Dr G S Gill, Environmental Engineer, Punjab Pollution Control Board stated that during COVID-19 lockdown, the pollution levels in Punjab were negligible meaning that



the environment can be cleaned if we decrease processes like stubble burning that lead to air pollution. He shared that stubble burning is banned and detailed about the punitive provisions for violation. Dr Gill informed that PPCB has been educating farmers regarding technologies available for crop residue management through banners, literature etc.

Prof. Paramveer Singh, Punjabi University, Patiala shared that he has been campaigning with the help of student volunteers to educate farmers for curbing stubble burning for the last four years.

Dr Lavleesh Garg, Skill Development Centre of PAU, Ludhiana shared details of the training courses and skill development programs being run by PAU jointly with the Crop Residue Management Association and various NGOs.

Dr Rajbir Singh Brar, Director, ICAR-ATARI, Ludhiana mentioned that harmful gases released on burning of crop residue causes air pollution and climate change, which is dangerous as it can help in the spread of COVID-19. Mr. Brar added that although many ex-situ options are available but in situ mixing of crop residue is the best option as it increases soil fertility and the results become evident in three years.

Mr. Manmohan Kalia, Joint Director, Agriculture Engineering-

Department of Agriculture and Farmers' Welfare, Punjab informed that appropriate technology is available for crop residue management and the required machines and tools have been provided all over Punjab for which the State Government has provided funds. There is a need to change the mindset of farmers to succeed in curbing stubble burning, he asserted.

Addressing the conference from California, Mr. Baldev Singh Bhangu, Agri Specialist, Dept. of Food and Agriculture, California & Former Prof. PAU shared that advance and cheap machines for recycling the crop residue are available in US that can be used. Triple press is used to conveniently store the crop stubbles as they occupy less space. He also mentioned that stubbles are also converted into small pellets and used as manure. These advanced technologies will be useful for farmers in India also as besides providing efficient solutions for crop residue management, they will help in iob creation.

Dr Harminder Singh Sidhu, Director, Gadri Baba Dulla Singh Giani Nihal Singh (GBDSGNS) Foundation, Jalaldiwal mentioned that although machines and tools for crop residue management are available for farmers but the technique has not reached them. Besides educating farmers about the benefits of residue management, there is need to train them in the use of technology.

Dr Manjit Singh, Head-Farm Machinery & Power Engineering, PAU, Ludhiana shared the details of farm machinery made available to the farmers in the State.

Mr. Jagdeep Singh Rajoana, a progressive farmer from Ludhiana shared how he has been benefitting by mixing the crop stubble in the fields. He mentioned that his crop yield of potatoes has increased without any additional inputs. Mr. Rajmohan Singh Kaleka, another Progressive Farmer from Patiala shared that farmers need to be educated about the easy technology available for crop residue management so that the menace of residue burning could be curbed.

Mr. Sukhwinder Pal Singh, Executive Director, Sikhar Trading Ltd., Vancouver, Canada suggested that NRIs should be involved in persuading farmers for stopping stubble burning. He said that the farmer himself is the first one to be affected when he burns the crop residue.

Mr. R S Sachdeva, Mentor, PHD State Chapter, PHDCCI delivered the vote-of-thanks to the participants and hoped that the session will benefit all stakeholders and help in curbing the menace of stubble burning.

More than 100 progressive farmers from different districts of Punjab and various agri stakeholders attended and benefited from the programme.









#### STARTUP BOOTCAMP

he Punjab State Chapter of PHD Chamber in association with the Ministry of Micro, Small & Medium Enterprises and Central Tool Room (CTR) Ludhiana organized a Startup Bootcamp, October 22-24, 2020.

Welcoming the participants, Mr. A.P. Sharma General Manager, Central Tool Room (CTR), Ludhiana highlighted the facilities and services provided by their Centre to MSMEs in Punjab. He informed that CTR, Ludhiana provides assistance in tooling, product development and validation with latest technology of 3D printing. Short and long term training courses are also offered by the CTR, Ludhiana to skill entrepreneurs and manpower for MSMEs in the State.

Mr. Sharma informed that during the COVID-19 lockdown, CTR helped in manufacturing of face shields, masks and other COVID-19 related products.

A detailed presentation was made by Mr. Jagdeep Saini, Manager Training, CTR, Ludhiana and Mr. Mrinankush Datta, Incubation Incharge, CTR, Ludhiana about the facilities available at CTR, Ludhiana including metallurgical support and material testing services, product designing & manufacturing, human resource development, etc.

CA Gaurav Singhal, Co-chairman, Taxation Committee, Punjab State Chapter, PHD Chamber & Partner, Heads Up Consulting Pvt. Ltd. made a presentation to explain various types of legal entities and the importance of business formats. He said that business format that Startups adopt is important as it impacts the startup ecosystem, the entrepreneurial spirit and the fund raising capacity of the startup. He stated that like other business entities, a Startup can be Proprietorship, Partnership or a company.

He informed that Proprietorship firms require least regulatory compliances and companies the maximum. He said Sole Proprietorships are preferred due to simplicity but they involve high risk. He explained that Partnership firms

also carry high personal risk whereas in LLPs the risk is slightly less. He said a Partnership firm is created on basis of a Partnership Deed. It is important to have a well-documented Partnership Deed to avoid any misunderstanding among the partners at a later stage.

He also explained the Tax benefits available to startups and eligibility for registration to avail these benefits.

#### Session on Importance of IPR for Startups

Ms. Geeta Gulati, Advocate, Trade Marks & Patent Attorney said that every startup has Intellectual Property (IP) Rights, which it needs to understand and protect. IP includes trade name, brand, logo and designs. The startup ventures should be proactive in developing and protecting their intellectual property for many reasons like improving the valuation of their business, to generate goodwill, to protect their competitive advantage, to use intellectual property as a marketing edge and to use the IP Rights as a potential revenue stream through licensing.

She mentioned that trademarks give identity to the venture and includes name, color combination and style of writing the name. A trademark can be registered provided some other person has not registered for the same or similar name. The validity of trademark is 10 years from the date of filing the application and can be renewed infinitely. The trademark is valid only in the country in which it is registered.

She added that civil and criminal remedies are available for violation of IP Rights like using a similar mark for similar or related goods or services or is using a well-known mark.

She mentioned that copyright means a legal right of an author/artist/ originator and prevents such work from being copied or reproduced without the consent of the copyright holder. Copyright registered in one country gets registered automatically in other countries and is valid for lifetime of the holder and 60 years after his death.

She said that industrial designs include product design that can be manufactured in a factory and their registration is valid for 15 years. New invention can be patented and their



registration is valid for a period of 20 years.

Ms. Shweta Sen, Head, IPR Integrum IP explained that in India, a Startup is defined as a company which is fresh or not older than 10 years and is engaged in development of a new product or improvement of an existing product. A company formed by splitting of an existing company is not considered as a Startup. She added that it is important for Startups to get their ideas patented at the earliest so that they are not copied by larger companies having better resources.

Discussing about the strategies for protection and exploitation of IP Rights for startups, Ms. Sen

mentioned that Startups should evaluate and prioritize the IP Rights involved in their business.

She advised that Startups should protect their ideas with Patents. She added that for patenting, it is not necessary that the idea should be about a technological breakthrough. Even simple ideas can be patented. However, patents are not free and all ideas are not patentable. Therefore, it is necessary to determine whether the idea is patentable before filing the application.

#### Session on Steps involved in formation of an entity and registration process


CA Mastan Singh Chambyal, Founder partner at M S Chambyal

and Associates made a detailed presentation on the various requirements in formation and registration of a legal entity including filing of MOA, AOA, filing of form 32, form 18, Power of Attorney; Requirement for section 25 Company, Joint Stock Company, Non Joint Stock company, Producer Company; Public Limited and Private Limited company.

# ROLE OF INTELLECTUAL PROPERTY (IP) IN INNOVATION MANAGEMENT: CHALLENGES & PROSPECTS



he Punjab State Chapter of PHD Chamber in association with the Ministry of Micro, Small & Medium Enterprises and Desh Bhagat University, Mandi Gobindgarh organized a video conference on 'Role of Intellectual Property (IP) in Innovation Management: Challenges & Prospects' on October 29, 2020 to educate startups and students about various types of Intellectual Property Rights and their importance in innovation management.

Welcoming the participants, Mr. R S Sachdeva, Mentor, Punjab State Chapter, PHDCCI informed that PHDCCI has set up an IP Facilitation Centre at Amritsar under the aegis of Ministry of Micro, Small & Medium Enterprises for providing services in Patents, Copyrights, Trademarks and Geographical Indications.

Ms. Geeta Gulati, Advocate, Trade Marks & Patent Attorney said that students in US Universities create a lot of patents as they patent all their research work but in India, very little research work is patented due to lack of awareness. She described in details the definition of each IP product, procedure for their registration,

period of their validity, remedy for their violation and also the way these can be commercially exploited by the innovator.

Dr Shweta Sen, Head IPR, Integrum IP in his presentation on Innovation Management stated that innovation refers to an invention and its commercialization i.e. converting innovative ideas into a practical action plan so that it becomes a reality. She mentioned that innovation is important for every startup in terms of its growth, standing out from its competitors and meeting the needs of customers.

Dr Sen pointed out that a business stops growing when it is unable to respond to the changing needs of the customers. She added that an innovation process includes preparation, implementation, scaling up, evaluation and improvement of ideas. She said that for businesses, the key to success is inventing and encouraging new ideas and leveraging the years of experience.

She informed that innovations can be protected through patenting as it prevents others from copying without due permission of the inventor, thus allowing the patent holder to commercially exploit his innovations.

Prof. Shalini Gupta, Vice Chancellor, Desh Bhagat University said that new ideas are important for growth. She mentioned that during COVID-19, only those companies survived or even thrived who innovated new ideas for staying connected and continuing their activities.

Underlining the need protecting innovation through IPRs, she stated that Research, Innovation and Entrepreneurship are the guiding principles of the academic policy of Desh Bhagat University and they encourage their students to patent their research work. To develop and sustain the IPR Culture among their students, the University has set up an IP Fund which provides financial support to students for patenting their work. She said the University is keen to collaborate with PHDCCI and other similar institutions to take their innovations to MSMEs.

More than 100 Startups and students of Desh Bhagat University, Mandi Gobindgarh attended and benefited from the programme.





# INPUT TAX CREDIT UNDER GST — RESTRICTIONS & ISSUES

he Punjab State Chapter of PHD Chamber organized an interactive video conference on 'Input Tax Credit under GST – Restrictions & Issues' to educate Industry members about the provisions related to Input Tax Credit under GST on November 27, 2020.

Welcoming the participants, Mr. R S Sachdeva, Mentor, Punjab State Chapter, PHDCCI stated that the GST Act came with a very special feature of linking the Input tax credit with the payment of consideration of the value of supply along with tax thereon, received by a registered person. But numerous issues have been cropping up in GST Input Tax credit from time to time. He added that it becomes highly critical for businesses to be highly compliant under the GST regime.

Moderating the Session, CA Vishal Garg, Co-chairman, Taxation Committee, Punjab Chapter, PHDCCI & Partner, Vikas Garg & Associates said that due to ignorance, some industry members are taking wrong credits and refunds. Therefore, it is important to educate industry members about the various provisions of ITC.

Explaining about various sections of GST Act for availing of ITC, Adv. Pawan K Pahwa, Chairman, Taxation Committee, Punjab Chapter, PHDCCI & Partner, Panacea Legal Services, Chandigarh pointed out that GST being a value added tax, input tax credit has a great significance in the compliance process under GST. He added that certain issues on the admissibility of input tax credit are still ambiguous and need appropriate and positive intervention of the government.

He underlined that it is necessary to file the Returns on time to avail ITC as delay of even one day can render the person ineligible for availing ITC. He informed that ITC is also disallowed in case if goods lost, destroyed or written off and exempted supplies. He advised the participants to take cautious decision as these could have a significant impact on the business as and when the same are objected by the authorities during the audits.

Adv. Pradeep S. Rawat, Founder-VLR Legal made a presentation regarding the eligibility and restrictions on admissibility of ITC. Detailing various clauses of Sections

16 and 17 of the GST Act, he stated that ITC provisions are very complex and need to be well understood. He said that the Government needs to strengthen GST infrastructure for ease of doing business.

Mr. Rohit Chawla Key Partner Manager, Tally Solution Pvt. Ltd. explained the main features of their company's latest product offerings, TallyPrime, the Next Gen Business Management Software, a powerful software to enhance business productivity of MSME owners and new-age entrepreneurs. He informed participants that TallyPrime Release 1.0 has a fresh look and comes with several new features that will benefit the entrepreneurs along with accountants in their day- to- day work.

He shared that to simplify data entry and make it faster and flexible, a new feature 'GoTo' has been introduced. This capability has taken Tally's famous reporting engine to the next level. Multi-task facility has been added in the product and it has been designed such that it is scalable for future feature rollouts and is supported by this interface without breaking the frame. A Ride for Homage to the Fallen Soldiers : Through paying homage


by laying wreaths at Longewala and other War Memorials.

# REVISED GUIDELINES ON GROUND WATER EXTRACTION



regulate and control management and development of ground water in the country and to issue necessary regulatory directions for the purpose, the Central Ground Water Authority (CGWA) was constituted under Section 3 (3) of the Environment (Protection) Act, 1986. The implications are on existing and new industrial, infrastructure & mining projects. The state government is required to enact the ground water legislation. Industry is not very clear about the implications and compliance needs. In this context, Uttarakhand Chapter of PHD Chamber on November 24, 2020 organized a webinar with CGWA to present the new guidelines which were issued on September 24, 2020 and also to address the industry queries.

Mr. Ravikalayan Bussa, Senior Hydro Geologist from CGWA Govt. of India presented a brief snapshot of various provisions of the new guidelines. The industry is finding the registration, process of depositing water conservation fees & taking NOC very cumbersome. This had been a deterrent to the new investments in the industrial estates.


Mr. Rajeev Ghai, Co-chairman, Uttarakhand Chapter of PHD Chamber informed that PHDCI had been active with its policy level interventions at state and central level for issuance of new guidelines. The new guidelines as of now have brought in some provisions which are welcomed by the industry. In the pretext of ongoing pandemic emergency, Mr. Ghai iterated the appeal of the industry members to extend the last date of registration from June 2020 to April 2021.

Mr. Udayraj stated that the draft of the policy for water management is in process and be finalized soon in consultation with the industry.

Mr. Meena urged investors to invest in cold storages, reefer vans and mobile units to prevent spoilage and waste of the raw materials produce of the State.



The Foundation takes appropriate initiatives in the areas of Healthcare & Sanitation, Education, Skill Development, Women Empowerment and Water Harvesting Conservation and seeks to empower individuals and community at large by providing them with the support they need to affect change in their own environment for social and economic development.

#### PHDRDF HEALTHCARE INTERVENTION AND SANITATION

HDRDF has been actively conducting free health camps for the low-income population in various geographical locations across the country to increase access to healthcare. A team of a qualified Doctor, ANM, Lab Technician and project coordinator are present for each camp and are responsible for its success. Emphasis is given on generating awareness among the community on sanitation & hygiene, child & maternal health, waterborne diseases, communicable diseases and other geography based medical problems.

### PHDRDF- NATIONAL SAFAI KARAMCHARIS FINANCE & DEVELOPMENT CORPORATION

HDRDF in partnership with the National Safai Karamchari Finance Development Corporation (NSKFDC), Ministry of Social Justice & Empowerment is conducting 25 health camps across seven states in India for manual scavengers. In this regard, PHDRDF organized a total of 10 health camps, that included - in Uttar Pradesh- two health camps at Sitapur and Ghazipur; in Orissa- five health camps at Khordha, Subarnapur, Puri, Koraput and Rayagada and in Assam – three health camps were held at Kamrup (Metro), Mangaldoi and Kamrup (Rural).

he camps were organized with five specialists including one physician, one eye specialist, one gynaecologist, one dermatologist and one pediatrician along with paramedical staff. Around 180-230 patients were treated and free medicines were provided in each camp. Facilities like testing of blood pressure, blood sugar, ECG, eye testing were done during the camp. Along with medicines, free spectacles were also distributed to more than 70 patients at each location. Additional camps will be conducted in the state of Assam, Bihar and Odisha soon. In addition to the existing 25 health camps, eight more camps were awarded to PHDRDF to conduct in the states of Punjab, Uttar Pradesh and Gujarat in the month of December 2020.

#### **PHDRDF - ROTARY CLUB OF ROORKEE**

HDRDF has partnered with the Rotary Club of Roorkee, Rotary International, Rotary District grant through THDC, Rishikesh for a Mobile Medical "Sehat Van" to provide a holistic health care program to 30 villages in Tehri Garhwal. The project will provide screening, diagnosis and treatment for Non-Communicable Diseases (NCD) including diabetes, hypertension, cardiac problem and/or oncology through on-ground health camps as well as tele-medicine consultations with specialist doctors. The mobile medical van will be equipped with testing devices like ECG, blood test and supported by a qualified medical team consisting of a medical doctor and paramedical staff. In women and child care camp, focus will be on women based health issues. The project is expected to reach out to approximately 12,000 people in the areas of Tehri Garhwal, who are unable to access healthcare easily.

#### PHDRDF WATER MANAGEMENT

HDRDF has been constantly working towards recharging of ground water table by establishing Rain water harvesting structures and generating awareness amongst the community on need and technologies of water conservation.

#### PHDRDF - COCA COLA FOUNDATION

HDRDF and Coca Cola Foundation have partnered together to promote sustainable solutions for water resource management with surface water conservation and ground water recharge, through construction of seven check dams in water-stressed two blocks of Ranchi district – Kanke and Ratu in Jharkhand. The project will reach out to more than 15,000 people, creating a total water recharge capacity of 292,100 cubic meters. Three check dams have been completed out of seven check dams, namely, Kadru Chuwa Wala, Fauji Wala and Sukkhal Khatt Wala check dam so far and the remaining are in progress.

#### PHDRDF AND FMS BATCH OF 1979-81 (UNIVERSITY OF DELHI)

HDRDF and FMS Batch of 1979-81 (University of Delhi) have partnered together to construct one water harvesting structure 'Gular wala check dam' in Hajipur Village, Alwar, Rajasthan with a length of 65 feet. The check dam will have a water holding capacity of 275,000 cubic feet. Currently, the construction of the check dam has begun with active participation from the community. The check dam will help in recharging the ground water and help increase the water table.

HDRDF has been undertaking skill development programmes with various corporate organizations with an aim to enable the under-privileged youth to be economically independent. These programs include training in: stitching & tailoring, beauty culture, computer literacy including tally software, spoken English language, soft skills etc. and training in employable skills such as electrician, welding etc., bee keeping.

#### PHDRDF - DONALDSON INDIA FILTER SYSTEMS PRIVATE LIMITED

HDRDF in collaboration with Donaldson Filters India Pvt Ltd is running a "Skill Development Centre" since the last four years in village Mohammadpur Gurjar, Sohna block, Gurugram. Two batches consisiting of 20 girls in each batch of cutting & tailoring and beauty culture courses have been completed. Currently, one batch of 20 girls in both courses i.e. cutting & tailoring and beauty culture is undergoing training. After a long halt in physical training at the center due to the pandemic, it's gradually being started now with maintaining social distancing and other protocols for the pandemic.

(IYFV), 2021

he UN General Assembly designated 2021 the International Year of Fruits and Vegetables (IYFV). Fruits and vegetables are the cornerstones of a healthy and varied diet. They provide the human body with an abundance of nutrition, strengthen the immune system and help lower risk for a number of diseases

As proclaimed at the 74th session the UN General Assembly, the IYFV 2021 is a great opportunity to raise awareness on the importance of fruits and vegetables in human nutrition, food security and health. They will act as a catalyst towards achieving the UN Sustainable Development Goals by 2030.

FAO is celebrating the year in collaboration with other organizations and bodies of the United Nations system. QU Dongyu, Director-General of FAO while launching the International Year of Fruits and Vegetables on December 15, 2020, requested the international community to improve healthy and sustainable food production through innovation and technology.

#### Nutrition, Lifestyle, Sustainability and Livelihood

The International Year of Fruits and Vegetables (IYFV), 2021 aims to bring awareness on the health benefits of consumption of fruits and vegetables; promote healthy diets and lifestyles; reduce losses and waste in fruits and vegetables; foster sustainable production of fruits and vegetables; improve sustainability of storage, transport, trade, processing, retail, waste reduction and recycling; integrate family farmers into local, regional, and global production; improve value/supply chains for sustainable production and consumption of fruits and vegetables

and improve nutrition, livelihoods and incomes. It will strengthen the capacity of developing countries to adopt innovative approaches and technology in combating loss and waste of fruits and vegetables.

Consuming sufficient, or even more than the recommended amounts, of fruit and vegetables has many health and nutrition benefits. They are also linked to lower risk of depression and anxiety, obesity and non-communicable diseases; promote gut health; and counter micronutrient deficiencies. According to WHO, people should eat a minimum of 400 grams of fruits and vegetables daily, as part of a healthy diet.

However, due to a number of factors, such as availability, affordability, or lack of knowledge and awareness, many people around the world consume less than the required amount.

Against this background, Dr QU Dongyu, Director-General of the Food and Agriculture Organization (FAO) described the International Year as "a unique opportunity to raise global awareness." Speaking at a virtual launch event, Dr. Qu also highlighted the role of digital technologies in reducing waste, improving nutrition and market opportunities.

He outlined the challenges in improving production and agri-food chains, and called on countries to use the International Year to improve infrastructure, farming practices thereby supporting small scale farmers. Alongside, he also emphasized the importance of fruits and vegetables as a good way for farmers to generate more income.

#### Sustainable approaches for food systems

Innovation, improved technologies and infrastructure are critical to increase the efficiency and productivity within fruits and vegetables supply chains and to reduce loss and waste. Sustainable and inclusive value chains can help increase production, enhance the availability, safety, affordability and equitable access to fruits and vegetables to foster economic, social, and environmental sustainability.

Cultivating fruits and vegetables can contribute to a better quality of life for family farmers and their communities. It generates income, creates livelihoods, improves food security and nutrition, and enhances resilience through sustainably managed local resources and increased agro-biodiversity.

Gender equity opportunities are also noteworthy, as women often play leading roles for their households in both e production and consumption of fruit and vegetables.

The International Year complements several other key initiatives including the Decade of Action on Nutrition (2016-2025), the Decade of Family Farming (2019-2028), and the Global Strategy on Diet, Physical Activity and Health. These observances reinforce each other while providing greater visibility to small-scale producers and raise awareness on food security and nutrition.

As Hippocrates, the father of Modern day Medicine said "LET FOOD BE THY MEDICINE, THY MEDICINE SHALL BE THY FOOD", let us make sure to value the food on our plate and the food producers who make sure we have it in abundance and repay our gratitude to them.

#### Rate status quo to aid economic recovery

Corporate India and experts today said the RBI's decision to hold interest rates will support economic recovery in the aftermath of the Covid-19 pandemic and that they expect the central bank to maintain an accommodative stance in the near future.

The Reserve Bank of India (RBI) today left interest rates unchanged for a third straight meeting as inflation stayed stubbornly high, and said the economy was recuperating fast and would return to positive growth in the current quarter itself.

The benchmark repurchase rate will be maintained at 4 per cent, RBI Governor Shaktikanta Das said.

In the Budget earlier this year, the Centre had reduced the days an NRI can spend in the country to 120 days from 182 days earlier, failing which the person is to be treated as residents and liable to pay tax on income. "Residential status of directors is important to determine the residential status of companies as per provisions of Place of Effective Management under Section 6(3) of the I-Tax Act,"the pre-budget memorandum on direct taxes said.

Johnson is the chief guest at India's Republic Day celebrations on January 26, a significant development in terms of strategic relations between the two countries, especially after Beexit, be said.

Some key trade deals are

expected in 2021, but a compre-hersive trade deal between India and the UK is expected only in two-three years; the officials said. "India is very cautious while signing any FTA because of its past experience. Various FTAs signed in a hurry by the previous governments, particu-arly with the Asean, are under review as these deals are heavily tilled against Indian interests," the second official said. the second official said.




