PRESIDENT'S MESSAGE

Friends,

As we all are aware, the COVID-19 pandemic has affected our lives in an unprecedented manner. However, I firmly believe that crises can be a time of deep reflection and positive transformation, strengthening our capacity for lateral thinking and responsible decisionmaking process.



With India presently undergoing 'Unlock 2", further easing of restrictions imposed during the initial phase of contagion spread, is a welcome measure in resuming and normalizing economic activities. It is indeed promising that amidst the global economic recession, India has retained its position as the third-largest economy in the world in terms of purchasing power parity, behind the US and China.

I am also heartened that a few green shoots of recovery are visible across the country, though needless to say, much more efforts are required for full-fledged economic revival. In the farm sector, record rabi output and procurement are expected to spur rural demand during the current fiscal. Also, plentiful rain in June and forecast of a normal monsoon leading to an equally good kharif crop portends well for food inflation. Also, tractor, two-wheeler and passenger car sales are rising in rural areas which are in contrast to the urban slump. Having said this, I appreciate the Prime Minister for extending the 'Pradhan Mantri Garib Kalyan Anna Yojana', to provide free ration to over 80 crore people, mostly from the underprivileged section, by five more months, till November end. However,

I opine here that cash transfers are needed to support those who have lost livelihoods owing to the lockdown, a much-needed move to restore equity and stimulate demand in the economy.

GST collections and electronic waybills, though lower than last year, are gradually inching back to pre-Covid levels; E-commerce sales are back to almost 90 per cent; and power and fuel is back in demand, all positive indicators of businesses getting back on track. More companies are embracing digital, VR, and exploring other out-of-the-box innovative solutions to sustain their business model, all positive indications of a recovering economy.

However, I must comment that the lockdown did severely affect industry as it faced drastic disruptions of raw material supplies, and mass backward rural migration, leading to almost nil operations in several sectors. Given this situation, Prime Minister, Mr. Narendra Modi efforts to boost local manufacturing and reduce India's reliance on imports is a welcome relief. These bold steps for making India self-reliant indicate towards a larger role for Indian entrepreneurs and startups, to strengthen the local supply chain to integrate into the global supply chain. It's time for India to become 'Self Strong' which means develop its local market, structure an efficient mechanism for supply chain logistics, produce superior quality and cost-effective goods and services, and last but not least, ensure the labor is well rewarded, so as to move towards inclusion with growth and prosperity.

During this pandemic, we realized our dependence on global suppliers for our health and pharmaceuticals needs. Nonetheless, just within two months our local manufacturers boosted their operations and today we stand as the world's second biggest maker of PPE kits, after China.

It has come to notice that China has been resorting to unfair trade practices. As a result, unfair competition from low-cost imported products has impacted the sentiments of domestic manufacturers. resulting in significant effect on production employment process and generation. I opine that though anti-dumping duties significantly help in supporting the domestic industry, the government should strictly impose quality assurance norms to check import of counterfeit products.

On the front of PHD Chamber's efforts, we were fortunate to have a very fruitful interaction with Hon'ble Finance Minister, Ms. Nirmala Sitharaman last month, wherein the Finance Minister stated that the Government has always recognized the importance of wealth creators as they generate employment and utilize resources in an optimal manner, for promoting socio-economic development in the country. We presented our recommendations to the Finance Minister for onetime restructuring of loans without affecting the classification, for COVID impacted sectors such as tourism, aviation, entertainment, real estate and automobiles.

Having said this, tourism, hospitality and aviation industries are in a tailspin, with travel restrictions imposed, globally. In order to support these affected businesses, the PHD Chamber has been conducting 'Virtual Online Tours', an effort to satiate the wanderlust of people. From using 360 degree panoramic views to holding online sessions, viewers enjoy these beautiful locations, digitally and experience the joy of travelling, from the comfort of their homes. Going forward, we need to focus and leverage on the power of Digital Technologies such as IoT, VR & AR, etc, as India emerges as a superpower.



INTERACTIVE SESSION WITH MS. NIRMALA SITHARAMAN, UNION MINISTER OF FINANCE AND CORPORATE AFFAIRS

s. Nirmala Sitharaman, Union Minister of Finance and Corporate Affairs interacted with the Members of the Managing Committee on June 19, 2020 through video conferencing.

Dr D K Aggarwal, President, PHDCCI welcomed Ms. Nirmala Sitharaman, Union Minister of Finance and Corporate Affairs and expressed his gratitude for sparing her precious time to interact with the Members of Managing Committee of PHDCCI.

Dr D K Aggarwal introduced Ms. Nirmala Sitharaman, who is a member of the Rajya Sabha since 2014. She formerly served as the Defence Minister of India, thereby becoming India's second female Defence Minister and also second female Finance Minister after Ms. Indira Gandhi and first full-time female Finance Minister. During COVID-19 pandemic, she was made in-charge of the COVID-19 Economic Response Task Force. The Forbes Magazine has ranked her 34th among the 100 most powerful women in the world in 2019.

Addressing the Managing Committee Members of PHDCCI, Ms. Sitharaman showed her gratitude for the opportunity to interact with the members. She said that the Government has always recognized the importance of wealth creators they generate employment as opportunities and utilize resources in an optimal manner for promoting the socio-economic development in the country. She acknowledged that the Prime Minister has always facilitated a helping hand and recognized MSMEs. She said that they are closely monitoring the situation in consultation with banks so that relief measures announced by the Government are effectively percolated at ground levels especially

the transmission of repo rate cuts to consumers in terms of reduced interest rates.

The Finance Minister stated that they are closely watching developments in disbursement of loans under the provision of Rs 3 lakh crore collateral free automatic loans for businesses to mitigate the daunting impact of pandemic COVID-19 on trade and industry. She said that the Union Government has always focused on 'Minimum Government and Maximum Governance' with a special focus on addressing challenges faced by Industry and promote ease of doing business.

INTERACTIVE SESSION WITH UNION MINISTER OF COMMERCE & INDUSTRY AND RAILWAYS



n interactive session was organized with Mr. Piyush Goyal, Union Minister of Commerce & Industry and Railways for the Managing Committee members of PHD Chamber on April 22, 2020 through video conferencing.

Dr D K Aggarwal, President, PHD Chamber introduced Mr. Piyush Goyal, currently a Member of Parliament for Rajya Sabha from Maharashtra and the Deputy Leader of Rajya Sabha. Mr. Goyal, a Chartered Accountant by education also has a degree in Law. Mr. Goyal took over as the Union Minister of State for Power, Coal, New and Renewable Energy in 2014 and introduced the Ujwal DISCOM Assurance Yojana (UDAY) and Deen Dayal Upadhyaya Gram Jyoti Yojana (DDUGJY). He was awarded the 2018 Carnot (CARNOT) Prize by the University of Pennsylvania's Kleinman Center for Energy Policy.

Addressing the Managing Committee Members of PHD Chamber, Mr. Goyal appreciated that PHD Chamber has a good combination of old, new, big and small industries unlike other chambers. He appreciated the work being done by PHD Chamber in providing suggestions and contributions to Government for dealing with COVID- 19. He mentioned that the lockdown was providing collateral benefits to environment with lesser numbers of patients in India as compared to other countries. He highlighted that the government is keen to open up the activities of industry, trade and economy but not at the cost of lives of its citizens.

Mr. Goyal highlighted that history will judge us by our actions of today. According to the history of past global pandemics, it has been observed that countries which focused more on the health of its countrymen and took stringent measures to save lives fought the adversities better. Also, post lockdown, such economies bounced back and revived much faster than the economies which placed preference to livelihood more than the lives of their citizens.

The Hon'ble Minister requested each citizen to abide by Hon'ble Prime Minister's guidelines to contain the spread of this pandemic. He urged the citizens to download the Arogya Setu App which will aid the government in taking the right decisions and measures to free the Nation from the grip of COVID- 19. He highlighted that



it should be our National Duty to buy and consume Made in India goods rather than expecting the government to levy stringent import laws or stop imports from other nations.

Mr. Piyush Goyal responded to the various queries raised by the members during the meeting. Mr. Sanjay Aggarwal, Senior Vice President, PHD Chamber delivered the vote-of- thanks to the Minster.





INDIA-US BUSINESS PROMOTION CHALLENGES AND OPPORTUNITIES - POST COVID-19

he International Affairs and Trade Fairs Division, PHDCCI organized an interactive video conference on "India-US Business Promotion Challenges and Opportunities- Post COVID-19" on June 16, 2020.

Dr DK Aggarwal, President, PHDCCI while welcoming the dignitaries highlighted India-US relations and said that post COVID-19, there will be lot of opportunities and both India and US will come out stronger. India-US relationship is at its best as US is the largest trading partner for India. In 2018-19, total trade between both nations was 87.95 billion dollars, whilst US trade with China was 80 billion dollars. Due to COVID-19, economies will be affected not only in 2020-21 but also in 2022.

Mr. Sandeep Chakravorty, Consul General, Consulate General of India, New York, US thanked the Chamber for the initiative and apprised that India-US bilateral relations have developed into a "global strategic partnership," based on shared democratic values and increasing convergence of interests on bilateral, regional and global issues. He further said that New Jersey will continue to maintain a strong position as a hub of pharmaceutical business and with more than 2,000 US companies present in India and over 200 Indian companies in the US which signifies two-way investments, mutuality of interests and benefits in the economic partnership. He said that the US is looking for restructuring the global supply chains and India has a significant role to play.

Ms. Aileen Nandi, Minister Counselor for Commercial Affairs, U.S. Commercial Service, US Embassy, New Delhi shared that India-US relations have become even stronger after the high-level visits of leaders and ministers of both the countries. However, the pandemic has impacted global trade. She said that both nations



have to work towards eliminating the trade barriers for free flow of goods and services. She highlighted about the CEOs forum which has led to a sort of cooperation especially in the IT Sector. She said that US Embassy will fully support the Chamber in its initiative to promote bilateral trade between both the countries.

Dr Manoj Kumar Mohapatra, Minister Commerce, Embassy of India, Washington DC said that bilateral trade has grown over 200 percent in the last 10 years with US, which indicates a huge potential of doing business with US. He also said that PHDCCI should play a role in educating the exporters to rightly brand their products and take care of shipments related issues so that their shipments don't get rejected. He mentioned that in the year 2019, the number of consignments rejected by US authorities was 1,813. He also mentioned that 7 Indian companies are also working on a tieup to upscale the production of the 3 vaccines currently being tested in US for Covid-19.

Mr. Sanjay Chadha, Additional Secretary, Dept. of Commerce, Ministry of Commerce and Industry highlighted India-US trade relations and the strong foundation that the two countries share. He said even in 1920, US was the largest trading partner of India, that shows the strong bonding they share, that will surely become even more stronger post COVID-19 though there are several hiccups and challenges.

The session was also enriched by views of Mr. Nishant V Berlia, Co-Promoter, Apeejay Stya Group & Svaran Group; Mr. Amitava Ray, Chairman and Ms Rashmi Chopra, Co-chair International Affairs Committee for Americas, PHDDCI; Mr. Mohammed Asaria, Founder and Managing Director, Range Developments and Mr. Steve Gervasio, Managing Director, ALED Partners.

Mr. Pradeep Multani, Vice President, PHDCCI delivered the voteof-thanks to the guests. Apeejay Stya Group & Svaran Group, Range Developments & ALED Partners were the Strategic Partners of the event.

INDIA - AUSTRALIA BUSINESS PROMOTION, CHALLENGES AND OPPORTUNITIES - POST COVID-19

The International Affairs and Trade Fair Committee, PHDCCI organized an interactive video conference on "India - Australia Business Promotion, Challenges and Opportunities - Post COVID-19" with H.E. Mr. A. Gitesh Sarma, High Commissioner of India to Australia, Canberra on May 6, 2020.

The objective of the video conference was to have a meaningful discussion to understand the Impact of COVID-19 and challenges being faced for promoting business activities with regards to export and import, travel restrictions and also understand potential possibilities of enhancing bilateral trade post lockdown.

Mr. Sanjay Aggarwal, Senior Vice President, PHDCCI while welcoming H.E. Mr. A. Gitesh Sarma, High Commissioner of India to Australia, briefed him about PHDCCI and its activities. He informed about the stimulus packages estimated which includes increase in healthcare services, tax relief, wage subsidies, cash payments for businesses and cash bonuses for welfare recipients.

Mr. Ajay Poddar, Chairman, International Affairs Committee for ASEAN, East Asia & Oceania, PHDCCI highlighted how India-Australia economic relationship has grown significantly in recent years.

H.E. Mr. A. Gitesh Sarma, High Commission of India, Canberra, Australia highlighted that the bilateral relationship between India and Australia has grown significantly encompassing political, economic, defence and strategic aspects. Exports and attracting foreign investments are key elements of Australia's economy and its ability to maintain a high standard of living.

H.E. Mr. Sarma also added that Australia has performed exceptionally well to fight against COVID -19 pandemic and to get the number of cases down relatively quickly. He mentioned that Indian companies should invest in Australia as it can provide services like education, resources and energy; food, health care, tourist destinations and expertise in water and environmental management. In the present era of climate change, clean coal technology and renewables too will probably emerge as great potential collaborators of India–Australia strategic relationship.

He said that "India is the flavor of the season" and Australia is definitely looking at India for extensive trade. Trade with China has helped them in the past, but in the last few years they felt that they are being over



dependant on China and putting everything in the Chinese basket.

He remarked that before the pandemic, ties were in an upward direction, culturally close because of the English language and cricket as in the recent years, there has been a greater convergence of business ideas. H.E. mentioned about the Prime Ministerial visits that have built a significant momentum in the relationship and affirmed the Strategic Partnership. He shareed that there is about 30 billion Aus Dollar trade between India and Australia. Major exports to India from Australia include coal, copper and gold; major imports from India to Australia include refined petroleum, pearls and gems, etc.

Mr. Saurabh Sanyal, Secretary

General, PHDCCI shared the overview of India-Australia relationship and requested to organize specific B2B and B2G meetings on a bigger platform in order to increase the business interests of both sides.

The session was moderated by Mr. Naveen Seth, Principal Director, PHDCCI.



INDIA-TANZANIA BUSINESS PROMOTION, CHALLENGES AND OPPORTUNITIES-POST COVID-19

Mr. Vivek Agarwala, Co-chairman, International Affairs Committee for Africa, PHDCCI while thanking the High Commissioner for sparing his valuable time to address the members of the Chamber, highlighted that this was the opportune time for the Indian businessmen to identify the areas of potential cooperation between both the nations, in order to capitalize on the same once things return to normal post the pandemic.

Mr. Pradeep Multani, Vice President, PHDCCI shared that various opportunities for businesses existed in the AYUSH and traditional medicine sector.

H.E. Mr. Sanjiv Kohli, High Commissioner of India to Tanzania while addressing the participants, highlighted that Tanzania was one of the most vibrant and dynamic economies in the African continent. He also shared that it remained one of the top recipients of lines of credit in the region apart from being one of the largest beneficiaries of India's ITEC programme. India was also one of the largest trading partners of Tanzania. India enjoyed an encouraging 18% share in Tanzanian imports and 14% share in Tanzanian exports. Port development, infrastructure, mining, pharmaceuticals, agro and agro prospective processing remained sectors of bilateral economic cooperation between both the nations.

Mr. Pradeep Multani, Vice President, PHDCCI, delivered the formal vote- of- thanks and praised the Government of Germany for taking proactive measures against COVID -19 and elaborated on the opportunities present for the Indian companies to collaborate with their German counterparts.

INDIA - OMAN BUSINESS PROMOTION, CHALLENGES AND OPPORTUNITIES - POST COVID-19



Mr. Pradeep Multani, Vice President, PHDCCI, welcomed His Excellency and gave a brief insight about PHDCCI and the relations between India and Oman. His Excellency, Mr. Mahawar thanked PHDCCI and called it an excellent initiative to bring together the industry leaders of both sides. India and Oman are doing business for many years and over the years the dynamics of doing business have changed thanks to joint ventures and quantum of investments. Mr. Mahawar said that COVID-19 pandemic has been a big disruption in Oman. Nonetheless, India has provided special assistance to Oman during this time. He apprised that the Oman Government has taken swift action which makes it the least affected country in the region, leading Oman to enter a phase where curbs and restrictions will be removed and the economy will be uplifted.

The session was divided into two parts- the first session moderated by Mr. Prashant Ajmera, Ajmera Law Group. They highlighted various Citizenship programmes based on Investments for various countries.

Ms. Inga Wellings, Business Development Manager, CS Global Partners, spoke on the investmentcitizenship programmes based specifically for the Caribbean Region particularly of Dominica, St. Kitts and Nevis. Ms. Leena Motwani, AVP, Arton Capital highlighted the citizenship Investment programme for Montenegro and Portugal. Mr. Mohammed Asaria, Managing Range **Developments** Director. highlighted the various luxurious projects developed by them in Caribbean region like The Park Hyatt, St. Kitts, Cabrits & Spa Kempenski, Dominica and Hotel Six Senses, Grenada. Mr. Christos Vardikos, an Athens based Attorney at law and the Honorary Consul for the Commonwealth of Dominica in the Hellenic Republic, acting also as the Special Advisor to the Prime Minister of the Commonwealth of Dominica for Maritime Affairs, spoke about the Economic Citizenship Programme of Commonwealth of Dominica.

The second session comprised of a Panel Discussion on the US EB5 programme, moderated by Mr. Mark Davies, Chairman, Davies & Associates LLC, and had speakers namely: Mr. Matt Hogan, Vice President of Project Development, CMB Regional Centers and Mr. Ramin Asgard, Senior Vice President of Global Business Development, FirstPathway Partners. Mr. Matt Hogan said that the program provides investors to invest US\$ 900,000 and allows the person, spouse and children (under 21 of age) to get permanent residency in the United States. While Mr. Ramin Asgard of the FPP project shared that unlike most projects of the EB-5 visa, the FPP project provides tremendous returns, which range in between 13-22%.

In the concluding remarks, it was mentioned by the speakers that USA is a preferred country for immigration as the economy is strong, and even during COVID-19, their relief packages have been very beneficial. The webinar was moderated by Mr. Naveen Seth, Principal Director, PHDCCI.









INTERACTIVE SESSION WITH COUNTRY DIRECTOR, WORLD BANK (INDIA)



n interactive session was organized for the Managing Committee members of PHD Chamber with Dr Junaid Kamal Ahmad, Country Director, World Bank (India) on May 20, 2020 through video conferencing.

Dr D K Aggarwal, President introduced Dr Junaid Ahmad who was formerly the Chief of Staff to World Bank Group President. With a PhD in Applied Economics from Stanford University, MPA from Harvard University and BA in Economics from Brown University, Dr Junaid was the Senior Director for the Water Global Practice since 2014. Prior to this, he was the Deputy **Resident Representative and Principal** Economist in Johannesburg and then as a Regional Team Leader of the Water and Sanitation Program in New Delhi. He was also the Director for Sustainable Development in the Middle East and North Africa Region, a position he held from 2012-2014.

Addressing the Managing Committee Members of PHDCCI, Dr Ahmad showed his gratitude for the opportunity to interact with the members. He mentioned that India is moving around at a 7% growth rate and needs to work harder to sustain itself. Every country needs to have a social intervention so that they can move from slowdown to the revival of the economy. He stated that PM Mr. Narendra Modi's scheme of 'Pradhan Mantri Garib Kalyan Yojana' is a fundamental intervention to support the economy during these times of crisis.

Dr Junaid, while deliberating on the "Impact of COVID-19 on the Indian Economy as well as World Economy" gave an insight into the nature of stock witnessed by India and the World due to this pandemic COVID-19 by giving a flashback of the 2008 financial crisis. He said that what distinguishes the 2008 financial crisis with the current times is the focus on supply and health care systems and facilties. He also emphasized that it is important to protect the economic base of the country which will help to stabilize the economy.

Dr Junaid Kamal Ahmad stated that there is no way this pandemic can be dealt with without the states' intervention and it is important to focus on the nature of economic and health conditions of the country. He suggested that we need to strengthen the federal system and the states and unite them to fight against the crisis.

Talking about the MSME sector which is one of the backbone sectors of the country, Dr Junaid Ahmad said that the government has created some liquidity in the market for the MSMEs. But the challenge is how to use the liquidity. MSMEs need strong intervention with the NBFCs along with banks for coming back as an impactful sector in the economy that creates jobs and opportunities for growth in the country.

Konrad Adenauer Stiftung (KAS) in India was the partner of PHDCCI for the interactive session and Mr. Peter Rimmele, Representative of KAS in India also interacted with the Members. Mr. Rimmele gave a brief insight into the measures and reforms taken by Germany to combat the impact of COVID-19. He also gave a global perspective about the financial packages announced by different countries of the world.

At the end of session, Dr Junaid responded to the various queries raised by the members. Mr. Sanjay Aggarwal, Senior Vice President, PHDCCI delivered the vote-of-thanks to Dr Juniad and KAS team.



OPPORTUNITIES AND CHALLENGES IN DIFFERENT ASSET CLASSES DUE TO COVID-19

He highlighted that it will take 6-8 months for the economy to revive itself. He stated that India is seen as a place for manufacturing base of multinational companies and global liquidity is also an opportunity to grow in the world market.

Mr. Navneet Munot, Executive Director & Chief Investment Officer, SBI Mutual Funds Management Pvt Ltd in his special address highlighted that while the world has focused a lot on survival, the public dispose will start moving towards revival now. He suggested that we have to make the right kind of financial institutions and market infrastructure which helps in the equity market and financial planning for the future. He stated that finance is the right-hand player of the economy and we have to ensure that the financial system once fine, shall put right technology and people to create the opportunity for them to grow. He mentioned that public banks have great liability ventures and India has an opportunity to convert Red Tape to Red Carpet.

Mr. S Naren, Executive Director & Chief Investment Officer, ICICI Prudential Asset Management Co. Ltd. said that fiscal deficit is not a problem in this current time and emphasized that we are in the deflationary period and one should invest and save in debt mutual funds. He stated that equity is the most asset class and attracted on an evaluation basis. He mentioned that the market is looking attractive and one can buy long-term and also can buy in small bits for short-term depending on the position of the concerned company in current times.

WEBINAR ON COVID-19: IMPACT ON CONSTRUCTION CONTRACTS



HD Chamber in collaboration with S Jalan & Co. and Lex Witness organized a webinar on 'COVID-19: Impact on Construction Contracts' on May 16, 2020. Mr. Amir Z Singh Pasrich, Chairman, Law & Justice Committee, PHDCCI; Mr. Abhijit Mitra, Senior Advocate, Calcutta High Court; Mr. Badrinath Dhruvsula, VP & GC, HCC Ltd.; Mr. Jaideep Gupta, Senior Advocate, Supreme Court of India; Mr. Subhash Sethi, Chairman, SPML Infra Ltd.; Mr. Sourav Ghosh, Managing Partner, S Jalan & Co. and Mr. Samrat Sengupta, Partner, S Jalan & Co. were the speakers at the session.

The Real Estate and Construction Sector is one of the worst affected sectors due to the current coronavirus pandemic. In this context, the session elucidated almost all facets of the current and future scenarios of the construction industry. The discussion illuminated the delegates on several aspects starting from problems being faced in the form of labour crisis, liquidity crunch and shortages of materials leading to an escalation of project costs and measures that should be taken to deal with the situation.

The eminent speakers also emphasized that the extension of schedule for fulfilment of construction contracts is necessary along with other suggestions such as allowing of reasonable and genuine price escalation, workers welfare cess on new contracts should not be levied, there should not be fresh bank guarantee requirement for escalated price, tax exemptions and moratorium should be for one year.

The important deliberations included- (i) applicability of various status on the two types of construction contracts viz. Real Estate contracts which are mainly governed by Transfer of Property Act, Registration Act, Stamp Act, etc. and Infrastructure Contracts mainly regulated by the Indian Contract Act. (ii) effects of COVID-19 on construction in the light of partial suspension of contract and frustration of contract. (iii) urge for new set of rules to minutely observe and deal with matters such as escalation in project cost, bank guarantee, termination of contract, blacklisting.

Mr. Amir Z Singh Pasrich, Chairman, Law & Justice Committee, PHDCCI speaking on the Justice Delivery System opined that the virtual hearings by the courts and tribunals will ease the stress of the courts to some extent and the parties to the dispute should look towards Mediation and Arbitration for dispute resolution in place of going directly for litigation through courts. This will only increase the burden of the already overburdened courts and delay the justice further. He was also of the view that there is an urgent need for a change in law, to promote both virtual hearing and means of ADR and that the legislation should be strong and capable enough to maintain proper balance having a wider scope. Mr. Pasrich answering a few questions of Force Majeure propounded that the Doctrine of Force Majeure cannot apply to lease deeds and also cannot apply to payment obligation, already accrued.





BUSINESS STRATEGIES TO SURVIVE COVID AND THRIVE AFTERWARD-DESIGN THINKING AND HR 4.0

Prof. N K Ganguly, Former Director General, Indian Council of Medical Research (ICMR) shared some facts that India is doing 1 lakh COVID -19 tests per day and US is doing many more and so are other counties. If we were to follow minimum testing more, the actual number of positive symptomatic and asymptomatic COVID-19 cases would be 10 times Prof Ganguly called for higher. planning the testing around rural areas and poor as they are most vulnerable with lot of disadvantages like poor nutrition, lack of social distancing and many more other factors which lead us to look around for redistribution of our healthcare infrastructure. Prof. Ganguly requested the Government to harmonize for a single regulatory framework in such an emergency situation. He also explained about the Smart Testing techniques and shared his focus on tracking and tracing to fight the pandemic.

Dr N Subramanian said that there is a need to recreate the healthcare facilities without disrupting the flow of the current treatment. He said they considered changing the dynamics of staff/ employees at all levels and have a backup for the manpower. Dr Subramanian emphasized on the passion of the healthcare workers & importance of restoring the environment and social balance.

Prof. (Dr) Arvind Kumar, Chairman, Centre for Chest Surgery and Director, Institute of Robotic Surgery at Sir Ganga Ram Hospital (SGRH) New Delhi said that this pandemic has actually depicted that there is a very low investment by the Government on Healthcare infrastructure / facility. He said we should all work together on the preventive steps to deal with this pandemic. Prof. Arvind advised every sector of the economy to rebuild on the Green Agenda and keep the environment clean as it is our duty to make our mother earth healthy which alone can keep such pandemics away.

Prof. Bejon Misra, Founder, Partnerships of Safe Medicine (PSM) India specifically pointed out the highly underutilized infrastructure the nation has which should be connected & made accessible to patients and technology can play a major role on how to utilize it to its optimum capacity. Prof. Misra also pointed out that every year more than two crore people go under poverty line because of the high cost of healthcare expenditure. He said that healthcare should be affordable and accessible to all by following the ethical practices.

Mr. Pradeep Multani, Vice President, PHD Chamber welcomed



all the panelists and delegates for the webinar and shared the facts regarding the current COVID-19 situation related to public & private healthcare delivery system. Mr. Multani said that if red tape will be removed than India will be the hospital of the world. He further added that after this phase of lockdown and social distancing comes to an end, the world's largest democracy needs measures to promote "Health for all" by improving the Public Healthcare facilities to combat such myopia in future.

Mr. Pradeep Multani, Vice President, PHDCCI deliberated on the fact that Mobile Journalism (MoJo) is a game changer and offers a lot to the media fraternity. Smartphones are heart of MoJo through which story telling can be possible. Mr. Peter Rimmele, Resident Representative to India of Konrad-Adenauer-Stiftung (KAS) asserted that MoJo is future of Journalism. He also shared the manual prepared by KAS to use MoJo professionally.

Mr. Mukesh Gupta, Chairman, Media Entertainment, Art & Culture Committee of PHDCCI and CMD, Graphisads shared his views on how MoJo has drastically changed different aspects of journalism.

Prof. Ujjwal Chowdhury, Pro Vice Chancellor, Adams University, Kolkata shared that biggest breakthrough in this century are smart phones and how Barkha Dutt started MoJo channel via YouTube. He explained that the basic concept of MoJo is to shoot, edit and publish using smartphones. MoJo has been empowering individual storytellers via available consumer technology through cross-platform creativity. He also explained the difference between User generated content and User generated structured story.

Dr Stephen Quinn, Professor of Mobile Journalism (Mojo), Kristiania University in Norway talked about three benefits of MoJo – speed, cost and flexibility. A MoJo trained journalist can produce content in less than 3 minutes. Intimacy of smartphones is the main concern at the time of COVID-19 as certain distance is required to be maintained. He suggested to use selfie stick or wireless microphone for Mobile Journalists. He said inexpensive setup required for MoJo will be an attraction for journalism in the coming future.

In his concluding remarks, Prof. Ujjwal Chowdhury suggested to have MoJo as part of the curriculum in Universities. He emphasized on providing practical training to the students as well. Dr. Stephen Quinn said a good journalist is always learning and we should provide MoJo trainings to the existing journalists. He said that it is about story-telling and not about the technology.

Mr. Saurabh Sanyal, Secretary General, PHDCCI while delivering the formal vote-of-thanks mentioned that India is the second largest country with one billion mobile users out of which 400 million are smartphone users and 12 million Iphone users and have more opportunities in MoJo.

TECHNOLOGIES MITIGATE **AGRICULTURE CRISIS IN** COVID-19 AND BEYOND

Mr. Himanshu Goyal, India Business Leader, The Weather Company- an IBM Business; Mr. Shantanu Godbole, Senior Manager for Climate and Supply Chains IBM Research - India; Mr. Krishna Rao TVB, GIS Technology Evangelist, Esri India; Mr. Chacko Jacob, Co-Founder -US, MistEO and Mr. Kunal Prasad, Co founder and COO, Cropin Technology were the esteemed speakers.

Experts delved on subjects such as AI, GSI that go a long way in helping farmers, customisable solutions that help supply chain managers in Ag-tech

companies and make faster and more informed decisions by combining weather forecasts with their unique business insights. Soil and crop health, as well as yield estimation can be monitored remotely using technology. The technology is also helpful in weed identification, crop shift, acreage and field boundary identification as well as crop identification and acreage estimation. DIGITAL HEALTH: THE FUTURE: SERIES 1: TELEMEDICINE-WHERE DO WE STAND TODAY



he Health Committee of PHD Chamber organized an interactive video conference on "Digital Health: The Future: Series 1: Telemedicine-Where do We Stand Today" on May 29, 2020.

Eminent panelists at the webinar included Dr Ν. Subramanian, Chairman, Health Committee, PHD Chamber & Director, Medical Services, Indraprastha Apollo Hospitals; Mr. Aditya Berlia, Co-founder & Pro-Chancellor, Apeejay Satya University; Dr Hans Raj Baweja, Chairman, Ethics Committee, Medical Council of India; Dr Harsh Mahajan, Founder & Chief Radiologist, Mahajan Imaging; Dr Puneet Girdhar, Sr. Director & Spine Surgeon, BLK Super Speciality Hospital and Mr. S K Mehra, Managing Director & CEO, Health Insurance TPA of India.

Dr N. Subramanian welcomed all the panelists and said that telemedicine plays a very important role in our lives to reach everyone which is expanding and getting better every year. The risk of NCDs are so high for the treating doctors that awareness and prevention is the only way to avoid complications where telemedicine and AI play a major role to make the data available and stratifying the risks. It can also manage the algorithms in treating patients with high risk demographics where the Government has access to real time data and the changing patterns of the disease.

Dr Harsh Mahajan, while briefing about the tele-radiology said that computing and internet availability has improved exponentially which also reduces the cost drastically of healthcare delivery and helps to serve the underprivileged sections. He also stated that telemedicine and AI make work easier and it will become indispensable in the coming years but it has to be under the supervision of a clinician. He further added that apart from tele-radiology, telemedicine can be used in digital pathology, dermatology, ophthalmology and many other segments.

Mr. Aditya Berlia said that the doctor to patient ratio in urban areas is around 1:10,000 and in rural areas, it is worse at 1:30,00,00 and this is a worldwide scenario. COVID-19 has changed the patient & doctor psychology and 20-25% medical system will move to telemedicine in the coming years. He also stated that COVID- 19 had given a massive

boost to telemedicine and urgent intervention is needed from the regulatory part as there is a problem with the data collection part. He further added that in the next one year there will be a tremendous use of telemedicine for quick follow-up consultations, consultations for panic and second opinion consultations for referral patients.

Dr Hans Raj Baweja said that there were a lot of legal limitations we faced before Covid era. Its only due to this Corona pandemic, telemedicine guidelines were finalized which says that every doctor in India can go on the telemedicine platform in India. Dr Baweja emphasized that it is mandatory for doctors to introduce themselves at the time of consultation and prescribe only generic medicines.


Dr Puneet Girdhar pointed out that in the past everyone knew about telemedicine but due to legal limitations, patient psychology and other complications very few were using it and now with the pandemic, even hospitals have come up with their individual telemedicine apps.

Mr. S.K. Mehra stated there is a huge demand of Telemedicine among doctors in the coming years.



He said this is the right time to start and set some protocols and regulations, which will also help in the expansion of Telemedicine. He said this concept will certainly help the senior citizens, where they require general consultation or normal follow up for the medicine. Mr. Mehra also explained about the existing insurance policies and the important aspects of telemedicine consultation coverage in insurance.

he Industry Affairs Committee of PHD Chamber organized a webinar on 'Industry Strategy in COVID-19 and Post COVID-19 Scenario' on May 29, 2020.

In his welcome address, Dr D K Aggarwal, President, PHD Chamber launched a Report on 'PHDCCI Quick Survey on Post Lockdown Business Scenario, wherein he spoke on the challenges of the industry post lockdown as per the survey findings, including demand & supply disruptions, over dependence of India on few countries for imports, liquidity crunch, maintenance of profitability, among others. He congratulated the government's stimulus package of Rs 20 lakh crores, which has given India the vision to emerge as one of the largest economic power in the world and make 21st century belong to India. He welcomed the government's initiatives to de-criminalize corporate laws, commercial coal mining, contract enforcement, land & labour reforms,

privatization in sectors, among others. He suggested a few industry strategies including integration of Indian economy with global supply chain, creation of a conducive environment for companies interested to invest in India, reduction in the costs of doing business and embracing of Industry 4.0 to combat the impact of COVID-19.

Mr. Sanjay Aggarwal, Senior Vice President, PHD Chamber, in his special remarks stated that the package announced by the Government of Rs 20 lakh crores is not small by any standards. India stands among the countries, which have done most in terms of providing a COVID-19 relief stimulus. In this regard, he mentioned that the portion of package in the form of direct payment to the affected people is limited. He opined that the government should support the small businesses that are facing the issues of paying salaries to employees and subdued demand environment. He opined that the government should

spend on national infrastructure pipeline which will help in creation of demand in the economy.

Mr. Ajay Shankar, Former Secretary, Department for Promotion of Industry and Internal Trade (DPIIT), Ministry of Commerce and Industry in his address stated that industry chambers should interact with the authorities on reducing the pain points of the restrictions and restart the economy frictionlessly. He was of the view that direct payment of wages by the Government to the workers would have been an appropriate step. Further, he suggested that ease of doing business is the subset of costs of doing business and therefore focus should be put upon reducing the costs of doing business in the country.

Mr. Kuntal Sensarma, Economic Adviser, DPIIT, Ministry of Commerce and Industry stated that the Government is working tirelessly on the promotion of champion sectors



and undertaking facilitation measures to boost the manufacturing sector and to strengthen India's position in global supply chains. He said that the stimulus package should not be seen as a monetary package but should rather be seen from the reforms perspective. Going ahead, he suggested that the focus should be on reducing the excessive dependency of India on imports, enhancing research & development, upgrading skill set, increasing use of digital technology, among others. He said that there are around 10-12 sectors which have been identified for giving a boost to domestic manufacturing and for adding to the global supply chains, including food processing, electronics, organic farming, furniture, production of masks, sanitizers, ventilators, etc. He informed that they are closely working with the states on ease of doing business and adoption of the public procurement order. He said that they are also working with the NITI Aayog, on champion sectors, as well as on the network products for adding to the global supply chains.

Sudhir Kumar, Mr. Adviser, NITI Aayog, mentioned that at the current moment, one cannot clearly differentiate between COVID-19 and post COVID-19 period. He added that in the current scenario, important guestions are how to address demand and supply side disruptions, how to resume supply and demand of nonessential consumer goods and how to quickly ramp up production capacities. In this regard, he was of the view that sub-sector to sub-sector approach should be taken up. He further said that there is a need to focus on industry perspective on human resources as well as on increasing research & development and innovation in the industry.

Dr Rajesh Chadha, Program Director, Natural Resources, Brookings India, stated that mining sector is an integral part for the development of industry and appreciated the Government announcement on the commercialization of coal mining. He said that strengthening of the manufacturing sector is the need of the hour as there will be major changes in the dynamics of the global supply chains.

Prof. (Dr) Kavita Sharma, Former

Head & Dean, Department of Commerce, Delhi School of Economics, University of Delhi discussed about the collaborative agreement between PHD Chamber and Delhi School of Economics that was signed in 2018. She said that under the agreement, few reports have been prepared and currently work is going on regarding EODB index for MSMEs. She opined that there is a need to move towards digitization, address demand & supply situation, reduce the cost of logistics along with contractualisation and transparency in the logistics sector, bring in more IT infrastructure, focus on environmental perspective, green jobs, among others.

Mr. Deepak Pahwa, Chairman, Industry Affairs Committee, PHD Chamber in his theme presentation stated that India should look at success of its neighboring countries, such as China, Thailand and Vietnam in increasing the share of manufacturing in their GDP and attracting foreign investors. He opined that as part of industry strategy there is a need to focus upon development of MSME sector, increase research and development to boost Make in India, creation of business friendly environment in the country for both domestic and foreign companies/ investors, increase in localization, among others.

Mr. Vishwa Nath, Co-chairman, Industry Affairs Committee, PHD Chamber, appreciated the extensive relief measures announced by the government to mitigate the impact of pandemic COVID-19 on trade, industry and the economy. He suggested the need to provide continuous support to industry to revive it from the impact of COVID-19.

Mr. Vikram Agarwal, Co-chairman, Industry Affairs Committee, PHD Chamber in his vote-of-thanks discussed the disruptions caused by the rapid spread of COVID-19 and the relief measures provided by the government through the stimulus package. He said that there is a need for greater hand-holding of trade and industry by the government to revive economic activity in letter and spirit.

Mr. Saurabh Sanyal, Secretary General, PHD Chamber, expressed gratitude to the esteemed panelists for addressing the webinar and all stakeholders who have contributed to the PHDCCI Quick Survey on Post Lockdown Business Scenario.

Dr S P Sharma, Chief Economist, PHD Chamber presented the highlights of the PHDCCI Quick Survey on Post Lockdown Business Scenario.


The top ten challenges for businesses in the post lockdown business scenario include:

- 61% of the respondents said maintaining price-cost margins/ profitability
- 60% opined payment of wages/ salaries to employees
- 58% said availability of working capital
- 53% stated repayment of loans/ payment of EMIs
- 52% said high costs of capital
- 51% respondents said availability of finances/loans
- 51% opined costs of social distancing
- 51% said weakening of demand
- 50% stated compliances of labour laws
- 49% said retaining of the full workforce

The survey has revealed the top ten plans of the businesses firms in the post lockdown business scenario:

- 67% respondents said increasing the sales volume
- 65% opined enhancing competitiveness of business
- 64% said cost cutting of business operations
- 60% opined enhancing business operations in the domestic market
- 58% stated focus on innovation, research & development
- 53% respondents said enhancing the price-cost margin
- 50% said reducing the workforce in business operations
- 44% stated increasing the scale of business operations
- 43% opined diversification of business operations
- 36% said enhancing business operations in the international market.





The Minerals and Metals Committee of PHD Chamber organized an interactive video conference on "Atmannirbharta in Steel and Mining Sector: What the Structural Reforms Mean for India" with Ms. Rasika Chaube, IDAS, Additional Secretary, Ministry of Steel on May 30, 2020.

Ms. Rasika Chaube, IDAS, Additional Secretary, Ministry of Steel while deliberating on the Steel and Mining sector said that COVID-19 has given a lot of challenges as well as opportunities. This is the time to become self-reliant as much as possible and the Ministry of Steel has been working on self-reliance even before COVID-19 as well.

She explained that for the Ministry of Steel, self-reliance can be broken into two parts- production and consumption. In production, we are trying to make quality steel at competitive prices so that it can be transported and used on a profitable basis and add value. In terms of consumption, we must try to consume as much steel as possible or make a substitute and use domestic steel. Our prime objective is to produce and consume domestically. The challenge for reaching on self-reliance is to try to manufacture within the country and figure out export opportunities outside the country.

Ms. Rasika Chaube gave detailed insights about the initiatives towards domestic Manufacturing, Producing, and Atmannirbharta like National Steel Policy, Domestic Manufacturing Iron and Steel Policy, Import Steel Monitoring System, Steel Actions and many more. She was quoted to have said, "We have made a lot of action plans so that we can achieve our targets and goals. We are taking diligent steps in making India selfreliant in the steel industry and we are optimistic to achieve them".

Dr D K Aggarwal, President, PHD Chamber remarked that the Hon'ble Prime Minister's vision of Self-Reliant India gives a message to India that to come out of this adversity, we need to be self-reliant, independent and become a net exporter to the world. He said that the reforms and developments announced for the minerals and mining sector like mining auctions, mining serving, surplus production and others will help to boost the mining sector and go a long way to make this industry emerge stronger in future. It will create employment and new forms of investment which will help the economy to be self-reliant.

PhD Chamber organized a webinar on "Innovate for A Green Future – Hydrogen Production Technology & Relevance of Hydrogen Fuel in India" on June 1, 2020 with Mr. Sturle Harald Pedersen, Chairman of the Board, Greenstat Hydrogen India Pvt. Ltd. The objective of the webinar was to spread awareness of the hydrogen production technology and the relevance of Hydrogen Fuel in India which can be a substitute for natural gas or oil for a diversified energy economy.

Mr. Sanjay Aggarwal, Senior Vice President, PHD Chamber while welcoming Mr. Sturle Harald Pedersen mentioned that Hydrogen is the simplest and most abundant material available on earth and its usage in energy will help to boost the energy sector.

Dr J P Gupta, Chairman, Environment Committee, PHDCCI in his address talked about the positive effects of the pollution free fuel on Climate Change. He also said that Renewal fuel is going to be a path breaking fuel in future and it will positively be the foundation of a sustainable energy economy. Further, he said that Planet earth is facing an energy crisis. And human race must grow, develop, and move past the old and inefficient ways of generating energy and into a future where clean and efficient hydrogen fuel cells generate energy for years to come.

Mr Sturle Harald Pedersen, Chairman of the Board, Greenstat Hydrogen India Pvt. Ltd. gave an indepth insightful presentation about the Characteristics and Benefits of Hydrogen along with Regulatory Frameworks required. Looking at the present scenario, he explained how Hydrogen Fuel can be an effective energy resource in this world of climate change and help in green future sustainability.

He explained that Hydrogen is the fuel with the highest energy content per weight but its density in atmospheric conditions is only at 90 grams per cubic meter. To achieve this level of energy density, efficient comprehension of hydrogen is essential. He further explained that there are two mechanisms for creating clean hydrogen which is Green and Blue. Green Hydrogen can be created by splitting water into hydrogen and oxygen using electrolyzes and Blue Hydrogen can be produced through steam methane reforming or auto thermal reforming coupled with Carbon Capture Usage and Storage. He also gave a detailed understanding of the H2 Production Method.

Mr. Sturle Harald Pedersen also talked about the benefits of Hydrogen which is flexible, storable, transportable and safe. Hydrogen is relevant for India energy mix as it can have impacts on its main incentives: meet climate policy commitments, energy security and urban air pollution, he further elucidated.

Mr. Mahendra Rustagi, Cochairman, Environment Committee, PHD Chamber delivered the voteof-thanks wherein he expressed his gratitude to Mr. Pedersen for his excellent presentation which covered all the aspects from the characteristics, benefits and production to the regulatory aspect.







RENEWED ROLE OF INDUSTRY AND THE GOVERNMENT FOR SKILLED MANPOWER: POST COVID 19 PERSPECTIVE



The Skill and Entrepreneurship Development Committee of PHD Chamber organized an interactive webinar on the 'Renewed Role of Industry and the Government for Skilled Manpower: Post COVID 19 Perspective ' with Mr. Praveen Kumar, IAS Secretary, Ministry of Skill Development and Entrepreneurship, on June 5, 2020.

Mr. Praveen Kumar, IAS, Secretary, Ministry of Skill Development and Entrepreneurship, said that the Ministry of Skill Development will be releasing soon the SOPs for opening and operating of Skill Centres with Social Distancing Norms and will launch the Skill Management Information System while working on Reverse Migrants. He also said that there was a great asymmetry in the information of demand and supply of skilled workers - a need which will be fulfilled by the Skill Management Information System.

The Secretary further added that we are entering an era of Blended learning wherein techniques and technologies like AI and Simulation will be used for learning outcomes; yet he cautioned that we are faced with the challenge of a large section of population not equipped with laptops, though smart phones can fill in the gap. Online monitoring of the skilling activities need to be done not for attendance but for the learning outcomes, he added.

He also suggested that overdependence on the government for Skilling needs to pave the way for Fee based programmes. The Secretary shared that ITI Rejuventaion plan is underway on lines of the Sarv Shiksha Abhiyan and welcomed the industry to tie-up with 15000 ITIs. He also talked about the openness of the government to look at the regulatory simplification of the Apprenticeship Act to encourage industry for taking up apprentices for industrial training. He also clarified that the government is not looking at any bail out package for the Skill Development Industry.

Dr D K Aggarwal, President, PHD Chamber talked about the manner in which the labour work force has got displaced during these Covid times and the need to ponder over the fact that many of those may not return to their workplaces for months now which may require re-skilling the workers. The Skill Development Ministry may like to guide the industry and issue necessary guidelines for online skilling for various skilling projects sanctioned under the Skill Development Schemes of the Government of India, the President added.



He added that there is always an Asset Liability mismatch and the reducing gap of overnight commercial papers. He highlighted that the frauds are allowed to happen due to lack of governance and corporate frauds basically emerge from the greed. He suggested that it is a better way of surviving in the industry by not

CANCER CARE DURING COVID-19 TIMES- TACKLING OF NCDS

The Health Committee of PHD Chamber organized an interactive video conference on "Cancer Care during COVID-19 Times: Tackling of NCDs" on June 11, 2020. The webinar was moderated by Mr. Vivek Seigell, Principal Director, PHD Chamber.

Mr. Pradeep Multani, Vice President, PHD Chamber in his remarks mentioned that non-communicable diseases - including cardiovascular, cancer, chronic respiratory diseases and diabetes - kill 41 million people every year. Mr. Multani further added that investing in better management of NCDs is critical. Management of NCDs includes detecting, screening and treating these diseases, and providing access to palliative care for people in need. High impact essential NCD interventions can be delivered through a primary health care approach to strengthen early detection and timely treatment. Evidence shows such interventions are excellent economic investments because, if provided early to patients, they can reduce the need for more expensive treatment.

Dr N Subramanian, discussed the

impact of COVID-19 pandemic on Cancercare, highlighting that COVID-19 is global which is disrupted healthcare. He explained that one dimension is the number of deaths due to COVID-19 and the other is a disruption in life and care. As a medical practitioner, we cannot delay treatment of any disease during this period.

He further highlighted that cancer needs early attention. Apart from cancer, there are other (NCD) like diabetes, hypertension, health, and lung disease which constitute a large portion of deaths. We are aware that raising awareness, treatment, and prevention of these conditions is going to cost us nearly US\$ 47 trillion in the next 10 years.

He said that old people suffering from diabetes, kidney and lung diseases are required to be cautious and try to take measures to boost their immunity.

Heemphasized the need to focus on early interventions and the detection of NCDs as it is critically important. It's time to understand that COVID is going to take a while to go away and we cannot let other diagnostics suffer because of this pandemic. We need to take the necessary precautions, we also need to make our healthcare services adequately safe for the non-COVID conditions, protect the patients, community, workers, and doctors. All the procedures for early diagnostics will have to go on with added precautions without any delay, stated Dr Subramanian.

Dr Gopi Chand Khilnani deliberated about the COVID infection and its effect in various parts of the world and talked about its characteristics and symptoms. He said that when COVID-19 reached India, the government took swift action by taking measures like quarantines, isolation, social distancing, and lockdowns which helped to prevent the massive spread of this pandemic. After 2 months of lockdown, as we have started to unlock ourselves, we are noticing a severe escalation of the number of cases. But, we are doing robust testing, providing medical treatment and facilities to the patients at the earliest.

Talking about Cancer and other NCD, Dr Gopi Chand Khilnani said that recently, there was an increase in the cases of heart attacks in the US as the



people in the US were sceptical about going to hospitals. We have learned that COVID-19 not only affects the lungs, it also affects the brain, heart, cardiovascular system, intestines, and other parts of the body. Early detection and treatment are one of the most advised ways to treat this disease.

Dr Amish Vora discussed that Cancer is not a terminal disease and statistics show that cancer patients can be cured completely for life and there is treatment available to treat this disease. During COVID-19, there is a change in perception towards cancer. He further deliberated about the short pause in the availability of medications and facilities of cancer during this pandemic and how it shiftily got back to track. Today, in every part of the world, cancer treatment is not interrupted. It is done slowly by taking all the precautions.

Mr. Aditya Talwar gave a brief insight into H.O.P.E. Oncology Clinic, its journey, and how it facilitates as a center for cure for cancer patients. He also highlighted the measures taken by the organization is keeping their patients safe during these times and treating every patient, health worker and support staff as a part of the family. He also discussed that while the organization takes care of the patients medically; it also looks after their beauty and wellness.

Mr. Saurabh Sanyal, Secretary General, PHD Chamber delivered the vote- of- thanks to all eminent panellists for sharing their knowledge and experience. He further shared that eating a healthy diet, increasing physical activity and avoiding tobacco use can prevent 80% of premature heart disease, 80% of type 2 diabetes cases and 40% of cancers. Mr. Sanyal lastly concluded that Epidemic preparedness – today and in future – depends on strong health systems, a resilient, qualified, well-resourced health workforce and healthy populations.

Ltd. shared that due to the availability of 20% labourers, construction work has started in green zones and in some parts of Karnataka, Gujarat and J&K. Mr. Chaudhary pointed out that since, construction is a laborintensive sector, it will be critical how the labour is handled with proper and safe spaces will have to be provided for their accommodation while being educated about certain practices such as wearing masks, sanitizing, maintaining social distancing, etc. As a result, this will increase the cost of labour. The CMD also opined that according to industry expectations, the situation is likely to improve by September 2020.

He gave an overview of the measures initiated by RBI which helped in revival of industries and sectors up to some extent. He also lauded the support given by SBI to their customers.

Chief Guest, Mr. Sujit Varma, Deputy Managing Director-Corporate Accounts Group-SBI in his address mentioned that COVID -19 has turned from a health crisis to an economic crisis. In his expert insights on the current statistics, he further added that the severe digital disruptions in supply chains, cash flow mismatch, increased working capital requirements, raw material shortages, forex losses, labour crisis are the major challenges of the industry. He added that banks are flushed with liquidity. The banks on an average are parking Rs. 6-7 lakh crores to the reverse repo window (of the RBI where they earn interest), because banks do not see any credit off-take, there are no credit demands from the private sector amidst the coronavirus crisis, there is a complete lack of fresh investments by businesses. However, the lenders at this juncture still have to be prudent in their lending decisions and cannot be "reckless".

He further stated that "Our chairman has mentioned that wherever there is a bankable proposal, we are willing to fund that, which we keep on saying as well. SBI being the largest bank, I can tell you that we are always willing and we are ready to play our part and extend that support to help the economy and various industries." The Chief Guest said that Post lockdown the corporates -- big or small -- will have to re-evaluate and re-asses their business plans. He also suggested the businesses to make best use of the relief package provided



by the government and the RBI.

Mr. Sanjay Aggarwal, Senior Vice President, PHDCCI applauded the initiatives provided by SBI to their customers. He also mentioned that 21% of the share of deposits of the country is controlled by the SBI, making it one of the strongest pillars of the country in the banking sector. Mr. Pradeep Multani-Vice President, PHDCCI appreciated the efforts done by State Bank of India to help businesses.

Mr. Vinod Jain, Chairman- BFSI Committee, moderated the session. He put the industry perspective, issues and challenges being faced by industries and also suggested relief measures to smooth the operations.

WEBINAR ON 20 LAKH CRORE STIMULUS PACKAGE GROWTH PROSPECTS OF INDIAN ECONOMY IN COVID-19 AND POST COVID-19 SCENARIO

The Economic Affairs Committee of PHD Chamber organized a webinar on '20 Lakh crore Stimulus Package: Growth Prospects of Indian Economy in COVID-19 and Post COVID-19 Scenario' on June 13, 2020.

Eminent Economists, Dr Ashima Goyal, Member of Economic Advisory Council to the Prime Minister & Professor, Indira Gandhi Institute of Development Research; Prof N R Bhanumurthy, National Institute of Public Finance and Policy (NIPFP); Prof Ram Singh, Department of Economics, Delhi School of Economics, University of Delhi and Mr. T K Arun, Editor, Economic Times participated in the webinar.

Dr Ashima Goyal, Member of Economic Advisory Council to the Prime Minister & Professor, Indira Gandhi Institute of Development Research in her address said that the large economic loss due to COVID-19 will pass soon as it is temporary in nature and result of a natural shock. In regard to high frequency data, she mentioned that there was recovery in some indicators, stock market has somewhat recovered, there is a rise in demand for consumer durables, among others. crore should be seen with the aspect of sequencing of measures as the lockdown has affected the supply side much more than the demand side. She opined that with phased lifting of the lockdown, there will be focus on more direct demand measures in the coming times and spending on infrastructure development will get a boost.

Prof N R Bhanumurthy, National Institute of Public Finance and Policy (NIPFP) mentioned that India was already experiencing a slowdown in pre COVID-19 period, which has been further aggravated due to emergence of COVID-19 and resultant lockdown. While appreciating the measures



taken by the government in areas of agriculture, defence, opening of strategic sectors, among others, he stated that these measures will help the economy in medium and longterm. He suggested that there is a need to focus on tackling the shortterm demand side situation, handhold the state governments and focus on achieving US\$ 5 trillion economy in the coming times.

Prof Ram Singh, Department of Economics, Delhi School of Economics, University of Delhi stated that several national and international agencies have reduced India's growth forecasts, investments have come to a halt and consumer & non consumer durables have taken a hit. He mentioned that the economic scenario due to COVID-19 started as a supply side problem, which has now transformed into demand side problem. Going ahead, effective implementation of reforms and spending on building infrastructure at ground level will help in mitigating the impact of pandemic COVID-19.

Mr. T K Arun, Editor, Economic Times said that it is essential that hospitals are being built, manufacturing of PPE kits and other consumables should be seen as growth opportunities. He suggested that investment in infrastructure needs to step up and create a viable and functional bond market. He opined that health infrastructure is crucial at this juncture and bank lending should be promoted to boost industrial and investment activities in the economy.

Dr D K Aggarwal, President, PHD Chamber in his presidential address appreciated the mega economic stimulus package of Rs 20 lakh crores and relief measures announced by the Government. He added that the reforms announced by the Government will strengthen the various segments of the economy and socio-economic development in the country and lead to meet our objective to become a self-reliant country going forward.

Mr. Sanjay Aggarwal, Senior Vice President, PHD Chamber stated that credit delivery must be promoted; direct benefit transfers should be encouraged along with reviving demand in the economy. He stated that there is a need to develop soft infrastructure along with hard infrastructure. He also mentioned that the announcement on removing the norm for farmers to sell agriculture produce only to licensees in APMCs is appreciable as it will provide adequate choices to them to sell their produce at attractive prices in a common market. He urged that money should be provided to states /local municipalities

for the socio-economic development of the economy.

Dr Lalit Khaitan, Chairman, Economic Affairs Committee, PHD Chamber said that Rs 20 lakh crore would change the curve of economic development and will move towards reviving growth, infrastructure development, reaping demographic dividend, demand and technology. The reforms and relief measures provided by the Government will go a long way to make Atmanirbhar Bharat.

Ms. Yashika Singh, Co-chairperson, Economic Affairs Committee, PHD Chamber was hopeful that the policy focus on self-reliance is likely to give a fillip to overall manufacturing in India that in turn will benefit the SMEs through the value chain linkages.

The Insolvency and Bankruptcy Committee of PHD Chamber organized a webinar on "Impact of IBC (Amendment) Ordinance, 2020" on June 16, 2020. The objective of the webinar was to deliberate on the impact of IBC (Amendment) Ordinance, 2020 for the survival of numerous corporate debtors across the country in the wake of COVID-19 scenario.

The eminent speakers at the interactive webinar were Mr. Sanjiv Sen, Senior Advocate, Supreme Court of India; Mr. M M Kumar, Chief Justice (Retd.) J&K High Court, Past President, NCLT & Patron, NCLTBA; Mr. Sanjay Aggarwal, Senior Vice President, PHD Chamber; Mr. Vipul Maheshwari, Advocate & Chairman, Insolvency and Bankruptcy Committee, PHD Chamber; Mr. G P Madaan, Advocate & Co-chairman, Insolvency and Bankruptcy Committee, PHD Chamber and Mr. Dinesh Agarwal, Cochairman, Insolvency and Bankruptcy Committee, PHD Chamber, Mr. Saurabh Sanyal, Secretary-General, PHD Chamber and Dr S P Sharma, Chief Economist, PHD Chamber.

Mr. Sanjay Aggarwal, Senior Vice President, PHD Chamber in his welcome remarks highlighted about the Insolvency and Bankruptcy Code (Amendment) Ordinance, 2020 which has recently been promulgated by the Hon'ble President of India. He added that the Ordinance takes cognizance of the fact that it would be difficult to find an adequate number of resolution applicants to rescue the corporate person who may default in the discharge of their debt obligation during these difficult times. He opined that the Ordinance is a game-changer for the survival of numerous corporate debtors across the country in the wake of COVID-19 scenario.

Mr. Sanjiv Sen, Senior Advocate, Supreme Court of India, stated that the Insolvency and Bankruptcy Code (IBC), 2016 is a landmark reform in the history of ease of doing business initiatives undertaken by the government. The code aims to protect the interests of the industry stakeholders by providing one-stop solution for resolving insolvencies and by fostering healthy, transparent and vibrant growth of the corporate sector



of the country. He highlighted the pre and post (Amendment) Ordinance, 2020 scenario of the Insolvency and Bankruptcy Code and stated that the suspension of Section 7, 9 & 10 will provide a great relief to corporate debtors.

Mr. M M Kumar, Chief Justice (Retd.) J&K High Court, Past President, NCLT & Patron, NCLTBA, stated that the IBC (Amendment) Ordinance, 2020, issued on June 5, 2020 is only a partial relief to the ongoing economic crises. He opined that section 240A should have been used to rescue the MSME sector. He suggested that there is a need for continuous handholding of the MSME sector through various reforms to revive it from the impact of COVID-19.

Mr. Vipul Maheshwari, Advocate & Chairman, Insolvency and Bankruptcy Committee, PHD Chamber, mentioned that the introduction of Section 10A imposes a specific bar on initiation of corporate insolvency resolution process under Sections 7, 9 and 10 for a default arising on or after March 25, 2020 for a period of six months or upto one year as may be notified. He added that there is a need to look at cases where creditors, as per the Purchase Order or Contract of Supply, hold raising of invoices and issue them post the completion of 6 months of the Ordinance to move the date of default as per their convenience.

Mr. G P Madaan, Advocate & Cochairman, Insolvency and Bankruptcy Committee, PHD Chamber stated that through suspension of the operation of Sections 7, 9 & 10 of the IBC, 2016, the Ordinance will help prevent corporates, facing distress on account of unprecedented situation of COVID-19, from being pushed into the insolvency proceedings.

Mr. Dinesh Agarwal, Cochairman, Insolvency and Bankruptcy Committee, PHD Chamber mentioned that the spread of pandemic COVID-19 has led to a situation of cash crunch, thereby impacting the economy, industry and trade. He added that COVID-19 pandemic has impacted the business and financial markets across the country and created uncertainty and stress for the business beyond their control. Further, he accentuated about the provisions of suspension of the Section 7, 9 & 10 of IBC Code.

Mr. Saurabh Sanyal, Secretary General, PHD Chamber, delivered the vote-of-thanks to all the esteemed dignitaries and summarized the session.

Dr S P Sharma, Chief Economist, PHD Chamber while moderating the webinar mentioned that the relaxations and ease in compliance deadlines provided will help businesses to sustain themselves in the current atmosphere and will have a positive impact on economic activities.

The webinar concluded with an extensive discussion and Q & A Session with an overwhelming response from the participants.







RAMIFICATIONS AND RELIEFS IN GST IN LOCKDOWN PERIOD COVERING DECISIONS TAKEN UP IN 40TH GST COUNCIL MEETING

The Indirect Taxes Committee of PHD Chamber organized a webinar on 'Ramifications and Reliefs in GST in Lockdown Period Covering Decisions taken up in 40th GST Council Meeting' on June 20, 2020.

Mr. Pradeep Multani, Vice President, PHDCCI stated that the decisions to provide relief to small tax payers in terms of filling GST returns, waiver of late fees and interest are highly encouraging to mitigate the daunting impact of pandemic COVID-19 and promote ease of doing business for small tax payers in the coming times. He said prior to COVID-19 period, all those who have no tax liability but have not filed GST returns for tax period July 2017 - Jan 2020, there shall be no late fee at all. He also said that the launch of e-Office marks a fundamental change in internal office procedures which is so far based on manual handling of files and paper movement.

Mr. Bimal Jain, Mentor, Indirect Taxes Committee, PHDCCI discussed the GST impact of terminated contracts on taxpayers and suggested measures on how to resolve GST issues in terminated contracts during COVID-19 period. He also discussed the Input Tax Credit pertinent to goods lost, destroyed, written off and disposed of by way of gift & sample during COVID-19 period.

Mr. N K Gupta, Chairman, Indirect Taxes Committee, PHDCCI in his theme presentation said that no tax relief has been provided by the Government or GST Council under GST. He said that extension of dates and the reduction of interest rates are already available under the doctrine of Force Majeure. Further, he discussed the circular issued by the Central Board of Indirect Taxes and Customs regarding provincial clearance of goods under India's Trade Agreement (ITA). He said that the circular provides an option to clear goods under preferential tariff claim, in terms of section 18 of the Customs Act, 1962, where a Certificate of Origin (CoO) is not available at the time of filing customs documents.

Mr. Gaurav Gupta, Co-chairman, Indirect Taxes Committee, PHDCCI highlighted that the maximum late fee for non-filing of GSTR-3B returns for period July 2017 - January 2020 for people who have tax liability has been capped to Rs 500 and will apply to all returns submitted during July 1, 2020 - September 30, 2020. He highlighted that Small tax payers are not required to pay interest for late furnishing of GST returns till July 6, 2020 and after that interest rate will be reduced from 18% to 9% till September 30, 2020. He suggested that the government should provide complete waiver of Interest instead of reduction of interest rates from 18% to 9%.

Mr. Puneet Agrawal, Partner, ALA Legal discussed the rejection of installment for the payment of tax application under section 80 of the CGST Act and Non-Sanctioning/ Withholding of eligible refund in case of exports. He stated that the Hon'ble Finance Minister has announced immediate relief to the assessee in form of expeditious disposal of export refunds during the COVID 19 crisis.

Mr. Rakesh Garg, Partner, SSAR & Associates in his presentation said that the provisions related to 'time of supply' are very important; and until the 'time of supply' has not arrived, GST shall not be levied. He mentioned



that Sections 12 and 13 of the CGST Act provide separate provisions for time of supply for goods and services. He said as per Section 12(2), the time of supply of goods shall be the earlier of the following dates, namely (a) the date of issue of invoice by the supplier or the last date on which he is required to issue the invoice with respect to the supply, or (b) the date on which the supplier receives the payment with respect to the supply.

Mr. Saurabh Sanyal, Secretary General, PHDCCI appreciated the relief measures announced by GST Council as these decisions were aimed at easing the burden of businesses facing challenges because of the COVID-19 crisis. Dr S P Sharma, Chief Economist, PHDCCI said that GST Council discussed a number of aspects related to GST and provided relief measures for filing GST returns to promote ease of doing business especially for small tax payers. The webinar concluded with an extensive discussion and Q & A Session with an overwhelming response from the participants.

The session was introduced by Ms. Priya Hingorani, Chairperson, ADR Cell who spoke about the status of Mediation in India and its importance in the coming times.

The facilitator and keynote speaker of the workshop, Mr. Alok Krishna Agarwal, Co-chairperson, ADR Cell and Founder, Sheldon Law Firm delivered an informative session covering almost all major aspects in the field of out of court dispute resolution. He extensively encrusted the concept of Arbitration, Mediation, Conciliation, Negotiation and ODR.

Starting with the genesis of ADR, he elaborated the concepts of various ADR mechanisms, explaining the idea of Domestic and International Arbitrations. Several other important concepts were discussed which included Institutional Arbitration, Ad-hoc Arbitration, Evolution of ADR in India (staring from the

Panchayat system till the recent 2019 Amendment Act), Arbitral Awards (both domestic and foreign), (their Arbitrators qualifications, appointment and removal), Essential Elements of Arbitral Agreements, Stages of Arbitral Proceedings, Applicability of Indian Statutes and Laws on Arbitration (Principles of Natural Justice, CPC, Evidence Act and Limitation Acts), Arbitral Appeals, New York and Geneva Conventions besides various other notions. On emphasizing the importance of ODR as the most important tool for dispute resolution in coming times, he also opined that usage of ODR mechanism in India as compared to foreign nations is very minimal but soon it will become a new normal in India as well.

The session ended with the closing remarks by Dr Jatinder Singh, Director, PHDCCI.

Mr. D.P Goel, Co-chairman, MSME Committee, PHDCCI in his welcome address stated that sales have declined by almost 70 per cent during the lockdown with fear of further decline in times to come even as majority of retail brands are opening physical stores in a structured manner with reduced shifts and restricted customer entry. He mentioned that in order to steer the business through this pandemic with limited physical contact as much as possible during this COVID-19 outbreak and ensure business continuity, now is a good time to encourage the customers to

shop online.

Mr. Preveen Khandelwal, Secretary General, Confederation of All India Traders in his special address mentioned that Indian retailers do a daily business of around Rs 15,000 crore and since the country is in a lockdown there has been a huge loss of over Rs 5.50 lakh crore of business, which is done by 7 crore traders of the country. This will force around 1.5 crore traders to permanently close down their shutters and a further 75 lakh traders, who are dependent on these 1.5 crore traders, will fold up in the medium-term.

Mr. Aankit Handa, Founder Rack 37 Innotech Pvt. Ltd. talked about the introduction to Secondary Market Channelizing Tech Based B2B Platform for MSMEs. This platform helps to sustain the pressures of competition that has also brought unforeseen burdens on the MSMEs. They increasingly have to bear risks of just-in-time delivery such as holding higher and diverse inventories, thereby increasing working capital requirements and incurring additional costs.

Member for Digital Health, AI Health, Telemedicine & Innovation, WHO Global Digital Health, WHO Geneva while emphasizing the importance of Digital Health said, "Sharing of Health Data of Public and Private Hospitals is critical to development of Digital Health in India and it can go a long way in forecasting and managing Pandemics." He also added that this should be done in framework of the Indian Regulations and Data Protection Act. He said that the goal is to have accessible and affordable health for all but on the input side we need to have a lot of standardization and structuring of the data. He further underlined that for digital healthcare, the need is to have a collaborative approach of all stakeholders as

technology by itself will not be enough to reduce inequalities in healthcare delivery.

Mr. Rani Shifron while deliberating on the topic, mentioned that the critical requirement is to create technologies and quickly take them across the Globe. He presented the Digital Health ecosystem in Israel and shared that any such initiative has to have the Will of the Government to make it a success which is what has happened in Israel.

He discussed the need to bring medical technology into the rural areas to be able to provide healthcare in remote areas. He also shared that the best way to collaborate with Israeli companies would be through



the Israel India Collaboration Body while direct options are also available.

Dr Pankaj Gupta said that during this pandemic, we see acceleration and adoption of digital healthcare due to COVID-19 in India. Technologies that have worked right have led to better results and are being used clinically starting from remote doctor checkup to other solutions. He mentioned that data quality and governance are major challenges to the growth of the Industry. He emphasized the need for creating an eco-system for digital health technology by bringing them to the market. He deliberated about the work done by Access Health International in promoting digital health.

EMERGING CYBER THREATS AND CHALLENGES IN INDIA DURING COVID -19

he Women Entrepreneurship Committee of PHD Chamber organized a webinar on 'Emerging Cyber Threats and Challenges in India during COVID-19 Lockdown' on June 27, 2020.

Eminent speakers included Mr. Anyesh Roy, DCP, Cyber Crime, Delhi Police; Dr Pavan Duggal, Founder & Chairman of International Commission on Cyber Security Law; Mr. Matthew See, Manager, Sales Engineering -APAC, WatchGuard Technologies Inc. and Mr. Sachin Dedhia, Founder & CEO, Skynet Secure Solutions.

Mr. Sanjay Aggarwal, Senior Vice President, PHD Chamber in his welcome address raised concerns regarding the increase in cybercrime and hacking cases that have led to loss in businesses and other conglomerate companies. Due to COVID-19, there has been an increase in the digitalization of working but most of the businesses and companies are not equipped with the right awareness or right resources to secure their networks.

Dr Aruna Abhey Oswal, Chairperson Women Entrepreneurship Committee, PHD Chamber spoke on the need to secure the gateways and protect ourselves from the ongoing cyber attacks.

Dr Pavan Duggal, Founder & Chairman of International Commission

on Cyber Security Law in his presentation mentioned that cyber attacks have become a new normal in today's times. He cited case studies of corporate companies, hospitals, and banks in India and globally that have been hit due to cyber attacks.

He also shared information about data protection and privacy laws in India which still needs a lot of work. He said that while companies are letting their employees work from home; they need to strengthen their safeguarding policies so that they don't fall into the pit hole of cyber attacks. He highlighted that cyber security law should be a part of national law.

Mr. Anyesh Roy, DCP, Cyber Crime, Delhi Police highlighted that Business E-mail comprises one of the most common frauds which can be prevented which involves writing the email id instead of an automatic reply which helps to prevent fraud. He also raised the need for having antivirus on emails, mobiles, and other frequently electronic devices.

Mr. Anyesh Roy highlighted the preventive measures or precautions taken care of to protect data from the cyber threats.

Mr. Matthew See, Manager, Sales Engineering - APAC, WatchGuard Technologies Inc. in his presentation shared the spike in the number of hacking cases during the lockdown worldwide. He gave a brief insight into the working of WatchGuard Technologies Inc. in safeguarding the networks of business and corporate companies.

Mr. Sachin Dedhia, Founder & CEO, Skynet Secure Solutions gave a presentation with practical examples of retrieving any person's password from their system and how hacking is done on electronic devices. He also shared how one can monitor the number of users on a network via useful sites and apps.

Ms. Nazm Bilochpura, Member, Women Entrepreneurship Committee, PHD Chamber gave a brief insight into the increase in cyber hacking cases in the past few months during the lockdown.

Dr Blossom Kochhar, Cochairperson, Women Entrepreneurship Committee, PHD Chamber delivered the vote- of- thanks to all the delegates.




Mr. N K Aggarwal, Chairman, Agri Business Committee, PHDCCI

PHD RURAL DEVELOPMENT FOUNDATION (PHDRDF)

n January 30, 2020 WHO declared the outbreak of Corona virus as Public Health Emergency of International Concern followed by declaring COVID-19 as pandemic on March 11, 2020 after seeing the severity and spread of the disease and the alarming levels of inaction affecting globally including India. India has been on lockdown since the last week of March and many have been stranded in different parts of the country with the daily wagers, rag pickers, migrant workers, and street food vendors being the most suffering people getting affected economically.

PHD Chamber of Commerce & Industry strongly believes in its social responsibility being an important part of business philosophy and is contributing through its social arm PHD Rural Development Foundation. PHDRDF has partnered with Coca Cola India and is distributing beverages to CRPF jawans, Police Personals on duty, gas distributors, DTC bus drivers, MCD workers, slum areas and migrant workers across different states including Kirti Nagar Industrial Area, Sangam Vihar, Khanpur, Narela, Patel Nagar, Vikaspuri in Delhi/NCR, Ludhiana, Sangrur and Jalandhar in Punjab, Uttar Pradesh and others. PHDRDF has been actively conducting free health camps for the low income population in various geographical locations across the country to increase access to healthcare. A team of a qualified Doctor, ANM, Lab Technician and project coordinator are present for each camp and are responsible for its success. Emphasis is given on generating awareness among the community on sanitation & hygiene, child & maternal health, waterborne diseases, communicable diseases and other geography based medical problems.

PHDRDF- NATIONAL SAFAI KARAMCHARIS FINANCE & DEVELOPMENT CORPORATION

HDRDF has got into partnership with NSKFDC for conducting 25 health camps from August to November 2020 in 25 locations. The camps are intended to provide basic health check-up facilities including Blood Pressure/Sugar check, ECG, Eye check-up, free medicine etc to safai karamcharis/manual scavengers PAN India. Doctors including general physician, eye surgeon, paediatrician, dermatologist and a gynaecologist will be available in these camps.

PHDRDF- DHAMPUR SUGAR MILLS LTD.

HDRDF and Dhampur Sugar Mills Limited, Asmoli, have been working for the last two years towards providing health care services to less privileged community. Dhampur Sugar Mills Limited, Asmoli, Uttar Pradesh collaborated with PHDRDF for another one year for the project "FREE MOBILE HEALTH SERVICES" in Asmoli across og villages near Dhampur Sugar Mills. During the year, 115 camps were organized in which 13430 patients were provided health care services. Patients were provided with free medical counselling, ECG, blood sugar, haemoglobin test facility and medicines. Specialised health facilities are being arranged in the factory premises of Dhampur Sugar mills during COVID-19 for the employees of company. Scanning through thermometer gun is being done regularly. The health camp will continue after the lockdown.

PHDRDF-ROTARY CLUB OF HARIDWAR

PhDRDF has partnered with Rotary Club of Haridwar through THDC, Rishikesh for a Mobile Medical "Sehat Van" to provide a holistic health care program to 30 villages in Tehri Garhwal. The project will provide screening, diagnosis and treatment for Non-Communicable Diseases (NCD) including Diabetes, Hypertension, Cardiac problem and/ or Oncology through on- ground health camps as well as Tele-medicine consultation with specialist doctors. The mobile medical van will be equipped with testing devises like ECG, blood test and supported by a qualified medical team consisting of a medical doctor and paramedical staff. The project will reach out to approximately more than 1000 people every month for a period of one year. The project will be initiated after the lockdown and receiving requisite approval from the government authority.

PHDRDF WATER MANAGEMENT

HDRDF has been constantly working towards recharging of ground water table by establishing Rain water harvesting structures and generating awareness among the community on the need and technologies of water conservation.

Students of electrician batches were also provided with placement links for their livelihood. Currently, activities under DRI Computer Centre are on hold due to the spread of Coronavirus and lockdown announced by the government. Currently, both courses training are on hold due to the pandemic situation and lockdown.

Dow Agro Sciences India Ltd has partnered with PHDRDF to implement a project for empowering rural women by training them on "Beekeeping" as a supplementary source of income. An estimate of 200 women were trained in bee keeping and harvesting honey and allied products like – royal jelly, bee wax, bee pollen, etc. The training project in Maharashtra and Haryana has been successfully completed. After the training, women in Maharashtra have been provided with 5 bee boxes with bee hives each and tools free of cost. In previous year, a total 40 girls in each course, two batches consisiting 20 girls in each batch of cutting & tailoring and beauty culture courses had been formed but due to the pendamic situaltion, the training of these batches is on hold. Presently, due to Coronavirus outbreak, the centre has been initiated with maintaining physical distance and precaution and the girls are being trained to make cloth masks in collaboration with one of the local hospital. To address the demand of the low cost cloth based masks, a goup of 5 girls has been formed to stitch the masks. Till date, around 500 pcs of masks has been stitched out of which around 400 pieces has been sold. The revenue earned through this activity is being disbursed among the girls.

Govt plans to cut import dependence

NEW DELHI: The government is working on a sectoral strategy to reduce import dependence by building local capacity, creating value chains and quickly attaining self-reliance in at least half-adozen areas ranging from foot-wear and furniture to technical textiles and medical equipment to electronics and defence production, people aware of the development said.

The sectors will receive fiscal incentives credit support and tariff protection from an influx of cheaper imports, particularly from China, the people said, requesting anonymity.

"All custom duty exemptions would be comprehensively reviewed and many of them will go as they are hurting domestic manufacturing. A view on this is expected by the end of this quarter [FY-2021]," one of the people, who works for an economic ministry, said.

The sectors are being identified carefully on the basis of availability of supply chains and skilled workers, besides their potential to create job opportunities, the people said.

Prime Minister Narendra Modi has spelled out a vision for an Aatmanirbhar Bharat (Self-Reliant India) as the country bat-

tles the coronavirus pandemic and subsequent lockdown that is expected to cause an economic contraction this financial year. India has also been concerned about the size of its trade deficit with China, a concern that has been accentuated by this month's military faceoff in the Galwan valley in eastern Ladakh.

The balance of trade between India and China is hugely tilted in the favour of the latter. Accord-ing to recent trade figures released by the General Administration of Customs of China (GACC), India's trade deficit with China was \$56.77 billion in 2019. Bilateral trade between the two countries was about \$92.68 billion in the year.

"The government's strategy is a combination of its ongoing Make in India policy and Atmnirbhar Bharat Abhiyan (Self-reliant India Initiative). It should not be seen as a reaction to the Chinese misadventure at the border," the first person said.

Relations between New Delhi and Beijing have soured after China's People's Liberation Army engaged with the Indian Army in a brutal brawl at the Galwan valley on June 15, leading to the loss of 20 Indian personnel. The unprovoked Chines eaggres sion has triggered calls for a boy-cott of Chinese goods.

"The policy to reduce import dependence predates the recent Chinese aggression. The finance minister did mention it in her budget speech. However, a popular sentiment against Chinese imports [after China's recent aggression], will certainly also help us in our objective," a second person, who advises the government on trade issues, said.

While presenting the Union budget on February 1 this year, finance minister Nirmala Sitharaman said the unhindered imports of goods under free trade agreements (FTAs) were hurting domestic industries, particularly MSMEs and such imports required stringent checks.

The government is also considering persuading big industries to use locally produced raw mate-rials such as steel. "This is the policy even in some of the developed countries where Indian MNCs own automobile companies. The automakers are told to use locally purchased steel," a third person, who works in the steel ministry, said.

"The government is taking measures to curb dumping of steel and steel products that are sub-standard in quality," he added. The ministry has already issued a directive for state-run firms asking them to prefer domestically manufactured iron and steel products.

Experts said the government's sectoral strategy was a step in the right direction, but import curbs should be calibrated to avoid any abrupt disruption in supply.

"Yes, a sectoral strategy is the only way to reduce dependence on imports. India should immediately consider sector-based clusters, on plug and play model," Mohit Singla, chairman of the Trade Promotion Council of India (TPCD, said,
