A toxic mix of poor governance, a deficit in fiscal resources and grand corruption finds the Namibian government at a loss on how to plan, implement and manage its big-ticket development projects, many of which are white elephants pushing it further down the path of public private partnerships.

In a notice of gratitude to sponsors for the 6th Public Private Procurement Conference held from 16- to 17-Jun-21, the Ministry of Finance said it had identified seven of thirteen projects launched during the conference, that are suitable for development through public private partnerships

The conference was staged under the theme, 'PPP – a recipe for economic recovery and infrastructure development'

The priority list of the screened and assessed projects suitable for PPP development consists of:

(1) Development of Student Village for the Ministry of Higher Education, Training & Innovation;

(2) Concentrated Solar Power for Nampower:

(3) 25MW Solar PV Plant for the City of Windhoek:

(4) Otjiwarongo Wastewater Treatment Works Project for Otjiwarongo Municipality;

(5) Katima Liselo Green Scheme Irrigation Farm for AGRIBUSDEV

(6) development of Direct Reclamation Plant for the City of Windhoek; and

(7) Desalination Water Supply project for NamWater.

Feasibility studies for Projects 1, 2 and 7 are currently being undertaken, while the remaining projects "will soon be ready to undertake feasibility studies", according to the ministry's notice.

Over 550 participants attended the conference virtually, although

only 250 were anticipated. The ministry said its PPP Unit and PPP Committee looked forward to engage with the respective public entities to get their projects registered as PPPs and to provide relevant support to take the projects through the next stages of preparation and procurement by obtaining Transactional Approvals 1-4 in accordance with the PPP

Details on some of these projects have earlier been published from the Tender Bulletin's database.

Student Village

A request for proposals for the provi-sion of Transaction Advisory Services to the Ministry of Higher Education, Training & Innovation closed on 10-Aug-20 under tender SC/RP/32-01/2020.

It called for consultants to work with the ministry through the stages of project feasibility assessment, project structuring, undertaking the developer selection process, including developing the procurement documents, drafting the PPP agreement and running the procurement process - up to developer selection. The notice stated that the MHETI

wishes to enter into a Public Private Partnership with a reputable private entity "having experience in offering affordable accommodation to students" for its Student Village Development PPP Project (more details in *Bulletin* 1355).

Concentrated

Solar Power

The only public tender for the CSP project issued by Nampower to date was under NPWR/2016/11 that closed 01-Apr-16.

The tender called for a study of the macro economic impact to qualify and quantify the impact and effect of implementing a CSP generation facility on the

Namibian economy, including storage. NamPower said it had embarked on the development of CSP generation facility with thermal storage as one of the solutions to resolve the medium- and

long-term power supply deficit. Seven offers from N\$1.3-m to N\$9.6-m were received at the time (details and bids were published in Bulletin 1150).

The awards currently posted on the NamPower website do not include the successful consultant for this tender from 2016. This project is also not listed under 'projects - generation' on the power utility's website

City's 25MW PV plant

The Windhoek City Council issued a 'request for qualification' on 18-Jun-21 under W/RFQ/COW-101/2021 (PPP), inviting applications from experienced Independent Power Producer developers for the construction, financing, commissioning, operation and maintenance of a 25MW solar PV plant for the Council on a Build, Own & Operate (BOO) model over 25 years.

The tender closes on 19-Aug-21 (details in Bulletin 1401).

Katima Liselo

Green Scheme

The last Katima Liselo tender was issued by the Ministry of Agriculture, Water & Land Reform as an invitation to lease the Katima-Liselo Green Scheme Irrigation Farm for one rain-fed cropping season from Dec-20 to Jun-21. A total of 1,700ha was available

- 60ha per person. This tender closed on 27-Nov-20 (*Bulletin 1373*).

Desalinated water supply

The second desalination plant for NamWater estimated to cost N\$3.5-b was covered in a special report on the history, progress and feasibility study for the project in Bulletin 1403 ('Salty Water Everywhere, not a drop to drink for the next decade').

Problems with PPPs

In a report in April 2018, the World Bank advised the Namibian government to finance the upgrade of Hosea Kutako International Airport through private partner investors.

The Ministry of Finance had also asked the Bank the previous year for advice on how to manage the N\$4.2-b container terminal in the port of Walvis Bay, as well as the HKIA upgrade through PPPs.

The Bank provided several options on the government partnering with a private company, such as sale of shares (privatization), a concession up to 30 years (through a public tender) or a management contract (where the private operator only manages certain parts of the airport).

Finance permanent secretary Ericah Shafudah had written to the World Bank in 2017 for advice on the possible ap-pointment of a private sector operator as a plausible route to maximize the utilization of the Walvis Bay container terminal.

Critics see the World Bank's advice as a way to promote the interests of private companies to generate profits, resulting in strategic entry points into the country falling into private hands.

The government pushed ahead with the development of big-ticket projects such as the maritime container terminal and the national fuel storage facility without thinking through the manage-ment of these multi-billion strategic facilities.

Unions not

impressed

The National Union of Namibian Workers was upset, to say the least, upon hearing about the finance ministry's request for PPP advice from the World Bank.

In a statement in 2017, the union raised concerns about the possible transfer of the management of some state-owned enterprises to private companies.

The NUNW was "perplexed, disheartened and infuriated" by the com-munication of the finance ministry with the World Bank and said it rejected "with contempt" the attempt by government to get advice from international banks.

This was an indication that those in leadership positions did not have the in-terests and welfare of current and future generations at heart, as they appeared intent on gambling away the assets of the country.

The union demanded the withdrawal of such "ill-considered advice" and of the "sinful Public Private Partnership legislation". Otherwise government would face unspecified consequences from the Namibian workers.

The federation had in the past raised concerns about political leaders with hidden agendas to sell off public assets. Foreign companies seeking to increase their profits would not operate in the best interests of Namibia (The Namibian 13-Oct-17; Bulletin 1225).

Project execution failure

Every year, Namibian government planners complain about poor project execution - but they only have them-

selves to blame. During a visit to the Fonteintjie Fish Farm in southern Namibia in 2019, Works & Transport minister, John Mutorwa, said state entities were sometimes slow in implementing development projects, so that at the end of the financial year there was nothing to show and the allocated money had not been utilized.

He questioned whether there were action plans in place for these projects, whether tenders had been advertised and projects awarded. Mutorwa revealed that between

2016 and 2019 only 54 capital projects

were completed out of 153 projects awarded between 2012 and 2014. Of these, 56 projects had not yet been completed, while 43 were abandoned

by contractors over the three years. He called the "delays, maladmin-istration and corrupt practices unacceptable, because they are essentially criminal

In May 2020, the executive director of the works and transport ministry was instructed to send professional teams to investigate the status of all the unfin-ished projects in the regions.

The report compiled by the ministry's technical teams was completed on 30-Jun-20 and finalised on 22-Jul-20, the

details of which have still not been made public (*Bulletin 1373*). Also in 2019, it emerged that the National Planning Commission remains uninformed about the implementation of development projects, the planning of which it is responsible, but not their implementation.

At least 406 projects worth billions of dollars are still incomplete in Namibia, it was revealed by the Minister of Economic Planning and Director General of the National Planning Commission, Obed Kandjoze.

He said during 2018, the NPC went on a fact-finding mission and found 493 projects of which only 87, worth N\$24-m, had been completed (*Bulletin 1321*).

White elephants

in the rose garden Grand corruption triggered incon-clusive official probes into two of the biggest show-piece projects to date, costing well over N\$10-b, without any consequences for any of the top govern-ment officials that were implicated.

Although it would require a separate report on the allegations of corruption, malfeasance and corruption in these two projects, it is worthwhile recalling the outcomes of the national fuel storage facility in Walvis Bay and the Neckartal Dam in the middle of nowhere in the deep South.

Fuel storage faux pas

Another project that could undergo the PPP treatment is the N\$5.5-b+ fuel storage facility at Walvis Bay, now nearing completion, at a cost overrun of billions and years late. The bulk fuel storage facility in the

of the government's SADC gateway project, has escalated from N\$3.7-b in 2014 to N\$5.6-b when it should have been completed in 2018. In 2010, the project was estimated to cost N\$800m and should have been completed by 2012.

As at 31-Aug-17, government pay-ments totaled N\$3.6-b, while the total amount borrowed by government to finance the project was N\$4.3-b.

A cost recovery model prepared by consulting engineers in Feb-17 projected the final cost at N\$10.8-b, including forex and financing charges, after the contract was erroneously signed off in

US\$, grossly inflating the price tag after the depreciation of the ZAR, to which the Namdollar is pegged.

Namdollar is pegged. Another report in Feb-17 found that the government was clueless about many key aspects of the oil storage facility, such as a plan on how to re-cover the N\$5.5-b invested, who would own the assets, the operating model of the facility, the cost recovery plan and what volumes of fuel products would be

stored (*Bulletin* 1198). In November 2020, the second tender closed for the construction of a firefighting system at the fuel tank farm after it was discovered that an additional N\$50-m would be required to upgrade the system to comply with new minimum international standards something had been overlooked in the project specifications.

Namcor, which is responsible for the fuel facility, issued a tender in late 2017 for the development and preparation of site specific operational procedures and manuals for petroleum terminals in Walvis Bay.

The nowhere Neckartal Dam

Agriculture and land reform minister Calle Schlettwein told the National Assembly in March this year that the government lacked the finances to develop the second - irrigation - phase of the Neckartal Dam on the Fish River near Berseba, on which it had spent N\$5.5-b.

This turns the massive project into a concrete white elephant – at least for the foreseeable future - since the main purpose of the dam was to irrigate 5,000ha for horticultural cultivation. Ironically, upon the its completion in

2020, Namibia experienced such good rains that the 800 million cubic metre dam was filled to overflowing. Schlettwein also admitted that the land surrounding the dam did not contain soil suitable for cultivation un-der irrigiton and that his ministry had

der irrigation and that his ministry had identified three farms as possible sites

for developing the irrigation project. The farms Schlangkopf (1,900ha), Dagbreek (1,700ha) and Schaapplaats (370ha), fell short of the targeted 5,000 by 1,030ha that still had to be found the irrigation scheme were to go ahead

Neither has the water reticulation for the irrigation project been built as part of the second phase (The Namibian 04-Mar-21).

Given the current failure rate of the government's string of green schemes in northern Namibia, a build, own, op-erate and transfer (BOOT) PPP model could well be on the cards for the Neckartal Project.

The all-Chinese airport freeway

CLOSING AT THE ROADS AUTHORITY 21-MAY-21

Five offers from only Chinese contractors were received for the construction of Phase 2B of Trunk Road 9/1 from Windhoek to Hosea Kutako International Airport to dual carriage freeway standards – Dordabis turnoff to Hosea Kutako International Airport - when tender RA/DC-CR/06-2014/28 closed at the Roads Authority at 10:00, Friday 21 May 2021.

This tender was not advertised in the public domain, as only Chinese contractors were invited to tender.

The prices posted on the Roads Authority website are only in Chinese Yuan, compared to amounts on previous tenders, which had to be expressed in Namdollars. At an exchange rate of approximately ¥1.00 to ZAR2.23 the bids range from N\$943,552,300 to N\$996,324,980. The five offers, in ascending order, are:

* China Civil Engineering Construction Cooperation [probably Corporation] = C¥423,117,625.66

- * China Railway Seventh Group =
- C¥430,190,066.32 [built the 15km N\$922-m Phase 1A of the HKIA project in JV with Onamagongwa]
- * China State Construction Engineering Corp = C¥432,506,618.80
- * China Harbour Engineering =
- ¥C442,003,298.10
- * Qinghan Group Co Ltd = C¥446,782,502.77 [possibly Qingjian International Group].

The Roads Authority has a history of awarding major road construction contracts to Chinese companies – often without public tenders (especially when Chinese funding was involved) and in past years frequently in JV with the - now insolvent – state-owned Roads Contractor Company.

Since all these companies are stateowned in China, any profits on this section of the highway will be repatriated to Beijing.

The five Chinese firms have all been operational in Namibia for many years and have received major Namibian government contracts in the past.

* China Railway Seventh Group was awarded the contract for Phase 1 of the airport freeway.

* China Civil Engineering Construction Corp. - in partnership with local BEE firm, Oshilongo Investment, is currently building the Ministry of Home Affairs & Immigration's twelve-storey new head office in Windhoek at an estimated N\$1-billion, for which no public tender was issued.

China Civil in joint venture with Dynamic Investment Group also built the Ministry's a new regional office at Oshakati under TIPEEG tender MHAI/21/01/2013. This tender closed 06-Feb-13.

* China State Construction Engineering Corp's contracts in Namibia include joint ventures with politically connected Kata Investment for the N\$100-m contract to rehabilitate 25km of the Eenhana – Ekongo road under tender RA/DC-CR/02-2013 (closed 02-Apr-14) and the construction of the Omdel – Swakopmund pipeline replacement under NamWater tender * Only Chinese contractors were invited to bid for the last stretch of the Windhoek – HKI Airport highway.

Five offers from N\$943.55-m to N\$996.325-m - all in Chinese Yuan/Renminbi - were received for the longest, 23.5km stretch from the Dordabis turn-off to the airport.

* Now that the entire highway will have been built by Beijing's state-owned firms at a cost of N\$3-b (¥6.7-b), the new international airport is next on the agenda also to be funded by the Red Dragon.

NW/034/2015/O (closed 28-Oct-14). China State, in joint venture with Northern Sanitary Services, was also awarded tender F1/10/1-32/2014 for bulk earthworks in Love Street for the new head office of the Ministry of Information & Communication Technology (closed 03-Feb-15, but has been put on hold).

In 2015, China State was awarded the Namibia Airports Company contract for Phase 1 to rehabilitate the Ondangwa Airport runway for N\$208-m, and then also landed the second phase for N\$184-m in 2016.

* China Harbour Engineering was the main contractor for both the N\$4 billion Container Terminal project and the N\$3.7-b Fuel Storage Facility in Walvis Bay.

* Qingjian International recently bid on several large public construction tenders, including for the Roads Authority and Education Ministry.

The N\$715-m 'Works Package C002'rail upgrade contract from Arandis to Kranzberg was awarded to the Qingjian / Unik joint venture in Dec-19 under tender MWT-DRIM/2018-05 for the Ministry of Works & Transport, finance by the African Development Bank, for supply of materials, civil works, plate laying, trackside furniture and bridges (closed 10-Oct-18).

Chinese grant - no public tender

The contract for Phase 2B of the Windhoek-HKIA highway covers the longest, 23.5km stretch from the Dordabis turn-off to the airort.

During a press briefing in March, Roads Authority CEO, Conrad Lutombi, confirmed that this phase will be financed through a grant from the Peoples Republic of China, indicating he anticipated having a contractor on site by June or July 2021.

In November 2019, Lutombi was quoted as saying that the process towards the commencement of Phase 2B woul be finalised 'in the coming weeks' so that construction of Phases 2A & 2B would run concurrently.

So far these is no indication on whether Namibian sub-contractors will be engaged on the last section of the highway, as had been the case for the previous two sections.

Previous sections

Although the previous airport highway sections were financed through an AfDB loan, they were all built by Chinese contractors.

While there have been several public tenders for consultancy services and construction work for the AfDB co-funded Phase 2A of the Windhoek - HKIA dual carriageway, procurement for the longest stretch under Phase 2B - funded through a Chinese grant – has been shrouded in secrecy until the Roads Authority posted the offers from May on its website, although the tender process had started already in late 2019.

While commenting on the progress of Phase 1 to be completed by August this year, the RA's Lutombi said during a press briefing in March, that Phases 2A and 2B had would be completed by September 2023.

Phase 2A

Phase 2A is for the upgrade of 19.5km of the HKIA highway to freeway standards between Sam Nujoma Avenue close to Avis/Auasblick and the Dordabis intersection.

At an estimated cost of N\$949-m, this phase is co-funded by the AfDB and was 13% complete in March 2021, with the involvement of SMME subcontractors.

The section includes three interchanges and seven new bridges, of which one is a river bridge.

The African Development Bank announced the award of Phase 2A on 18-Dec-19 to China's **AVIC International Project Engineering Company** for N\$826,080,338.40 excluding VAT (N\$949,992,389.10 incl. VAT).

AVIC's offer was initially rejected in Jul-19 as being 'too low', after which two other Chinese companies were recommended in Sep-19.

The most recent tenders for the airport highway were:

- * RA/DC-CR/06-2014/2A-AW Lot 1 for eligible Namibian Micro, Small and Medium Enterprises to carry out clearing, grubbing and fencing operations on the Windhoek HKIA road upgrade from km17 to km26.5 ((closed 05-Aug-20 bids in Bulletin 1360); and
- * RA/DC-CR/06-2014/2A-AW Lot 3 for small auxiliary works (inlet and outlet structures to pre-fabricated culverts) from km6.5 to km 26.5 for registered SMMEs (closed 23-Apr-21 - bids in *Bulletin* 1395).

Phase 1

Phase 1 of the project commenced in Jan-16 and includes 15 km of ramproads, four interchanges and 13 new bridges. The estimated cost of this section, fully funded by the Namibian government, is N\$922-m, according to Lutombi.

The tender for this phase was issued by the Roads Authority under RA/DC-CR/06-2014, calling for the construction of TR9/1 to Hosea Kutako International Airport to dual carriageway standards.

The tender was for an 8.4km stretch from Main Road 49 at UNAM to the Sam Nujoma Drive Extension and closed on 07-Oct-15.

It was awarded to **China Railway Seventh Group** in joint venture with Onamagongwa Trading Enterprises for N\$799-m (*Bulletin 1129*).

Phase 1 was supposed to be completed by Jan-18 but was then extended by 3km for N\$150-m in 2019.

23 - 29 July 2021

In February this year, the Roads Authority announced the partial opening to traffic of Phase 1 of the Windhoek - HKIA road. The completed section of 9km of the freeway is between Auas Road and Robert Mugabe Avenue and will be known as the Windhoek Southern Bypass.

Next comes the airport

With the latest contract now inevitably destined for another Chinese firm, it means that the new international airport itself will probably also be an all-Chinese project.

During a conference call with Chinese president Xi Jinping on 03-Apr-20, Namibia's president Hage Geingob not only thanked China for its assistance in fighting the Covid-19 pandemic, but also mentioned the proposed new international airport at Hosea Kutako.

Geingob thanked the Chinese leader for favourable terms to fund the Namibian airport project under a "special financial package to help Namibia commence with plans to modernise and expand its main airport to international standards" in the coming years.

The last HKIA upgrade tender, valued at N\$7-billion - also underwritten by China - was cancelled six years ago under former finance minister Calle Schlettwein.

His successor, appointed on the eve of the lockdown last year, Iipumu Shiimi, is expected to finalise the 'special financial package' under a loan agreement for the new HKIA airport.

According to leaked documents in 2018, then finance minister Schlettwein had accepted China's conditions for a US\$215.5-m (about N\$3.5-b) loan and grant package to build a new international airport at Hosea Kutako.

At the time, Chinese ambassador to Namibia, Zhang Yiming, had proposed the terms of the loan agreement to include that China funds the project through a 10% grant as well as a 90% concessional loan at an annual interest rate of 2% over 20 years, including a five-year grace period with a 0.25% management fee and commitment fee respectively.

After the Namibia Airports Company had hastily awarded a N\$6.8-b (US\$477.8-m) tender for a second airport at HKIA on 03-Dec-15 to long-favoured Chinese state-owned firm, Anhui Foreign Economic Construction Corporation, the award was cancelled two weeks later on instruction of president Geingob, following a public outcry about the inflated price.

At the time, other, more cost-effective bids were ignored amidst allegations of bribery and corruption as well as NAC's non-compliance with legal requirements.

By January 2016, then Finance Minister Schlettwein had halted negotiations with the Chinese government over the N\$7.5-b soft loan to fund the HKIA upgrade in two stages, which included a deal that Anhui would also get the contract for a portion of the dual-carriageway upgrade of the road from Windhoek to the airport at N\$1.2b [presumably Phase 2B].

The new airport – still not listed in the national development budget - will be amongst Namibia's biggest capital projects, probably overtaking the container terminal (N\$4-b) and fuel storage facility (N\$5.2-b) in the Port of Walvis Bay, as well as the Neckartal Dam (N\$5.5—b) (*Bulletins 1278, 1346, 1392*).


