

ISOLATION PREFABRICATED IN CHINA

10 SEPTEMBER 20 he Ministry of Health & Social Services has awarded another four contracts for the construction of Covid-19 isolation facilities in different towns, worth N\$22.6-m.

These are among a handful of awards of open national bidding, emergency procurement and quotation tenders listed on the ministry's website.

This is only a fraction of the over 300 tenders the health ministry has issued this year, that the Tender Bulletin is aware of.

The new awards include four 'Emergency Procurement' tenders that were not posted on the MHSS website, which the Bulletin monitors closely.

The latest awards are for new pre-fabricated isolation units in four towns, after the emergency tenders had closed on 23 June, following quotations invited one week earlier on 16 June.

But it took the ministry until the end of July and early August to produce an Executive Summary recommending the successful contractors.

Only four companies appear to have been invited to tender, but only two were successful including Chinese company Nami Prefab, which was the successful bidder for most (if not all) pre-fab isolation units constructed in several towns during 2020.

least ten other towns

Bulletin 1365 reported that the MHSS had constructed similar Covid-19 facilities - most with twelve beds - in Windhoek, Rundu, Okongo, Oshakati, Opuwo and Keetmanshoop, while Gobabis and Mariental were also on the list and Nkurenkuru commenced in Sep-20.

No bidding or award details could be found on the MHSS website on these contracts. Most of these pre-fab facilities were most likely erected by the same contractor - by and large without competitive bidding and bypassing Namibia's public procurement system.

The favoured contractor is probably built the Chinese company Nami Prefabricated Building Solution (also known as Nami Prefabricated Housing), which has been operating in Namibia since 2011 from Swakopmund.

Chinese news agency Xinhua reported in November 2020 that Nami Prefabricated Housing built several Covid-19 prefabricated isolation facilities across Namibia, of which four were completed by July that year.

The pre-fabricated 24-bed facility for MHSS in Walvis Bay was built - without public tender - for N\$12-m by Nami Prefab.

Xinhua reported on 09-Apr-20 that the Namibian health minister had praised the speedy completion of a 12-room Covid-19 isolation facility built by Chinese firm Nami Prefabricated Housing cc at the Windhoek Central Hospital.

Nami Prefabricated Building Solution was awarded the contract for the 12-bed Covid-19 unit in Katima Mulilo for N\$5,768,081.45. When the tender closed on 02-Nov-20 the prices of eight bidders were more favourable than Nami Prefab, but they were found to be non-responsive, while another six companies were also rejected.

According to the executive summary dd 15-Nov-20, reasons for rejection included that the nature of business was not attached "hence the registration document is incomplete" or 'lack of experience

- a condition clearly favouring the Chinese contractor (Bulletin 1383).

* Nami Prefabricated Housing was also awarded an 'Emergency Procurement' contract for the construction of a new 12-bed prefabricated isolation unit at Eenhana District Hospital, that had closed on 02-Nov-20.

According to the MHSS executive summary dated 19-Nov-20 for the Eenhana tender, the only responsive bid out of 13 offers was from Nami Prefabricated Housing, whose bid of N\$5,869,961.10 was accepted - the second highest offer (Bulletin 1379).

The only Covid-19 related works tenders publicly issued by the MHSS on its website last year were for Otjiwarongo and Eenhana:

* An 8-day RFQ for renovation of the TB Ward to be used as isolation ward for Covid-19 cases at Otjiwarongo Hospital closing 28-Jul-20 (this seems to have been replaced by the 2021 emergency procurement tender);

* On 22-Aug-20 MHSS issued a 6-day 'Emergency Procurement' tender for the erection of a new 12-bed pre-fab isolation unit at Eenhana District Hospital (including ancillary services, electrical/ mechanical and sewer installation, and connection to medical gas), that closed on 28-Aug-20 - after a public holiday - and was re-issued in October (see 2021 award).

Justice ministry investigated for Nami Prefab's

magistrates courts

Nami Prefabricated Housing is the same company that was hand-picked in 2018 by the justice ministry to construct six pre-fabricated courtrooms in different towns for N\$14-m under tender 'exemption', after the 2017 public tender W/ONB/16-01/2017 for this project was suddenly cancelled.

It seems that Ministry of Justice officials had selected Nami Prefab for the contract in 2018 without following proper procurement procedures.

Nami Prefab's letter of appointment by the ministry's procurement committee was signed by the executive director, his deputy and the director of central administration.

Allegations of corruption, favoritism and irregularities were being investigated by the finance ministry in mid-2020. No details have been made public since, however.

When the justice ministry announced the completion of the pre-fab courts in Grootfontein, Ondangwa, Rundu, Henties Bay, Otjiwarongo and Outjo in July 2020, also thanking an unnamed contractor, no company name or costs were disclosed (Bulletin 1364).



THE NS5.5-M MEDICAL EMERGENCY AFRICA HOLI-DAY TENDER

10 SEPTEMBER 2021 ifty-three offers were received

for the supply and delivery of coveralls, medical masks and gloves, when emergency procure-ment quotation G/EP/1304VA-15/2021 closed at the Ministry of Health & Social Services in Windhoek at 11:00 on Wednesday 26-May-21 as part of the ministry's Covid-19 response.

This RFQ for five items did not have a reference number when it was posted on the MHSS website on 24-May-21 with a two-day notice period that included Africa Day on 25 May - a public holiday.

According to the Bid Executive Summary dated 09-Jun-21 that was posted on the MHSS website 18 of the 53 bids received were found to be responsive. This award is only one of a handful of award notices posted on the MHSS website so far this year - from hundreds of tenders issued.

Seven companies awarded items totaling N\$5.5-m

But the summary lists only seven companies marked 'responsive' - mostly in terms of their pricing that were awarded the listed items for VAT inclusive prices:

* Alby de Trading was awarded N95 masks in packs of 20 for N\$2,495,000

* Allybaba & Family was awarded 3ply surgical masks in packs of 50 for N\$517,500

* Cotton Family Investment was awarded coveralls M, XL, XXL, XXL

- & XXXXL for a total of N\$630,000 * Destiny Planner Investment was awarded examination gloves L for N\$465.750
- * Tia's Medical Supplies was awarded examination gloves M & XL in packs of 100 for a total of N\$600,000 excl. VAT
- * Performance Development Centre was awarded 3x sterile gloves in packs of 50 for a total of N\$741,750
- * Wandeuya Investment was awarded coveralls L for N\$68,402; this company's total amount of N\$17,521,816.88 was the highest of the 53 offers.

- * Ministry of Health & Social Services gives a rare glimpse into its Covid-19 emergency procurement, eliciting an amazing 53 offers for coveralls, masks and gloves worth N\$5.5-m in response to its two-day quotation that included a public holiday.
- * Prices of seven firms from N\$56,373 to a N\$17.5-m total were evaluated, after the remaining 46 were rejected.




GRN DOMESTIC DEBT GROWS 20.8% TO NS83.9-B

10 SEPTEMBER 2021 Namibia's domestic government debt increased to N\$83.9 billion during August, according to the Bank of Namibia's latest monthly report. The increase was reflected in

Internal Registered Stock (IRS) and Treasury bills (TBs) issued, which rose by 1.2% and 1.0%, respectively to N\$54.4-b and N\$29 6-b

On an annual basis, domestic debt increased by 20.8%, with





new IRS and T'bill issued rising by 27.3% and 10.5%, respectively. As a percentage of GDP, domestic debt rose by 0.5 percentage point month-on-month to 44.6% and by 5.7 percentage

points year-on-year, reflecting increased ratios of both IRSs and TBs to GDP of 5.0 percentage points and 0.7 percentage point, respectively.

10 SEPTEMBER 2021 The minister of Environment, Forestry & Tourism, Pohamba Shifeta, has seemingly handpicked Sky Eye Hospitality & Tours as exclusive operator for the 4x4 shuttle service to visitors along a 5km offroad stretch to Sossus Vlei and Dead Valley inside the Namib Naukluft Park - without public tender.

The company was only formed in 2019 and is 75% owned by politically well-connected Laban Kandume, with Fillemon Hasheela as 25% partner.

Six months after its registration, Sky Eye was awarded the 20-year concession (previously operated by Namibia Wildlife Resorts) after making an unsolicited proposal to MEFT.

MEFT Executive Director, Theo Nghitila, informed NWR MD, Matthias Ngwangwama on 07-Apr-20, that the NWR would no longer have the right to this shuttle service, since the concession was awarded to Sky Eye.

The ministry fully recognized the role NWR "plays in the current shuttling of passengers, hence the ... concession is awarded on condition that SEHT engages NWR to see how you can work together", read Nghitila's letter.

NWR had operated the fourwheel-drive shuttle for more than ten years, generating at least N\$10-m annually. According to informed sources, NWR could earn up to N\$1.5-m during a good month in high season - before the Covid-19 pandemic.

According to MEFT spokesperson Romeo Muyunda, the NWR was never granted the right to operate the concession. Others argue that NWR was given the right of refusal on all tourism concessions within national parks



OHANGWENA SECURITY TENDER TO COURT OVER ALLEGED COLLUSION

10 SEPTEMBER 2021 A second security tender award is being challenged in the High Court, according to papers filed on behalf of Nahole Security & Debts Collection Service.

The tender closed on 10-May-21.


A notice by Ndaitwah Legal Practitioners published in *The Namibian* on 17-Aug-21, cites the Chairperson of the Review Panel, the Review Panel itself, the Ohangwena Regional Council and its Chief Regional Officer, the Ministry of Finance's Procurement Policy Unit and the ministers of Finance and Urban & Rural Development as respondents 1 to 6 plus 24 security companies, who had presumably participated in the bid.

The 30 respondents had five days to state their intent to oppose the application and deliver their answering affidavits within 14 days (respondents 7 - 30) or 21 days (respondents 1 - 6).

The matter would then be moved under case no. HC-MD-CV-MOT-REV-2021/00327 to the High Court on 15-Oct-21 to set aside the award dated 16-Jul-21 and declare the procurement process null and void. The affidavit of Sem Nuukongo Tuhadeleni Shilimela will be used in support of the application, the notice states.

The last such urgent High Court challenge was by Bertha Security Services against the Central Procurement Board, the Review Panel, GRN and 80 tenderers over the health ministry's N\$220m security tender under bid NCS/ ONB/CPBN-05/2019, also filed by Ndaitwah Legal Practitioners (Bulletin 1407).
