The midyear cutback to N\$5.2-b in domestically-funded development expenditure means it is now 19% less than last year's revised N\$6.456-b – widening from 14% at the beginning of the year.

oreign finance (mainly loans) as a component of Namibia's development budget has jumped to an all-time 22.4% high, following this month's 5.3% midyear reduction of the central government's own investment in capital projects for the remainder of 2021/22.

Before the midyear cutback in N\$5.55-b voted domestic development expenditure at the beginning of the year, 21% or N\$1.478-b of the total N\$7-b development budget was financed through external

funding outside the State Revenue Fund.

But after 2021/22's midyear cutback to N\$5.2-b - mostly diverted to operational spending – the proportion foreign finance jumped to 22.4% of the lower overall N\$6.7-b development budget.

The initial N\$1.478-b or 21.13% external funding component of the N\$7-b overall development budget at the beginning of 2021/22 was marginally below 2020/21's 21.3%, when N\$1.748-b of N\$8.2-b revised capital projects expenditure was funded through foreign inputs.

# **Development**

This 21.3% had been a sharp reversal on 2018/19, when only N\$513-m or 6.6% out of N\$7.8-b development spending was financed outside the State Revenue Fund, mainly through foreign loans (with some external grants).

# Debt versus development revisited

s we wrote in *Bulletin 1420* before the midyear cutback in domestic development expenditure, Namibia had voted an all-time high of N\$8.5-b for servicing central government debt

in 2021/22 - 53% more than the N\$5.5-b it had voted for development projects – the biggest disparity to date.

The central government's development budget funded inside the State Revenue Fund in 2021/22 at the beginning of the year accounted for 8.2% of all N\$68-b operational and development expenditure combined, compared to 12.5% that it set aside for servicing domestic and foreign debt.

This was a reversal on last year when the N\$6.4-b domestically-funded development budget accounted for a **higher** 8.95% and debt servicing costs a **lower** 10.7%

share of overall operational and development expenditure totaling N\$72-b.

The central government's N\$8.5-b expenditure on servicing its domestic and foreign loans in 2021/22 is 9.85% **higher** than last year's N\$7.7-b revised estimate, contrasting with the 14% **decline** in domestic development expenditure to N\$5.55-b from last year's N\$6.456-b revised estimate.

Debt servicing costs exceeded domestically-funded development expenditure for the first time in 2018/19 when N\$6-b was spent on domestic and foreign loan interest repayments, overtaking the N\$4.8-b development budget funded inside the State Revenue Fund – a 25% gap that has now more than doubled to 53%.

As we also wrote in *Bulletin* 1420, development expenditure of N\$5.55-b from the central government's own fiscal resources at the beginning of 2021/22 approximated the N\$5.6-b in 2017/18 and was 44% below its N\$9.8-b peak in 2015/16 seven years and

2015/16 seven years ago. This year's initial 14% decline on 2020/21's revised N\$6.456-b is the fourth year-on-year decline over the nine-year span since 2013/14, with a cumulative **contraction** of 26% or -2.9% averaged annually over the past nine years.

Over the nine-year period, this 26% contraction contrasts with the national budget's 45% increase, the 10% increase in overall procurement spending, the 60% growth in civil service remuneration and the 372% expansion in

debt servicing costs.

Compared to this 3% annual decrease in domestically-financed development expenditure over the past nine years, government debt servicing costs have ballooned 41.3% averaged annually, overall budget expenditure has risen 5% annually, the government wage bill 6.55% and procurement expenditure by only 1.12%

The N\$5.55-b domestically-funded development budget at the beginning of 2021/22 was on par with 2017/18's N\$5.6-b and 2019/20's N\$5.7-b - with development expenditure accounting for over 8% of overall budget expenditure in each of the three years, with this year's 8.17% the lowest and half the 16% share of the budget that capital projects expenditure comprised in 2013/14.

#### From bad to worse

fter 2021/22's midyear revisions, the situation with regard to development and debt has worsened considerably.

The midyear cutback to N\$5.2-b in domestically-funded development expenditure means it is now 19% less than last year's revised N\$6.456-b – widening from 14% at the beginning of the year.

Foreign funding in the development budget has remained a constant N\$1.5-b before and after midyear.

In the midyear budget tabled by finance minister lipumbu Shiimi on 05 November, the N\$5.5-b devel-

opment expenditure voted at the beginning of 2021/22 was reduced by N\$290-m or 5.3%, while provision for treasury's debt servicing costs were reduced by 5.68% from N\$8.8-b to N\$8.3-b — largely due to lower anticipated borrowing on the domestic money market — from a targeted N\$6.06-b at the beginning of the year to N\$5.86-b. Foreign debt costs remain at a constant N\$2.44-b.

The domestic development budget's reduction from N\$5.5-b to N\$5.2-b and the operational budget's increase by N\$2.2-b has raised overall expenditure from N\$68-b to N\$70-b

This means, domestic development expenditure's share of the total budget has now fallen from 8% at the beginning of the year to 7.4%.

In his midyear budget address, Shiimi highlighted two positive outturns in respect of the previous year, 2020/21:

- \* nominal GDP was registered at N\$178.1-b 4.1% better than estimates:
- \* actual revenue outturn amounted to N\$57.8-b – "significantly better than the budget revenue estimate of N\$51 4-b"

But on the negative side:

- \* total expenditure, including interest payments amounted to N\$72-b, relative to N\$72.8-b – "an underspending on the development budget and statutory expenditure";
- \* the budget deficit stood at 8.0% of GDP, compared to the budgeted 12.5% due to a combination of upward revisions in nominal GDP, superior revenue performance and underspending (on the development budget).

And, as far as central government debt is concerned, Shiimi said "interest rate payments lingered at 12.8% of revenue, significantly overshooting the 10% benchmark and reflecting the steadily increasing cost of high public debt stock".

He provided two yardsticks of debt: at N\$110.6-b, it represented 62.1% of GDP on the one hand, but on the other, "at the half-year mark, the total debt stock stood at N\$126.1-b, equivalent to 68.3% of GDP".

The latter includes US\$500 million outstanding on the first Eurobond, which was successfully redeemed, reflecting 57% of the budgeted financing requirements that had been effectively met by the mid-year point.

But he warned: "At this pace of projected revenue growth coupled with elevated public debt levels, it is critical for total aggregate expenditure over the MTEF to remain aligned to the revenue outlook so as to safeguard fiscal sustainability and stabilize the growth in public debt.

"The projected budget deficit is still relatively high, particularly in FY2022/23 and public debt as a percentage of GDP is projected to increase from 68.7% in 2021/22 and peak at 74.2% by FY2023/24. These high debt levels remain a

real concern in the medium term."

#### Foreign development finance grows, domestic development funds contract

According to the National Planning Commission's own summaries this year and the previous two, 2021/22's initial N\$1.479-b development funding outside the State Revenue Fund was 14.86% less than 2020/21's N\$1.7-b, which was 13.25% higher than 2019/20's N\$1.5-b - nowhere near 2019/20's 193% increase over the previous year's N\$513.2-m.

The NPC notes that the domestically-financed development budget was reduced by N\$1-b to N\$5.5-b in 2021/22 compared to last year (a 14% reduction that has grown to 19% after midyear).

The Tender Bulletin's analysis of 2021/22's detailed project listing of all 397 development projects reveals that the number of projects with foreign funding components decreased by 25% to 15, compared to last years' listing of 401 projects, of which 20 had foreign funding components – an 11% increase from 2019/20's 18, which had been a 12.5% increase from 2018/19's 16.

But by value, external funding is clearly on the increase as a proportion of total development expenditure – more so after 2021/22's midyear revisions.

At the beginning of 2021/22, the N\$5.55-b domestically-funded development budget (inside the SRF) was supplemented by N\$1.479-b foreign funding outside the SRF (N\$1.749-b last year), according to the NPC.

This raised 2021/22's total development budget to N\$7.03-b, of which a little over 21% was foreignfunded. After the midyear N\$290-m cutback to voted development expenditure, the same N\$1.479-b constitutes 22.14% of the lowered N\$6.679-b development budget.

The foreign funding development component last year was a little over 21% or N\$1.7-b of 2020/21's N\$8.1-b overall development

budget, compared to only 16% or N\$1.5-b of 2019/20's N\$9.4-b, which was a sharp reversal on 2018/19, when only N\$513-m or 6.6% out of the N\$7.8-b overall development budget was financed outside the SRF, with N\$7.3-b or 93.4% financed through the SRF.

While not addressing this issue in its budget this or last year, the NPC had specifically noted in 2019/20 "a significant increase in the external support earmarked for the development of infrastructure outside the State Revenue Fund from N\$1-b to N\$4.3-b" from the previous three-year medium term expenditure framework to the current one ending 2021/22.

The NPC also noted in 2019/29 that the four-fold increase in external funding compared to a much milder 6% increase in N\$24.6-b funding inside the SRF this MTEF over the previous MTEF's N\$23.3-b for development projects.

To repeat, externally-funded development expenditure has increased four-fold over three years to over 22%, from only 6% in domestically-financed development expenditure.

In its 2021/22 development budget, the NPC tries to paint a rosier picture for the current medium term expenditure framework ending 2023/24, according to which the three-year overall development budget of N\$22.157-b will consist of only 12.27% or N\$2.77-b foreign funding, with the remaining N\$19.4-b or 87.7% to be financed domestically.

This will have to be seen to be believed, as the trend until now is for foreign development finance to grow more than its domestic counterpart.

This year's midyear revised N\$5.2-b domestically-financed development budget is 19% less than 2020/21's N\$6.5-b, but the N\$1.5-b foreign funding component is only 11.76% below 2020/21's N\$1.75-b.

Last year, the N\$6.5-b domestically-funded development budget was 12% more than 2019/20's N\$5.8-b, while the N\$1.7-b foreign

#### Foreign-financed projects

Fifteen of the 397 central government development projects presently under implementation in 2021/22 depend on foreign fun-

ding.
This additional development funding outside the SRF totals N\$1.479-b in 2021/22 (N\$1.748b last year). This raised the total development budget to N\$7.03-b at the beginning of 2021/22, reduced to N\$6.75-b midyear after the domestically-funded development budget was reduced by N\$290-m. Overall development expenditure amounted to N\$8.2-b in 2020/21 17.68% more than this year.

# Foreign development finance has grown

This year's foreign development inputs are spread across four votes (last year's external funding in parentheses):

- \* Education, Arts & Culture (Vote 10)
- N\$350-m (N\$350-m);
- \* Environment, Tourism & Forestry (Vote 18) - N\$53.998-m (N\$53.998-m);
- \* Transport (Vote 24) N\$779.939-m: (N\$1,055,054,000);
- \* Agriculture & Land Reform (Vote 37)
- N\$272.48-m (N\$244.658-m);

\* Water (Vote 38) - N\$22.399-m (N\$45.248-m).

Six votes benefited from foreign funding for twenty capital projects in 2020/21, compared to the same number of votes with eighteen projects in 2019/20.

Foreign-financed projects per vote in 2021/22 are:


- Education, Arts & Culture (Vote 10) with one project, unchanged from the past two years;
- \* Environment, Forestry & Tourism (Vote 18) with the same four projects as last year, compared to one in 2019/20;
- \* Industrialisation & Trade (Vote 19) with one project, the same as last year, compared to none in 2019/20;
- \* Transport (Vote 24) with three projects, down from five last year and four in 2019/20;
- \* Agriculture & Land Reform (Vote 37) with four projects, half of last year's eight, compared to ten in 2019/20 - which then included water, forestry and land reform which were all part of

its mandate;
