rest of the world. In fact, the mission is clearly aimed to open the world of opportunities from India.



116TH ANNUAL SESSION



INAUGURAL SESSION

The PHD Chamber organized its 116TH Annual Session on September 30, 2021 at Hotel Taj Palace, Sardar Patel Marg, New Delhi in a Hybrid mode. The inaugural session was presided over by General Manoj Mukund Naravane, Chief of Army Staff and Mr. Nitin Gadkari, Union Transport Minister as the Chief Guest. The Annual Session of PHD Chamber focused on the measures taken to restore the Indian economy to pre-pandemic levels by the Union Government in tandem with the Defence Forces.

Chief Guest, Mr. Nitin Gadkari highlighted how India can cut down on its import bill on the purchase of petrol and diesel which is as high as of Rs 12 lakh crores now. He spoke about the requirement to switch to indigenous fuels. He discussed how the government is working on steps to bring down the pollution levels in Delhi. He mentioned that new infrastructure is being developed in the form of new highways including Delhi-Meerut highway, Delhi-Mumbai

green corridor, peripheral road for carriage goods that will strengthen the industries by reducing the logistics costs and reduce the congestion and pollution prevailing in the city.

He stated that the government is seriously looking at ways to tap the potential of the waterways in the country. He explained that as compared to roads and railways, the cost of logistics on waterways comes to just around 10 percent of the cost. This would mean huge savings and give the Indian companies a competitive edge for exports. He said that this would provide more connectivity to the South-East Asian region. He further mentioned that new highways will reduce the travel time from Kashmir to other parts of the country.

"We aim to make India a global power in using green fuel by 2024" proclaimed Mr. Nitin Gadkari. The Transport Minister discussed future plans for making Delhi a clean and green city by promoting green fuels such as ethanol, LNG, Bio CNG and

Green Hydrogen. He proposed to introduce flex engines as mandatory in India to reduce cost and pollution. India has the capacity to produce ethanol, methanol and other green energy sources as India has excess capacity for the same.

He said that India is producing around 85% of Lithium batteries and working aggressively for promoting electric vehicles in the country. He concluded by saying that the government is working to make the automobile industry a Rs 15- lakh crore worth segment that will offer additional employment to around 1 crore people in India.

SESSION: FIRE SIDE CHAT - EMPOWERING WOMEN IN BUILDING RESILIENT INDIA

A Fire Side Chat on the theme 'Empowering Women in Building Resilient India' was organized at the 116TH Annual session of PHD Chamber on September 30, 2021 on a virtual mode. Ms. Smriti Irani, Union Minister for Women & Child Development, Government of India, presided over the chat.

While addressing the gathering, Ms. Smriti Irani said that India ranks 148th in a list of 193 countries based on the percentage of elected women representatives in the national parliament. However, women at grassroots levels are fighting their own political battles and coming out with flying colours. She stated that the issue of women's emancipation need not be addressed by women alone and that men, too, need to contribute to it.

She informed that the government seeks industry support to ensure that the Legislative Acts passed with regards to women are, at least, followed by the members of the industry. She also added that women in India need to be given the joy of equal participation based on their competence.

Commending the government's schemes like 'Beti Bachao, Beti Padhao', she said that the program has become so popular that it has seen immense community participation related to it.

The Union Minister informed that initiatives like 'Swachh Bharat Abhiyan' ensured that 10 crore families



had access to their own toilet, and all this was possible due to the efforts made by a male Prime Minister, Mr. Narendra Modi.

Also, for the first time, through the 'Swamitva Yojana', the government used drone technology to ascertain digital land records. Through PMG Disha, 2 crore women were made digitally literate, she informed further.

Ms. Anuradha Goel, Chairperson, PHDFWF spoke on the meaningful work done by the Foundation over the last 35 years. She informed that the Foundation has been running skill development programs in North India where skill sets such as computer repair, electrician, tailoring is taught to the people in a holistic manner.

Ms. Goel also informed that in the last 2 years, the Family Welfare Foundation has been taking care of 3000 abandoned orphan children, many of whom were orphaned due to the COVID pandemic. She added that the Foundation also operated six mobile medical vans

during the Pandemic and 12 oxygen plants are also being donated to needy hospitals across the NCR by managing committee members. She also highlighted the unique initiative undertaken for 60 identified women, who have lost their sole earning member during the pandemic time.

Mr. Sanjay Aggarwal, President, PHDCCI stated that women empowerment is essential for realizing the power of demographic dividend of the country and making it a catalyst for enhancing economic resilience. He said that with the emerging digitalization, education, modernization, globalization and urbanization, women are seeking gainful participation in several fields. Mr. Aggarwal added that India's story on women empowerment is not complete without focusing on grassroots initiatives adopted by the Government.

Mr. Pradeep Multani, Senior Vice President, PHDCCI delivered the vote-of-thanks to the Minister.





SESSION: INTERNATIONAL CONNECTIVITY AS A FORCE MULTIPLIER FOR RESILIENT INDIA



A session on “International Connectivity as a Force Multiplier for Resilient India” was organized on a virtual mode at the 116TH Annual Session on September 30, 2021. The session was presided over by Chief Guest, Mr. Jyotiraditya M. Scindia, Union Civil Aviation Minister.

“The pandemic has taught us to share and collaborate and this would be the new mantra not only between individuals but going forward also between nations. Collaboration will be the new Mantra between countries”, stated the Union Minister for Civil Aviation.

He underlined that the topic of connectivity assumes more relevance today as it promotes global interactions. Though the aviation sector suffered during the pandemic, it provided a lifesaving service with air cargo lifting, medical aid, food packs, etc. across the globe. Mr. Scindia stated that even during the pandemic, when the global economy plummeted, the air cargo sector boomed as it carried life-saving medicines and vaccination to different countries.

Mr. Scindia said that two Cs- connectivity and commerce are vital for economic growth. Geopolitical boundaries have not restrained India, he added as we believe in “Vasudeva Kutumbakam”. He stated that Saath, Vikaas, Vishwas and Prayas with a prefix of ‘sabka’ as coined by the Hon’ble Prime Minister is central to the growth of international relationship and diplomacy. It opens the floodgates of economic progress, business network as well as social network.

The Minister explained how a neglected airstrip of Darbhanga has transformed into a busy airport today with a huge footfall. He also stated that Belgavi which is an educational hub has become an important centre for students and cargo movement.

The Hon’ble Prime Minister has stressed on an infrastructural strategy in this field. He mentioned that there were only 76 airports built in 70 years but in the last seven years alone, 60 more have been added.

Mr. Scindia urged the State Governments to work together with the Central Government in the

development of the aviation sector. He praised the Uttarakhand State and the Union Territory of Andaman and Nicobar for lowering the VAT on aviation. By this move, there would be boost in the volume of air travel.

With two mega hubs in the NCR and more on the drawing board, the sector will contribute immensely to turn the economy into a five trillion dollar, he added.

Mr. Sanjay Aggarwal, President, PHD Chamber, welcomed the Hon’ble Union Civil Aviation Minister and handed a digital Statue of Unity to the guest. He fondly remembered the dynamic and sterling leadership of Mr. Madhavrao Scindia in leading several departments of the Government of India and his proven transformational reality and the ability of a paradigm shift.

Mr. Saket Dalmia, Vice President, PHD Chamber, delivered the vote-of-thanks to the Minister saying that with the Minister introducing drone delivery regulations and ambitious projections for futuristic growth, it would be a hall mark of connectivity globally.

SESSION: INDIA'S RESILIENCE: CONVERTING RECESSION TO REBOUND

A session on “India’s Resilience: Converting Recession to Rebound” was organized at the 116TH AGM of PHD Chamber on September 30, 2021 on a hybrid mode. Mr. Pradeep Multani, Senior Vice President, PHDCCI gave the welcoming remarks.

The COVID-19 pandemic has been a time of learning on multiple fronts and presented us with an opportunity to revisit our economic model for improvisation, stated Mr. Sanjeev Sanyal, Principal Economic Advisor, Ministry of Finance. Mr. Sanyal shared his views on the current state of the economy and explained how during the peak of COVID-19, the Indian government emphasized on mobilizing available resources and took bold steps to combat the unprecedented crisis. The business sector received various incentive packages to keep it stable through the lockdown. He highlighted the Finance Minister’s announcement of a series of mid-size packages. Despite being adversely affected by the outbreak of the pandemic, significant parts of the economy continued doing reasonably well, he said.

Dr D Subbarao, renowned Economist and Former Governor, Reserve Bank of India stated that despite the second wave being a lot more devastating, the economy was able to escape any serious consequences. He further mentioned that though the economy is showing signs of recovery, yet there is a wide gap that is building up between the rich and poor as a direct result of the pandemic. The rising inequality needs to be rectified by adequate measures. Therefore, he said, that in the short-term, we need to focus on exports and government spending while for long-term we need all four factors for GDP — consumption, investment, government spending and exports to come together. To attain a higher growth and sustainability in the long term, he suggested expanding government spending to create more jobs and increase consumption.

Dr Ajay Chhibber, renowned Economist and Distinguished Visiting



Scholar to the Elliott School of International Affairs and the George Washington University, US said the economy is witnessing a K-shaped recovery. He said that we have come back a full circle to where we were two years prior. We must consider where we were before the pandemic -we weren’t doing that well back then either. He emphasized that we need to prioritize on reducing the cost of doing business in the country. He explained that we have higher electricity prices for the producers, higher freight rates, higher turnaround times in ports, etc.

He embarked upon reviving consumer demand back on track for a growing economy.

Mr. Atantra Das Gupta, Director, South West Asia and Head, Samsung HME spoke about the impact of COVID-19 on healthcare sector. He stated that the maternal and infant mortality rates have reduced. He raised the issue of limited budget in health care as India’s spending on health sector is quite low. Thus the need for strong technological intervention in building resilient infrastructure for inclusive growth.



SESSION: CHIEF MINISTERS' ROUNDTABLE WITH CEOS

A session on CHIEF MINISTERS' ROUNDTABLE with CEOs ON "Is India 1 Nation or 30 States in Sustainability, Agriculture, Food Processing, Manufacturing and Exports?" was organized on a virtual mode at the 116TH Annual Session of PHD Chamber on September 30, 2021.

Mr. Pushkar Singh Dhama, Chief Minister of Uttarakhand stated that Uttarakhand has witnessed massive growth in the past few years and is once again opening its arms for potential investors to invest in the State. He mentioned that road connectivity is all set to improve with Delhi-Dehradun connectivity cutting short to just two hours in the near future. He also informed that his Government is in talks with the Union Railway Ministry to improve railway transportation in the State.

Welcoming the industry representatives in the State, the Chief Minister promised to hold deliberations with them at least once a month. The Government of Uttarakhand has been continuously working to facilitate the industries and businesses in the State through effective policies, infrastructure connectivity, among others, he underlined. by 2032-33. He opined that combined efforts of the Central and States are crucial to enhance economic growth. He suggested that the focus should be on developing a central feedback mechanism, boosting exports, adopting global best practices, investing in technology, among others.

Mr. Sanjiv Puri, CMD, ITC Ltd. spoke on how India is a diverse country in terms of natural endowments, location, access, size and culture. This multifaceted diversification creates unique opportunities for each State. He emphasized on the importance of the agriculture value chains as immense population depends on this sector. He suggested focusing on climate change, smart agriculture, promoting food processing at a larger scale, among others.

Mr. Alok Kirloskar, Managing Director, SPP Pumps Ltd. UK Head-International Business, Kirloskar Brothers Limited said that a significant amount of progress has been witnessed in the areas of logistics, infrastructure, power, among others. He opined that there is a need to

focus on climate change, attracting middle sized companies, enhancing plug-n-play infrastructure, facilitating intellectual property (IP) registrations, among others.

He mentioned that focus is required on capitalizing the growth momentum in manufacturing sector, enhancing healthcare industry and identifying sectors of promising growth, going ahead.

He concluded the session by highlighting that the success in each State reaps a multiplier effect towards the national development in a holistic way. He emphasized on the need for sharing the best practices and capacity development among the States to amplify ease of doing business and accelerate the economic momentum.



ASSISTED LIVING FOR SENIORS

The Health Committee, PHDCCI initiated a webinar series on Healthy Ageing and as part of the same, the first webinar on 'Need and Requirement of Assisted Living for Seniors' was organized on September 27, 2021.

While welcoming the dignitaries, Mr. Pradeep Multani, Senior Vice President, PHD Chamber, mentioned that after a life of working and caring for others, the senior loved ones deserve the physical and mental well-being of happy retirement. Assisted living communities provide privacy and independence, but they also provide care and safety for your loving family member.

Chief Guest, Mr. R. Subrahmanyam, Secretary, Ministry of Social Justice & Empowerment said that now a days people live longer and seniors are the most important members of the society as one-third of the seniors are in a position to contribute to nation building. He mentioned that how to build livelihood among the seniors, promoting innovation for the sake of elders for their needs and need of great marketing efforts to look for their requirements and services are main parts of the policy for seniors. He also apprised that the Ministry has launched Senior Care Ageing Growth Engine Portal where the innovators can register their innovative products

for seniors and the Government would recognize them.

Dr N. Subramanyam, Chair Health Committee, PHDCCI said that we have more than 100 million seniors in our country where the ratio of elder women is more than men and 13 percent by 2021 will be over the age of 60 years.

Dr Sameer Gupta, Co-chair, Health Committee, PHDCCI, mentioned that that 20% of India will be of seniors by 2050 and challenges of seniors like financial, social, medication management, assistance in daily activities can be resolved with assisted living.

Dr O. P. Sharma, General Secretary, Geriatric Society of India said that there are 5 signs to recognize the elders which are incontinence, in-coordination, insomnia, insecurity and illhealth.

Dr Sonia Lal Gupta, Sr. Consultant Neurologist, Metro Group of Hospitals said that there is a need to recognise whom and where assisted living is required and for that more programs on awareness are necessary at the country level.

Mr. Sanjoy Pasricha, Chief Advisor, Aurum Senior and Assisted Living said that the needs of seniors from 60 to 90 years keep changing significantly every 3-5 years going from a "slowing

process" to a "loosing confidence process" to "loosing physical abilities status" to a "dependency status" to finally a "surrender" status". For improving quality of life of seniors, there is a need for a professional holistic approach involving physical, mental, spiritual and emotional engagement to enhance and enrich the life of elders.

Ms. Nanki L. Singh, CEO & MD, Protribe Senior Care Services Pvt. Ltd, highlighted various significant points about Healthy Ageing. She urged the government to provide some financial support and paid incentive for this rising sector for better quality assurance.

Dr Vishal Sehgal, President Medical Services, Portea Medical said that the population of elderly in India currently stands at 130-140 million and is expected to reach to about 200 million when the next census takes place.

Mr. Ipsito Chakravarty, Director of Gerontechnology Research Wing, Calcutta Metropolitan Institute of Gerontology said that in this era of Digital Revolution, Technology has the potential to bring about a metamorphosis in the process of ageing.

Prof. (Dr) Harvinder Popli, Co-chair, Health Committee, PHDCCI delivered the vote-of-thanks to the Chief Guest and the dignitaries.







Mr. Jigme Takpa also urged for collaborative efforts from the industry and public private corporation to share best practices to foster innovation in the field of sustainability.

Mr. Manish Dabkara, Managing Director, Enking International in his presentation "Carbon Markets and Expectation from COP26" briefed about his company which is working on climate change, carbon credit and sustainability solutions across the globe. He mentioned about the strategic solutions for helping businesses and organizations to achieve their climate ambition.


VANIJYA UTSAV AZADI KA AMRIT MAHOTSAV

The check dam will have a water holding capacity of 21, 67,500 cubic feet and help with augmentation of the water table and recharge the groundwater. India launches the 41st Scientific Expedition to Antarctica

India successfully launched the 41st Scientific Expedition to Antarctica with the arrival of the first batch of its contingent at the southern white continent. The first batch comprising of 23 scientists and support staff reached the Indian Antarctic station Maitri reached in second week of November. Four more batches shall be landing in Antarctica by air using DROMLAN facility and onboard chartered ice-class vessel MV Vasilii Golovnin by mid-January 2022. The 41st expedition has two major programs. The first program encompasses geological exploration of the Amery ice shelf at Bharati station. This will help explore the link between India and Antarctica in the past. The second program involves reconnaissance surveys and preparatory work for drilling of 500 meters of ice core near Maitri. It will help in improving the understanding of Antarctic climate, westerly winds, sea-ice and greenhouse gases from a single climate archive for past 10,000 years. The ice core drilling will be done in collaboration with the British Antarctic Survey and the Norwegian Polar Institute. In addition to accomplishing scientific programs, it will replenish the annual supplies of food, fuel, provisions, and spares for operations and maintenance of life support systems at Maitri and Bharati.

The Indian Antarctic program, which began in 1981, has completed 40 scientific expeditions, and built three permanent research base stations in Antarctica, named DakshinGangotri (1983), Maitri (1988) and Bharati (2012). As of today, Maitri and Bharati are fully operational. The National Centre for Polar and Ocean Research (NCPOR), Goa—an autonomous institute under the Ministry of Earth Sciences—manages the entire Indian Antarctic program.

The crew is expected to return to Cape Town in late March/early April of 2022, leaving a team of 48 members for over winter. It will also bring back the over winter team of the preceding 40th expedition.

DECARBONIZATION THROUGH GREEN HYDROGEN

When global leaders meeting in Glasgow in November, 2021 for COP- 26, the back drop is serious. Urgent actions to strengthen global commitments to reduce emission are needed. The imperatives to decarbonise the global economy is omnipresent. A transformational system change that calls for increase international cooperation that rises above regional politics is required. It is getting increasingly obvious that climate crises are inter-linked and that we need to deal with them holistically.

Through the governmental initiative, India is making efforts to 'build back better' in dealing with the outgoing crises as inter-linked. Energy is seemed as a key enabler in this complex situation and in a series of recent announcements, the Indian Govt. shows that it is extremely serious about the transition of Green Energy and Green mobility, reflected in climate policies gaining a more central road in the nation's strategy to cut green house gas emission. The energy transformation involves a transition form of fossil fuels to new value chains, based on renewable energy solar and wind power are renewable energy sources that are the most invested in.

Hydrogen has the clear potential to transform our existing large dependence on fossil-based energy to low carbon and green energy to facilitate process of decarbonization for our net zero transition.

India is beautifully positioned to take a lead in the global Green H2 economy, due to her position on Renewable Energy. Today, India has 141 GW of installed capacity of RE making it the fourth largest installed capacity globally- fourth largest for wind and fifth largest for solar. India has also set for itself the world's largest RE expansion plan to achieve 175 GW by 2022 and 450 GW by 2030 in installed capacity. The RE installed capacity has seen a 226 per cent increase in the

last five years. India's RE sector has already received investments worth \$70 billion in the last seven years and delivered capacities presents additional business prospects worth \$20 billion for the next decade.

To succeed with necessary and rapid technology transfer and development, increased global cooperation is needed. No single country can complete the entire value chain for hydrogen and thus, there is a need for cooperation among countries to secure markets and make green energy available at the earliest opportunity. 'International Hydrogen Alliance' would also help create a large investment enabling environment into global Hydrogen ecosystem. Not only the partner countries benefit immensely but would accelerate & fast track global transition to Hydrogen economy worldwide.

Just like our Hon'ble Prime Minister Narendra Modi proposed & initiated highly successful 'International Solar Alliance', in 2015 - ahead of COP 21 at Paris, Indian government should put forward the proposal for initiation & development of International Hydrogen Alliance at the forthcoming UN Climate Change Conference (COP 26) in Glasgow this November.

Proposed Alliance would bring different countries - the key global stakeholders, on one platform to facilitate international corporation to fast track Hydrogen Energy transition, through aligned policies, shared plans, wider sharing of technical knowledge through technology transfers & collaborations, global capacity building for sharing and balancing demand and supply side matrix and the most important - creating the large investment environment for creating structured global Hydrogen Economy.

Conclusion

The need of the hour is free flow of technology and funds from the developed to the developing and LDCs to achieve growth with equity ,

drastic reduction of GHG emissions by developed countries and supporting development of the IDCs through investments in Green energy .

Global emission of CO2 today are at least 55 giga ton a year with the present pace, the emissions are projected to grow to about up to 80 giga ton per year by 2055. To bring this to net zero ambition by 2050-55, the fossil fuel based industries will have to make large changes, such large changes are not possible to achieve, in the short period of time particularly for developing countries, like India. Moreover, India's present emission of CO2 is 2.6 giga ton per year. Today our contribution towards global emission is around 7 per cent.

In view of above, India needs not to come under pressure to set carbon emission targets until India becomes a developed country.

Bulk of CO2 in the air was put by the developed countries. It is the sole responsibility of developed countries not only to work on zero carbon, but also set goals for carbon negative, to atone the cumulative damage done through GHG emissions.

Drastic and immediate action is needed now to save the planet.

Circa 1974 – as invitees on the inaugural JAL jumbo flight, from Bangkok to Tokyo, we had been put up at the spanking new “Hotel New Otani”. After a delightful teppanyaki lunch at the Rose Gardens, we took the elevated monorail to Tokyo Central, from where we would take the tube to our hotel. Armed with the address of our hotel in Japanese, we were quite ready to venture out on our own.

A motley group of 14 - 13 men and a lone woman, from India & Pakistan - most of us were in this wonderful country for the first time. No one understood a word of the Japanese language. Perfect colour coding of the metro lines made transiting underground fairly easy. However their roads were a very different cup of tea. We were discussing whether it would not be better to get down at an earlier station from where the hotel should be closer. Despite looking around frantically we could not locate anyone who would follow English and guide us. Suddenly a young school girl - perhaps 10 or 12 years old - got up from her group, came up to us, curtsied - as only the Japs can - and in halting English asked us to disembark at the next station from where she would put us in taxis for the New Otani nearby.

Gratified at her gesture, we followed her out of the train. She called four cabs and gave instructions to the drivers. Out of politeness I asked her if one of the cabs could drop her at her house before going to the hotel. Her answer floored us completely; “No, I thank you, I go back, take next train to my station”. Imagine a young kid, leaving her school group and her train to help strangers - and that too

without asking. This was definitely a different world.

On another occasion, I was roaming around the Shinju-ku area looking for a particular store. I stopped two teenagers and showed them the slip of paper on which I had written the store’s name. Very apologetically they shrugged and showed their ignorance, all the time saying ‘solly’, ‘solly’. A few minutes later, I heard someone calling out Sir, Sir and looked back to find the same boys running up to me, all smiles and bidding me to stop. I was amazed when one of them said “We telephone, we find your store, we take you” and beckoned me to follow till we reached the place I was looking for. “Solly, we did not know first” was their parting sentence, leaving me completely stumped with their extra ordinary painstaking decency.

In yet another encounter, it was the taxi driver who was just too good. I wanted to visit the Taiwanese Consulate for a visa. The hotel concierge had written the address in Japanese and asked me to show it to the driver. This place was located in some God forsaken crowded area and with their funny street numbering system - or the absence of it - there was no way I could have found the place on my own. The taxi driver saw the address, nodded affirmatively and started. Throughout the half hour that we were on the road, going through a million turns and intersections, he must have spoken to his office on the radio phone at least twenty times, always looking at the address slip and obviously making enquiries. Not once did I notice any hint of annoyance on his face. There was a big grin when he finally pulled up

and pointed out the small signboard in an old office block.

I thanked him, saw the meter and handed over enough yens to cover a generous tip. As I tried to open the door, it was locked. My good man turned back, smiled and motioned for me to wait. Only after he had fished out the exact change from a conveniently hung pouch in front and handed it over to me, did he unlock the doors, indicated a firm no to the tip and bowed a hundred times, apologizing for the long time it had taken him to find my destination. How do you explain such humility?

A friend tells me of yet another very pleasant experience. He lost the handbag containing his passport, money, tickets etc. on a shopping trip. His frantic call to the Indian embassy received a cool response; there is no need to worry, just leave your contact number with us and relax; you will get your bag. Sure enough, there was a call from the embassy within half an hour. Someone had found the bag at a shop, seen the Indian passport and called our embassy to tell them from where it could be collected. Nothing was lost, not even the cash.

There are numerous such cases of the Japanese sense of concern for others, their helpful nature, their disdain for gratuities and tips and their desire to go out of their way to help aliens. All this co-exists with their blatant sense of overkill in business, their use of all overt and covert measures during negotiations, which only strengthen their enigmatic image for the rest of us - lesser mortals.

'Need a level-playing field for domestic industry'

Govt must bring fuels within GST ambit to improve competitiveness, says PHDCCI chief

New Delhi, October 7

The domestic industry needs a level-playing field vis-à-vis China, and the government must take steps to ease the cost of doing business to enable competitiveness, Pradeep Multani, the new President of the PHD Chamber of Commerce and Industry said. "Industry doesn't want anything extra. Please analyse what China is giving to their industries and let us have a level playing field. The same level of incentives should be there. We need cost of manufacturing to be made at par with them. We are not seeking protectionism. All that we are saying is don't make Indian industry face a situation of unfair competition from them (China)," Multani told *BusinessLine* in an

interview. Multani also made a case for bringing petrol and diesel under the Goods and Services Tax (GST) to enable industry to take input tax credit and thereby improve competitiveness. "This will be a big help to the industry," he said.

He also stressed the need for review of free trade agreements that are not beneficial to domestic industry and add services in the FTAs, especially when they account for 56 per cent of GDP, he added.

Other bottlenecks

"We strongly support the policies of this government. Aatmanirbhar Bharat is fantastic. But things have not percolated to the ground level, especially at the level of State government. There are bottlenecks in implementation.

Even today banking sector has not changed with the times. Their mindset has not changed at all when it came to collaterals," he said.

Multani, who is Chairman of Multani Pharmaceuticals, a manufacturer of Ayurvedic and Unani products, highlighted that land prices, logistic costs, interest rates, electricity costs and cost of compliances are "very high" in India and this was making the products uncompetitive. For instance, logistic costs in India are at 12-13 per cent as

against 7-8 per cent in China, he noted, adding that this clearly gave them the edge both in domestic and international markets.

"On cost of capital, though RBI has taken several steps to bring down interest rate in the system, this has not fully percolated at the ground level. Interest rates in India are significantly higher than many advanced economies and availability of finances is still a problem for MSMEs. Banks continue to demand huge collaterals," Multani said.

Seeking facilitation steps

He said that government must sort out implementation issues at the ground level and facilitate a conducive business climate. "For instance, it took a lot of time for RoDTEP rates to get announced. This uncertainty on the new rates had led to blockage of working capital

for many of us," he said. Multani said industry would prefer a system where government hands out a licence in perpetuity rather than continuing with the present norm of periodical renewals. This system of issuing licences in perpetuity has started in the pharma department. It should get extended to other sectors and government departments as well.

PHDCCI chief also said that government should move to a system where a responsible, compliant industry should be encouraged. He also underscored the need for expeditious and timely justice from the legal system. "We even more FDI if we do," he said.

Stating that India is on strong recovery mode post pandemic, Multani said that PHDCCI expects a record 10.2 per cent growth this fiscal and about 10 per cent in next fiscal.

Cos that don't matter must be out of audit net: Experts

Most firms that have filed their FY19 financial statements have net worth below ₹250 crore

The statutory audit requirement should be eased for small businesses, but only entities that do not matter should go out of the audit net when a threshold for exemption is set, audit experts and industry representatives said in response to a regulatory proposal.

Audit watchdog National Financial Reporting Authority (NFRA) last week published a consultation document that most of the 600,000 active companies that have filed annual financial statements for FY19 have net worth — the difference between assets and liabilities — below ₹250 crore and a large section of these paid policy means to auditors for their audit without any quality.
