Natural gas is a clean eco-friendly fuel that forms an important part of global energy mix, accounting for almost a fourth of primary energy. However, natural gas accounts for only 7% of India's energy mix as of now. The Demand for natural gas is growing and is expected to remain range-bound over the foreseeable future. Given the government's move to make India self-reliant in fertilisers, demand for natural gas from this sector is expected to rise in the near term. Propelled by schemes such as HELP, OALP, setting up of piped natural gas (PNG) network in over 200 cities of the country and the Smart City mission, demand for natural gas is expected to rise continuously.

However, despite the high demand potential of a growing economy like India, the sector continues to face a few challenges like inadequate infrastructure, affordability, supply constraints and taxation. Indian government has launched multiple initiatives to spur consumption of natural gas, such as developing CGD networks and pushing growth of the manufacturing sector. To transform India into a gas economy, the supply side of the natural gas sector requires strategic focus and attention. Exploring unconventional sources of hydrocarbons such as deep-water and ultra-deep water crude reserves, could improve domestic supply of oil and gas.

On this backdrop, PHD Chamber is organizing a **“Natural Gas Conclave 2019 - India Moving towards Clean Energy” on 26th March, 2019 at 9:45 a.m., PHD House, New Delhi**. The objective of this Conclave is to bring all the relevant stakeholders and key international players on same platform to evolve a pragmatic roadmap for energy development in the country.
