



Government announces amendment in import policy of biofuels

In exercise of the powers conferred by Section 3 of FT(D&R) Act, 1992, read with Paragraph 1.02 and 2.01 of the Foreign Trade Policy, 2015-2020, as amended from time to time, the Central Government has amended the import policy of biofuels under Chapter 22,27 and 38 of ITC (HS), 2017, Schedule – I (Import Policy):

Effect of the notification: Policy Condition providing for free import of bio-fuels by actual users is deleted. <u>Import policy of bio-fuels is "restricted" for all purposes and its import will require import license</u> from DGFT.
