

Uttar Pradesh is the rainbow land where the multi-hued Indian Culture has blossomed from times immemorial. Blessed with a variety of geographical land and many cultural diversities, Uttar Pradesh, has been the area of activity of historical heroes like - Rama, Krishna, Buddha, Mahavira, Ashoka, Harsha, Akbar and Mahatma Gandhi. Rich and tranquil expanses of meadows, perennial rivers, dense forests and fertile soil of Uttar Pradesh have contributed numerous golden chapters to the annals of Indian History. Dotted with various holy shrines and pilgrim places, full of joyous festivals, it plays an important role in the politics, education, culture, industry, agriculture and tourism of India.

The State is garlanded by the Holy rivers Ganga and Yamuna. The two pious rivers of Indian mythology, Uttar Pradesh is surrounded by Bihar in the East, Madhya Pradesh in the South, Rajasthan, Delhi, Himachal Pradesh and Haryana in the west and Uttaranchal in the north and Nepal touch the northern borders of Uttar Pradesh, it assumes strategic importance for Indian defence. Its area of 2,36,286 sq kms. lies between latitude 24 deg to 31 deg and longitude 77 deg to 84 deg East. Area wise it is the fourth largest State of India and third largest economy in India. In sheer magnitude it is half of the area of France, three times of Portugal, four times of Ireland, seven times of Switzerland, ten times of Belgium and a little bigger than England.

The Gross State Domestic Product (GSDP) of Uttar Pradesh grew at a CAGR of around 7% between the year 2016-20 and State contributes 8% to the National GDP.

State of the art expressways for seamless connectivity with access controlled navigation and Existing Yamuna & Agra-Lucknow Expressway connecting the State Capital to National Capital Region. 302 kms Agra Lucknow Expressway is one of the longest expressways in India and also proposed Purvanchal Expressway & Bundelkhand Expressway to connect the exporting hubs in eastern and Bundelkhand region as Lucknow-Azamgarh-Ghazipur- Expressway known as Purvanchal Expressway is an under construction 6-lane, divided and access-controlled 343 km long. Also the Upcoming 603 kms long Ganga Expressway will be one of India's longest expressway, connecting key exporting hubs, 296 kms long Bundelkhand Expressway is an under construction, 4lane Controlled-access highway, Broad route, connecting Chitrakoot-Banda-Orai-Jalaun-Auraiya-Etawah and Gorakhpur Link Expressway will connect North eastern UP viz. Gorakhpur area through the Purvanchal Expressway to Lucknow, Agra and Delhi with smooth traffic corridor. With this Uttar Pradesh has become the premier state of the country with five major expressways.

UP is committed to providing affordable, accessible, safe air services to common citizens by connecting each region to air services. Alongside the development of a world-class international airport at Jewar in Gautam Buddha Nagar district, Kushinagar airport is also ready for international flights.

Earlier the State medical colleges/institutions were operational in only 12 districts, but currently construction of Government medical colleges/institutions are in progress in 30 more districts. AIIMS has been established in the districts of Gorakhpur and Rae Bareli for excellent medical education in the state. An AYUSH University has also been set up in Gorakhpur district to promote excellent research in Yoga and Naturopathy.

The State Government has also announced the development of the Film City project. Subsequently, YEIDA has offered land located only 6km from the upcoming Jewar airport and 12 km from the Eastern Peripheral Expressway. The proposed Film City is expected to provide the platform to encompass all aspects of filmmaking -- related with script, music, writing, editing and production -- under a single roof.


