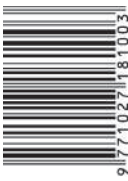

Pimped-up projects budget for security apparatus

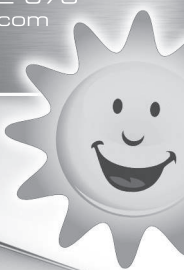

With N\$375-m to spend on capital projects, Home Affairs, Immigration, Police and Prisons have been merged into one vote - the only one in Namibia's security apparatus to have its allocation increased midyear in 2021/22, accounting for over half the cluster's N\$735-m development budget.

And despite mild reductions in the Defence Vote's expenditure on capital projects, its share of the shrinking national development budget has climbed to 5.7% after midyear from 5.5% at the beginning of 2021/22 and 4.96% last year.

This is because this year's national development budget is 14.72% less than 2020/2021's, while the Defence Vote's allocation was reduced by only 6%.

And although the security cluster's Veterans Affairs Vote had its 2021/22 cut back midyear by 22% to N\$7-m, its development budget has grown from only one-fifth last year, to half that of Gender Equality, Poverty Eradication & Social Welfare, whose allocation was cut by almost twice as much - 42% - to N\$13.75-m midyear.

As we noted in *Bulletin 1426*, the security sector is the only one to walk away with a higher development budget after midyear, despite the N\$280-m cutback in overall capital projects voted expenditure – in addition to scoring the biggest slice of the additional N\$2.2-b allocated to the operational budget after midyear.

The security cluster retained its second-biggest share of national development expenditure after November's midyear budget revisions that saw allocations for capital projects reduced from N\$5.5-b by N\$280-m or 5.08% to N\$5.2-b and operational expenditure increased by N\$2.2-b or 4.09% from N\$5.4-b to N\$5.6-b.

The Ministry of Defence & Veterans Affairs received N\$477-m - by far the biggest slice of the midyear top-up in

operational expenditure - accounting for 21.7% of the additional N\$2.2-b operational spending supplement and 11.5% of the higher N\$56-b operational budget, compared to a lesser 11% of overall N\$54-b operational expenditure at the beginning of the year.

The defence ministry's additional midyear N\$477-m boost increased its original operational budget from N\$5.98-m to N\$6.457-m – an 8% increase that is double the 4.09% overall increase in operational expenditure after midyear.

Its development budget was trimmed marginally, however, by N\$2.5-m or 0.83% from N\$300.9-m voted at the beginning of the year to N\$298.4-m, which hardly compensates for its generous higher operational allocation.

The operational budget of the Ministry of Education, Arts & Culture, on the other hand, was increased midyear by N\$400-m or 3% from N\$13.37-b to N\$13.77-b – far less than the 8% increase in the operational ceiling of the Ministry of Defence & Veterans Affairs.

The education ministry's higher mid-year operational allocation lowered its relative share of the operational budget from 24.8% at the beginning of the year to 24.5% - compared to the increase enjoyed by the Ministry of Defence & Veterans Affairs.

The N\$7.7-b original operational budget of the Ministry of Health & Social Services at the beginning of 2021/22 was also increased by N\$400-m (identical to that of Education) or 5.2% to N\$8-b.

This increased its share of operational expenditure from 14.3% of N\$54-b at the beginning of the year marginally to 14.46% of the midyear revised N\$56-b overall operational budget.

As noted in *Bulletin 1422 (Another 'blunder-budget')*, almost the entire N\$280-m midyear cutback in the development budget was reallocated to operational expenditure, where the Ministry of Defence & Veterans Affairs received the biggest, N\$477-m, slice of N\$2.2-b additional reallocations to

the operational budget, with N\$458-m allocated "to meet the funding shortfall on personnel expenditure and N\$19.1-m for veterans expenditure".

Not only did the security cluster benefit most from the midyear operational budget reallocations, it did so too in the case of revisions to development expenditure ceilings.

As the central government invests even more capital in its security apparatus after 2021/22's midyear development budget revisions, health and welfare suffered the biggest, 16% cutback to N\$330-m - less than half the security cluster's N\$735-m, which is now one-third more than education's N\$475-m.

To summarise the post-midyear redistribution of the development budget (*Bulletin 1426*):

* The security cluster's second-biggest share of the development budget increased from 13.33% at the beginning of 2021/22 to 14.07% after midyear.

* The Ministry of Defence & Veterans Affairs' additional midyear N\$477-m boost increased its original operational budget by 8% – double the 4.09% overall increase in operational expenditure after midyear.

* All N\$11-m re-allocated back to the development budget midyear went to another vote in the security cluster - the Ministry of Home Affairs, Immigration, Safety & Security - to complete its N\$800-m new head office.

* In third place, the education cluster's development budget was cut back by 1.4% to N\$475-m midyear - over one-third short (35.4%) of the security cluster's development allocation and contributing 2.4% to the overall N\$280-m reduction in voted development expenditure, compared to security's 0.54% gain.

* In fourth place, the health and welfare cluster's development budget was reduced midyear by the most - 16% or N\$330-m, lowering its share of the revised development budget from 7.13% to 6.3% and contributing 22.5% of the N\$280-m reduction in the development budget as a whole, (compared to security's 0.54% gain).

* The economic cluster's midyear development budget was reduced by 5% to N\$3.4-b, accounting for over two thirds of the total N\$280-m reduction in the development budget, but still accounting for over 65% of the total.

* Ranked fifth and last, the administrative cluster's development budget was reduced midyear by 9.37% N\$250.4-m, its share of all voted development expenditure falling marginally to 4.8% and contributing 9.26% to the N\$280-m midyear reduction in the development budget – well below health and welfare's 22.5%.

Security's midyear development budget in 2021/22

In 2021/22's midyear revisions, N\$280-m was cut from development expenditure, reducing it from N\$5.5-b to N\$5.2-b, with the security cluster still in second place behind the economic cluster.

Of the N\$11-m re-allocated back to the development budget midyear, all went to another vote in the security cluster - the Ministry of Home Affairs, Immigration, Safety & Security - to complete its N\$800-m new head office building in Windhoek West – awarded to a Chinese contractor without public tender in 2015.

In fact, the security cluster's share of the development budget increased from N\$733.7-m or 13.33% of N\$5.5-b at the beginning of 2021/22 to N\$735.2-m or 14.07% of the lowered N\$5.2-b after midyear.

This is after its development ceiling was increased by N\$1.5-m or 0.2% midyear, contrasting with cutbacks in all other clusters.

Instead of contributing to the N\$280-m midyear cutback in the development budget, the security cluster posted a 0.54% net gain due to the N\$11-m reallocation back to the Home Affairs, Immigration, Safety and Security vote.

The security cluster's initial development budget at the start of 2021/22 had

MIDYEAR REVISIONS: The development budget for 2021/22 was revised downward from N\$5.5-b to N\$5.2-b, with a realized saving of N\$290.8-m, of which N\$11-m was re-allocated back to Development Budget - all to Vote 39 - and the remaining N\$279.8-m was reallocated to the operational budget "to cater for critical needs", according to the Ministry of Finance's midyear budget document.

MIDYEAR DISCREPANCIES: There are discrepancies for four votes between their original allocations for 2021/22 as stated in the main budget and their original allocations as stated in the midyear budget: Vote 27 - N\$15,429-m in the main budget but N\$13,429-m according to the midyear budget (N\$2-m less); Vote 31 - N\$10-m in the main budget but N\$9-m in the midyear budget (N\$1-m less); Vote 37 - N\$392,426-m in the main budget, but N\$347,772-m in the midyear budget (N\$44.65-m less); Vote 38 - N\$264,603-m in the main budget, but N\$259,929-m in the midyear budget (N\$4,67-m less). The inside SRF development total of N\$5,505-b at the beginning of 2021/22 according to the midyear budget document is therefore N\$5,028-m less than the N\$5,557-b according to the main budget book at the beginning of the year. This is either due to errors in data capture or misallocations not clarified in the midyear budget statement.

been a 9.75% reduction on 2020/21's revised N\$813-m, its share still rising from 12.6% of N\$6.456-b to 13.3% of this year's initial N\$5.5-b.

In the process, it contributed 8.34% to the N\$950.5-m reduction in the development budget at the start of 2020/21 compared to the previous year – a fraction of the education cluster's 68.68% contribution.

Comparing clusters in 2019/20

The initial astronomical midyear N\$1-b cutback in the national development budget from N\$7.9-b to N\$6.9-b excluding foreign funding in 2019/20 turned out to be far worse in terms of actual expenditure, which amounted to only N\$5.7-m.

According to the 2021/22 budget book, 2019/20's actual development expenditure turned out at N\$5.7-b – over N\$1-b below the N\$6.9-b to which it was already reduced at the time of that year's midterm cutback.

This means 2019/20's actual development expenditure (excluding foreign inputs) of N\$5.7-b was N\$2.2-b or 28% below what had initially been voted at the beginning of the year.

Comparing clusters in terms of midyear revised and actual 2019/20 development expenditure, this once

2020/21 was N\$305-m or 8.4% higher than 2019/20's actual N\$3.6-b.

* The health and welfare cluster's actual development expenditure of N\$192.4-m in 2019/20 was even lower than the N\$276-m to which it had been cut midyear, accounting for 38% of the N\$2.2-b overall reduction, leaving it with the lowest, 3.4% share of the N\$5.7-b total.

In 2019/20's N\$1-b midyear cutbacks, the health and welfare cluster's development budget was slashed by the most of all – 43.3% to N\$275.989-m, contributing 21% to the N\$1-b overall cutback.

Health and welfare's revised 2020/21 N\$266.6-m development allocation was 38.5% or N\$74-m more than its actual N\$192.4-m actual expenditure in 2019/20.

* The education cluster's N\$593-m actual development expenditure in 2019/20 turned out higher than its revised N\$566.4-m midyear development budget, with a 10.4% share of the total in third place – but still behind the security cluster.

Midyear in 2019/20, the education cluster's revised N\$566.4-m development budget was already 19.8% less than its N\$706.5-m initially voted, contributing 14% to the N\$1-b overall reduction.

The education cluster's revised

Safety & Security's biggest project in 2021/22 is N\$31.5-m for ongoing construction of Kuisebmond police station in Walvis Bay involving a charge office, cell block, offices, fuel station, accommodation and helipad.

more demonstrated the government's typically shrewd bias in downscaling more project funds in the economic, education and welfare clusters in favour of their administrative and security counterparts.

* Although the security cluster's second-biggest share of development spending before and after 2019/20's midyear revisions was smaller than the economic cluster, the security cluster's mild midyear reduction was far more favourable than that of the former – aside from steeper reductions for the education and health/welfare sectors.

With a revised development budget of N\$1.3-b for 2019/20 in second place, the security cluster's 18.37% share of the N\$6.9-b revised total was higher than its 17.25% share of 2019/20's original N\$7.9-b total, despite a moderate 6.98% or N\$95.255-m reduction in its voted allocation midyear.

Although the security cluster's N\$1-b actual development expenditure in 2019/20 turned out to be less than N\$1.27-b revised midyear estimated, it still accounted for 18.69% of N\$5.7-b in second place.

This is despite it being the only one of the five clusters with a reduced development expenditure ceiling of N\$813-m in 2020/21 compared to 2019/20's actual N\$1.065-b – a 23.7% or N\$252.6-m reduction.

But the security cluster's 6.98% reduction in its development allocation midyear 2019/20 from N\$1.36-b to N\$1.279-b was the second lowest, contributing 9.5% to the overall development budget reduction of N\$1-b.

* The economic cluster's actual N\$3.6-b development expenditure was over 27% below its original N\$4.965-b allocation, contributing the biggest, 62% to the overall N\$2.2-b reduction in actual expenditure, but still accounting for 63% of the lowered total.

Midyear in 2019/20, the economic cluster suffered a 10.63% midyear reduction on its original N\$4.965-b development allocation, contributing the biggest, 52.8% share of the overall N\$1-b development cutback.

The economic cluster's revised N\$3.9-b development expenditure in

N\$266.6-m allocation in 2020/21 was a generous N\$74-m or 38.5% more than its actual N\$192.4-m 2019/20 expenditure.

* Ahead of education in second-last place in terms of actual expenditure in 2019/20, the administrative cluster's N\$233-m was considerably lower than its revised development allocation of N\$358.5-m at midyear and accounted for 4% of the N\$5.7-b total.

The administrative cluster's mid-year revised development budget of N\$358.5-m in 2019/20 was 6.76% less than its N\$384.5-m, contributing 2.6% to the overall N\$1-b development budget cutback – the least.

This cluster's revised N\$320.76-m 2020/21 development allocation was N\$87.76-m or 37.7-m more than its N\$233-m actual expenditure in 2019/20.

'Peace and stability' with an iron fist

Bear in mind that the security cluster's project spending allocation excludes the Central Intelligence Agency (NCIS) that resorts under the Presidency, where N\$41-m has been voted in 2021/22 for state security infrastructure expansion for the construction, renovation and acquisition of operational equipment and furnishing of office accommodation countrywide (*Bulletin 1427*).

We noted at the time of 2018/19's original development budget (*Bulletin 1269*), that the government purchased two farms for N\$57-m in 2015 plus a house for N\$8.2-m in 2016, for 'former members' of the spy agency, according to papers filed before court in April 2018.

This emerged when the NCIS successfully muzzled *The Patriot* newspaper from publicly revealing the facts around the property purchases.

This was quite apart from the two farms the Namibian Defence Force purchased in 2018/19 for N\$70-m – both without full disclosure to the presidency and finance ministry during the 2016/17 and 2017/18 financial years.

Home Affairs, Immigration, Safety & Security has N\$375.2-m to spend on 28 projects in 2021/22 (three for Home Affairs and 25 for Safety & Security), accounting for 51% of the security cluster's total of N\$735.2-m total after midyear.

The government continues to hold the line on its standard spin on development spending priorities: the maintenance of 'peace and stability' is a necessary precondition to secure an environment within which socio-economic development can thrive.

The secrecy with which defence and intelligence expenditure is cloaked however, has become a ticket to malfeasance and corruption to such an extent that the auditor general's office has blocked by the MoD from conducting its annual inspections of defence assets.

The security cluster's 2021/22 development budget

There are 42 development projects under implementation by the security cluster's four active votes out of six until the end of March 2022 – compared to 51 last year and significantly fewer than 2019/20's 67, compared to 50 in 2018/19, none of which were cut back midyear compared to over half of those in the economic cluster in 2018/19 – the last time that projects affected by midyear revisions were disclosed.

None of the security cluster's projects this year are new, compared to one in 2020/21 – renovations to the Office of the Judiciary in Windhoek – compared to four in 2019/20.

Our project-by-project procurement guide to the Namibian government's 2020/21 development budget currently underway continues this week with a detailed look at the security cluster, consisting of:

- * Vote 8 – Defence with five projects;
- * Vote 16 – Justice with seven projects;
- * Vote 31 – Veterans Affairs with two projects and

* the newly created Vote 39 – Home Affairs, Immigration, Safety & Security with 28 projects. This vote consolidates Home Affairs & Immigration (Vote 5 with three projects) and – Safety & Security (Police & Correctional Services – Vote 6 with 25 projects).

Two of the cluster's votes have had no development allocations over the past two years:

- * Vote 21 – Judiciary; and
- * Vote 35 – Attorney General.

Home Affairs, Immigration, Safety & Security

The new Vote 39 combines former Vote 5 (Home Affairs & Immigration) and Vote 6 (Safety & Security – Police and Correctional Services).

It has N\$375.2-m to spend on 28 projects in 2021/22 (three for Home Affairs and 25 for Safety & Security), accounting for 51% of the security cluster's total of N\$735.2-m total after midyear.

Vote 39's initial N\$364.2-m development allocation at the beginning of this year accounted for 49.5% of the N\$733.7-m cluster total.

Its N\$11-m increase at midyear all goes to Home Affairs for the completion of its new head office in Windhoek.

When votes 5 and 6 were still separate in 2020/21, Home Affairs recorded N\$90-m revised expenditure and Safety & Security N\$335-m.

Their combined N\$425-m revised development expenditure in 2020/21 was therefore 14.35% higher than this year's initial N\$364-m.

Safety & Security

Last year, when still on its own, Safety & Security (Vote 6) enjoyed its usual biggest share of the security

cluster's 2020/21 development budget, which was reduced to N\$813-m at mid-year from N\$825-m initially.

Safety & Security's midyear revised N\$335-m allocation for 31 projects in 2020/21 accounted for 41.20% of the cluster total, following a marginal N\$5-m or 1.47% haircut to its original N\$340-m allocation at the beginning of 2020/21, accounting for 4.21%. Its 25 projects currently under implementation in 2021/22 is considerably less than 31 last year.

Nationally, the new Vote 39's N\$375-m allocation this year accounts for 7.2% of the N\$5.2-b post-midyear development budget, following its N\$11-m or 3% midyear increase from N\$364-m at the beginning of the year when it accounted for a lower 6.6% of the N\$5.5-b total domestically funded development budget.

On its own, the former Vote 6's 2020/21 allocation accounted for 5.15% of the N\$6.5-b total after midyear – considerably lower than its revised 8.3% with N\$484.9-m in 2019/20's actual expenditure out of N\$5.8-b nationally.

This N\$485-m expenditure in 2019/20 was lower than its N\$526.954-m development allocation for 39 projects at the time of 2019/20 midyear adjustments, when it accounted for 41.5% of the N\$1.269-b cluster total and 7.63% of the N\$6.9-b midyear revised overall development budget total.

This had been a dramatic 77.7% increase on 2018/19's revised N\$330.8-m, when it accounted for 4.22% of the overall N\$7.8-b development budget, compared to 2019/20's 7.63% of the revised N\$6.9-b.

Nationally, the new Vote 39's N\$375-m post-midyear development budget in 2021/22 accounting for 7.2% of the national total is ranked fourth behind Transport's 41% (N\$2.1-b), Urban & Rural Development's 10.2% (N\$532-m) and only marginally less than Education, Arts & Culture's 7.6% (N\$399-m) of the N\$5.2-b total.

None of Safety & Security's projects this year and last year are new, compared to two in 2019/20.

Safety & Security's biggest project in 2021/22 is N\$31.5-m for ongoing construction of Kuisebmond police station in Walvis Bay involving a charge office, cell block, offices, fuel station, accommodation and helipad.

N\$30-m has been voted for the ongoing construction of its Kavango West regional HQ in Nkurenkuru and N\$26-m for the ongoing construction of police accommodation in Oshikoto, Zambezi, Khomas and Eenhana.

None of Vote 39's 28 projects for 2021/22 – all but one of which is for construction – has gone out on public tender.

Home Affairs & Immigration

Last year, when still on its own, Home Affairs & Immigration (Vote 5) was in its traditional third place

within the security cluster, with only N\$90.02-m to spend on three development projects in 2020/21, its allocation unchanged after those midyear revisions, but its share of the cluster total rising to 11.07% of N\$813-m from the initial 10.9% of N\$825-m.

It has the same three ongoing projects under implementation in 2021/22. In 2019/20, Vote 5 had a midyear revised N\$232.785-m to spend on three projects, which was a generous 62.8% increase over 2018/19's N\$164-m also for three projects, unaffected by 2018/19's midyear revisions.

It started 2019/20 with N\$267-m which was reduced by N\$34.215-m or 12.8% midyear, its share of the cluster total falling marginally from 19.6% of N\$1.36-b at the beginning of the year to 18.3% of the lowered N\$1.27-b post-midyear total.

That darned new head office

The reduction in the number of projects in the Home Affairs Vote from 13 in fiscal 2017 to three over the past four years coincides with the emergence of its head office project in Windhoek in 2015 without public tender.

The *Tender Bulletin* reported in March 2015 that the MHA had awarded the secretive tender for the 12-storey head office to China State Construction (with local partner Oshilongo Investment) on donated public land sold by the Sam Nujoma Foundation to MHA at an unethical N\$13-m profit.

The award of the contract was rushed through within two weeks after the tender had closed on 26-Feb-15, without being fully budgeted for at the time (*Bulletin 1243*).

When the project appeared in the development budget for the first time in the 2014/15 financial year, the N\$14.9-m project total was in relation to ongoing upgrading at the ministry's head office in the Continental and Sam Cohen Buildings.

The Windhoek West mega-HQ project appeared in the development budget for the first time only in the 2015/16 financial year that commenced in March 2015 – one month after the tender had closed in February (i.e. in the previous, 2014/15 financial year).

A modest N\$127.488-m was budgeted in 2015/16 referencing the new project for the first time, when the total stood at N\$822.36-m.

N\$60.756-m supposedly spent in 2013/14 in the 2015/16 budget was probably for the earlier project located in the Continental and Sam Cohen Buildings.

There was no funding allocation for 2014/15 – signaling the transition between the previous project scope and the new head office.

The new Home Affairs head office remains the vote's biggest project as it has been ever since 2015/16, for which N\$56-m was voted in 2020/21 (N\$263-m in 2019/20, with the project total standing at N\$789.836-m).

N\$167.223-m was voted for this project in 2018/19, when the total stood at N\$800.214-m.

N\$167.2-m was also voted in 2017/18, when the project total stood at N\$564.235-m.

In 2016/17 the project total stood at N\$1.065-b, with only N\$76.289-m voted

for the year.

According to this year (2021/22)'s budget book, N\$48.68-m was voted for the head office project at the beginning of the year, to which N\$11-m was added midyear – its biggest project.

According to the redacted (and distorted) format in which the development budget is now presented, only N\$116.776-m has been spent on this head office since its inception, which is obviously grossly understated.

Defence

In second place behind Home Affairs, Immigration, Safety & Security is the Defence (Vote 8), with a midyear development budget of N\$298.4-m for five projects in 2021/22, accounting for 40.6% of the N\$735.2-m security cluster total following a N\$2.5-m or 0.8% decrease on its N\$301-m allocation at the beginning of the year when it accounted for 41% of the N\$733.7-m cluster total.

Its N\$301-m development budget the beginning of this year was almost 6% or N\$19-m less than 2020/21's revised N\$320-m, when it accounted for 39.36% of the N\$813-m cluster total, also for five projects (half 2019/20's ten).

Defence's N\$320-m revised development budget in 2020/21, followed a N\$5-m or 1.54% reduction on its initial allocation at the beginning of the year when it had a 39.4% share of the original N\$825-m cluster total.

Despite these reductions, the Defence Vote's midyear N\$298.4-m 2021/22 allocation accounts for 5.7% of the reduced N\$5.2-b national development budget – higher than 5.47% (of N\$5.5-b) at the beginning of the year and significantly above 2020/21's 4.96%, when it spent N320-m out of the N\$6.456-b national total.

Defence's N\$325-m ceiling at the beginning of 2020/21 was 13.4% or N\$50.3-m below 2019/20's actual N\$375.3-m, which was slightly lower than 2019/20's midyear revised N\$385.321-m at the time - unchanged from its allocation at the beginning of the year.

This, in turn, had been an 11.5% decrease on 2018/19's revised N\$435.48-m.

Defence's development budget in 2019/20 accounted for 30.4% of the midyear revised N\$1.269-b cluster total and 5.58% of the post-midyear N\$6.9-b overall development budget total, lower than its 42% share of 2018/19's N\$1.036-b cluster total and 5.56% of the revised N\$7.8-b overall total.

At the beginning of 2019/20, Defence accounted for a lesser 28.25% of the N\$1.36-b cluster total and 4.87% of the N\$7.9-b overall development budget.

Its current 5.7% share of the national development budget (2021/22) ranks it seventh behind Transport's 41% (N\$2.1-b), Urban & Rural Development's 10% (N\$532-m), Education, Arts & Culture's 7.6% (N\$399-m), Home Affairs, Safety & Security's 7.2% (N\$375-m) and only marginally behind Agriculture & Land Reform's 5.97% (N\$312-m) as well as the Health & Social Services Vote's 5.92% (N\$309-m).

It ranked sixth last year in relation to roughly the same votes excluding Health & Social Services which had a lower revised development allocation than Defence.

Defence Vote's N\$150-m R&D budget is all for

Defence also ranked sixth in 2019/20 – but still ahead of the Health & Social Services vote.

This had been a relegation from 2018/19's fourth ranking behind only the transport, agriculture and urban & rural development votes.

In 2015/16 it ranked third - after only transport and agriculture.

As usual, Defence's biggest project is still its ubiquitous 'Research & Development' project for which N\$150-m has been voted in 2021/22, compared to N\$170-m last year and N\$125-m in 2019/20 – all for operational equipment, machinery and plant (as it is every year).

This is much less than 2018/19's N\$227-m and 2017/18's N\$263-m.

Details of this never-ending R&D project are annually described as 'classified information'.

Thanks to the development budget's redacted (and distorted) format, only N\$2.5-b is recorded as having been spent on the R&D project to date.

The project total (now no longer disclosed) stood at the same N\$6.7-b last year as it had over the past four years, which was more than 2020/21's entire N\$6.5-b national development budget.

All five the Defence Vote's projects currently under implementation are ongoing.

Defence's second-biggest project currently underway is N\$90-m for upgrading Leopards Valley Military Base outside Windhoek, involving the continuing construction of the office complex in 2021/22.

Justice

With the number of votes in the security cluster now reduced from seven to six, Justice (Vote 16) has the third-highest development allocation in 2021/22 with N\$54.6-m to spend on seven projects, accounting for 7.4% of the N\$735-m cluster total, after its initial N\$59.6-m accounting for 8% of N\$733.7-m was cut by N\$5-m or 8.4% midyear.

Justice's initial N\$59.6-m development ceiling at the beginning of the year was 5.35% below 2020/21's revised N\$63-m for nine projects, when it accounted for 7.75% of the higher N\$813-m cluster total.

Its original N\$65-m voted at the beginning of last year was reduced by 3.08% in those midterm revisions, its share of the security cluster falling marginally from 7.88%.

Its initial N\$65-m allocation at the beginning of 2020/21 was 32% below 2019/20's actual N\$95.5-m expenditure, accounting for 7.98% of the N\$5.8-b cluster total.

This is short of the N\$115-m Vote 16 had to spend on twelve development projects after 2019/20's midyear revisions at the time, accounting for 9% of the N\$1.269-b cluster total post-midyear - more than 8.45% of N\$1.364-b cluster total at the beginning of the year, although its ceiling for development projects remained unchanged.

This, in turn, was 15% more than 2018/19's revised N\$100-m, when it accounted for 9.65% of the revised N\$1.036-b cluster total.

The biggest project in the Justice Vote in 2021/22 is N\$42-m for alterations and additions to the Ministry's Justicia building in Windhoek, scheduled to have started during the year, although N\$29-m has already been purportedly spent.

The Justice Vote has one new project on its programme this year (as it did in 2020/21) – upgrading the Supreme Court in Windhoek, for which N\$800,000 has been voted for feasibility and design.

Veterans' privileged affairs

In fourth and last place within the security cluster, Veterans Affairs has N\$7-m to spend on two projects in 2021/22, accounting for 0.95% of the N\$735.2-m cluster total, after its N\$9-m allocation at the beginning of the year accounting for 1.2% of the N\$733.7-m cluster total was cut by N\$2-m or 22.2% midyear.

Its original N\$9-m development ceiling at the beginning of the year was a handsome 80% or N\$4-m increase on 2020/21's N\$5-m - unaffected midyear, although its share of the cluster fell from 0.71% to 0.61%.

Vote 31's modest development allocation in 2020/21 was 41% or N\$3.5-m below 2019/20's actual N\$8.5-m expenditure - for three projects in both those years.

This had been nearly 42% more than 2018/19's revised N\$6-m.

In 2017/18, Veterans Affairs had N\$14.9-m to spend on capital projects, up 55% from the previous year's revised allocation.

In contrast, Gender Equality & Child Welfare had N\$8.2-m – not quite double 2016/17's revised N\$4.2-m, when N\$9.6-m development project funding for war veterans was more than double the N\$4.2-m allocated for impoverished children, while in the same year (2016/17) the much-heralded new Ministry of Poverty Eradication & Social Welfare had its development budget slashed 99% in its first year, affecting the construction of the new food bank in Katutura, where N\$39.1-m was suspended midyear from an initial N\$39.7-m voted.

The same disproportionate allocation of development funding between war vets and poverty-affected children also applied in 2015/16 (*Bulletin 1141*).

The *Tender Bulletin* had pointed two years earlier that "the development budget shows a distinct bias favouring the gracefully retired members of the Peoples Liberation Army of Namibia, with the construction of housing and recreational facilities for veterans supplementing their generous financial grants under the operational budget."

"On the other hand, vulnerable civil society groups such as old age pensioners and children living in poverty are biting the bullet when it comes to development funding."

As we pointed out in our assessment of development spending in 2015/16, there were an estimated 360,000 children living in poverty in Namibia in 2010, according to a UNICEF report at the time.

Yet, the Ministry of Gender Equality & Child Welfare's development spending in 2015/16 specifically targeting vulnerable children totaled only N\$1.8-m, compared to N\$4.5-m in 2014/15 – a 60% reduction.

In contrast, for about 24,000 Swapo war vets, 2015/16's development budget for the Ministry of Veterans Affairs amounted to N\$44.5-m – exceeding the N\$1.8-m benefiting vulnerable children 25-fold and more than double 2014/15's N\$19-m for the war vets (*Bulletin 1190*).

Fast forward three years, when the N\$8.5-m Veterans Affairs had to spend in 2019/20 (unaffected by the midyear revisions), was a generous 240% increase over 2018/19's revised N\$2.5-m, which had been a 42% reduction on its original N\$6-m voted at the beginning of that year – all for one project.

At the time of 2018/19's midyear revisions, however, the vote's N\$6-m was not reduced - unlike all votes in the health and welfare cluster.

Its development budget in 2018/19 was 51.5% below 2017/18's revised N\$12.38-m, which commenced with just below N\$15-m for three projects.

The VA Vote's biggest project on the development budget in 2017/18

As usual, Defence's biggest project is still its ubiquitous 'Research & Development' project for which N\$150-m has been voted in 2021/22, compared to N\$170-m last year and N\$125-m in 2019/20 – all for operational equipment, machinery and plant (as it is every year).

equipment the auditor general cannot see

totalated a generous N\$370-m for the construction of veterans' recreational facilities, for which N\$2.9-m was voted for the construction of chalets in Onesie, Omusati Region.

This project, which had an exorbitant N\$341-m balance to complete in 2017/18, was moved to the back burner in 2018/19 but was revived in 2019/20 with a modest N\$1.5-m allocated.

The Veterans Affairs project for the construction of recreational facilities totaled N\$573.375-m in 2020/21, for which a mere N\$572,000 was voted, however.

According to the National Planning Commission's 2020/21 development budget, this project involves "counseling and rehabilitating traumatized veterans as well as redirecting their "thing" [thinking] and changing their mindset on other social aspects of the country".

It must be pointed out that this project commenced in 2019 - three decades after independence, when war vets are apparently still in need of counseling for post-traumatic stress disorder in the form of recreational facilities. Presumably due to budget constraints, this project has disappeared from Vote 31's development programme in 2021/22.

Thankfully, some balance was restored in the government's development priorities last year when the N\$5-m capital projects budget for Veterans Affairs in 2020/21 was only one-fifth of the N\$25.67-m voted for Gender Equality, Poverty Eradication & Social Welfare (Vote 36).

But post-midyear in 2021/22, the VA Vote's N\$7-m development allocation is over half Gender Equality, Poverty Eradication & Social Welfare's N\$13.75-m - a sharp reversal on last year's one-fifth disparity in favour of the Social Welfare Vote.

And while the VA vote's N\$7-m mid-year allocation this year is still higher than last year's N\$5-m, the Social Welfare Vote's N\$13.75-m is almost half 2020/21's revised N\$25.67-m.

This means N\$7-m for 24,000 war vets equals N\$291.6 per capita, compared to N\$13.75-m for 360,000 impoverished children which works out

to N\$38.2 per head.

The VA Vote's biggest project in 2021/22 - the same as last year - is the acquisition/construction of MVA regional offices in the Otjozondjupa, Ohangwena and Oshana regions, for which N\$9-m had been allocated at the beginning of the year, but which has obviously been cut back (by how much has not been disclosed).

According to this year's redacted (and distorted) development budget format, N\$6-m has been spent on this project to date.

In last year's development budget when project totals were still recorded, the project totaled just below N\$4-m - considerably scaled back from its N\$71.4-m total in 2019/20.

MIDYEAR DISCREPANCIES: There are discrepancies for four votes between their original allocations for 2021/22 as stated in the main budget and their original allocations as stated in the midyear budget: Vote 27 - N\$15,429-m in the main budget but N\$13,429-m according to the midyear budget (N\$2-m less); Vote 31 - N\$10-m in the main budget but N\$9-m in the midyear budget (N\$1-m less); Vote 37 - N\$392,426-m in the main budget, but N\$347,772-m in the midyear budget (N\$44.65-m less); Vote 38 - N\$264,603-m in the main budget, but N\$259,929-m in the midyear budget (N\$4,674-m less). The inside SRF development total of N\$5,505-b at the beginning of 2021/22 according to the midyear budget document is therefore N\$52,028-m less than the N\$5,557-b according to the main budget book at the beginning of the year. This is either due to errors in data capture or misallocations not clarified in the midyear budget statement.

CHINA TIGHTENS ITS CHOKEHOLD

14 JANUARY 2022

The love affair between Namibia's ruling party and the Chinese government involving the exchange of confidential financial favours is an open secret, watched by Namibians with growing trepidation as Beijing continues to shower its African client with gifts in exchange for awarding government contracts to Chinese contractors.

While Uganda is in danger of losing its international airport to China over unpaid loans, the Namibian government is lapping up Beijing's slow poison in the form of grants and soft loans in exchange for the award of mega state contracts to Chinese players at an alarming rate.

Under its long-serving president Yoweri Museveni, Uganda has reportedly defaulted on a US\$207-m loan for the Entebbe International Airport at an interest rate of 2%, advanced in 2015 by the China Export-Import (EXIM) Bank over 20 years following a seven-year grace period.

The loan conditions include the possible attachment of the country's only airport and other Ugandan assets. Efforts to renegotiate the loan terms with China have failed.

It has also been reported that China had taken over national assets in Zambia for defaulting on debt repayments - including airports.

In Namibia, China is funding the construction of the ruling party's N\$750-m new headquarters, currently being built by Unik Construction under financial terms that have not been disclosed (*The Namibian* 29-Nov-21, 08-Oct-21).

China's special financial package for Namibia's new airport

During a conference call in Apr-20 with Chinese president Xi Jinping, Namibia's president Hage Geingob expressed appreciation for "the special financial package to help Namibia commence with plans to modernise and expand its main airport to international standards".

The terms for the construction of the airport were "favourable and Namibia looks forward to urgent commencement and completion of the project in the coming years," Geingob was quoted as saying.

The last airport upgrade tender valued at N\$7-b - also underwritten by China - was cancelled in 2016 under former finance minister Calle Schlettwein.

After the Namibia Airports Company had hastily awarded a N\$6.8-b (US\$477.8-m) tender for a second airport on 03-Dec-15 to long-favoured Chinese state-owned firm, Anhui Foreign Economic Construction Corporation, the award was cancelled two weeks later on instruction of president Hage Geingob, following a public outcry about the inflated price, while

more cost-effective bids were ignored and amidst allegations of bribery and corruption as well as the NAC's non-compliance with legal requirements.

Schlettwein's successor, Iipumu Shiimi, was expected to finalise the 'special financial package' under a loan agreement for the new HKIA airport.

In 2018, Chinese ambassador to Namibia, Zhang Yiming, had proposed that the terms of the loan agreement would include for China to fund the project through a 10% grant as well as a 90% concessional loan at an annual interest rate of 2% over 20 years, including a five-year grace period with a 0.25% management fee and commitment fee respectively.

Funding for the airport forms part of the US\$60-billion in new development financing for Africa pledged by Chinese president Xi Jinping in Beijing in 2019 (*Bulletins* 1278, 1346, 1392).

N\$3-b Chinese grants for twenty projects

Since the Johannesburg Summit of the Forum on China-Africa Cooperation in 2015, China has completed nearly twenty grant projects in Namibia valued at approximately N\$3-b, the Chinese ambassador in Namibia Zhang Yiming confirmed at the recent signing of the Economic & Technical Cooperation Grant Agreement with Namibia.

The latest agreement totals over N\$936-m for projects to be mutually agreed upon.

The ambassador mentioned the satellite data receiving ground station and processing system outside Swakopmund as an example of cooperation between the two countries in the high-tech field of aerospace (New Era 26-Nov-21).

Chinese grant for final section of airport highway

After a tender process behind closed doors - exclusively for Chinese contractors - the Roads Authority recently awarded the final stretch of the Windhoek - Hosea Kutako International Airport highway to Zhong Mei Engineering Group for over N\$1.035-b - on the back of a grant from Beijing.

RA CEO Conrad Lutombi announced that the successful bidder would build the final 21.3km section of the highway from the Dordabis turnoff to HKIA, which includes three interchanges at Dordabis, Sonnleiten and the airport, plus two river bridges. This stretch (previously stated as 23.5km) has a contract period of

36 months.

During the site hand-over, Lutombi said this part of the project is financed through a Chinese grant of about N\$1-b and only Chinese companies registered in Namibia were short-listed for the award.

Zhong Mei was chosen after a 'successful procurement process' headed by the Chinese Embassy in Namibia under the auspices of the Chinese Project Management Enterprise, in consultation with the RA.

Both the earlier two phases of the highway were also built by Chinese companies as main contractors.

Phase 1 was financed by Namibia and awarded to China Railway Seventh Group in joint venture with Onamagongwa Trading Enterprises for N\$799-m under tender RA/DC-CR/06-2014.

The second phase 2A was financed through an AfDB loan under tender RA/DC-CR/06-2014/2A and awarded in Nov-19 to Chinese company AVIC and Namibian SME subcontractors for N\$950-m.

For the final phase, Zhong Mei's offer of ¥447,746,240.08 was the most expensive of the six offers received, when tender RA/DC-CR/06-2014/28 for Phase 2B of (Dordabis to HKIA) closed at the Roads Authority on 21 May 2021 (*Bulletins* 1424, 1406).

China Railway awarded N\$475-m section of Windhoek - Okahandja highway without tender

The Roads Authority has awarded a 5km stretch of the Windhoek - Okahandja road upgrade to China Railway Seventh Group for N\$475-m without public tender.

POLICY & GOVERNANCE

The RA requested an exemption from public tendering procedures from the finance ministry to save government 'unnecessary costs and time'. Consultant VKE was asked to do thorough due diligence and negotiate the priced bill of quantities submitted by the Chinese contractor.

According to the RA's Lutombi, the 5km works for Section 1 of TR1/6 was originally not budgeted for in the current financial year, but the RA obtained support from the Road Fund Administration for a bridging facility of N\$40-m so that works could commence (*The Namibian* 08-Oct-21).

As far as the *Tender Bulletin* could ascertain, China Railway Seventh Group has no previous involvement in this road project.

The 2021 - 2022 Annual Procurement Plan on the RA website lists a project for the rehabilitation and upgrading of TR1/6: Sections 4A and Section 4A Extension, which should have been advertised under Open National Bidding in Aug-21 and should be awarded by Feb-21 [presumably Feb-22]. The cost estimate is N\$200-m.

Previous tenders under RA/DC-CR/09-2013 for the rehabilitation and upgrading of Trunk Road 1 Section 6 between Windhoek and Okahandja were awarded as follows:

* Section 4A, 27.6km freeway from Döbra River to Omakunde Interchange to dual carriageway was awarded in Dec-15 to CMC (Italian 70%) and Otesa Civil Engineering (Namibian 30%) JV for N\$1.08-billion (*Bulletin* 1159);

* Section 3 between Brakwater and Döbra River bridge over 10km was awarded to Grinaker LTA for \$239.7-m (*Bulletin* 1039).

In 2013, the 78km upgrade to dual carriageway standard of the entire road between Windhoek and Okahandja in four sub-sections was estimated at N\$1.5-b to be completed over five years.

OVER N\$34-M RESTRICTED SUPPLY TENDERS AWARDED

14 JANUARY 2022

NamPower announced the awards of five supply tenders worth over N\$34, according to its website as at 13 December 2021.

These are part of 14 'restricted bidding' tenders worth over N\$120-m in which selected bidders were invited to tender without advertisements in the public domain.

Of the 14 restricted bidding tenders, four were for 'non-consulting services', five for 'works' and five for various supplies, award details of which are reported separately.

The value of some of these tenders confirms that NamPower is currently handling procurement above its threshold without having to go through the Central Procurement Board - as disclosed by the CPB at its latest media briefing in November. NamPower's special exemption from going through the CPB was first announced by finance minister lipumu Shiimi when tabling the midyear budget at the beginning of November.

Some of these 'restricted bidding' tenders awarded as at 13-Dec-21 date back to 2020 but from the awards posted on the NamPower website it is not clear when the awards were processed.

MV & HV trans-formers to Siemens/Trench and Actom for N\$12.5-m

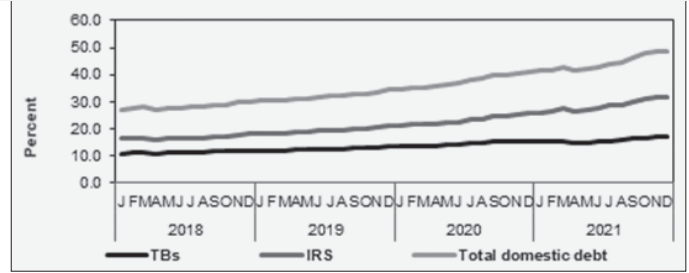
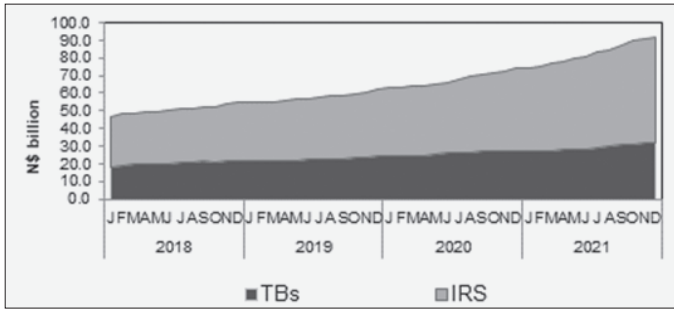
GRN DOMESTIC DEBT GROWS 24.5% TO N\$91.8-B

14 JANUARY 2022

Namibia's domestic government debt reached N\$91.8-b at the end of December, according to the Bank of Namibia's latest

monthly report.

This reflects 0.2% increase on the previous month, resulting from the sale of Internal Registered Stock and Treasury Bills, which rose by 1.3% and 0.2% respec-



tively to N\$60.1-b and N\$31.8-b.

On an annual basis, domestic debt increased by 24.5% through the issuance of both IRS and TBs, which rose by 29.4% and 16.2% respectively.

As percentage of GDP, do-

mestic debt rose by 0.4 percentage point month-on-month and by 7.7 percentage points to 48.8%, reflecting increased ratios of both IRSs and TBs to GDP of 6.0 percentage points and 1.7 percentage points.

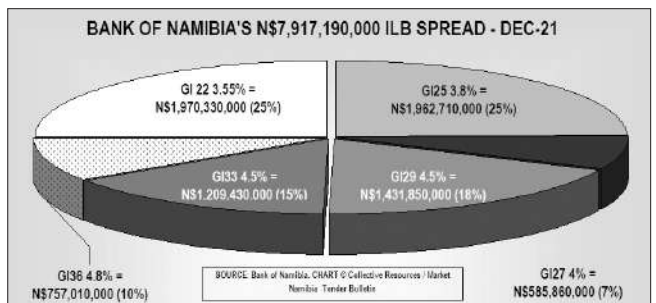

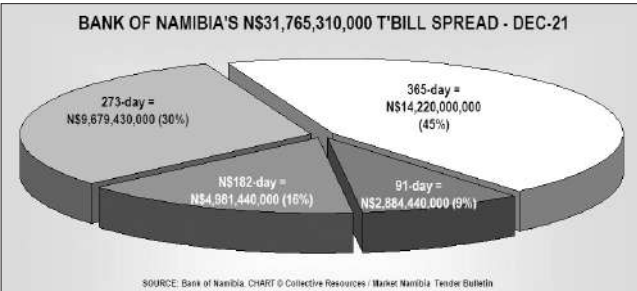
