**Launching a dedicated cell to facilitate Business
Responsibility and Sustainability Reporting**

Executive Summary

Target 12.6 of the SDGs underlies Transparency. This signifies that companies should adopt sustainable practices and integrate sustainability information into their reporting. The Securities and Exchange Board of India (SEBI), in its board meeting held on 25th March 2021, decided to introduce new requirements for sustainability reporting by listed companies, to be called the Business Responsibility and Sustainability Report (BRSR), replacing the existing Business Responsibility Report (BRR). The BRSR shall be applicable to top 1000 listed entities (by market capitalization), for reporting on a voluntary basis for FY 2021-22 and on a mandatory basis from FY 2022-23. This move shall bring in more transparency and enable market participants to recognize and assess sustainability-related risks and opportunities.

On this backdrop PHDCCI is organizing 'E-Conference on Integrating SDGs in Business Responsibility and Sustainability Reporting with the following objectives: -

- To devise a framework for embedding SDGs in existing business and reporting processes
- To understand Business Responsibility-Sustainability Index
- To deliberate on quantifiable metrics, for easy measurement and comparability across companies, sectors and time periods.
- To understand essential (mandatory) and leadership (voluntary) indicators under BRSR
- To disseminate ESG-related information to enable market participants to identify and assess sustainability-related risks and opportunities
- To deliberate on strategic engagement of global, national and local institutions to achieve SDGs
