### WHY AFT?

- Alternative Fuel Technology (AFT) is all about ensuring a cleaner alternative for mobility, it broadly reflects on the commitment for Sustainable Development Goal (SDGs).
- India, as one of the world's fastest growing economies have significant bearings with adoption of a sustainable mode of transportation and environmental protection.
- An awareness about the requirement of Alternative Fuel for vehicles is a very important issue in India. We have seen in the last few years both center and state governments are taking this matter very seriously.
- As an ambitious exercise to curb the city's high pollution, the Government of Delhi successfully implements odd/even twice for 15 days in Delhi where on odd days only odd number vehicles were allowed on the roads and on even days only even number vehicles were allowed on the road.
- AFT ensures clean, green and cost-effective alternative to the other fuels and technologies.

### INDUSTRY IN INDIA

- India has one of the biggest fleet of natural gas vehicles in the world but most importantly holds the highest NGV growth potential in the world with over 220 cities planned for CNG development, a nationwide distribution pipeline.
- Indian Government aims to bring 6-7 million electric and hybrid vehicles on road by the end of 2020.
- India's transport sector accounts for about 6.7 per cent of India's Gross Domestic Product (GDP)
- Currently, there are 30 lakh CNG vehicles are plying on Indian roads
- The Electric Vehicle market is anticipated to grow at a robust CAGR of 43.13% during the forecast period from 2019 to 2030.
- India has the potential to become one of the largest electric vehicles (EVs) markets in the world, with the government pushing for the segment in order to curb pollution

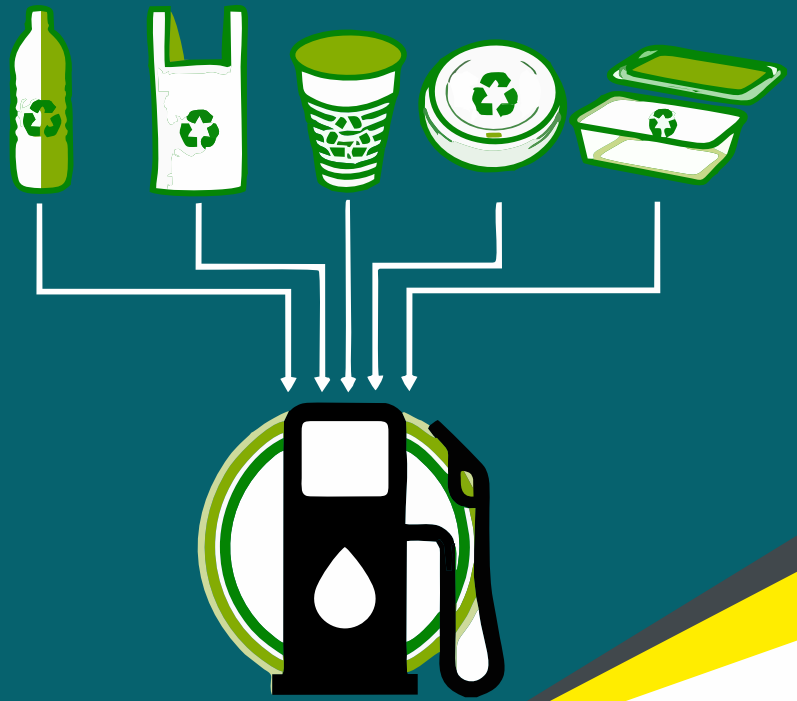
