National Planning Commission director general, Obeth Kandjoze concludes his preface to the 2023/24 development budget with a call repeated each year – to no avail: "... where funds are allocated, implementation should be executed in full in order to ensure the full benefits of government investment and within [a] reasonable timeframe".

15 DECEMBER 2023 amibia's central government implemented less than a third of its development projects for 2023/24 by the end of the first half of the year, lagging dismally behind its annual target by the widest margin over the past three years, while latest measured annual project execution rates have plunged from 95% in 2018/19 to 58% in 2021/22 before recovering to 71% last year.

Finance minister lipumbu Shiim disclosed in his midyear budget speech at the end of October the 32.6% execution rate for development projects between April 2023 to mid-September was well below the 50.6% for operational expenditure. "[G]iven the low execution rate on several projects, N\$167.3-m was identified for reallocation across votes within the development budget".

At last year's halfway mark in September 2022, 49.6% of the operational budget had been spent, while the development budget implementation rate was 38%, on which Shiimi nonchalantly remarked at the time that this

lackluster execution of develop-ment projects was "fairly in line with past trends", expressing no concern over the endemically low achievement.

This had been a deterioration on the previous midvear in 2021/ 22. when operational expenditure stood at 43.8% (compared to last year's 49.6% and 2023/24's 50.6%), while the development budget implementation rate stood at 39% (compared to 38% last year and below 32.6% in 2023/24)

The gap between the development budget's low execution rate and the operational budget's consistently higher rate has therefore widened over the past three

He implores implementing institutions "to strictly ensure full deployment of funds allocated to the various programmes and that projects are executed in a cost effective and efficient manner"

Members of society should inform themselves with the development budget, to enable them to monitor project implementation, utilization of allocated resources, "directly assisting in holding those responsible accountable".

Although Kandjoze has repeated this mantra year after year, what we have witnessed instead is the steady deterioration in transparency in the development budget, combined with inaccurate recording of project expenditure and foreign funding.

Referring to previous years, the NPC in the Office of the President, responsible for compiling the development budget, says in its 2023/24 budget that the development budget financial execution rate "has been satisfactory", standing at 81% on average for the past three years.

Under-performers fingered

ff However, some votes have performed below 50 percent throughout the three financial The NPC named the Ofyears." The NPC named the Office of the Prime Minister (Vote 02), Finance & Public Enterprises (Vote 09), Labour, Industrial Relations & Employment Creation (Vote 14) and Fisheries & Marine Resources (Vote 22) who "have underperformed, citing various implementation challenges such as poor workmanship, delays in project planning processes, delays in the procurement processes, and in some instances, project abandonment" – an observation made repeatedly over previous years.

Average project rates were 82% in 2020/21, increasing to 89% the following year, before falling to 71% in 2022/23

Votes with implementation rates below 50% over the past three years were:

- * 26%, 34% and 0% for the Office of the Prime Minister:
- * 44% for International Relations & Cooperation last year;
- * 42% in 2020/21 and 0% last year for Finance & Public Enterprises;
- * 34% for Labour, Industrial Relations & Employment Creation in 2020/21 and 28% last year;
- * Industrialisation, Trade & SME Development 48% last year;
- * Fisheries & Marine Resources - 11% in 2020/21 and only 4% last
- * Sport, Youth & National Service -34% last year;
- * Gender Equality, Poverty Eradication & Social Welfare - 10% in 2020/ 21 and 30% the following year

Compared to five in 2023/24, six votes implemented half or less of their development allocations last year, according to the NPC's 2022/23 budget book, compared to seven in 2020/21 and three in each

of the previous two years. In its 2022/23 Development Budget, the NPC repeated its complaint of previous years that these implementation challenges" were due to factors such as "poor workmanship, delays in project planning processes, delays in the procurement processes, and in some instances, project abandonment" - all of which points to poor governance.

Previous project execution rates

s noted above, as far as execution rates are concerned, at the halfway mark in September this year, 50.6% (49.6% last year) of the operational budget had been spent, while the development budget implementation rate was only 32.6% (38% last year).

This is even worse on both counts than at midyear in 2021/22, when operational expenditure stood at a lower 43.8%, while the development budget implementation rate stood at a higher 39%.

Previous to that, by midyear in 2020/21, 42% of the operational budget had been spent, compared to a pitiful 27% of the development budget.

Although this poor performance was largely due to the Covid-19 restrictions that year, the gap between the shortfalls in operational and development expenditure is

eye-watering.
This had been a woeful deterioration on midyear in 2019/20, when operational expenditure had reached 49% of its budgeted allocation by September 2019, compared to 48% after the first half of 2018/19.

In terms of development expenditure, 2022/23's 38% had been better than 2019/20 midyear, when it reached only 30% - an improvement on the previous year's even more dismal 27%

Unsurprisingly, things aren't any better as far as annual project

execution rates are concerned.
The National Planning Commission found in its Development Budget for 2022/23 that overall project execution has declined from 87% in 2019/20 to 82% the following year, before sinking to 58% in 2021/22.

Earlier, according to the NPC's 2021/22 development budget book, project execution rates declined from 95% in 2018/19 to 93% in 2019/20 (since downgraded to 87%) and 82% in 2020/21, compared to 96% in 2017/18.

Personnel v. development expenditure

his midyear budget provides for the first-ever reduction in the provision for personnel expenditure by 0.19% or N\$61.87-m to N\$32.82-b from last year's revised N\$32.88-b.

Shimmi commented in his mid-term budget speech: "We have broadly not reduced the initial ceilings of most votes despite noting

low implementation rates during the first half of the year, particularly on personnel expenditure due to the slow pace of recruitment.

"[W]e have encouraged the votes to reallocate the savings on personnel expenditure during the first half of the year to meet other urgent operational expenditure".

This is a rather refreshing occurrence, considering that in 2022/23's midyear expenditure, a generous N\$2.9-b increase in voted remuneration expenditure was six times more than the N\$500-m additional investment in the development budget - not that all those extra bucks in the bureaucracy's purse translated into speedier implementation of capital projects, where the midyear execution rate was only 38%, compared to 50% for operational expenditure, to be followed by even worse outcomes this midyear with project execution below 33% and operational expenditure at almost 51%.

At 2022/23's mid term, the extra N\$2.9-b remuneration expenditure accounted for 83% of the entire N\$3.5-b additional operational expenditure, compared to midyear in 2021/22 when N\$865-m additional allocations for remuneration accounted for 40% of the N\$2.2-b overall increase in the operational budget.

The generally positive midyear 2022/23 revisions were in sharp contrast to the previous year, when the development budget was cut to prop up runaway operational overexpenditures – as usual.

As was the case in 2022/23, most of the higher operational expenditure reallocations in 2021/22 were for additional remuneration – a foreseeable cost that should have been budgeted for at the beginning of the year and which resurfaced last year.

While the development budget was cut midyear in 2021/22 by N\$290.8-m or 5.3% from N\$5.5-b to N\$5.2-b, the operational budget was increased by N\$2.2-b or 4% to N\$56.1-b.

Midyear revisions

Following 2022/23's midyear revisions, the development budget was back at the N\$5.5-b it was at the beginning of 2021/22 before its reduction, while the operational budget's N\$60-b post-midyear was 6.2% more than its revised N\$56.5-b in 2021/22 – even higher than the N\$56.1-b to which it was increased midyear in 2021/22.

Ás had been the case in 2022/23's midyear revisions, the reshuffling of allocations the previous midyear was for "critical expenditure items that could not be postponed" (in finance minister lipumbu Shiimi's own words in both years).

The big difference last year was that both operational and development expenditure were

raised, while in 2021/22's midyear reallocations only N\$41.4-m was sourced through suspensions in the operational budget, compared to N\$279.8-m in the development budget.

At the time of 2021/22's reallocations, Shiimi euphemistically described the N\$290.8-m cutback on capital development projects as "a saving on the development budget".

This "saving" resulted from projects "whose tenders are not awarded, projects without contractors on site, projects with zero execution rate, projects below 60 percentage execution rate and projects that have not yet started with procurement and advertisement processes", Shiimi told the National Assembly in October 2022.

Out of these "savings" - resulting from poor development project execution rates - only 3.7% was re-allocated within the development budget with the remaining 96.3% allocated to operational expenditure.

In 2023/24, the rate of development project implementations is even worse, the difference being

General "has flagged persistent overspending" by the health and education votes in previous financial years, primarily due to underbudgeting.

But in 2021/22's midyear remuneration increases, when the Ministry of Defence & Veterans Affairs received by far the biggest - N\$458-m - increase personnel and veterans expenditure, the finance minister said nothing whatsoever about the auditor general's findings of a string of irregularities relating precisely to salaries in his report on the defence ministry for the 2019/20 financial year – the latest audit at the time.

These involved questionable salary expenses by the defence ministry on behalf of August 26 Holdings and on a defence attaché in the Democratic Republic of Congo (Bulletin 1422).

Last year's completed projects

that lagging project expenditure has been reallocated within the development budget and not diverted to operational expenditure to the same extent, although some the development budget has certainly been diverted.

Previous midyear remuneration expenditure

perational reallocations midyear in 2021/22 were primarily to address underbudgeting on personnel expenditure, amounting to about N\$865m or 40% of the N\$2.2-b increase in operational expenditure.

Of last year's N\$3.5-b midyear increase in operational expenditure, almost N\$2.9-b or 83% had been for remuneration – more than double the previous year's share.

In 2021/22's midyear, the Ministry of Defence & Veteran Affairs was allocated by far the biggest, N\$477-m or 55%, slice of the N\$865-m increase in remuneration (22% of the N\$2.2-b reallocations to the operational budget), consisting of N\$458-m to meet the funding shortfall on personnel expenditure and N\$19.1-m for undisclosed veterans expenditure.

There were no remuneration adjustments for veterans last midyear, while the defence vote received only an additional N\$3-m.

Addressing remuneration in last year's budget speech, Shiimi was quick to point out that the Auditor

ccording to the 2022/23 NPC development budget book, 26 projects were completed in 2021/22, compared to fifteen in 2020/21.

Fifteen of the 26 projects completed in 2021/22 were for Health & Social Services, three for Urban & Rural Development, three each for International Relations & Cooperation and Agriculture & Land Reform, two for Home Affairs, Immigration, Safety & Security and one each for the Water vote, Transport and the Justice Vote.

According to the 2021/22 NPC development budget book, of the fifteen projects completed in 2019/ 20, nine were for Safety & Security, two each for Transport and Education, Arts & Culture, with one each for Information & Communication Technology and Agriculture & Land

Governance deficit undermines project implementation

here are 417 development projects on the agenda for 2023/24 of which 33 are new - a record not seen in recent vears

A perpetual governance deficit, inadequate planning and oversight not to mention corruption - continues to stymie the Namibian government's implementation of its own development programmes even as the number of capital projects on its agenda continues to dwindle year after year - apart from 2023/24's refreshing increase to 417 from the lowest ever count of 375 in 2022/23, compared to 397 in 2021/22 and 401 in 2020/21.

Government officials often blame the malaise of poor project execution on 'poor workmanship', but this is the result of appointing contractors not up to the task - under a procurement policy designed to promote under-pérformers through the wholesale promotion of inexperienced SMEs.

The overall N\$6.486-b post-

Of 417 development projects in 2023/24,

midyear domestically-funded development budget for 2023/24 for 417 projects is 19% or N\$1.02b more than last year's revised N\$5.46-b for 375 projects.

In addition to this year's N\$6.5b domestically-financed development budget, foreign loans (and to a lesser degree, grants) totaling N\$2.365-b (N\$2.7-b last year), raise the total to N\$8.87-b (N\$7.7b last year), according to the National Planning Commission, budget book this year.

The expanded development budget including foreign funding therefore increased by N\$1.17b or 15% in 2023/24 - a lower percentage than the 19% for the domestically-funded components because foreign funding declined this year by 12% to N\$2.365-b from last year's N\$2.7-b.

But this year's decline in foreign development funding is a hiccup, since there are considerably more foreign development loans the pipeline for 2024/25 and beyond.

As Shiimi already signaled in last year's midterm budget speech: 'Consideration has been made to execute large capital projects, going forward, through long term funding from Development Finance Institutions (DFIs) to minimise the pressure on the budget"

What this means is that in order to channel most of its domestically sourced revenue into operational expenditure, the government has become more reliant on external capital for its development budget, since foreign lenders are hardly going to finance operational expenditure items such as remuneration. other current overheads and interest repayments on debt.

Projects in decline

s noted above, 2023/24's refreshing increase to 417 projects of which 33 are new, is a clear improvement on last year when the lowest-ever count of 375 projects included only three new, compared to eight out of 2021/22's 397 and eleven new projects of 2020/21's 401.

This was a decline on 2019/20 when fourteen of 422 projects were new – almost half of 2018/19's 26 new projects out of 406.

Without having to repeat him-self again this year, the NPC's Kandjoze had repeated his appeal verbatim from previous years in his foreword to 2022/23's development budget:

"Resulting from the reduced development budget ceiling when compared to previous years, the call is once more made to all implementing agencies to ensure that the limited resources allocated to the development projects are indeed deployed for the intended purposes and not re-allocated to operational activities at all (our emphasis)

Despite the recent year-onyear decline in projects under implementation, the NPC was also mortified by the slow implementation of development projects, the planning for which it is responsible, but not their implementation by line

ix years later in 2023/24. Kandjose has not updated us on his finding announced in 2019, that at least 406 projects worth billions of dollars were still incomplete by the previous year.

The NPC's fact-finding mission in 2018 found that of 493 projects, only 87, worth N\$24-m, had been completed.

"All these projects were supposed to deliver services by now, but are either incomplete or abandoned," Kandjoze complained at the time.

A directive was sent out to the regions to find out what these projects lacked so that they could be completed as planned.

Look at some of the rural toilets built at a cost of N\$70,000, while the shack dwellers can build a house for the same amount," he lamented at the time.

The NPC was carrying out a situation analysis to understand what caused the projects not to be completed - about which we have heard nothing six years later.

We also still remain in the dark as to whether the 406 projects backlog has diminished or increased

One of the bottlenecks the NPC identified at the time was that the regional budgets only get to the regions in August, which leaves only six months for planning and execution before the end of each financial year. More poor governance.

The director general need look no further than the ministry of finance's serial cutbacks of the development budget each midyear over most past years - with the exception of this year and 2022/23 compounding already-inefficient project implementation.

Little widening of development horizons

he NPC says in its 2023/24 development budget that a total of N\$21.1-b has been allocated to development capital projects over the next three years ending 2025/26 to implement 470 development projects, 439 on-going and 31 new.

This is a rather lacklustre projection, considering that last year's development budget said during the three-year medium term expenditure framework between 2022/23 and 2024/25, a total amount of N\$21.4-b had been allocated for the implementation of 400 development projects - 398 ongoing and two new. This had been an 18.86% decline on the 493 projects envisaged over the 2019/20 to 2021/22 MTEF

The NPC acknowledged that

the 2022/2023 development budget amounting to N\$4.9-b, represented a 10% reduction on 2021/22's N\$5.5-b (which was only achieved following last year's midyear addition of N\$500-m).

The NPC added: "Allocation for the subsequent financial years have also been reduced significantly due to some projects that are expected to be completed by the end of the MTEF period".

Last year's MTEF development outlook had been a deterioration on an earlier one running from 2019/20 to 2021/22, when the implementation of 493 were foreseen, of which 479 were ongoing and 14 new, the NPC said in its introduction to 2019/20's development budget - which has not materialised.

The total number of projects decreased from 531 in the previous MTEF mainly due to prioritization efforts, according to the NPC

The foreword to the NPC's budget in 2019/20 continued along the same vein: "While government continues to invest amidst limited resources, it is crucial for implementing agencies to ensure that implementation is done at 100 percent level.

Therefore, the time is "now" when all the implementers are called to look back and identify what impeded implementation in the previous year, especially the procurement issues and ensure that all impediments are addressed and implementation is done in full force. It is crucial that this support is maximized."

This "now" was six years ago

with limited, if any, progress.
Instead, the NPC's 2021/22 development budget introduction was far less ambitious: "The programmes and projects that are to be implemented in this MTEF [ending 2023/24] are mainly those that are on-going, while the new projects are those that contribute to the economic revival and/or those that contribute to the social and economic impact of COVID-19.

As a result, the 2021/22 midyear budget again saw the suspension of some projects in the annual midterm reprioritization exercise.

Abandoned projects

ven with this midyear's virtually unchanged domesticallyfunded development budget, it will probably turn out in line with the two previous years that have seen midyear development projects adjusted downwards, targeting those with below 10% execution rates or zero commitments by midyear, those that have not yet started with the procurement process and "abandoned projects with allocations"

This admission of inadequate project implementation in 2019/20, was cut, pasted and embellished upon in 2020/21's midterm budget

Of the N\$1-b in additional requests received for development projects at midyear 2023/24, only N\$167.3-m was allocated to Defence, Finance & Public Enterprises, Education, Arts & Culture, Health & Social Services and Urban & Rural Development.

tabled in October 2020 by finance minister lipumbu Shiimi.

In that year, the criteria for projects dropped from the midyear development programme ... are those "that have 10% execution rate with no indication of accelerated implementation plan[s] for the remaining months or known commitments or outstanding invoices, projects that have not yet started with the procurement process, projects with land disputes or any other unsolved issues that have impacts on the roll out of the projects, and abandoned projects and/or projects affected by COVID restrictions.

The N\$1-b bloodbath inflicted on Namibia's N\$9.4-b 2019/20 development budget in that year' midyear review was a sordid repetition of previous years, when investment funds voted for capital projects at the beginning of the year were diverted into operational expenditure for the remainder of the year.

Although this was not the case between 2020/21 and 2023/24, what has now become a feature since 2020/21 then is the non-disclosure of which specific projects were affected by the midyear adjustments in successive midyear budgets. The *Tender Bulletin* is only able to uncover these through it project-by-project analysis that is to follow.

Midyear black hole

√hile in 2019/20 the development budget was slashed by N\$1-b (12.7%) from N\$7.9-b to N\$6.9-b, 2020/21 saw a modest increase in development expenditure from N\$6.4-b to N\$6.5-b, but we remain clueless about which projects were canned in order to make this possible.

As are we again faced with a black hole this year in the postmidyear development budget - as was the case last year, rendering impossible any assessment of what's left for suppliers and service providers over the remaining months of this financial year (to 31 March 2024) on a project-by-project basis, as has been the case for the past three years.

In the absence of a list of affected projects, this amounts even more to a testimony of governance incapacity conveniently feeding into each midyear's project reprioritization - a recurrence ever since 2015, when the midyear budget review was reintroduced after a long interregnum (Bulletin 1323).

n his 2023/24 midyear budget speech at the end of October 2023, Shiimi said of the N\$1-b in additional requests received for development projects at midyear in 2023/24, only N\$167.3-m was recommended for consideration, benefiting the following votes:

Unik Construction faces taxing times

As reported in Bulletin 1521 the finance manager of Chinese firm Unik Construction & Engineering, Jiaxue Liao, was arrested on 28-Nov-23 after he allegedly bought a tax clearance cer-

tificate from an intermediary outside the office of the Namibia Revenue Agency in Windhoek for N\$600.

He was charged with fraud and forgery when he appeared before magistrate Dawid Mukuyu and remained in police custody until 05-Dec-23 to allow the police to conduct sensitive investiga-

tions and pursue more suspects.
Unik Construction had applied for work permits for four of its employees with the Ministry of Home Affairs, Immigration, Safety & Security. The tax clearance certificates submitted in support of the work permit applications appeared suspicious and during verification with NaMRA, it was uncovered that the tax clearance certificate was not on the

NaMRA system.

NaMRA had in fact not issued Unik with a tax clearance certificate because the company is currently being audited by the Revenue Agency.

Besides the fraudulent tax certificate, Unik Construction is accused of bribing procurement officials and unfair labour practices and has been implicated in scandals in various countries including Botswana and Eswatini

Major beneficiary of Namibian tenders

Unik Construction is the contractor for the new SWAPO head office in Katu-

tura estimated at over N\$1-b.
Unik Construction has over the years become a prominent player in landing major government construction tenders in Namibia.

In 2016, the Roads Authority selected Unik as main contractor for the construction of the highway between Swakopmund and Walvis Bay, which was later extended to include an additional 12km and four bridges. This contract is valued at N\$967-m.

In 2019, Unik, in joint venture with another Chinese company, Qingjian Group, won an N\$1-b tender for the rehabilitation of the Walvis Bay - Kranzberg railway line, financed through an AfDB loan.

In 2021, Unik was awarded a tender to construct a 6 8km road in the Ohangwena Region for N\$24-m.

In joint venture with West Trading, Unik recently submitted a N\$259-m ten-der to the Central Procurement Board for the construction of the Ohangwena Regional Council Offices (see separate report on the bid opening on 25-Oct-23

in *Bulletin 1521*).

The media report about the arrest of Jiaxue Liao raised alarm bells at NamWater, which is now investigating the award of a N\$248-m tender for the Ohangwena II Wellfield Water Supply

Scheme to the Chinese company.

NamWater chief executive, Abraham Nehemia, told The Namibian that the water utility was monitoring the situation closely and was conducting its own investigations. "We normally do due diligence with all the companies we award tenders to," he said (*The Namibian* 30-Nov-23; 01-Dec-23).

Award of Ohangwena II Wellfield to Unik not confirmed

Tender Bulletin 1510 published the bid opening of three massive water infrastructure projects in Northern Namibia financed through a N\$1.8-b AfDB loan, where the bids were dominated by Chinese companies.

On the Ohangwena II Wellfield project, Unik Construction was the second-highest offer out of nine tenders

involving ten Chinese contractors. As at 06-Dec-23 no awards for these projects were posted on the NamWater website.

But now it has emerged that Nam-Water awarded tender W/ONB/NW-005/ 2024 for the replacement of Collector 1 - Schwarzekuppe - Swakopmund pipe-line (Collector 2 - Collector 1 section) to Unik Construction / CK Heydt Civils joint venture for N\$59.6-m on 02-Aug-23.

AfDB finds corruption in Eswatini

The African Development Bank Group recently found that Unik Construction had been accused of bribery and engaged in "corrupt practices" on

On 13-Oct-23, the AfDB issued a public statement announcing the conclusion of a negotiated settlement agreement with Unik Construction Engineering (Pty) Ltd, putting an end to sanctions proceedings for a corrupt practice against the Chinese company.

Pursuant to the negotiated settle-ment agreement, Unik Construction Engineering (Pty) Limited, registered in Botswana, will be under a conditional non-debarment for twelve months, effective 11-Oct-23.

During the period of conditional non-debarment, Unik Construction will remain eligible to participate in AfDB Group financed activities, but will be required to enhance its anti-bribery and

its integrity compliance program.

An investigation conducted by the Office of Integrity and Anti-Corruption of the AfDB Group established that Unik Construction Engineering (Pty) Ltd "engaged in a corrupt practice in the context of tenders for the construction of Raw Water Pumping Main, Water Treatment Plant and Treated Rising Main and Construction of Treated Gravity Mains, Storage Reservoirs and Distribution Network - components of the *Manzini* Region Water Supply and Sanitation Project in Eswatini. A representative of Unik had made a corrupt offer to an official involved in the procurement process (from the AfDB website).

The Namibian defence ministry,s August 26 Construction was awarded the contract to upgrade the International Women Peace Centre in Windhoek for N\$30.1-m earlier this year, it has for Ns30.1-m earlier this year, it has emerged. August 26 Construction is a subsidiary of August 26 Holdings, wholly owned by the Ministry of Defence. According to Penda Naanda, execu-tive director of the Ministry of Interna-

tional Relations & Cooperation, this contract was awarded under a restricted bidding process due to the "sensitivity of the project". The MIRC was well within its threshold of a building project up to N\$35-m, he added.

Five pre-qualified tenderers were invited to tender, but only three submitted offers. Naanda said all procedures prescribed by the Public Procurement Act 15 of 2015 were followed, adding: "After following a meticulous process, the tender for the upgrading of the IWPC was awarded to August 26 Construction (Pty) Ltd, which scored 90 points after combining both technical and financial

Only bidders within the range of 15% below and above the cost estimate of N\$27.4-m were considered, after which the N\$30.1-m award was approved by the Ministry of Works & Transport, which was involved in the planning of the project on the property purchased on recommendation of the MWT.

A technical team from the MWT assisted with the evaluation of bid documents, following which the tender was awarded on 24-May-23 and the site handed over on 14-Jun-23. The renovations should be completed by May 2024.

The upgrade was supposed to be

completed before Namibia took over the completed before Namibia took over the chair of the SADC Organ on Politics, Defence & Security Cooperation but Namibia's tenure as chair ended 17-Aug-23, as a result of which the centre could not be used for the SADC Organ meetings.

According to Naanda, this was due to the prolonged procurement process and serious deficits.

The IWPC located at Ausspannplatz in Windhoek was inaugurated in 2020 by vice president Nangolo Nambumba and current deputy Prime Minister, Netumbo Nandi-Ndaitwah. It was then decided that the centre should be renovated to cater for different activities and to enable MIRC to host SADC meetings. The IWPC consists of offices, conference rooms, ablutions and a kitchen (New Era 05-Dec-23).

No record of tender

There is no record of a tender opening or award notice for this project posted on the MIRC website, which does list the executive summary for tender W/ONB/07-02/2021 for minor renovations of the MIRC headquarters and the IWPC that closed on 25-Jun-21. Four offers were received ranging from N\$169,446.75 to N\$418,865.54 Another tender was issued for the same project in 2021 for electrical renovations

Restricted Bidding

August 26 lands mega contracts amidst

controvery and secrecy

August 26 Construction was earlier this year awarded an N\$255-m tender for the construction of classrooms nationwide without any competitive bidding.

Despite not being listed as a state entity in the PPA and its regulations, Sanet Steenkamp, the education ministry's executive director, defended the decision to award the contract to August 26 because the PPA made provision for the execution of projects by public enti-

ties such as August 26. Although the MEAC's 2022/23 annual procurement plan lists 1,053 items on 98 pages that are almost exclusively to be implemented through Open National Bidding, not a single ONB tender for construction has been issued by the education ministry in 2023, according to the *Tender Bulletin*'s database. Another August 26 Holding subsid-

iary, August 26 Logistics, is still trying to recover its N\$2.5-m advance to Penda Enterprises, supposedly to facilitate weapons purchases from Uganda.
Since its formation in 1998, the de-

fence force's business wing, August 26 Holdings has never opened its books for public scrutiny, despite receiving government contracts worth millions.

Reports have repeatedly emerged

of ongoing corruption. These include the procurement of military equipment and theft at the August 26 Textile & Garment Factory that had to be liquidated in 2019 alongside the August 26 Industries Shoe Factory.

Another example relates to North Korea, who built an arms and ammunition factory south of Windhoek in 2005, while North Korean companies were still involved in the construction of a military academy, barracks and the new headquarters for the Namibian defence ministry in 2015, despite international sanctions against that country.

North Korea's state-owned firm

Mansudae Oversees Projects, through its subsidiary Korea Mining Development Trading Corporation, was involved in other Namibian government projects such as the new state house, National Heroes Acre, the NDF's military mu-seum and the Independence Museum (Tender Bulletin 1503).
