

Recent Cabinet Approvals- January 2024

1. Cabinet approves Memorandum of Intent (Mol) between India and Netherlands on cooperation in the field of Medical products Regulation: The Memorandum of Intent seeks to establish a framework for fruitful cooperation and exchange of information between the Central Drugs Standard Control Organization (CDSCO) and the Ministry of Health, Welfare and Sport, Kingdom of the Netherlands on behalf of Medicines Evaluation Board, Health and Youth Care Inspectorate, Central Committee on Research Involving Human Subjects in matters relating to Medical products regulation in line with their International responsibilities.

Cabinet approves Memorandum of Understanding between India Dominican Republic on cooperation in the field of Medical Products Regulation: The Memorandum of Understanding will promote exchange of information and cooperation in areas pertinent to medical products and relevant administrative and regulatory matters within the jurisdiction of the parties. In order to tackle issues of substandard, falsified medicines moving in the international markets, interaction amongst regulatory agencies is facilitated through signing of MoU.

Cabinet approves Memorandum of Understanding between India and Kenya on cooperation in the field of sharing successful Digital Solutions implemented at Population Scale for Digital Transformation: The Memorandum of Understanding intends to promote closer cooperation and exchange of experiences and digital technologies-based solutions in the implementation of digital transformational initiatives of both the country. Both G2G and B2G bilateral Cooperation in the field of Digital Public Infrastructure (DPI) will be enhanced.

4. Cabinet approves Memorandum of Understanding (MoU) between India and Ecuador on cooperation in the field of Medical Products Regulation: The
