# How August 26 coins

**August 26 Construction's honeymoon with the education ministry over its exclusive access to school construction contracts appears to be on the wane after the ministry this month issued 28 open tenders for school construction projects countrywide. But other big state construction contracts are still being dished out to the defence ministry's shadowy business empire on a silver platter, while there's no end to its other corporate escapades below the public radar – still without public disclosures on its financial audits.**

Education Directorate decided to go ahead with the N\$10-m contract.

Although one of the conditions of the contract award to August 26 was that locals should be employed as general workers, August 26 brought in 50 to 60 workers from outside Omaheke.

August 26 was therefore allowed to breach the tender conditions, while the procurement department turned a blind eye. It seems that the governor of the Omaheke Region, Pijoo Nganate, agreed that August 26 could simply ignore the tender regulations.

Finnies called on Nganate and the education directorate to suspend August 26's operations until their concerns were addressed. "We will not allow our political administrative leaders and officials to kill us deliberately by using our own tax money against us in the region", he said (*New Era* 21-May-24).

The *Tender Bulletin* has no public tender on record for this works contract awarded to August 26 without competitive bidding, as in the case of other education contracts since 2023.

## N\$52-m education offices in Ohangwena - were N\$60-m in 2015

Another project that was handed to August 26 without following public procurement processes was the completion of the offices for the Ohangwena education directorate in Eenhana, comprising 80 offices for 450 employees.

The N\$52-m project was supposed to be completed by Mar-19, but came to a standstill after the appointed contractor failed to deliver within the prescribed period.

The education directorate had to pay a monthly rental of N\$400,000 for office space to a privately owned office complex in Eenhana when it moved from Ondangwa to Eenhana in October 2020.

The Oshikoto education directorate is still operating from Ondangwa since there are no offices at Omuthiya. According to Oshikoto education director, Aletta Eises, N\$132-m was allocated in 2016 towards the construction of offices in Omuthiya, but in view of the poor educational infrastructure in the region had prioritized improving school premises for pupils instead.

The education ministry's Steenkamp confirmed that a feasibility study for an education directorate building in Omuthiya was conducted in 2016, but due to a moratorium on new office construction, priority was given to the Ohangwena Region to finalize their offices (*The Namibian* 23-May-24).

According to the *Tender Bulletin* database, former Tender Board tender F1/10/1-2/2015 for the construction of offices for the Ministry of Education at Eenhana in the Ohangwena Region on behalf of the Ministry of Works & Transport closed 21-May-15.

The successful bidder was Andjamba Construction with an offer of N\$59,877,059.50 out of 74 offers from N\$46-m to N\$97.1-m when the tender closed (as reported in *Tender Bulletins* 1145 & 1109).

The contract award nine years ago was for a higher amount than stated above. It could not be established whether the price possibly escalated by N\$52-m for the works recently allocated to August 26.

## N\$26-m Swakopmund neonatal unit escalates from N\$11.9-m in 2020

The Ministry of Health & Social Services has re-awarded its contract for the construction of the N\$26-m neonatal unit at the Swakopmund Hospital to August 26 after the original contractor failed to complete the works in 2020.

The MHSS had to cancel the tender initially awarded to Shatty Construction and replace it with a new one, health minister Kalumbi Shangula confirmed.

The unit will have a 28-bed capacity divided into 12-standard care beds, six high-care beds, six intensive care beds and four isolation unit beds. Work on the facility had started in Nov-20 with completion scheduled for Feb-22.

August 26 is expected to complete the facility before the end of this year (*New Era* 17-Jul-24).

Open National Bidding Tender W/ ONB/1308PF-23/2019 for the construction of neonatal unit at Swakopmund District Hospital closed 08-Apr-20 with 25 offers from N\$11.9 to N\$18.1-m plus two off-the-mark offers of N\$3.1-m (Ipi-lak Construction) and N\$27.2-m (China Jiangxi International).

Shatty Construction's offer was N\$11,905,811 in 2020 which now seems to have escalated to N\$26-m. The 25 bids, including at least five Chinese contractors, were published in *Bulletin* 1348.

August 26 Construction was not one of the original 25 bidders and no public tender was issued by the health ministry for the completion of the project after the previous contractor was fired.

## Additional N\$36-m profit share demanded for Anixas II

Earlier this year, August 26 Construction demanded an additional N\$36-m profit share on the N\$1.2-b 50MW Anixas II Power Station in Walvis Bay.

This demand was rejected by the Israeli joint venture partners FK Generators & Equipment Limited, who were appointed by NamPower as lead contractor in Mar-22 alongside August 26 Construction and PHIM Investments cc.

NamPower had earlier warned the contractors to get their house in order or face a monthly N\$33-m penalty for delaying the project.

August 26 Construction's MD, Col. Martha Endjala, had complained in May-23 to NamPower MD, Simson Haulofu, that they had been removed from the partnership. Through their lawyer, Sisa Namandje, the military owned company demanded the withdrawal of NamPower's consent to change the JV agreement. Endjala told *The Namibian* that August 26 had been removed as a signatory to the JV account.

FK Generators & Equipment is a subsidiary of AUA Energy Limited, which claimed to be solely carrying the costs of the project. This was disputed by August 26's lawyer who pointed out that a credit facility was provided by Bank Windhoek to the joint venture.

In March 2023, FK's chief executive officer, Amir Kurz, explained that it had placed N\$51-m in a deposit account as part of the working capital for the project, which was not profitable partly

After the defence ministry's August 26 Construction Company executed N\$455-m worth of school construction works over two years without any competitive bidding, the Ministry of Education, Arts & Culture has now started advertising its construction tenders again.

As reported in *Tender Bulletin* 1560 the MEAC issued fourteen 'Open National Bidding' tenders for the construction of classrooms, pre-primary classrooms, admin offices, science labs, computer labs, school libraries, ablution blocks and cooking shelters education facilities in all fourteen regions. This is in addition to another fourteen ONB tenders for the construction of pre-primary classroom blocks with storerooms and ablution facilities also in all fourteen regions.

The closing dates for these 28 tenders are staggered from 13-Nov-24 (Erongo Region - Package 1) to 03-Dec-24 (Zambezi Region - Package 14).

The education ministry MEAC did not issue any public tenders for school construction works during 2022 or 2023, while in 2021, five school renovation tenders were publicly issued under the AfDB co-funded Education & Training Quality Improvement Project (ETQIP).

The Omusati Regional Council has just posted fifteen ONB tenders on the GRN eProcurement portal for renovations at schools in its region, completion of several abandoned projects and two new projects for ablution facilities - closing 04-Dec-24 (details in *Tender Bulletin* 1564).

Several regional councils also issued their own tenders on behalf of MEAC for repairs and minor renovations at schools in their regions plus a handful of minor new projects for ablutions, fencing, etc. under 'Request for Proposal' bid invitations during 2024. Here RC Zambezi tops the list by issuing eight ONB tenders for the renovation of damaged infrastructure at schools.

## Lüderitz's N\$60-m school bypassed the CPB

Under the heading 'More schoolyard gravy for the generals' *Tender Bulletin* 1537 reported that the Namibian defence ministry's August 26 Construction Company was contracted to build a new N\$60-m school in Lüderitz without public tender.

This was in addition to 512 classrooms at existing schools countrywide in 2024 under a N\$200-m tender exemption from the finance ministry, which followed its construction of 510 classrooms for N\$255-m at various schools in 2023 – all without competitive bidding.

The Lüderitz Town Council announced the site handover in March on its website after the government allocated land next to the Lüderitz Sports Stadium and the 'Nam!Nüs Constituency Office. It said the school would consist of 15 to 20 classrooms to accommodate 500 learners.

The new Lüderitz school is not listed as a separate project in the 2024/25 development budget, nor was a public tender issued for its construction, despite being "eleven years in the making", according to the town council's website at the time (<https://www.luderitz-tc.com>).

The *Tender Bulletin* has still not come across an annual procurement plan for the education ministry for 2024/25, which might shed some light on the matter. The last plan we could find is for the 2023/24 financial year. And what is posted on the GRN eProcurement portal as MEAC procurement plan 2024/25 is actually an executive summary of a MEAC bid evaluation report.

## Farming out work to other contractors

As reported in *Tender Bulletin* 1534 on 28-Mar-24, August 26 Construction has resorted to appointing other contractors to execute some of its school-upgrading works.

The case of Penatu Trading building the Havana Primary School in Katutura on behalf of August 26 became public knowledge because Penatu's subcontractors complained about underpayment and lack of building materials to complete the classroom blocks allocated to them.

In January 2023, late President Hage Geingob instructed the Ministry of Education, Arts & Culture to team up with August 26 to accelerate the construction and upgrading school infrastructure - at the expense of private building firms - but benefiting the military's secretive business empire, whose audit reports have never been made public.

There is no public tender on record for additions to the Havana PS which MEAC also seemingly handed to August 26 Construction without any competitive bidding.

The architect for the Havana PS project was Gachiku Kamau Architects, with the Ministry of Works & Transport as client. This must have been for the initial new school building, which was funded by the Embassy of Japan through its Grant Assistance for Grassroots Human Security Projects Programme and handed over on 15-Sep-16. The N\$1,041,405 grant was used for four classrooms, a storeroom, ablution facility and the school gate entrance.

## Doesn't qualify for 'Public Entity Procurement'

Although the Public Procurement Act provides for the allocation of tenders through 'Public Entity Procurement' by government institutions, the August 26 Group of Companies is not listed as public entities in an addendum to the Public Procurement Act 15 of 2015.

For the purposes of procurement, public entities are listed in Government Notice 46 'Commencement of Public Procurement Act, 2015' and GN 47 'Public Procurement Regulations' under the PPA in Government Gazette No 6255 of 01 March 2017.

Only two of the NDF's August 26 group of companies are listed under Category 3 state entities: Agro-Tour Company and Sat-Com (Pty) Ltd.

Despite claims by government representatives, such as education ministry executive director, Sanet Steenkamp, that August 26 is a public entity, August 26 Construction or the holding company is not listed as a state-owned enterprise on the Government of Namibia's own official website. Here only the August 26 subsidiary, Windhoek Maschinenfabrik, is mentioned as a state entity.

August 26 Construction is a subsidiary of August 26 Holding Company (Pty) Ltd, wholly owned by the Ministry of Defence & Veterans Affairs on behalf of the Namibian Government.

Projects involving classrooms and ablutions built by August 26 were listed for eight regions, valued at N\$189.9-m in 2023 (*Bulletin* 1510).

These tenders were all allocated to August 26 Construction without competitive bidding. The resultant lack of public scrutiny meant it could not be determined whether the government was getting value for money, since cost estimates were also not made public.

When August 26 Construction does participate in public tenders, it is generally not the cheapest bidder, according to the *Tender Bulletin*'s records (*Bulletins* 1534 & 1537).

The firm has competed in a number of recent tenders.

## N\$10-m Omaheke school ablution contract

Earlier this year, residents in the Omaheke Region were up in arms about a contract awarded to August 26 Construction to erect ablution facilities at eight primary schools.

Community activist, Wallace Finnies, spoke on behalf of disgruntled contractors who were not approached to submit bids when the Regional Council's

due to material price increases arising from the Russia-Ukraine war, amongst the reasons.

AUA transferred cash funds of N\$35-m and issued a N\$122-m bank guarantee from Israeli banks to obtain performance securities and working capital. At the time the aggregate "out of pocket" amount contributed by AUA was approximately N\$326-m.

NamPower spokesperson, Tangeni Kambangula, said in February that the matter was confidential and no information could be disclosed.

In February this year, about 240 of the 300 local workers refused to work due to non-payment of their full salaries since Dec-23. The remaining 60 workers on the Anixas II site were still working for PHIM Investments and Telemenia / FK Generators & Equipment. This resulted in progress significantly slowing down, although the project was about 80% completed at the time.

Due to the Namibian company's refusal to cooperate, no payments were made to employees, subcontractors or suppliers since Nov-23 as reported in February this year.

At the time, the joint venture was attempting to remove its Namibian partner from the agreement in order to regain control of the project (*Namibian Sun* 23-Feb-24; *Die Republiek* 27-Feb-24; *The Namibian* 07-Mar-24).

## Anixas II's 10-month late inauguration

The turnkey construction of the power station seems to have been finally completed, judging by a planned inauguration event. *Tender Bulletins* 1561 and 1562 listed three Requests for Quotations issued by NamPower for sound, lights and a staging services event, infrastructure and décor as well as catering services for the Anixas II Power Station Inauguration Event in October.

The Namibian power utility had issued its own tender in May 2021 for the Engineering, Procurement & Construction of the Anixas II Power Station in Walvis Bay referenced W/OIB/NPWR-03/2021 that closed on 22-Oct-21.

An earlier tender for the same project issued by the Central Procurement Board referenced W/OIB/CPBN-01/2020 closed on 19-Oct-20 but was cancelled in April 2021 (*Bulletin* 1403), after the CPB had already pre-quali-

fied four Chinese contractors (*Bulletin* 1389).

In 2022, NamPower announced the award of its contract for the EPC construction of the Anixas II power station to an Israeli-led joint venture, including August 26 Construction Company, for N\$1.259-b.

The joint venture is led by FK Generators & Equipment from Israel, while the third JV partner is PHIM Investments cc, a consulting engineering firm based in Swakopmund also active in minerals exploration and procurement in diverse fields.

Making the announcement on 11-Mar-22, Namibia's power utility said it would fund, own and operate the 50MW firm power station. Construction was scheduled to commence in May 2022 with a completion date of December 2023. (*Tender Bulletin* 1438)

## Auditor-general's reports remain secret

In May this year, leader of the Popular Democratic Movement, McHenry Venaani, wrote to President Nangolo Mbumba requesting the public release of the Auditor-General's report on August 26 Holding Company, a 100% government owned entity with the Ministry of Defence & Veterans Affairs as shareholding ministry.

After demanding in March that deputy finance minister, Maureen Hinda-Mbunde, should release the report, Venaani then wrote to the Anti Corruption Commission's Director General, Paulus Noa, in April to demand an investigation into the audit reports that have not been publicly disclosed.

In its reply to Venaani, the ACC indicated that former President Hage Geingob assigned the AG in 2021 to provide answers to questions surrounding August 26's finances between 2011 and 2021. The findings of the report were provided to the President in March 2023, after which no further instructions were received.

Since its inception in 1998, the Auditor-General's office has kept any audit reports on August 26 confidential.

Republican Party president, Henk Mudge, also fumed that it was unacceptable that August 26 had seemingly not been audited for years. He called for the 2023 report to be publicly released and discussed in parliament.

Namibia Economic Freedom Fight-

ers deputy leader, Kalimbo lipumbu, said the NEFF called for a criminal investigation into the company and a forensic audit.

"The continued culture of impunity on August 26 and the blatant failure to audit the books of what is otherwise a public company is a violation of the basic tenets of good governance," he added. August 26, where corruption was allowed to flourish, had become an "untouchable holy cow" run by people who have dared defy even the former and current heads of state. The AG should carry out its mandate and investigate the books of August 26 since its inception.

Political expert, Johannes Coetzee, explained that August 26 is a holding company and the financial activities of its subsidiaries' cannot be excluded from auditing by the AG. The company had been involved in several alleged corruption cases since its inception with generals enriching themselves in public-private dealings.

Although the public had valid concerns about August 26, it was expected that the ruling party would delay making available information about possible mismanagement of public funds at August 26 in an election year.

Former ombudsman, John Walters, had already recommended to the National Assembly and Cabinet in 2020 that August 26 should allow public scrutiny of its financial statements. But no action followed this recommendation (*The Namibian* 12-Mar-24; *Namibian Sun* 13-Mar-24; *The Namibian* 31-May-24).

## The battle over Mangetti Ranch

Meanwhile, the Ukwangali Traditional Authority and defence force linked government entities are embroiled in a legal dispute over the land rights to the Mangetti-Kavango Cattle Ranch.

In an application filed in the Windhoek High Court, the traditional authority claimed it could not perform its functions in terms of the Communal Land Reform Act, while the Namibia Industrial Development Agency, August 26 Holdings' Agrotour Development Initiative (Pty) Ltd, the Ministry of Defence & Veterans Affairs, as well as Sirtion Agricultural Projects continue to occupy the land illegally.

The Traditional Authority claimed that the 259,000ha ranch between the Kavango-Owambo Border and the Grootfontein-Rundu road falls within the boundaries of its communal land.

In October 1985, the then Kavango Administration had signed a 10-year lease agreement with the First National Development Corporation of South West Africa Limited for cattle

farming in the area. Although the lease agreement was terminated on 31-Jul-95, the FNDC continued to occupy the land without paying any royalties to the Kavango Regional Council.

The land was later occupied by the Namibia Development Corporation and in 2016 NIDA (Namibia Industrial Development Agency) took over the farming area without applying for occupational land rights from the TA.

In May-22, the TA discovered that the land was not only occupied by NIDA, but also by August 26 Holdings' Agro-Tour Development Company, the MDVA and Sirtion.

NIDA had since awarded a tender for harvesting encroacher bush for charcoal and related products on the ranch, which prompted the TA to initiate the lawsuit in 2023.

However, according to the *Tender Bulletin* database, NIDA Tender 01/2022 for harvesting of encroacher bushes for charcoal and related products at the Kavango Cattle Ranch closing 22-Oct-22 was cancelled on the NIDA website on 05-Dec-22.

On 28-Aug-23, the TA notified the defence ministry of the unlawful occupation by Agrotour Development and August 26 Holdings and demanded that they vacate the land. The TA sought a court order declaring the occupation of the ranch by NIDA and the other parties unlawful. NIDA's lease agreement with Agro-Tour Development, August 26 Holdings and the Defence Ministry is regarded as unlawful by the TA.

The TA also wants the charcoal and firewood harvesting activities by Sirtion Agricultural Projects at the ranch to be stopped. Gal Sirtion acknowledged that they had a contract with NIDA to be on the land.

But the TA also wants all the farmers and the animals to vacate the farm.

In their response, NIDA and the Ministry of Trade & Industrialisation claimed the land does not belong to the TA and the 1985 lease agreement had been extended in May 2010 by another 20 years (*New Era* 15-Apr-24; *Namibian Sun* 31-Jan-24; *Namibian Sun* 25-Jul-24).

Agrotour Development Initiative is the agribusiness and tourism subsidiary of August 26 Holding Company (Pty) Ltd and commenced its operations in 2011. The company primarily operates its agribusiness on 56,588ha at Agrotour Mangetti Ranch in the Kavango West Region, according to the August 26 website).

No judgment on the matter by Judge Shafimana Ueitele could be found, which should have been made in August.

## Chemicals to NamWater

Vast prices ranges from nineteen tenderers competing for the supply of coagulants and flocculants over three years

Nineteen offers were received for the supply and delivery of coagulants and flocculants to NamWater for 36 months, when tender G/ONB/CPBN-09/2024 closed at the Central Procurement Board of Namibia in Windhoek at 11:00, Wednesday 11 September 2024.

The CPB Procurement Management Unit had invited bids on behalf of the Namibia Water Corporation under Open Advertised Bidding. The tender was advertised in two local newspapers in July and listed in *Tender Bulletin* 1550.

The bid opening report was posted on the CPB website, with offers received from:

- \* Benchmark Industries & Investment Group
- \* Classic Technical Services
- \* FoodPro Investment
- \* Geodev Investment - no samples

- \* Heat Exchange Products; Helios Management Group

Bidders had to quote an average bulk price per kg (excluding VAT) for six items. Some tenderers did not offer all the items and several had three alternatives for Item 1.

As an indication, offers for:

- \* Item 1 ranged from N\$9.63 to N\$209.57;
- \* Item 2 between N\$15.30 and N\$80;
- \* Item 3 from N\$19.65 to N\$156.52;
- \* Item 4 from N\$19.65 to N\$156.52;
- \* Item 5 from N\$21.48 to N\$156.52; and
- \* Item 6 from N\$21.56 to N\$82.71.

The bid report did not provide item descriptions.

Commencing in 1990/91, the defence ministry's 'research and development' project has consumed N\$2,349,695,000 in actual expenditure until 2021/22.

Obscured within the Namibian government's N\$203-m 'research and development' programme in its 2024/25 development budget, the defence ministry's secretive N\$165-m R&D project comprises 81% - alongside a further N\$38-m for science and innovation programmes in the civil sector which is supplemented by a mysterious N\$72-m grant from Luxembourg on a project linked to China's satellite ground station.

The N\$203-m 'research and development' programme is one of 55 comprising the Namibian government's N\$12.5-b national development budget this year, of which N\$9.47-b is funded domestically, augmented by N\$3-b in foreign grants and loans.

The financial distribution of development programmes encompasses the 460 individual projects being implemented across the five clusters, with the administrative and security apparatus receiving more than the social sector, as pointed out previously (*Bulletin 1563*).

The National Planning Commission's development budget book for 2024/25 is sometimes vague in its description of development programmes, requiring closer scrutiny to unpick their content.

For example, the programme "Physical Infrastructure Development" for which N\$457-m has been voted inside the State Revenue Fund, augmented by N\$18.51-m in foreign funding, turns out to be for the construction of health facilities.

And the N\$203-m voted for the vaguely annotated "Research and Development" programme turns out to include the Defence Vote's N\$165-m for its R&D project.

### Military R&D

All the development budget has to say about this project is it aims to "provide a modern, well trained and well equipped defence force", stipulating the project as "classified", as in previous years.

Commencing in 1990/91, this project has consumed N\$2,349,695,000 until 2022/23 in actual expenditure, which was not updated from actual spending until 2021/22 as reported in last year's budget, for which N\$111-m voted expenditure has been revised to N\$120-m.

Of the N\$165-m voted for 2024/25, N\$150-m is allocated to the procurement of operational equipment, machinery and plant plus N\$15-m for construction.

It is perplexing to locate which R&D programme involves the remaining N\$38-m of the N\$203-m, but because the NPC stipulates that it is accompanied by N\$72-m in the form of foreign funding outside the SRF, this points to N\$18-m voted for the construction of the satellite ground data receiving station and processing system project in Windhoek, supplemented by an exact matching amount of N\$72-m in the form of the Luxembourg grant. This project is located under Higher Education, Training & Innovation (Vote 32).

# Development

The N\$165-m plus the N\$18-m inside the SRF amounts to N\$183-m, leaving a balance of N\$20-m unaccounted for under the "research and development" programme.

This is a precise match for the construction of the Biotechnology Testing, Training and Research Laboratory (BTTRL) in Windhoek, for which N\$20-m has been voted inside the SRF - also under Higher Education, Training & Innovation (Vote 32).

### The satellite ground station project

The NPC's detailed project description of the satellite ground data receiving station and processing system project in Windhoek, says it stems from a cooperation agreement signed between Namibia and China in 2018 on the operation of the TT&C Station [outside Swakopmund] "it was agreed that China funds the construction of a Satellite Data Receiving Ground Station as one of the benefits to Namibia coming from the Cooperation Agreement [which makes the external funding from the Luxembourg Government rather puzzling, as it evidently comes from China].

The ground station in Windhoek will be used for various applications of remote sensing and service provision, training and research.

The Ministry of Higher Education, Training & Innovation is the executing agency for the project.

"Namibia should be sufficiently capacitated to operate the SDGRS and provide services to the industry", according to the project description.

Responsibilities on Namibia's side include "acquisition of the land for the project, removal and clearing of on-ground obstacles, provision of on-site equipment storage space, security services, transportation of equipment from port to the construction site, facilitate the entry, exit and work permits for Chinese personnel, recommend qualified technicians for training, assist in the logistical arrangement for training, manage, employ and operate the ground station."

Activities for 2024/25 are identified as "construction continues", with last year's activities having been revised to add "commencement of construction" [no tender process] to complete site clearing and hire transportation, stor-

age space services and security [same as in 2022/23].

### Biotechnology Testing, Training & Research Laboratory project

The NPC's detailed project description of the Biotechnology Testing, Training and Research Laboratory (BTTRL) project in Windhoek states that it is renamed from 'National Science Technology and Innovation Valley in Windhoek' [with same project number when listed as new in 2023/24].

The executing agency is the National Commission of Research, Science and Technology (NCRST).

The main aim of this project is to spearhead the co-ordination, development and implementation of appropriate projects related to research science and technology to facilitate linkages and collaboration between different stakeholders in the national system of innovation.

Provision of the testing, training and research laboratory will be accredited to ISO/IEC level 2.

The facility will be used as a biotechnology laboratory including GMO testing services as per the provisions of the Biosafety Act 7 of 2006.

It will also house several units in different fields where other natural sciences tests and research will be conducted.

The previous National RSTI Valley included National Testing, Training and Research laboratories; the National Innovation Hub and National Science Demonstration Centre; to provide infrastructure and institutional arrangements and advocate the mechanisms necessary to encourage research, technical and scientific education, innovations and to facilitate value adding linkages within industry, commerce and S&T institutions, with science labs, offices and parking, whereas the renamed project lists no main components at all.

Activities for this year consist of land servicing Phase 2 and 3 [no reference to Phase 1 from last year, no tender process in either year].

Other development programmes

Besides these obscurities relating to healthcare infrastructure and R&D programmes by the NPC in its budget document, the other 53 programmes are more straightforward.

## The economic cluster

As usual, the economic cluster has the biggest share of 2024/25's development budget, with N\$5.85-b accounting for 61.77% of the N\$9.47-b total, following a 38.5% or N\$1.6-b increase on last year's N\$4.2-b revised expenditure accounting for a higher 65% of N\$6.48-b total development expenditure.

The economic cluster has N\$2.85-b in foreign loans and grants (outside the State Revenue Fund) supplementing its N\$5.85-b domestically funded development budget (inside the SRF) in 2024/25, resulting in a N\$8.7-b total overall.

The economic cluster is implementing 299 projects in 2024/25.

## The transport & industrial cluster

Within the economic cluster as a whole, the transport & industrial cluster's N\$4.38-b budget for development projects in 2024/25 accounts for 74.87% of the economic sector's N\$5.85-b, following a 33% or N\$1.1-b increase on last year's N\$3.288-b revised expenditure accounting for almost 78% of the N\$4.2-b economic sector total.

The transport and industrial cluster consists of four votes:

- \* Mines & Energy (Vote 15) – N\$176.5-m inside the SRF + N\$32.68-m outside the SRF for seventeen projects;
- \* Urban & Rural Development (Vote 17) – N\$1.2-b inside the SRF for 149 projects – the highest number of any vote;
- \* Industrialisation & Trade (Vote 19) – N\$50-m inside the SRF + N\$17.5-m outside the SRF for 20 projects;
- \* Transport (Vote 24) – N\$2.95-b inside the SRF + N\$1.628-b outside the SRF for 52 projects and, as usual, the vote with the biggest share by value of all votes.

## Programmes in the industrial & transport cluster

The industrial and transport cluster's N\$3,116,000,000 domestically funded development programmes in 2024/25 accounts for 32.90% of the total, supplemented by N\$1,661,293,000 foreign grants and loans accounting for 55.00% of the externally funded programmes.

The seven programmes are:

- \* Industrial infrastructure development – N\$36,500,000;
- \* Railway Network development – N\$1,324,000,000 plus N\$1,254,466,000 foreign funding;
- \* Airports infrastructure – N\$431,000,000;
- \* Infrastructure Development – N\$34,000,000;
- \* Roads Infrastructure – N\$1,123,000,000 plus N\$374,147,000 funding outside the SRF;
- \* Energy Infrastructure – N\$150,000,000 plus N\$32,680,000 foreign funding;
- \* Integration and Diversification of the Mining Industry – N\$17,500,000.

## Programmes in urban & rural development & housing

Strictly speaking part of the industrial economic cluster, urban and rural development and housing infrastructure consists of four programmes totaling N\$1,124,756,000 – all funded domestically, with an 11.88% share. They are:

- \* Mass Housing Development – N\$471,806,000;
- \* Rural Infrastructure Development – N\$35,500,000;
- \* Sanitation Infrastructure Development – N\$63,808,000;
- \* Massive Land Servicing – N\$553,642,000.

## The green economy

Within the economic cluster as a whole, the green economy's N\$1.47-b budget for development projects in 2024/25 accounts

for 25.13% of the economic sector's N\$5.85-b, following a marginal 3% or N\$536.58-m increase on last year's N\$933.685-m revised expenditure accounting for 22% of the N\$4.2-b economic sector total.

The green economy consists of four votes:

- \* Environment, Tourism & Forestry (Vote 18) – N\$100.27-m inside the SRF for eight projects;
- \* Fisheries & Marine Resources (Vote 22) – N\$30-m inside the SRF for eight projects;
- \* Agriculture & Land Reform (Vote 37) – N\$550-m inside the SRF + N\$49.55-m outside the SRF for 34 projects; and
- \* Water (Vote 38) – N\$790-m inside the SRF + N\$1.121-b outside the SRF for eleven projects.

## Programmes in the green economy

The green economic cluster's N\$1,372,525,000 development programmes funded inside the SRF account for 14.49% of the total, plus N\$1,170,343,000 foreign grants and loans that make up 38.74% of the total outside the SRF.

There are twelve programmes:

- \* Agriculture infrastructure development – N\$31,420,000;
- \* Crop and Horticulture Production – N\$153,000,000;
- \* Improving livestock production – N\$179,643,000;
- \* Land Purchase and Ownership – N\$170,987,000 plus N\$49,552,000 external funding;
- \* Sustainable Land Management – N\$23,150,000;
- \* Fisheries Infrastructure Development – N\$9,600,000;
- \* Water Infrastructure Development, Maintenance and Rehabilitation – N\$720,837,000 plus N\$1,120,791,000 foreign funding;
- \* Management of State Protected Areas – N\$20,375,000;
- \* Maritime infrastructure development – N\$3,000,000;
- \* Environmental Management – N\$2,450,000;
- \* Integrated Water Resources Management – N\$36,363,000;
- \* Tourism Industry Led Capacity – N\$21,700,000.

## The education cluster

In a repeat of last year, the education cluster enjoys the second-biggest share of 2024/25's domestically funded development budget, with N\$1.3-b – its first allocation above N\$1-b – accounting for 13.77% of the total following a N\$422.3-m or 48% increase over its N\$881.67-m revised expenditure in 2023/24 when it accounted for a similar 13.6% of the total.

N\$153-m foreign loans and grants outside the SRF supplement its N\$1.3-b domestically funded development budget inside the SRF in 2024/25, resulting in an overall N\$1.453-b total.

The education cluster consists of three votes implementing 49 projects:

- \* Education, Arts & Culture (Vote 10) – N\$970-m inside the SRF for 26 projects;
- \* Sport, Youth & National Service (Vote 27) – N\$124-m inside the SRF for ten projects; and
- \* Higher Education, Training & Innovation (Vote 32) – N\$210-m inside the SRF + N\$153-m outside the SRF for thirteen projects.

## Programmes in the education cluster

Development programmes in the education cluster for which N\$1,304,000,000 has been voted inside the SRF, account for 13.77% of the total, plus N\$153,000,000 in external loans and grants accounting for 5.07% of externally funded development budget.

The seven programmes are:

- \* TVET Transformation and Expansion – N\$20,000,000;
- \* Physical Education Facilities Development

Namibia and Beijing agreed in 2018 that China's satellite tracking station outside Swakopmund would be accompanied by satellite data receiving ground station in Windhoek, to be funded by China – which makes the N\$72-m grant from the Luxembourg Government for this project rather puzzling.

- N\$870,000,000;
- \* Strengthening Higher Education – N\$152,000,000 plus N\$81,000,000 external funding;
- \* Adult Education, Information and Lifelong Learning – N\$100,000,000;
- \* Sports Development – N\$103,000,000;
- \* Skills Training – N\$21,000,000;
- \* Research and development [higher education, science] – N\$38,000,000 plus N\$72,000,000 grant from Luxembourg Government.

## The security cluster

The security cluster's N\$867-m development budget is the third-biggest in 2024/25, with a share of slightly over 9% of the total – almost double the health and welfare cluster's 5%.

The security cluster's development allocation this year follows a N\$99.4-m or almost 13% increase – the lowest of five clusters – over last year's N\$767.57-m revised expenditure on capital projects when it accounted for a higher 11.8% of the total – also in third place behind the education cluster and 2.5 times more than health/welfare's 4.78%.

With no foreign loans or grants supplementing its N\$867-m domesti-

cally funded development budget in 2024/25, the security cluster consists of five votes, of which only four are active this year:

- \* Defence (Vote 8) – N\$400-m for four projects;
- \* Justice (Vote 16) – N\$71-m for three projects;
- \* Veterans Affairs (Vote 31) – N\$6-m for three projects;
- \* Home Affairs, Immigration, Safety & Security (Vote 39) – N\$390-m for 41 projects.

## Programmes in the security cluster

Security cluster programmes total N\$975,100,000, accounting for 10.30% of the domestically funded total, with no external funding.

The eight programmes are:

- \* Professionalized Force [military] – N\$235,000,000;
- \* Research and development [military] – N\$165,000,000;
- \* Immigration and Border Control – N\$17,000,000;
- \* Provision of Social Protection – N\$33,000,000;
- \* Rehabilitation and Reintegration – N\$94,566,000;

### The administrative cluster

The administrative cluster has a development budget of N\$975-m in 2024/25, again accounting for the fourth-biggest share of 10.3% of the total out of five clusters and more than double the health and welfare cluster's 5%.

Its ranking is a reversal of the two previous years when had the smallest allocation – trailing health and welfare.

The administrative cluster's 2024/25 development budget follows a fantastic N\$670-m or 220% increase over last year's N\$305-m revised expenditure when it accounted for only 4.7% of the total – less than half this year's 10.3%.

Its 220% increase over last year's expenditure is by far the biggest of all five clusters.

All the administrative cluster's N\$975-m development budget in 2024/25 is funded domestically, multi-sectoral programmes anchored in the administrative cluster total N\$1,103,469,000 funded domestically accounting for 11.65% of the total plus N\$17,510,000 externally funded accounting for 0.58% of foreign grants and loans.

It consists of the largest number of votes – twelve, of which ten are active this year:

- \* President (Vote 1) – N\$108-m for two projects;

- \* Prime Minister (Vote 2) – N\$41-m for two projects;
- \* National Assembly (Vote 3) – N\$10-m for one project;
- \* International Relations & Cooperation (Vote 7) – N\$70-m for two projects;
- \* Finance & Public Enterprises (Vote 9) – N\$425.74-m for six projects;
- \* National Council (Vote 11) – N\$10-m for one project;
- \* Works (Vote 23) – N\$150-m for eleven projects;
- \* National Planning Commission (Vote 26) – N\$10-m for one project;
- \* Information & Communication Technology (Vote 29) – N\$140-m for three projects;
- \* Anti-Corruption Commission (Vote 30) – N\$10-m for one project.

### Programmes in the administrative cluster

The administrative cluster totals N\$1,103,469,000 funded domestically accounting for 11.65% of the total plus N\$17,510,000 externally funded accounting for 0.58% of foreign grants and loans.

The fourteen programmes in the administrative cluster are:

- \* Revenue Management – N\$257,675,000;
- \* Efficiency and legal framework within the National Payment System (NPS) – N\$99,810,000;
- \* Project and Enterprise development – N\$5,000,000;
- \* ICT Infrastructure expansion – N\$70,000,000;
- \* Strengthening and sustaining multiparty democracy – N\$20,000,000;
- \* Public Service Performance – N\$111,100,000;
- \* SME Financing Strategy – N\$68,265,000;
- \* Public works and public property/ asset management – N\$300,869,000;
- \* Regional Integration Framework – N\$3,000,000;
- \* Good Governance – N\$10,000,000;
- \* Provision of Broadcasting Services – N\$80,000,000;
- \* International Relations – N\$70,000,000;
- \* Integration of Marginalized Communities into Socio-Economic Mainstream – N\$2,250,000;
- \* MSMEs & Entrepreneurship Development – N\$5,500,000 + N\$17,510,000 external funding.

### The health & welfare cluster

With N\$475-m to spend on development projects in 2024/25, the health and welfare once more has the smallest development budget out of five clusters, accounting for 5% of the total – a downgrade over the past two years when it ranked second-last – ahead of the administrative cluster.

This is despite a 53% or N\$164.7-m increase over its N\$310.3-m revised development expenditure last year when it accounted for 4.78% of the total which, although lower than this year, was marginally ahead of the administrative cluster's 4.7%.

N\$18.5-m in foreign loans and grants outside the SRF supplement its N\$475-m domestically funded development budget inside the SRF, for an overall total of N\$493.5-m in 2024/25.

The health and welfare cluster consists of three votes:

- \* Health & Social Services (Vote 13) – N\$457-

- m inside the SRF + N\$18.5-m outside the SRF for 25 projects;
- \* Labour, Industrial Relations & Employment Creation (Vote 14) – N\$6-m inside the SRF for two projects;
- \* Gender Equality, Poverty Eradication & Social Welfare (Vote 36) – N\$12-m inside the SRF for four projects.

### Programmes in the health and welfare cluster

The health and welfare cluster's N\$475,000,000 domestically funded development programmes accounts for 5.02% of the total, augmented by N\$18,510,000 external funding accounting for 0.61% of the total.

- \* Physical [healthcare] Infrastructure Development – N\$457,000,000 inside the SRF plus N\$18,510,000 foreign funding;
- \* Labour and Industrial Relations – N\$6,000,000;
- \* Gender Mainstreaming – N\$12,000,000.

# GERMANY LENDS NAM N\$190-M MORE TO FIX INFORMAL SETTLEMENTS

1 NOVEMBER 2024

Germany's KfW Development Bank is lending Namibia N\$190-m to establish an Urban Development Fund to upgrade the country's informal settlements, following a €7-m (about N\$133-m) grant from the Bank in 2021.

A media statement by the German Embassy in Windhoek announced that Namibia's finance minister Iipumbu Shiimi and Germany's ambassador to Namibia, Thorsten Hutter, signed the loan agreement in Windhoek on 24 October following negotiations on development cooperation between the two countries in 2023.

The agreement covers a €10-m (approximately N\$190-m) programme in support of the establishment of an Urban Development Fund, following the earlier €7-m grant via the KfW.

The 2021 agreement was for the provision of financial and technical assistance from Germany to "establish new and improve existing inclusive and sustainable urban development concepts for Namibia's informal settlements", the statement added.

"These concepts aim to improve numerous challenges of these settlements, including the lack of basic services and infrastructure. Roads and transportation systems are usually underdeveloped and limited access to

clean water, sanitation, electricity and waste management and the proximity to industrial areas promote health risks. "Informal settlements often have higher rates of crime and violence due to overcrowded living conditions and inadequate law enforcement and community support. Many structures are built with inadequate materials and are vulnerable to environmental hazards.

"Furthermore, many informal settlements exist without legal recognition, leaving residents vulnerable to eviction and lack of property rights."

The "multifaceted approach" to solve these problems will be executed by Namibia's Ministry of Urban and Rural Development.

The latest N\$190-m KfW loan will provide the basis for establishing a sustainable financing mechanism to develop a blueprint for upgrading informal settlements that can be replicated countrywide, the statement explained.

## DEVELOPMENT COOPERATION

### German development assistance since independence

Germany's development assistance to Namibia from 1990 to 2024 totals approximately €1.6-b (N\$32.3-b), with the KfW portfolio currently under implementation across over 40 projects amounting to €788.6-m (approx. N\$15.4-b), while future projects worth some €123-m (approx. N\$2.4-b) are under preparation.

Germany's €1.6-b development assistance to date makes Namibia the highest per capita recipient in Africa, according to the embassy's website.

It says the current portfolio of

grants and loans being implemented by the KfW comprises 40 projects and programmes worth €582-m (N\$11.4-b), while a pipeline of twelve new interventions worth €301-m (N\$5.9-b) is under preparation.

Alongside these grants and loans, the technical cooperation component implemented by the GIZ (Deutsche Gesellschaft für Internationale Zusammenarbeit) comprises thirteen projects and programmes worth €82.1-m (N\$1.7-b), with four new measures under preparation worth €22.5-m (N\$462-m).

During the negotiations in June 2023, Germany's Ministry for Economic Cooperation and Development (BMZ) committed €51.5-m for bilateral development cooperation consisting of €22-m in loans and grants plus €29.5-m in technical cooperation funding.

Three core areas are targeted:

\* sustainable economic development, training and employment, with areas of intervention consisting of technical and vocational education and training, private sector and financial sector development;

\* climate and energy and "just transition" with interventions in sustainable urban development, renewable energy and energy efficiency; and

\* nature conservation and natural resources, with interventions in biodiversity and water (<https://windhuk.diplo.de/na-en>).

# ONDANGWA'S GRAND SPORTS STADIUM

1 NOVEMBER 2024

The Ondangwa Town Council has awarded a tender for the construction of a state-of-the-art sports stadium to an unknown contractor and without involving the Central Procurement Board for the current N\$60-m stage of the project that could end up costing N\$260-m – well above the council's threshold for conducting procurement on its own.

This follows a groundbreaking ceremony in June 2024 for the construction of their state-of-the-art sports stadium, which might cost over N\$267-m in the end.

The Town Council seems to be unperturbed by the fact that a project of such magnitude should have been dealt with by the Central Procurement Board of Namibia.

During the ceremony, minister of Sports, Youth & National Services, Agnes Tjongarero, said the stadium would serve as a beacon of hope, hub of activity and a cornerstone for sports development in the region.

After the N\$8-m bulk earthworks under Phase 1 were completed, the council announced the commencement of the construction of a boundary wall, drainage, irrigation and planting of grass on the site in Ondangwa Extension 8,

The town council has appealed to government and the public sector for additional funds to complete the project that might cost up to N\$267-m.

The Namibia Fish Consumption Promotion Trust came on board in September with a N\$300,000 donation towards the sports facility.

In an interview with the *Windhoek Observer* in July, Ondangwa mayor, Paavo Amwele, said N\$60-m had so far been set aside for the project, on which over N\$25-m has already been spent since 2017.

Several media reports state that for the 2024/25 financial year Town Council has budgeted N\$16-m towards the project, which is listed on the council's annual procurement plan for 2024/25 for N\$14-m, scheduling an open works tenders for November this year.

The multi-purpose facility will ac-

commodate various sports, such as athletics, soccer, hockey, basketball, netball, volleyball, tennis and boxing, with amenities including fitness centres, sports bars, dining options and lodging.

The stadium's seating capacity has been reported as 7,500 in some media but 20,000 in the *Namibian Sun* of 05-Sep-24

Ondangwa Town Council Infrastructure & Town Planning senior manager, Petrus Shipanga, confirmed last year that the facility should be accredited by FIFA and the International Amateur Athletic Federation (IAAF) (*The Namibian* 07-Jun-23; *New Era* 12-

*Jun-24; Windhoek Observer* 02-Jul-24; *Namibian Sun* 05-Sep-24; *Confidente* 06-Sep-24).
