# INTRODUCTION

The intersection of African resurgence and India's growing economy and global profile has opened up new avenues for deepening the multi-faceted development partnership between the two emerging growth poles of the world. Increasingly, there is an alignment of India's growth agenda and Africa's Vision 2063, which is set to unleash new possibilities of partnering in key areas which are central to unfolding African resurgence, including education, health, capacity building and sustainable development. India and Ethiopia have a robust trade relationship, with India being Ethiopia's second largest trading partner, with significant potential for further growth, especially for small and medium enterprises (SMEs) across sectors like agriculture, textiles, pharmaceuticals, and engineering, due to Ethiopia's fast-growing economy and abundant resources; key Indian exports to Ethiopia include raw sugar, rice, and packaged medicines, while Ethiopia primarily exports pulses, soybeans, and flax yarn to India. India and Ethiopia have been actively fostering collaborations in the Small and Medium Enterprises (SME) sector through various initiatives and meetings. Small and Medium Enterprises (SMEs) play a pivotal role in the economic development of both India and Ethiopia, serving as significant contributors to employment, innovation, and GDP growth.

#### **OBJECTIVES**
