India and Africa share a longstanding partnership rooted in diplomatic goodwill, economic cooperation, and a shared commitment to addressing global challenges. This dynamic relationship continues to gain momentum, with India-Africa bilateral trade reaching approximately **USD 108 billion in FY 2024–25**, highlighting the depth and growing scale of their economic engagement.

Within the African continent, **Mauritius remains a key strategic partner**. Known for its political stability, transparent governance, and investor-friendly ecosystem, Mauritius continues to rank among the top African nations for ease of doing business. The recent business delegation visit to Port Louis further reinforced the shared vision of both nations to deepen economic ties, especially in light of the **Comprehensive Economic Cooperation and Partnership Agreement (CECPA)**—India's first trade agreement with an African nation—which continues to play a pivotal role in facilitating bilateral trade and investment.

In **FY 2024–25**, bilateral trade between India and Mauritius rose to **USD 975.36 million**, reflecting a continued upward trend. India's primary exports to Mauritius include pharmaceuticals, agricultural products, textiles, and seafood, while key imports from Mauritius include niche products like vanilla, medical devices, and specialty goods. India has consistently remained one of Mauritius' top trading partners, with trade volumes showing sustained growth over the years.

While Mauritius continues to be a major source of Foreign Direct Investment (FDI) into India—holding a significant share of cumulative FDI inflows—investment trends are gradually shifting in response to evolving global tax norms. Despite these changes, Mauritius remains an attractive destination for Indian investors, with the government offering targeted incentives across sectors such as **healthcare, renewable energy, ICT, education, and financial services**.

The delegation's visit served as a timely initiative to explore new opportunities in Mauritius' evolving business landscape and reaffirm the commitment to sustainable, inclusive growth. It underscored the potential for collaboration not only between India and Mauritius but also in positioning the India-Mauritius partnership as a gateway for deeper engagement across the broader African continent.

As both nations continue to align their goals for regional cooperation and shared prosperity, this enduring relationship is poised to play a transformative role across the **Indo-African corridor**—anchored in mutual respect, economic synergy, and a future-oriented vision.

INTRODUCTION

The business relations between India and Mauritius have continued to flourish over the years, grounded in mutual trust, shared values, and strategic cooperation. Bilateral agreements and collaborative frameworks have significantly strengthened trade ties, fostering economic synergy between the two nations.

Mauritius has emerged as a preferred destination for Indian investments, particularly in finance, information technology, tourism, and hospitality. The signing of the Comprehensive Economic Cooperation and Partnership Agreement (CECPA) in 2021 marked a pivotal moment in economic collaboration. Since then, trade and commerce between the two countries have seen notable growth across multiple sectors.

In 2024, India's exports to Mauritius were valued at approximately USD 774 million, while Mauritius's exports to India stood at around USD 73 million, resulting in a total trade volume of approximately USD 847 million.

This dynamic partnership has created a conducive environment for investment, technology transfer, and knowledge exchange. The growing economic engagement not only supports the development goals of both countries but also enhances regional connectivity and cooperation.

In March 2025, Prime Minister Narendra Modi embarked on a two-day state visit to Mauritius, serving as the Chief Guest at the nation's 57th National Day celebrations. During his visit, PM Modi and Mauritian Prime Minister Navinchandra Ramgoolam signed several agreements aimed at strengthening cooperation in maritime security, financial crime prevention, and civil service training. PM Modi also inaugurated over 20 India-funded projects and reaffirmed India's support for Mauritius's sovereignty.

As part of its continuous efforts to strengthen India's economic ties with Africa, the PHD Chamber of Commerce and Industry (PHDCCI) **mounted a High-Level Business Delegation to Mauritius from 23rd – 26th March 2025**. The initiative aimed to deepen business linkages and explore new avenues for trade and investment cooperation in the region.

H.E. Mr. Anil Kumar Bachoo, Minister of Health, Government of Mauritius welcomed the delegates and thanked PHDCCI for organizing the visit. He highlighted the strengthening bilateral cooperation in areas such as maritime security, trade and economic collaboration, small and medium enterprises (SMEs), oceanographic research, financial intelligence, digital health and traditional medicine, space research and artificial intelligence, and cultural and spiritual connectivity to leverage on the Free Trade Agreements Mauritius has with all the African nations. He emphasized the need for

The delegates then introduced their respective companies to the High Commissioner and elaborated on the areas of cooperation they would like to explore with their counterparts from Mauritius.

These meetings provided a valuable platform for exploring potential partnerships and joint ventures in key sectors such as healthcare, wellness, pharmaceuticals, fintech, digital technology, and traditional medicine.

Delegates from both sides exchanged insights on regulatory frameworks, investment opportunities, and market entry strategies, leading to the identification of synergies and avenues for future collaboration. Several companies expressed mutual interest in pilot projects and knowledge-sharing initiatives, particularly in digital health and hospital infrastructure.

The interactions reflected the shared vision of strengthening commercial and institutional linkages between India and Mauritius.

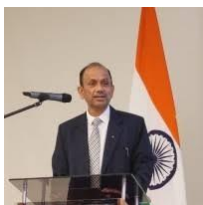

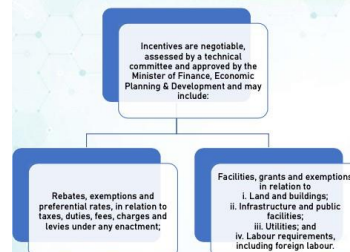

- Under CECPA, Indian service providers will have access to around 115 sub-sectors from the 11 broad service sectors such as professional services, computer-related services, research & development, other business services, telecommunication, construction, distribution, education, environmental, financial, tourism & travel-related, recreational, yoga, audio-visual services, and transport services. India has offered to Mauritius around 95 sub-sectors from 11 broad services sectors, including professional services, R&D, other business services, telecommunication, financial, distribution, higher education, environmental, health, tourism and travel-related services, recreational services and transport services.
- Both the governments are negotiating on attainment of a Mauritian document that can allow Indian SEZ investors visa-free travel to African countries to ease movement of Indian businessmen between India, Mauritius and Africa.
- Mauritius acting as a gateway to Africa and other parts of the world's enjoys a variety of benefits which can be derived by it being a part of the various regional trading blocs like Common Market for Southern and Eastern Africa (COMESA), Southern African Development Community (SADC), The Indian Ocean Commission (IOC) groups, African Growth and Opportunity Act (AGOA), European Union under the Interim Economic Partnership Agreement (iEPA), Economic Partnership Agreement (EPA) with the United Kingdom (UK) FTA with Turkey, China and India and a Preferential Trade Agreement (PTA) with Pakistan. This paves a duty free or preferential access to major tariff lines across the globe. The Indian Industry can leverage on investing in Mauritius and trading with the world.
- Eleven Indian PSUs are present in Mauritius: Bank of Baroda, Life Insurance Corporation, New India Assurance Corporation, Telecommunications Consultant India Ltd, Indian Oil (Mauritius) Limited, Mahanagar Telephone (Mauritius) Ltd., State Bank of India (Mauritius), National Building and Construction Company Ltd (NBCC), Rail India Technical and Economic Service (RITES), Hospital Services Consultancy Corporation Ltd. (HSCC) and EdCIL (India) Ltd. The PSUs have contributed to various activities in Mauritius under the Corporate Social Responsibility (CSR) schemes.



- Nearly 100 Indian Companies firmly established in Mauritius across several key economic sectors
