- Same hotel room (double occupancy; no extra room charge).
- Delegation fee applies only to the officer.
- All partner expenses (meals, sightseeing, etc.) will be borne by the officer.
- Partners/spouses will not be part of official delegation meetings.

- Participants with valid U.S. visas will be prioritized.
- PHDCCI will issue invitation letters and assist with supporting documents.
