- Explore adoption of IoT, fintech, renewable energy, and safety systems.
- Develop export frameworks for GI-tagged and organic products.

Flight Fare:

Logistics & Participant Responsibilities

- Visa Requirements: Submit all visa documents by October 1, 2025.
- Program Fee Payment: Full payment due by October 15, 2025 (non-refundable).
- Visa Fees: Participants are responsible for visa fees and compliance with U.S. visa bond requirements, if applicable.
- Extended Stay Notification: Inform PHDCCI of extended stay plans by December 31, 2025.
- Dress Code: Adhere to formal business attire and professional etiquette.
- Additional Costs: Participants will bear costs for optional sightseeing and personal expenses.

Weather & Clothing Recommendations

- USA Weather (May/June): 13–26°C. Pack light layers, breathable formal wear, and umbrellas.
- Comparison to India: Cooler than India's 35-40°C; light woolens recommended.
