Consulting Services for Project Management and Construction Supervision of Myliddy Fishery Harbour in Jaffna District

The Chairman, Ministry Consultants Procurement Committee on behalf of the Secretary of the Ministry of Fisheries, Aquatic and Ocean Resources now invites proposals from the qualified consultants to provide consulting services for Project Management and Construction Supervision of Myliddy Fishery Harbour in Jaffna District. Total cost estimate for development of Myliddy Fishery Harbour - Phase III is approximately Rs.298 million.

Accordingly, Request for Proposals (RFP) are invited from the well-established Consultancy Firms and more details of the scope of services are given in the Terms of Reference.

1. The consulting firm will be selected in accordance with the procedures set out in the Guidelines for Selection and Employment of Consultants August - 2007. A quality and cost-based selection method will be used based on a full technical proposal. The selection of the successful bidder among the shortlisted ones shall be based on technical and financial criteria, with 70 % weightage for technical competency/capability and 30 % weightage for financial proposal. The Executing Agency reserves the right to accept or reject any or all the offers at any stage of the process without assigning any reasons thereof and no claim/dispute on this aspect shall be entertained.
