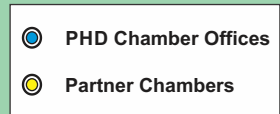
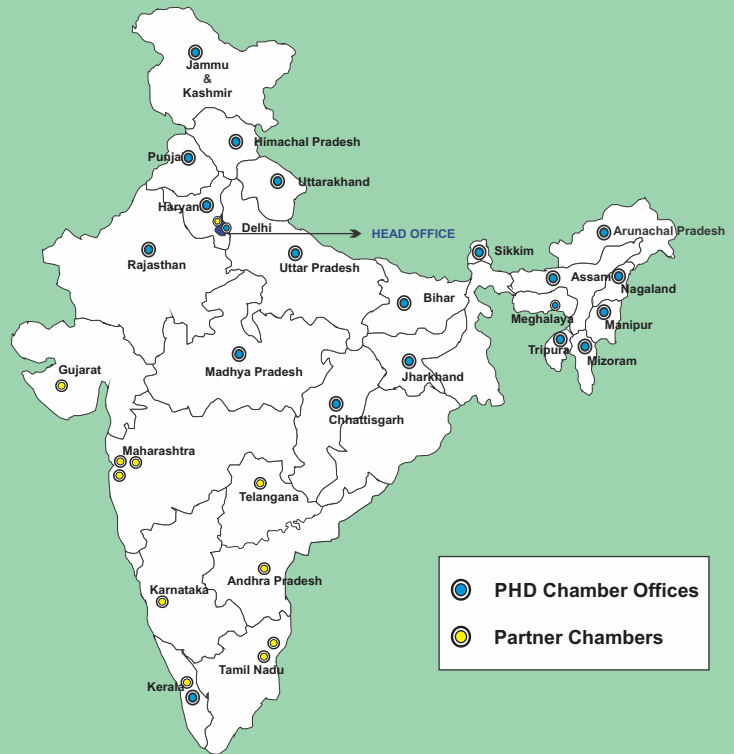

Intellectual Property (IP) refers to creations of the mind: inventions, literary and artistic works, and symbols, names, images, and designs used in commerce.

In the changing global scenario, the issues of IPR have gained special importance for the Micro, Small & Medium Enterprise (MSME) sector. IPR protection plays a key role in gaining competitive advantage in terms of technological gains for achieving higher economic growth in a market driven economy.

PHDCCI has Intellectual Property Facilitation Centre for Micro, Small & Medium Enterprises (MSMEs) supported by Office of Development Commissioner-Ministry of Micro Small & Medium Enterprises. Offering services like drafting of Application /Consultation/Filing/Follow-up for Patents/Copy Rights/Trademarks/Trade Secrets/Industrial Design/Geographical Indication/Present challenges of liberalization & various activities on IPR are proposed under this scheme.

ARBITRATION CELL

PHDCCI has the dedicated ADR Cell of extends institutional service for the Alternative Dispute Resolution (ADR) of commercial disputes.
