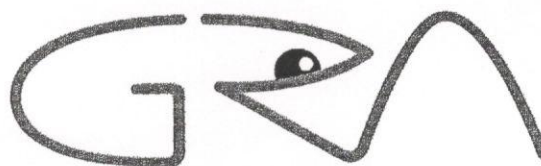
5. Bids will be opened online in the presence of the bidders' representatives who choose to attend at the address given hereunder on Thursday 24th September 2026 at 10.30 hours.
