FOURTH CIRCULAR

**121ST ANNUAL GENERAL MEETING OF PHD CHAMBER OF COMMERCE AND INDUSTRY –
 ELECTION TO THE MANAGING COMMITTEE FOR 2026-27**

This is further to our second circular No. AGM-4-12 dated 1st July 2026 inviting nominations to the Managing Committee of PHD Chamber of Commerce and Industry ("PHDCCI") for the presidential year 2026-27. A meeting of the Scrutiny Committee was held on 10th August 2026 in New Delhi to scrutinize the 39 nominations, in which 32 nominations were found valid. Subsequently communications were sent on 13th August 2026 to the eligible candidates who had submitted their nominations for election and also given an option to withdraw their nomination till 2nd September 2026. Since then, 9 candidates have withdrawn their nominations.

Accordingly, the updated list of valid nominations for election to the Managing Committee of PHDCCI for the year 2026-27 is enclosed herewith as **Annexure-A**.
